Queen's Praise for Canada Canada is an example to the World "A caring Home for it's own and a sanctuary for the others", says Queen Elizabeth II...

 Dressed in a red colored dress with a maple leaf pin, the 84 year old monarch Queen Elizabeth II was full of praise for Canada as she addressed a smiling Prime Minister Stephen Harper and a cheering crowd of 100,000 on Parliament Hill in the nation's capital on Canada Day.

The Queen has visited Canada which she described as her "second home" twenty-two times. She is currently on a visit to Canada as the country celebrates it's 143rd Birthday. Many of them dressed in red and waving Canadian flags, people from all walks of life lined up the streets of Ottawa to witness the Queen's motorcade and have a glimpse of the monarch. A warm sunshine and clear skies in the capital greeted the Royalty.

In her brief address to the nation, she praised Canada for it's values and character. She said "I

have watched with enormous admiration how Canada has grown and matured while remaining true to it's history, it's distinctive character and values. This nation has dedicated itself to being a caring home for it's own, a sanctuary for others and an example to the world".

In his Canada Day address, Prime Minister Harper spoke of the country's achievements this year, including the winning of gold medals at the Winter Olympics and the hosting of the G8 and G20 summits. He remarked that Canada is leading the world, beginning the recovery from the Global recession in the strongest economic position of any country in the world.

Although there is much controversy about the relevance of the monarchy in the 21st. century, there is no doubt that for many Canadians it is an institution that still has meaning.

From the Publisher's Desk ...**Violent Protests and Abuse of Powers takes Centre Stage at G 20**

On the weekend of June 26th, 2010 in Toronto; Canada hosted the fourth meeting of the G20 Summit at the Metro Convention Centre where heads of government gathered to discuss global affairs including the economy and other vital issues affecting the global community. This year's theme was called "Recovery and New Beginnings" in order to create strategies to successfully come out of the continuing recession.

As the G20 Summit drew closer, protests began to form around widespread issues including globalization, poverty, capitalism and other significant concerns. Although protests were held 1 week prior to the Summit, these protests remained peaceful as demonstrators addressed their

issues in a democratic and non-violent way.

This was not the case however towards the first day of the Summit where violent protests took place on the streets of downtown Toronto. The burning of police vehicles, vandalism of commercial buildings and other violent acts occurred during the two days of the Summit.

Security was an ongoing topic of discussion throughout the G20 Summit as Canada spent over 900 million dollars on the preparation and costs involved throughout the Summit. Even with all of this preparation, violent protests took place leaving the city with severe damages to the infrastructure and even during the clean-up.

Although the security of the Summit was given special powers throughout the two days, from arresting people

who would not identify themselves within the security zone to other arrests that the security had a warrant to use; these powers were seen to be taken advantage of. Even during the peaceful protests, several people were detained in the special detention centre for the G20.


Precautions must be taken during events such as these, but certain circumstances should not allow authority to abuse their powers. Media staff and other high profiled figures were detained for unlawful reasons, which created outrage to society. Protesters and other community members felt their democratic rights were being violated and the police and security exploiting their rights.

Protestors from all over the world came to voice their concerns to the world leaders and the greater global community.

Democratic opinions are encouraged in the Canadian society, especially in a culturally diverse city like Toronto, but protesters like the Black Bloc had taken their democratic privileges and abused them when they took part in violent actions during the Summit.

In order for protests to occur the general public and leaders in power have to cooperate together to ensure issues in the global community can be resolved. When violence takes place this trust is taken away, and change becomes more difficult to take place.

Democracy is a vital part of the Western world and will not be successful without compromises. We have moved too far in civilization to go back to winning battles through violence; going forward diplomacy is a key means to success.

Indian Aid Package of Rs.142billion for reconstruction of the North in Sri Lanka

India is emerging as the biggest donor to reconstruct and rehabilitate Jaffna which has been ravaged by the thirty year old war.

A huge sum of Rs. 142 billion has been allocated for this massive reconstruction work by the Government of India and most of this will be in the form of grants and loans. The aid package was finalized at the discussions held recently when Sri Lankan President Mahinda Rajapakse met Indian Prime Minister Manmohan Singh. Sri Lanka's Minister of Economic Development is scheduled to visit India soon to work out details of the implementation of the aid. Much of the assistance will go for the following projects:

Reconstruction of the Rail track from Pallai to K.K.S. and from Talaimannar to Medawachchiya which was badly damaged

during the war.

Construction of 50,000 houses for the displaced people in the North affected by the war Reconstruction and modernization of the Palaly Airport and the KKS Harbour

Restoration of the Duraippah Stadium and the construction of a cultural centre for Jaffna

Restoration of the historic Thirukketheswaram Temple

Establishment of an Agricultural Research Institute in the North

India is also considering direct disbursement of the funds for housing to those displaced by the war. India considers Sri Lanka as a strategic asset and is competing with China in it's aid assistance to counter Chinese influence in the country and to prevent Sri Lanka slipping out of India's orbit.

Here are the 15 conditions spelt out by the European Commission for renewal of GSP+ preferential trade with Sri Lanka. Sri Lanka government rejected the conditions as being an 'insult' and infringing on the 'sovereignty' of Sri Lanka:

1. Reduction of the number of derogations to the ICCPR (International Covenant on Civil and Political Rights).

2. Take steps to ensure that the key objective of the 17th Amendment to Constitution, namely to provide for independent impartial appointments to key public positions, is fully safeguarded, including through Constitutional Council which adequately reflect the interest of all political, ethnic and religious groups and minorities within Sri Lankan society.

The 15 EU conditions urging human rights in Sri Lanka turned down

3. Repeal the remaining part of the 2005 Emergency regulations, notably those Regulations concerning detention without trial, restrictions on freedom of movement, ouster of jurisdiction and immunity and repeal of the 2006 Emergency Regulations (Gazette No 1474/5/2006). If GoSL considers that it is essential to retain certain provisions which are compatible with the ICCPR or UCAT, such as provisions concerning possession of weapons, such provisions should be transferred to the Criminal Code.

4. Repeal of those sections of the Prevention of Terrorism Act which are incompatible with the ICCPR (in particular sections 9, 10, 11, 14, 15, 16 and 26) or amendment so as to make them clearly compatible with the ICCPR.

5. Repeal of the ouster clause in section 8 and the immunity

clause in section 9 of the Public Security Ordinance or amendment so as to make them clearly compatible with the ICCPR.

6. Adoption of the planned amendments to the code of Criminal Procedure, which provide for the right of a suspect to see a lawyer immediately following arrest.

7. Legislative steps necessary to allow individuals to submit complaints to the UN Human Rights Commission under the First Optional Protocol to the ICCPR and to the UN Committee against Torture under Article 22.

8. Steps to implement outstanding opinions of the UN Human Rights Committee in individual cases.

9. Extension of an invitation to the following UN Special Procedures who have requested to visit Sri Lanka (UN Working

Group on Enforced Disappearances, UN Special Rapporteur on Torture, UN Special Rapporteur on Freedom of Expression, UN Special Rapporteur on Independence of Judges and Lawyers).

10. Responses to a significant number of individual cases currently pending before the UN Working Group on Enforced Disappearances.

11. Publication of the complete final report of the 2008 Commission of Enquiry.

12. Publication or making available to family members a list of the former LTTE combatants currently held in detention as well as all other persons detained under the Emergency Regulations. Decisive steps to bring to an end the detention of any persons held under the Emergency Regulations either by



releasing them or by bringing them to trial.

13. Granting of access to all places of detention for monitoring purposes to an independent humanitarian organization, such as the International Committee of the Red Cross.

14. Adoption of the National Human Rights Action Plan by Parliament and its prompt implementation.

15. Take steps to ensure journalists can exercise their professional duties without harassment.

Freed Sri Lankan journalist Tissainayagam arrives in U.S.

Press Release from the Committee to Protect Journalists

New York, June 19, 2010-The Committee to Protect Journalists welcomes the arrival in the United States of Sri Lankan journalist J.S. Tissainayagam, who arrived at Washington's Dulles International Airport on Saturday, Jun19th morning.

He was met there by friends. According to CPJ representative Kamel Labidi, who was on hand to meet Tissa, "He was all smiles, and said to thank everyone who helped him gain his freedom."

"Tissainayagam's arrival in the United States is very welcome news, and we join in the joy that he and his wife Ronnate are feel-

ing," said Joel Simon, CPJ's executive director. "We hope his arrival in the U.S. is a step by the government to address its harsh policies toward the media-policies that have not changed since the end of Sri Lanka's more than 30 years of civil conflict."

On May 3, World Press Freedom Day, the government announced that it would grant Tissainayagam a presidential pardon. Tissainayagam had been released on bail in January and had lived in seclusion in Sri Lanka since. The Tamil editor was first jailed in March 2008 and eventually indicted under the Prevention

of Terrorism Act in August 2008.

So far, the Sri Lankan government has made no official statement about the terms of his release, and Tissainayagam and his wife have made no public statements.

Ontario's Tax Plan (HST) for Jobs and Growth - A special Press meet with Hon. Dr. Eric Hoskins, Minister of Citizenship and Immigration & Mrs Kathleen Wynne, M.P.P. Don Valley West

Canada being a country of cultural diversity, gives importance for the best prosperity of contended life with unity of all ethnic community in this beautiful nation. As such the Govt implements various projects for economic plans & developments particularly towards tax strategy and employment opportunities to the new immigrants. As part of its plan to make Ontario more competitive, the province is implementing the most important tax reform in a generation. most competitive jurisdictions in the industrialised world.

As the results of new comers companies will be able to invest the savings they generate from the HST on new training programs to ensure that newcomers can put their skills to work. Further this new plan includes permanent income tax cuts for families and new permanent sales tax credit. Advantages and Disadvantages of Anger

Following injury or during an illness, it is not uncommon for a person to experience increased irritability and anger. Pain, uncertainty, stress, and poor sleeping are often the underlying causes. Many people consider anger a strictly negative emotion to be avoided and ignored. Certainly, violent actions or harsh words towards others that occur as a result of anger often create problems and may drive others away. This is not to say, however, that anger in itself is a negative emotion. Rather, anger can be turned into a positive force when, for example, it stimulates a burst of energy to allow an individual to endure a frustrating situation, when it signals others that one will not be mistreated, or when it indicates that, for the moment, one needs to be left alone. In addition, anger can be an important signal to oneself that a situation is becoming overwhelming, that he or she is being threatened, or that one may be getting into a situation which may be beyond his or her coping abilities. In this respect, anger can help to teach an individual about his or her own limitations and capabilities.

Thoughts That Produce Anger

The expression, "Nothing is either good or bad, but thinking makes it so," provides a useful reminder that thoughts, rather than situations, produce anger. Clearly, the way in which individuals view certain events determines whether they are negative or positive experiences. For example, one may feel that a playful child who is getting into mischief is "curious, active, and healthy" or that he or she is "a nuisance, inconsiderate, and uncontrollable." When the child is viewed as simply showing curiosity and a desire to learn about the world, then his or her behavior is likely to be accepted with a calm disposition. If, however, the child is viewed as being disruptive, his or her actions are likely to make one feel angry.

Analyzing Angry Thoughts

When an individual becomes angry in a specific situation, and especially in situations which have caused anger in the past, it is important to analyze the thoughts related to those incidents. The following are some types of thoughts which will often provoke anger and/or stress:

" Having high or unrealistic

expectations (e.g., "The kids should be quiet all the time").

" Lacking self-confidence in managing the situation (e.g., "I can't cope").

" Neglecting to consider other people's point of view

" Seeing things in only "black and white" terms (e.g., "The pain must be completely gone before I can work").

" Blaming oneself or others, rather than showing forgiveness

Being Aware of anger Building

Many people insist that their anger builds up over the course of a few seconds, or that it does not build at all but comes on suddenly. In many instances, however, this is not the case. In fact, usually an anger provoking situation either has occurred in the past, making the person angry in similar situations, and/or the anger will gradually build over the course of a lengthy period of time, even though the person may not realize it. Often, small irritations over the course of hours or days build up, causing one final incident to spark more intense bursts of anger.

An individual can use his or her knowledge that certain people, conversations, places, or activities tend to provoke anger in him or herself. This knowledge can allow the individual to prepare a strategy in advance when these situations are about to unfold. Likewise, headaches, neck or back pain, increased blood pressure perspiration, and other signs of stress can signal an anger outburst about to occur. Furthermore, recognizing another individual's anger, as shown by way of certain signals such as intense facial expressions, tense

body posture, increased loudness of speech, or swearing, also can be used as signals to help avoid unnecessary conflict, harsh words, or violent actions.

Anger Management Techniques

The following is a six-step procedure to assess and manage situations of anger and assist in avoiding violent or confrontational circumstances:

1. Recognize and anticipate anger based on what you know of past situations. For example, seek signs that the other person/people are beginning to appear more tense and angry, and learn to recognize signs of your own anger and stress. These signals should prompt you to begin using an anger management technique.

2. Relax and evaluate the situation and then consider the best method to use, and to control your anger in case the situation gets out of hand.

3. Use a relaxation technique

such as slowing your breathing, imagining a tranquil scene, or relaxing your muscles.

4. Decide on your approach, which may include any of the following:

" Use humor to ease the tension

" Try to see the other individual's point of view or the view of an "objective observer"

" Excuse yourself and leave the situation; perhaps arrange to continue later

" Be assertive (not aggressive) and defend your right if you feel that it is appropriate to do so

" Count to ten; taking this brief pause is often effective in averting unnecessary anger

5. Evaluate how well you have managed the situation and reward yourself when you've done well, then suggest to yourself how you would like to handle similar situations in the future.

6. Maintain a long term "anti-tension" strategy

Seek professional help, especially when your actions are, or may become, physically threatening.

Managing Anger Towards Others

When you feel angry towards another person or his or her actions, give the person direct feedback on how his or her actions affect you. Indicate to the individual what behavior causes your emotional reaction by saying something like: "when you do_____, I feel _____ (irritated, angry, more pain, embarrassed, etc.)". For example, you might say, "When you play your music loudly, I feel edgy and my headaches become very intense". The individual is likely to react better to such an approach, than he or she would to swearing, shouting, or name-calling. If your anger is at the point where either physical violence or injury to others is a concern, please seek professional help immediately.





Legal Luminary Senator S.R.Kanaganayagam's Portrait unveiled at Jaffna Law Library

"He carried the torch of independence, dedication and courage" - Justice C.V.Wigneswaran

The portrait of Senator S.R Kanaganayagam, popularly referred to as "S.R." and a popular lawyer who had a half a century of civil practice, was unveiled at the Jaffna Law Library recently.

The function was presided by Shantha Abimanasingham P.C, President of the Bar Association of Jaffna who was a Junior Counsel in Senator Kanaganayagam's Chambers. The portrait was unveiled by Justice C.V.Wigneswaran, retired Judge of the Supreme Court. The event was well attended by a large gathering of members of the Judiciary of the Northern Province, several Attorneys-At-Law and members of the public.

Among the family members present at the function were "S.R's sons- Colombo's well-known Lawyer Kanag Iswaran, President's Counsel, Mr.Maheswaran and "S.R's daughter Savithri Devi and her husband Dr.Balasubramaniam from Sydney, Australia. Other members of Mr. Kanaganayagam's family circle present at the function were the sons of Kanag Iswaran - Kishaan and Shivaan (also a Barrister) and daughter Radhika and grand daughters Shayaana and Kiyasha (from U.S.).

Speaking at the function after the unveiling of the portrait, Justice Wigneswaran traced the career of Senator Kanaganayagam and remarked that he had a way of understanding the Judges and taking them along with his arguments. He remarked that "S.R" carried the 'torch of independence, dedication and courage'. He requested the younger attorneys to follow these principles. Justice Wigneswaran also reminded the audience that the Senator

was always conscious of his social responsibilities and had mastered the art of court craft.

Mrs.Savithri Devi Balasubramaniam, Senator "S.R."s adored daughter, proposed the vote of thanks. A dinner hosted by Mr.Kanaga Iswaran (Senator's eldest son and President's Counsel) followed the function.

Senator Kanaganayagam had a lucrative practice in civil law for well over half a century in Jaffna. He had a firm grasp of the basic principles of the Law and was known for his skilful cross examinations. He was called to the Bar in 1933 and worked in the Chambers of Sir Vaitilingam Duraisamy and Homer Vanniasingam, two well-known legal luminaries of the Northern Province at that time. The Thesavalamai Law and Temple Trusts were his forte in his legal practice. He was appointed a Senator in 1949 and served two terms till 1957 making valuable contributions in the debates in the Senate.

Senator Kanaganayagam was an excellent speaker both in English and Tamil. He was also involved in cultural and religious activities. He set up the Ramanathan Academy of Music and was its first President. He was also the President of the Ramanathan Trust.

Known for his ready wit and humour in his practice, "S.R." was the last of the Jaffna legal brigade which shed luster to the legal profession as well as to the public life of Jaffna. Senator Kanaganayagam's skill as a lawyer can be summed up in what people referred to him as "a good lawyer for bad cases".







Jayalithaa urges implementation of an 18 point plan to alleviate Tamils' plight



AIADMK General Secretary Jayalithaa

AIADMK General Secretary Jayalithaa on Saturday June 19th listed an 18 point request to help Tamils in Sri Lanka. "The Centre and the Tamil Nadu governments must ensure that the Lankan government fulfills these promises and resettles the Tamils," she said in a statement released in Chennai.

Ms. Jayalithaa said Tamil Nadu Gov. conducting Tamil Classical Conference in Coimbatore under the present circumstances is totally unnecessary, and called for the implementation of the following 18 points to alleviate immediate difficulties of Tamils in Sri Lanka:

- 1) Still there are still 100,000 people languishing in camps in Sri Lanka North. They should be accorded with resettlement and rehabilitation.
- 2) It is imperative that resettled people are provided with adequate relief supplies.
- 3) Scorched agro lands must be restored.
- 4) Re-construct destroyed water resources
- 5) Provide education for people
- 6) Inaugurate new educational institutions
- 7) Construct new educational facilities
- 8) Renovate and repair educa-

- 9) Enable rehabilitation of women widowed during the war
- 10) Provide counseling and assistance to sexually abused women and children during the war
- 11) Renovate temples, churches and mosques
- 12) Take measures to curtail temples and churches being converted into Buddhist monasteries
- 13) Provide medical assistance and rehabilitation to those became incapacitated during the war
- 14) As the number of males have dwindled, alleviate the stress encountered by women
- 15) Empower women through businesses run by women
- 16) Assure all relief assistance is properly reaches Tamil people
- 17) Allow Non-Governmental Organizations to operate there
- 18) Grant permission for media persons to meet Tamils.

UN Panel on Sri Lanka: 'Public report for one death, secret for tens of thousands of deaths?'

Indonesia's former Attorney General Murzuki Darusman, a member of the panel of Advisers on Sri Lanka announced by Secretary General Ban-Ki-moon also served on UN panel inquiring the death of Benazir Bhutto of Pakistan and that panel's report was released to the public.

However, in Sri Lanka case though, UN did not say today if the panel's report will be made public, nor if any of the three members will take questions from the Press, according to Inner City Press (ICP).

On War Crimes, UN Ban's Panel May Not Speak to Fonseka or Travel to Sri Lanka, Report May Be Secret

UNITED NATIONS, June 22 -- A panel on Sri Lanka war crimes has been named by UN Secretary General Ban Ki-moon, the day after Inner City Press exclusively disclosed the names of its three members -- but the panel, it turns out, won't necessarily travel to Sri Lanka or interview any witnesses.

Inner City Press asked Mr. Ban's spokesman Martin Nesirky if, for example, the panel will interview Sarath Fonseka, who served as General in charge during the final stage of the conflict and who has spoken of orders to kill people who surrendered, a war crimes.

Nesirky replied that "the mandate is such that some of the precise details, the who and how, still need to be worked out." The aim, he said, is to speak with "the concerned officials," and to finish in four months.

Which officials are more "concerned" than President Mahinda Rajapaksa, his brothers Gotabaya and Basil, and his Ambassador to the UN Palitha Kohona, named by Ban's chief of staff Vijay Nambiar as

having given assurances that those who surrendered would be treated in accordance with international law -- before they were killed

(Kohona disputes the timing of his communications with Nambiar, something that at a minimum one would expect this UN

Military mass wedding: "Rehabilitation rendered a publicity stunt"

"Freedom when?" was what many in the "wedding ceremony" asked according to BBC Sandeshaya and tweets remarked the military marriage of militants "hugely oversteps ethical boundaries".

The ceremony attracted widespread media coverage. Reports say the mass wedding was held under heavy military presence and future for the newly-weds remains uncertain:

Report by Sandeshaya:

The Sri Lankan military has organised a mass wedding of more than fifty couples suspected to be from the Tamil Tiger rebel group at a ceremony in Vavunia.

Suspected former rebels are being held at a military-run camp following their defeat by government forces in May last year.

Sri Lankan army says many of the couples had been unable to marry earlier because they were fighting in the civil war.

A BBC correspondent who attended the event says many now want to know when they will be freed from military custody.

The mass wedding was held under heavy military presence.

The director general in charge of rehabilitation, Brigadier Sudantha Ranasinghe said that the newly weds will be housed in

a designated village.

"Arrangements have been made for their relatives to visit them," added Brigadier Ranasinghe.

More than ten-thousand Tamil Tiger rebels, who surrendered following the defeat of Tamil Tigers in May last year, are under military custody in northern Sri Lanka.

Excerpts from the report by Guardian UK:

Ravichandra Rasikeshara, 26, married another former fighter, 22-year-old Thaksarani.

"We don't want an Eelam [a separate state]. We want freedom and a happy family life," Ravichandra, who worked as a paramedic for the LTTE, said.

The witness for the marriages was Indian film star Vivek Oberoi who had come to Sri Lanka for an Indian film awards ceremony earlier this month and visited the camp at the government's invitation.

The future for the newly-weds

remains uncertain. Sivapathasundaram Kavithas, 29, had been a fighter for nine years and had met his wife Bhavani, 28, a fighter for 12 years, when they went for weapons training together.

Kavithas said he was pleasantly surprised that his marriage was formalised but said he still longed for freedom from the camp to look after his sister who lives alone. Their parents and two brothers were killed in the last stages of the fighting, he said.

"We will live the same restricted life, the difference is we will be living together again," said Bhavani.

The couples will be provided with separate tents. Few will be going on honeymoon in the near future. Nearly 3,000 of the 11,000 former Tigers detained at the war's end have now been released but Brigadier Ranasinghe said "a little bit more rehabilitation work" was needed before those married yesterday could go free.

Inner City Press asked Nesirky, in light of the European Union's announcement that it will only extend the GSP Plus tariff benefit if the Rajapaksa administration takes specific human rights related actions in the next six months, if the UN believes or wants one of the actions to be cooperation with the UN panel.

Nesirky replied, we're focusing on the work of this advisory panel. So much for coordination.

So much, too, for consistency.

Murzuki Darusman served on Ban's panel on the death of Benazir Bhutto of Pakistan. That panel's report was released to the public. Darusman came to the UN briefing room on the day of its release, and Inner City Press asked him questions.

In this Sri Lanka case, though, Nesirky would not say if the panel's report will be made public, nor if any of the three members will take questions from the Press.

Inner City Press asked, for example, how Mr. Darusman will

handle his four month Sri Lanka focus with his new other job, as special rapporteur on human rights in North Korea / DPRK.

Has Steven Ratner performed any other service for the UN, other than advising Kofi Annan about Cambodia's Khmer Rouge in the last 1990s? Nesirky did not answer any of these. And so we'll add a third, about the third member: is Yasmin Sooka more about reconciliation or accountability?

Even as Nesirky announced the names, confirming what Inner City Press has asked him on the record the previous day, his Office did not have ready biographies for the three, as is the usual practice.

Later on Tuesday, Jun 22nd after Inner City Press asked Nobel laureate and Elder Maarti Ahtisaari a question, Ahtisaari said of Sri Lanka that it was sad that in the international community, no one had been prepared to do anything. Sad indeed.

From Indian point of view the much hyped visit of Sri Lanka President Mahinda Rajapaksa to New Delhi from June 8 to 11 can be summed up in one sentence as much ado about few things, with apologies to Shakespeare.

Shorn of usual diplomatic fillers, the tangibles in the joint statement issued at the end of the visit were on three tracks. One set formalised projects already in the pipeline for some-time and included financial incentives from India to push them forward. The other set attended to easing structural arrangements (i.e., agreements, MoUs, statement of intentions) to promote better relations and trading arrangements. And the third set related to rehabilitation largesse from India.

But there was little or no animation of perennial issues discussed in the joint statement. There were very few hopeful signs to progress three gritty issues rehabilitation, devolution, and strategic security. Overall, the impression created after the Presidents visit is that India had tacitly agreed to let President Rajapaksa handle these issues at his own pace in his own style. I will be happy if those involved in the process prove me wrong.

The Indian Prime Minister making the inane statement that a meaningful devolution package, building upon the 13th Amendment, would create the necessary conditions for a lasting political settlement, creates the impression that sidelining of the Tamil issue appears to have been accepted. In the last three years India's representatives have said the same thing a number of times. And Sri Lanka's response had been more to buy time than make any real progress on the issue.

President Rajapaksa does not talk any more about the 13th amendment or even the 13th amendment +. So not surprisingly in the joint statement he made no commitment to implement the 13th amendment which in any case has been pushed to the realms of relevance. The President merely reiterated his determination to evolve a political settlement acceptable to all communities that would act as a catalyst to create the necessary conditions in which all the people of Sri Lanka could lead their lives in an atmosphere of peace, justice and dignity, consistent with democracy, pluralism, equal opportunity

and respect for human rights. Towards this end, the President expressed his resolve to continue to implement in particular the relevant provisions of the Constitution designed to strengthen national amity and reconciliation through empowerment.

Have we not been hearing similar dialogue for a long time now between Sri Lanka and India? It is difficult to understand how the mere repetition of implementation of 13th amendment as a mantra from Indian side and the flowery rhetoric on democracy, pluralism et al from the Sri Lankan side are going to improve the lot of Tamils. Are we not thinking of any other options? Apparently not; otherwise it would have found a place in the joint statement.

So it is no wonder Tamils on both sides of the Palk Strait feel they have been let down very badly by India. The window dressing offered by arranging a meeting between the visiting President and the members of parliament from Tamil Nadu might satisfy the ruling coalition party leaders but not the people. The rhetoric and political manoeuvring on this count to be wearing thin as people are waiting to see visible action on all fronts from Indian side.

Of course, later in Chennai Home Minister P Chidambaram, presumably on a mission to enlighten Tamil Nadu on the take-aways, highlighted India's allocation of Rs 1000 crores to build 50,000 houses for people in north and south left to fend for themselves. And he explained that the money would be directly given to householders through banks.

While this is laudable, the process of rehabilitation has remained good in parts like the proverbial curates egg. But what is the overall architecture for enabling the people ravaged by war to resume normal life and join the national mainstream? Without such an architecture bound by a time frame, accountability from both sides and integrated execution, these welfare measures tend to get dislocated, downgraded or even get hijacked. For instance, in the east infrastructure facilities have made good progress, but peoples struggle for livelihood continues as before.

When the Eelam War raged there were protests in Tamil Nadu by pro-Eelam and pro-Tamil Tigers segments of political parties on happenings in Sri Lanka.

Then these were joined in by protests on human rights violations and humanitarian issues and war crimes. The protests were neither large nor spectacular. But they were there.

During President Rajapaksa's visit this time - a year after the war - the protests have become significant because there is no Prabhakaran or war to give a boost to these protests. The protests had gathered sufficient public and media attention, even without the orchestration provided by the war.

The pro-Eelam leaders Vaiko and Nedumaran and about thousand followers courted arrest while protesting against the Presidents visit. These protests have to be studied in sequence of Sri Lanka-centric events that have been happening. First there was pressure on film personalities to boycott the International Indian Film Awards function in Colombo. These were followed by protests in other forms in Tamil Nadu. There are indications of simmering discontent over Sri Lanka policy increasing into effervescence.

A Public Interest Litigation filed in the Madras High Court sought issue of directions to the government to arrest Sri Lanka Minister Douglas Devananda, who was part of President Rajapaksa's entourage. The PIL alleged Devananda was a proclaimed offender, wanted in a slew of cases including murder in Tamil Nadu.

The moot point is the Tamil Minister, well known for his strong anti-Prabhakaran stance and equally strong support to the President, had visited India and Tamil Nadu a number of times even at the height of the Eelam War. And nobody thought of raising the issue on such occasions earlier. Why now, after the defeat of the Liberation Tigers of Tamil

Eelam (LTTE) and decimation of its leadership? Clearly the PIL was aimed at embarrassing New Delhi and the visiting dignitary.

The other incident was more sinister. Thanks to alertness of railway staff, the Rock fort Express train going from Kumbakonam to Chennai escaped from accident after a metre-long portion of the railway track was found blown up at Sithani, about 25 km from Villupuram junction on the railway link to Chennai. The incident happened a day after President Rajapaksa flew out of New Delhi. High-power gel-type explosive device ignited by electric power had been used indicating familiarity with handling of explosives.

It was powerful enough to create 80-cm crater and blow up the sleeper along with a piece of the rail. The Police were quick to suspect the Tamil Nadu Maoist elements and later the Tamil Tiger acolytes in the act of sabotage. Both are capable of organising the sabotage. Even though they failed to derail the train, with their act they have sent a strong message of their extreme frustration at India's inability to respond to the Tamil problems in Sri Lanka.

During the Eelam War, there were a few instances of the LTTE elements and the Maoists coming together for mutual benefit. But caught between the turbulence of caste politics and the allure of Dravidian political idiom, Maoists were always weak force in Tamil Nadu. Even those few fell out with

the all India body of the organisation in the eighties over the question of supporting Tamil nationalism. They could not survive as a cohesive entity in the face of the Tamil Nadu police dragnet. So they scattered and have become embedded in one or more of the half a dozen small Tamil political outfits.

These fringe outfits have diverse agendas, but are united in the struggle to preserve exclusiveness of Tamil identity and Tamil nationalism which they feel are threatened by New Delhi and Colombo. They are unhappy that even the Tamil Nadu chief minister Karunanidhi, who used to tacitly support the Tamil identity issue, has joined the national political mainstream and let them down.

It is doubtful whether the disparate groups can come together to form a mighty insurgent body in Tamil Nadu like the LTTE and wage war as Prabhakaran did. That may never happen. But they represent the extreme edge of the anger many Tamils are feeling over India's failure to respond positively to attend to the Tamil grievances in Sri Lanka. This is more so because India had vigorously championed their cause in the past. This feeling has many takers among Sri Lankan Tamils both at home and abroad.

Usually police are left to handle developments of extremism in a knee jerk reaction. However, in Tamil Nadu the approach has to be more nuanced. We need to pay serious attention to the issues that have generated the discontent and act to produce visible results in Sri Lanka. And political parties of Tamil Nadu have a large responsibility in suggesting and steering New Delhi to positive courses of action than merely acting as listening posts, playing politics.

Recently Canada is looked upon as a super star. It is the nation that is the most preferred to migrate to compared to other developed countries. Although many factors contribute to this, the way in which Canada overwhelmingly accepts new immigrants while other receiving countries only tolerate them prompted me to write this article.

It makes us feel proud of who we are in the sense of identity and occasionally when we visit other countries around the world that the reflection of Canadian values wake us up and stirs in us a feeling of pride in our beloved nation of Canada and this has happened to me personally on a few occasions and I have heard similar anecdotes from my friends which had subsequently been buried in their subconscious mind through layers of memories. We who know not and are aware that we know not, will certainly open our eyes and minds to understand and merge with the growing global position of Canada on the international stage.

I appreciate the forefathers of this nation, the builders who made a tremendous sacrifice in constructing the castle of the nation with Canadian values as the bricks and a foundation so solid that even an earthquake would not be able to shake it. I would like to illustrate my point with this example; When some of the disappointed, dissatisfied British alongside the more adventurous and with the French descendants migrated and made their settlements in the northern part of the new world, at that time the Americans were involved in an aggressive and demanding revolution against the British Empire. The American Revolution was between the colonial rulers and the colonized inhabitants and the aim was to sever the connection to the Empire right down to the roots. But the Canadians, the British Loyalists took a different route and won their freedom while maintaining its cordial relationship with the Crown and to this day, we still have the British monarchy as the head of state in Canada, though it is only a symbolic position. Today, particularly since the beginning of the war against terrorism in Iraq and Afghanistan by the United States of America, the U.S and Britain have renewed their relationship, though not in the same vein as the colonial past. Although Canada made a

shift in having a close and effective economic relationship with Britain and later on shifting to the States a few decades ago, former Prime Minister Jean Chretien did not want Canada to join the American coalition forces in those wars, without the blessing of the United Nations. There were many occasions in which Canada did not dance to the piper of Great Britain and another example of this was the war in the Suez Canal against Egypt in 1957, Canada did not accept the request to join the British forces and kept itself away. Although Canada has very close ties with America from the cultural industry to our economic relationship, Canada maintains its distance and continues to do so.

Politicians of Canada comparatively have a high level of maturity in exercising their power. Of course they have their concerns over personality, promotion, party biases and actions but there are times when national interest and challenges overtake the party, regional and other interests and they extend a hand in cooperation and work together. I can cite many occasions where they have exhibited their concerns on the best interests of the nation. When the power of the Quebec nationalists was getting stronger and was on the verge of separating from Canada, the Progressive Conservative Party and the Liberals worked hand in hand and John Charest, the national leader of the Conservative Party was viewed as a capable leader who could stand against the Party Quebecois and keep Canada intact. The Conservatives had foregone their party interests and volunteered to lend him to the provincial party leader of the Liberals in Quebec and he is still in power today safeguarding the unity of Canada from the sovereignty movement.

Recently I have seen the Liberals and other opposition party members bitterly criticize the prorogation of the parliament from December 2009 to March 2010 and were on the verge of dissolving Parliament. But it never happened and though the primary purpose was not because it was in the best interest of Harper or the nation. It was due to the fact that the voters were not ready to go to the ballot box. Furthermore, whoever was the cause for the election would not be able to retain their support and on one occasion Mr. Michael Ignatieff openly acknowledged that he did not want to bring down Harper's government because Canadians were not ready for yet another election. Recently there was a heated



argument in and outside the parliament buildings on the proposal to spend nearly a million dollars for the security for the G8 and G20 summits and not including the issues of funding abortion and unwanted pregnancies in developing countries on the agenda

The right honourable Prime Minister Steven Harper is very smart and he knows how to move all of the powerful players on the chess board. Once the members of Parliament resumed with the Opposition members plan to bring down Harper's government on the issue of not being presented with the documents of Canadian soldiers who had handed over detainees to the Afghanistan government; Mr. Harper broke his silence on this issue which might have been going on even before he got into power and he might have been given the last stroke at the camel's back. I presume that Harper might have considered that this was a sensitive issue and in the best interest of national security and for the Canadian men and women in uniform and Canadian foreign missions. Whatever the reason, it could be said the members of the opposition were concerned more about integrity than the actual issue itself.

It is no one nation's issue and most of the nations who attended the summit last year in Copenhagen, talked loudly and added more to the temperature and have since done nothing tangible to implement anything. When Mr. Paul Martin called for the summit in the city of Quebec, America showed a blind eye and now some of the Americans say that climate change is a long term natural phenomenon and we cannot do much about it. I was surprised and disappointed about such

comments. Fast growing world super powers such as India, China, and Brazil have not taken the matter very seriously and have not taken adequate measures and the non industrialized nations suffer for others careless or unconcerned acts. It has been taken into consideration in these summits but how it will force any changes is anyone's guess.

I fully agree with Harper taking necessary precautionary measures on security and spending much more money on it compared with such summits held in other countries. We have to look into the current global developments on terrorism and counter terrorist activities and the timing. Usually terrorists think that Canada is a safe haven for their operations, because Canada has never earned any enemies. Canadian foreign policy is such that people who belong to opposing camps of rival ethnic groups who migrate to Canada, under the refugee category or skilled workers sponsorship, after living in this country for some time, inherit some of our Canadian values. Upon seeing the miniature world structure and the coexistence of many cultures, religions and political views, these new Canadians come to respect the rights of others. But Canada has been cautioned by our neighbour in the south that some of the terrorists have taken the widely opened immigration door as a sign of its weakness, rather than a generosity of spirit and lack of human resources.

We have to see the other side of the coin also that Toronto in particular and Canada in general is also in the targeted area of the terrorist attack list. The results of the enquiry and the verdict of the judiciary system revealed that Toronto -18 terrorists had already planned and prepared to carry out an attack of the Canadian financial capital city, Toronto in many

vital points. Once it has been said that Bin Laden warned Canada not to supply oil sand to America considered the prime enemy of the Islamic revolution. Most of the Arab nations are not very pleased and feel that Canada should have acted more fairly for the people of Gaza in terms of the boarding of the four Turkish ships in international waters by the Israelis. Although it is a recent development, this did not influence the planning for the security of the summits. I know that terrorists are the least concerned about attacking Canada but the leaders representing the other nations may not be considered in a similar ranking. Those countries have almost two thirds of the world's population and a very high percentage of the GDP and wealth. At the initial stages such summits were done in remote areas around the world but recently it has been determined that these summits would be better held in advanced cities.

Certainly the success of the summit in the long run places the positive image of Canada on the globe so high that many of us might have not even thought of this. Canada has carried itself well in handling the recession. Our financial policies and management have proven to the world that Canada is a role model. In the economic ocean, international ships have faced tough waters and cyclones. They could not sail their ships and struggled very hard. The ship of Greece like the Titanic was on the verge of sinking and those of Portugal, Italy, Spain, United Kingdom and the United States of America found the economic ocean rough. But the Canadian ship was navigated safely without any major mishaps but with the light shake of the mild ocean waves. Bravo to the Prime Minister and the Finance Minister.

The convention was a huge success, said President, Dr. Muthuvel Chelliah, during the closing ceremonies and during the time artists were being honored. The convention commenced on Friday, July 2nd and ended Monday, July 5th attended by almost 2000 participants. It was attended by many famous artists, Director Bharathiraja, Actor Vikram, Actress Priya Mani, Comedian Santhanam, Actress Lakshmi Rai, Singers Harish Ragavendra and Suchitra, Kavingar Thamarai and Dr Parveen Sulthana and many other distinguished writers, speakers, poets and popular cinema artists from Tamil Nadu.

FeTNA also had platform for Special event to highlight "The legal Basis for Starting a Divestment/Disinvestment Campaign against Sri Lanka by Prof. Francis Boyle, "Refining the Music in Post-War, Jaffna: Students Rebuild their Lives", speech by Prof. Adele Barker and speech by special invitee, Dr. Elyn Shander. All three of them were honored by the FeTNA at the end of their speeches.

The musical evening was performed by Agni Music Troup from Toronto, Canada and Harish

FeTNA's 23rd Annual Convention in Waterbury, Connecticut - A huge success

Ragavendra, Vikram and Suchitra sang few excellent songs to entertain the participants to Agni's music.

Many dignitaries commented in their speeches that it was an honor to attend the convention at the invitation of FeTNA and they enjoyed the entire set up of the event. FeTNA is an umbrella organization of Tamil Sangams that function within the North American Continent. FeTNA is a registered, non-profit, tax-exempt 501(c)(3) organization.

It was founded in 1987 by five Tamil Sangams: Tamil Association of Delaware Valley, Tamil Sangam of Washington & Baltimore, New York Tamil Sangam, Ilankai Tamil Sangam and Harrisburg Tamil Sangam. An assembly of over 400 Tamils near Philadelphia celebrated the inauguration in the spring of 1988. Since then the Federation (FeTNA for abbreviation) has organized an annual convention each of the subsequent years.

The Tamils in this country are spread over the entire country.

Distance has prevented us from forming large communities. A few well-organized Tamil Sangams are present in large metropolitan areas where there is sufficient number of Tamils present to obtain a sense of Tamil Togetherness. By and large, most Tamil Sangams consist of less than 100 active families. These are too small to form active communities and develop community features and resources, and fragile enough to fall prey to factionalism.

Networking with other Sangams offer the possibilities of connectivity, stability, and increased resources. FeTNA meets this need. FeTNA provides for developing connectivity among the Tamil Communities in North America. Its primary objective is the preservation and growth of Tamil Language, Culture, and Community.

FeTNA has been principally responsible for bringing together Forty Tamil Sangams to celebrate annually a festival in which the individuals and groups from mem-

ber Sangams have presented artistic programs or interacted in one of many activities organized during the convention weekend. People who have attended the past fifteen conventions have almost all had been complimentary in describing their experience. It has been tremendously heartening to note that the annual convention is an event to be at with the family.

The second accomplishment has been FeTNA's sponsorship of twenty four Tamil Scholars in the past fifteen years to visit the US and the various members Tamil Sangams. FeTNA is committed to sponsor at least two Tamil Scholar each year. The other accomplishments of FeTNA include the project for a Tamil chair and hence the support FeTNA has provided to the University of California, Berkeley Tamil Chair Project.

The Federation is a non-profit, literary, educational, cultural, charitable, secular, and nonpartisan organization. The objectives of FeTNA are as follows;

To establish a centralized

organization comprised of elected representatives of Tamil associations in North America and of individuals living in North America who have contributed to the objectives of the Federation and who join as Life Members.

To cultivate, promote, foster, and develop the advancement of knowledge in Tamil language, literature and culture.

To cultivate, promote, and foster the exchange of ideas and understanding between the Tamil people and other cultures.

To promote better understanding and foster friendship among various Tamil associations in North America and to encourage the formation of new Tamil Sangams.

To act upon charitable causes directly concerning the welfare of Tamil community living throughout the world.

According to Sigmund Freud's studies 'ego would actively attempt to rid itself of a traumatic experience by an effort of will and that trauma was not the result of an incident itself, but "an interaction between the patient's intrapsychic organizing tendencies and the external event" (Piers, 1996, p. 545). Freud suggested that an incident became traumatic as a result of "psychology of unique sensitivities of the patient" (Piers, 1996, p.545).

All types of Traumatic events usually lead to a different type of internal changes in the usual family system. Every types of traumas tend to be found festering within

applied to an already weakened family system, can literally reshape not only the personal workings of a family but also the delicate mechanisms of each family member. When a traumatic situation strikes with a family member or the whole family, the entire family experiences the aftermath. As traumatized parents often reduce physical contact and try to shield their offspring from facts. When trauma occurs in the family children may be particularly at risk.

In traumatic or violent moment the world can become unpredictable, dangerous and frightening.

It is very normal for children



immediately after the event or days and even weeks later. They may remind young children (or adults) about earlier traumas and can make the reactions more severe.

Children under five years of age witness a traumatic event or have suffered a significant loss as a result of a traumatic event show different behavior changes. Those behaviour changes are Less ability to tolerate frustration, may reenact scene in play, more aggressive behaviors, fear of being separated from parent, more withdrawn behaviors showing little emotion, more crying, whimpering, screaming, tantrums, aimless motion, disorganized behaviors, and or/freezing, more clinging and dependent behaviors, unable to comfort self and sleep problems.

It is very important that traumatized parents help themselves when they are traumatized and engage in self care.

Getting support and assistance will be particularly important as parents will be better able to listen to their children. What parents can do: they have to return to day to day structure as soon as possible and participate in activities that may distract them or try to be patient with others who are also under stress.

Try not to make any major life changes during a stressful time and seek out support from friends and colleagues may help parents. As traumatized parents you would get help by spend time with others or try to rest and eat balanced and regular meals. Keep a journal without pushing your self or make as many daily decisions as possible to have a feeling of control over your life. Give yourself permission to feel moody, nervous, or blue.

Don't hesitate to seek professional help if you are uncertain or think your family is struggling to recover.

Parents need to be able to listen to their children and hear their concerns and need to help them feel safe. It is important for parents to find support for themselves and to reach out, if they are traumatized,

Emergence of Debt crisis in Greece

The Greek economy was one of the fastest growing in the Eurozone during the 2000s. From 2000 to 2007 it grew at an annual rate of 4.2% as foreign capital flooded the country. A strong economy and falling bond yields allowed the government of Greece to run large structural deficits. Large public deficits are one of the features that have marked the Greek social model since the restoration of democracy in 1974. After the removal of the right leaning military junta, the government wanted to bring disenfranchised left leaning portions of the population into the economic mainstream. In order to do so, successive Greek governments have, among other things, run large deficits to finance public sector jobs, pensions, and other social benefits. Initially currency devaluation helped finance the borrowing. After the introduction of the euro Greece was initially able to borrow due the lower interest rates government bonds could command. Since the introduction of the Euro, debt to GDP has remained above 100%. The global financial crisis that began in 2008 had a particularly large effect on Greece. Two of the country's largest industries are tourism and shipping, and both were badly affected by the downturn with revenues falling 15% in 2009. To keep within the monetary union guidelines, the government of Greece has been found to have consistently and deliberately misrepresented the country's official economic statistics. In early of 2010, it was discovered that Greece had paid Goldman Sachs and other banks hundreds of millions of dollars in fees since 2001 for arranging transactions that hid the actual level of borrowing. The purpose of these deals made by several subsequent Greek governments was to enable them to spend beyond their means, while hiding the actual deficit from the EU overseers. In 2009, the government of George Papandreou revised its deficit from an estimated 6% to 12.7%. In May 2010, the Greek government deficit was estimated to be 13.6% which is one of the highest in the world relative to GDP. Greek government debt was estimated at €216 billion in January 2010. Accumulated government debt is forecast, according to some estimates, to hit 120% of GDP in

2010. Fitch, S&P and Moody's all down-graded Greece's credit rating in December 2009. On 27 April 2010, the Greek debt rating was decreased to 'junk' status by Standard & Poor's amidst fears of default by the Greek government. Yields on Greek government two-year bonds rose to 15.3% following the downgrading. Some analysts question Greece's ability to refinance its debt. Standard & Poor's estimates that in the event of default investors would lose 30-50% of their money. Stock markets worldwide declined in response to this announcement.

Austerity Package from EU-IMF

First time Greece - a country that uses the euro currency has gone to the IMF for borrowing. The fear of adverse market reaction has now moved Europe towards greater coordination and The IMF board approved a €30 billion, three-year loan for Greece in early May 2010, which complements €80 billion being lent to Greece from Eurozone countries. This €110 billion is treble the amount proposed in early April, reflecting the market's loss of confidence. Greece was unable to raise money from markets at affordable interest rates due to fears over an unsustainable debt and deficit burden. The first disbursements were made in time to stem a default on a Greek bond repayment due in mid May. The loan is designed to keep Greece afloat for 18 months, before the country must again sell bonds to cover its fiscal deficit. With the



EU-IMF loan, Greece's debt is projected to be nearly 150 per cent of GDP by that time.

European Financial Stability Facility

European Financial Stability Facility, the EFSF, which is for all practical purposes, will create Eurobonds and establishes a EU Treasury, for extending loans to nations experiencing sovereign debt distress. In order to reach these goals the Facility is devised in the form of a special purpose vehicle (SPV) that will sell bonds and use the money it raises to make loans up to a maximum of € 440 billions to eurozone nations in need. The bonds will be backed by guarantees given by the European Commission representing the whole EU, the eurozone

member states, and the IMF. The new entity will sell debt only after an aid request is made by a country. The EFSF will be combined to a € 60 billion loan coming from the European financial stabilisation mechanism (reliant on guarantees given by the European Commission using the EU budget as collateral) and to a € 250 billion loan backed by the IMF in order to obtain a financial safety net up to € 750 billions. The agreement allows the European Central Bank to start buying government debt which is expected to reduce bond yields.

Greece the next Argentina?

- The IMF Involvement

The "Greek expression" of the crisis has revealed an amazingly

broad range of issues not only concerning the structural problems of the Greek economy, but also those of the European Union (EU) as an economic and currency area, and its unwillingness or inability to react to the problem in a timely, meaningful and collective way. The Greek crisis is provoking comparisons to the Argentine collapse of 2001. In early May, Argentine president Cristina Fernandez said, 'The recipe behind all this is almost identical. Municipal suppression, reduction in salaries and the tightening of belts, it is the eternal recipe of the international financial institutions.' Analysts say that Greece, like Argentina, cannot avoid debt restructuring. Because of Greece's lack of con-

control over the European Central Bank, which issues Euros, some have even likened Greece's predicament to developing countries that are forced to borrow in foreign currencies. Argentina experienced enviable growth for years after currency devaluation and debt default. However, former Argentine finance minister Domingo Cavallo, the architect of the ultimately failed Argentine economic system in the 1990s, said the main lesson from Argentina to Greece was that currency devaluation is not the answer. He did argue for an early and orderly debt restructuring.

Loss of Control over its Monetary, Foreign Exchange and Fiscal Policies

Because Greece is a member of the eurozone, it cannot devalue a portion of its obligations by the means of introducing inflation, or otherwise stimulate its economy with monetary policy. For example, the U.S. Federal Reserve expanded its balance sheet by over \$1.3 trillion USD since the global financial crisis began, essentially printing new money and injecting it into the system by purchasing outstanding debt. The suggestion has been made that long term stability in the eurozone requires a common fiscal policy rather than controls on portfolio investment. In exchange for cheaper funding from the EU, Greece and other countries, in addition to having already lost control over monetary policy and foreign exchange policy since the euro came into being, would therefore also lose control over domestic fiscal policy. A March 2010 report from the University of London's Research on Money and Finance group argued that Greece's difficulties were exacerbated by the eurozone. "Monetary union has removed or limited the freedom to set monetary and fiscal policy, thus forcing the pressures of economic adjustment onto the labour market." This has resulted in trade imbalances with negative effects on labour: "The eurozone has become an area of entrenched current account surpluses for Germany, financed by current account deficits for peripheral countries. Monetary union is a 'beggar-thy-neighbour' policy for Germany, on condition that it beggars its own workers first." The report recommended that Greece exit from the euro, restructure its debt, and reorient its economic policies toward social welfare. Strong European Commission oversight in the fields of taxation and budgetary policy and the enforcement mechanisms that go with it have been described as infringements on the sovereignty of eurozone member states and are opposed by key EU nations such as France and Italy.

Spread of Sovereign Debt Crisis to other European Countries

A debt crisis is rippling through the weak economies of Europe, eliminating any hope that Greece's financial woes can be halted and raising the likelihood that European growth forecasts will be trimmed. In spite of spending cutbacks announced by the Greek government, bond yields in Portugal and Spain shot up as investors, fearing default. As the day wore on, the fears spread beyond Europe, feeding a slump in major stock exchanges like New York and Toronto and in commodities. Europe's mounting debt woes put Jean Claude-Trichet, the president of the European Central Bank (ECB), on the defensive as he sought to reassure investors that the problems of a few small countries did not mean the euro zone as a whole was in trouble. The broad selloff in euro zone bonds and stock markets, and the plunging euro, suggested investors did not share his confidence and expect the debt crisis to deepen. "This is sweeping from one country to another, and Spain and Portugal are next," said Russell Jones, managing director of strategy at Royal Bank of Canada's investment arm in London. In Europe, Portugal took the worst hit. The ECB continue to keep its benchmark interest rate at a record low of 1 per cent as the debt problems of the so-called PIIGS - Portugal, Italy, Ireland, Greece and Spain - pick up momentum and threaten to stall wider European economic recovery. As the debt crisis spreads, economists realize that forecasts for an economic rebound in the euro zone - the 16 EU countries that share the euro currency - might have to be scaled back. But if Spain, where the jobless rate is about 20 per cent, goes from recession to depression, the problem will deepen because the country accounts for a hefty 12 per cent of euro zone GDP. Markets rattled as woes of fragile countries such as Greece and Portugal start to infect other EU members. Fiscal tightening in Greece, Spain and Portugal might spread to Italy, France and Germany.

One of the central concerns prior to the bailout was that the crisis could spread beyond Greece. The crisis has reduced confidence in other European economies. Ireland, with a government deficit of 14.3 percent of GDP, the U.K. with 12.6 percent, Spain with 11.2 percent, and Portugal at 9.4 percent are most at risk. In early May 2010, Spain's government announced new austerity measures designed to further reduce the country's budget deficit. As one of the largest euro-

zone economies the condition of Spain's economy is of particular concern to international observers, and faced pressure from the United States, the IMF, other European countries and the European Commission to cut its deficit more aggressively. The downgrade for Spain was an ominous new blow, coming just as markets were recovering their poise after the double shock and Standard & Poor's downgraded for Greece to junk status.. Though Spain's overall debt burden is fairly modest at around 53 percent of national income compared to 115 percent for Greece the country is running a big budget deficit and has done less than others to get a handle on its public finances. Standard & Poor's cut Spain's rating to AA from AA+ amid concerns about the country's growth prospects.

This concern is focused on Portugal and Ireland, all of whom have high debt and deficit issues. Italy also has a high debt, but its budget position is better than the European average, and it is not considered amongst the countries most at risk. Spain and Italy are far larger and more central economies than Greece, both countries have most of their debt controlled internally, and are in a better fiscal situation than Greece and Portugal, making a default unlikely unless the situation gets far more severe. Other IMF programmes in Europe continue to be unpopular in Romania, Ukraine and Serbia. The British government's efforts to cut a record budget deficit will result in about 600,000 public sector job losses. The Guardian newspaper said it had obtained Treasury estimates which showed 1.3 million jobs would be cut in both the private and public sectors over the next five years as a result of austerity measures.

A Threat to Stability of Euro Currency, and the Unity of EU

Although, Greece represents only 2% of the eurozone economy the severe danger is that a default by Greece causes investors to lose faith in other Eurozone countries. On June 4th 2010 Euro plunged to 4 year low. It is observed that this currency impact is caused by delay in finding solution to Greece debt crisis by the EU. Diverging performances across the Continent are likely to widen further, complicating the ECB's task in setting interest rates. The falling euro is less help for countries such as Spain than export-dependent Germany, and fiscal austerity will be harshest in southern Europe. Greece is feeling the icy winds of austerity measures imposed by the International Monetary Fund and European Union. Portugal and

Spain face bleak, possibly stormy conditions. Ireland has yet to stage a recovery. Beyond the eurozone, the Baltics - Estonia, Latvia and Lithuania - have stabilized, and prospects have brightened in Russia, Turkey and Ukraine. But the crisis also makes the outlook uncertain beyond the eurozone's borders. Even for western European economies outside the eurozone with stable public finances, there are risks. Sweden has kept its currency but not complete economic independence. But Sweden relies on exports to rest of Europe. The International Monetary fund predicts a steadily rising debt-to-GDP ratio for the euro zone to as a whole. In 2007, it was 66 per cent. This year the figure will be about 86 per cent, rising to 96 per cent in 2014, the IMF says.

A Threat to the Recovery of Global Economy

This dynamic is one reason European leaders ought to be thinking harder about an economic aid package for southern Europe, rather than just a financial aid package. Absent a new economic boost for indebted nations, fiscal adjustments will be extremely painful at best and impossible at worst. Ultimately, citizens of the beleaguered countries will demand something different, including, potentially, an exit from the euro zone. The eurozone's debt crisis hangs like a dark cloud over Europe's economic prospects. But it is not yet clear that the Continent's slow recovery from its worst recession since the Second World War will be blown off course. The biggest economies have been stabilized by emergency measures taken by governments and central banks. In coming months, sharp falls in the euro - its trade-weighted value is down 8 per cent compared with a year ago - should boost eurozone exports. But the Financial Times' European economic weather map is at risk of sudden changes if market alarm about public finances does spread into the real economy, compounding the effects of higher taxes and sweeping cuts to public spending in the pipeline. The latest edition of the FT's European economic forecasts convincing evidence has yet to emerge of Europe's main economies taking a turn for the worse as a result of the global financial storm created in its own backyard. The Paris-based OECD (Organization for Economic Cooperation and Development) revised up its forecasts for eurozone growth this year and next, although it highlighted risks to the global outlook.

The measures tailored by finance ministers are feared to fail in containing the spread of the crisis and austerity measure will



only add more pressure and curb the economic recovery. Concerns of the debt crisis in the region is threatening the outlook and causing pessimism across global markets which continued to enforce the huge selloff seen across equity, commodity and currency markets. The outlook for the UK's growth is gloomy, especially as a result of the debt crisis in Europe that has overshadowed the fears of climbing inflation in the economy. The focus was frozen upon the pessimism revolving the debt crisis, especially as speculation remains the main driving force, while, one speculation was for the euro area to break up, and another speculation is for an extraordinary intervention to prop the euro. Royal Bank of Scotland analyst Jacques Cailloux said the statements by Merkel, Strauss-Kahn and European Central Bank president Jean-Claude Trichet "failed to provide groundbreaking information" and warned that Europe risked the "biggest coordination failure in modern history."

Warning of a Third Global Depression

The Group 20 has decided to argue against continued fiscal stimulus. Having in the mindset Sovereign Debt Crisis in Europe the G20 Summit leaders, except from US and Japan, have at the end of the meeting prescribed spending cuts to at least half deficits in the developed world by 2013 are essential to avert, not cause, a second financial meltdown. This policy has been pre-endorsed by the IMF (International Monetary Fund). This has also got the blessing from the BIS (bank of International Settlements) stating that, 'The first and most immediate challenge is to make a convincing start on reducing budget deficits in the advanced economies.' The Bank of England has said that "inadequate transparency" on sovereign exposure led to crisis in lending markets. 'We are now, I fear, in the early stages of a third depression' says Nobel Prize winner Paul Krugman 'and this third depression will be primarily a failure of policy around the world... governments are obsessing about inflation but the real threat is deflation.' He has added fiscal restraint is correct when the economy is strong, but under the circumstances, restraint actually causes problem you are trying to solve, since by slowing growth governments reduce their tax intake deficit rise rather than fall, citing the example of the 1870s and 1930s.

The theme underlines the concept that we are all spiritual beings on a human journey. It is Thamilinee's Tamil prose that was

most captivating. She remembered songs from past Tamil films and appropriately incorporated them into her style of writing. Eg. Vazlkaiyil ayiramirrukum, vaasalthorum vethanayirukkum", "Ulakam ayiram solladume", "Palahath therintha maname unakku marrakath theriyatha?". She didn't forget to use her biblical lines when she narrates "itho un annan", "itho en ammah".

It would have been better if the author had divided her tale into chapters with titles and logical paragraphing instead of just going from one issue of the paper to the other. However, she had shown tremendous potential as a novel writer and we hope and pray she will present her readers with many more tales to entertain them.

WORDS OF PEACE

Something to Depend on

In difficult times, when many of the things that people depend on fail them, life can seem cruel and unjust. We want something to depend on that will always be there for us. That something, says Maharaji, is closer than we think.

"People think their dependence and support is on everything that happens outside," Maharaji says. "We think, 'Today, everything went well, everybody was pleased with me, and so my day was good.' Yet we're not really dependent on those things. Our dependence, our support, comes from within."

Maharaji talks about finding strength and support through a deeper understanding of what it means to be human. Speaking to audiences around the world, he says that the peace and fulfillment people seek in so many ways can be found within. His words are backed by an offer to assist individuals in the discovery of that peace within themselves—a peace that he says can't be grasped intellectually. It must be felt within the heart.

"When I was very young," says Maharaji, who grew up in northern India, "we would sometimes go to a place that was very hot. There was no air-conditioning. To cool ourselves, we used to go to a spring where cold water was coming out. We would sit under it, and the cold water would hit our heads and cool the whole body. I cannot describe that feeling. I cannot describe what I used to experience—that coolness, that refreshing feeling.

"If we try to describe everything with words, we cannot. There's a limit. There's a limit to everything that exists in this world, and words, too, have a limit. Beyond that limit, beyond the boundary of words, is a place where real peace resides.

"As long as we cannot feel that peace within, we can only describe those things we either imagine or see. If we can't even




we know, we have learned.

Then how are we going to learn anything about that world within, if it is beyond the imagination? Don't we need to learn something there, too? We need someone who teaches about the world that resides within.

Q: If my mind can't recognize peace, how can I tell whether I have peace in my heart?

M: If someone is feeling sleepy but is unable to sleep because their back is hurting, they twist and turn. It's frustrating. They're hurting. The pain isn't going away, and they can't sleep. If on the second night they take some medicine, when will



see something, then how are we going to describe it? How are we going to imagine it? How are we going to think about it? We can't think about it, nor can we imagine it. It's beyond imagination."

During presentations around the world, Maharaji often answers questions from the audience.

Q: If the peace you talk about is within me, why do I need someone else's help to find it?

M: The way we know everything in this world is that someone taught us. Maybe we saw somebody making bread. We watched, we learned, and then we tried to make it.

Someone taught us how to read. We couldn't read before that. Once we learned how to read, then we could read lots of books and continue to learn many things. So in this world, whatever

they know if the medication worked? It will be when they wake up in the morning rested. With the pain removed, they know they slept well.

If you can understand this example, you will understand what peace is like. It's when we feel rested inside, when we feel the rest of the heart. Otherwise there's a feeling that something within is lost, is missing. This peace is not something we can describe. It's something to experience. When we experience it within us, then our heart will tell us we're fulfilled.

Question: I have two small children. They are very happy at home but when they go to school, they have to fight a battle every day. When so much conflict enters children I really don't know how does one go about it?

SADHGURU: Now if children are very unhappy at school I think we need to examine the teachers. (Laughs) Because it is a natural human trait that when you get to know something that you did not know it brings much joy to you. If learning is making people miserable then we have not understood what learning is.

Unfortunately you are not sending your children to school because you want them to learn. You want

their children to sit on top of every other child's head. They're not interested in learning. They're not interested in education. They're not interested in career; they're not interested in anything. Their whole effort in their life is how to sit on top of the pile. Isn't it so? Everybody wants to sit on top of the pile.

Everybody cannot sit on top of the pile. Only a few will sit on top of the pile. Others will naturally end up at the bottom and get suppressed, isn't it so? Whatever the activity, if our focus is just to sit on top of the pile, naturally many others will get suffocated under the pile. This is bound to happen; there is no other way.

So that orientation of education has to go. 'No, no I cannot do anything, the schools are like that'. No, the schools are just catering to your attitudes. If your attitudes change, the schools will change. They want to run the business the way it works, isn't it? All you want is, somehow you want your child to get a hundred marks. It doesn't matter what happens to the child. You want your child to get first rank. They're just trying to cater to it because you're paying them. They're trying to fulfill their job. In the course of your activity the child is getting ruined, but it doesn't matter. Your child is unhappy; it doesn't matter. You want him to get first rank. This is a sickness which has to go.

True human genius will not flower if this kind of education happens. True human capabilities will not find expression in competition. True human capabilities will find expression only in absolute relaxation. Your mind, your body will work best, will find fullest expression only when you are joyful and peaceful and quiet within yourself.

When you are trying to race with somebody you will think only one step ahead of them. That's all. You're not thinking of what is your ultimate potential to do. We're just ruining a whole generation of people with the kind of schooling we're doing.

them to earn. That's why you are sending them to school. It is an unfortunate way to handle education. That's not education. You want them enslaved, so the teachers are doing the job for you. You want them enslaved to what you call as economic well-being so the teachers are just doing the job for you. You are not sending your children to school because you want them to develop a thirst for knowing irrespective of whether it is going to make money or not make money, isn't it? So you better change your attitudes about education.

The whole focus of education is not about suppressive information, but about kindling the thirst for knowledge. If the thirst for knowledge is kindled in the child you can't stop him from learning. You cannot stop him from learning; he's going to learn anyway. But instead of kindling that, you're suppressing it. Beating it down with your idea of what is education, because your idea of education is social status and money. So, slowly these children these joyful bursting pieces of life slowly become sad because you're just disorienting them completely with your compulsions.

The pressure is also because you're putting two absolutely

Many readers may have seen if not read about Defence Secretary Gotabhaya Rajapaksa's interview with Stephen Sackur of the BBC HardTalk programme in which he calls Sarath Fonseka a liar and threatens to hang him for his position on a war crimes investigation. Local opinion, not surprisingly, given the current political context, has been divided on the propriety of Mr Rajapaksa's outburst and the damage it could do to the image of the regime and of the country internationally.

There are the shocked and perturbed, albeit mostly in private, on the one hand and on the other, the hallelujah chorus of the apparatchiks. According to them, Mr Rajapaksa showed Sackur what's what and saw off the smug arrogant, hostile Occidental propagandist with panache!

My concern here is to inquire into what this interview and the response to it tells us about the state of governance in our country, post-war and once more on the verge of constitutional reform.

Let us be clear at the outset as to what we are inquiring into - an interview given by a public servant in which he delivers threats and accusations against a former army commander and defeated presidential candidate who is currently in detention and who is -

and this is important - a Member of Parliament. The public servant is the defence secretary and an architect of the historic military defeat of the LTTE. He is also a former army officer and of course, this is important too, the president's brother. Furthermore - this is important as well - the public servant's minister is the president, his brother.

Were such an event to have occurred in India, the world's largest democracy or in Britain from where our parliamentary traditions and conventions of governance hail, the public servant would have had to resign and if he did not, he would have been sacked. Were the latter action not taken, the government of the day would be in jeopardy. Public opinion and the media would bay for its blood.

The rationale for all of this being that in functioning democracies, public servants are not supposed to make policy pronouncements of their own, voice their personal opinions to the international or local media or make statements that are tantamount to the grossest interference in an issue, which is the subject of an ongoing judicial process.

Was Mr Rajapajsa merely expressing government policy, the policy of his brother, his minister and president? Or, since no action has been taken, is it the case that this a case, not of Yes Minister but

of Yes Secretary?

It is indeed sad that Mr Fonseka apart, members of parliament have not seen it fit to raise what is surely a privilege issue. A secretary to a ministry has in effect called a MP a liar and traitor on international television and pronounced that he should be hanged. It is also sad that there has been little comment or observation of the insight this affords us on the state of governance in the land.

Is Gotabaya Rajapaksa a one man deterrent to discussion and dissent - the lifeblood of democracy? Does one decisive military victory and two thumping electoral mandates to his brother and by extension his family, give him the licence to mouth off maliciously in flagrant violation of the dignity and propriety of the office he holds?

Given the impending revocation of the Seventeenth Amendment and the jettisoning of the Constitutional Council and independent commissions it provides for and the removal of the term limit on the presidency, the structure of power and government in the country will be shoved further away from the structure of power and government that characterizes democratic governance.

Those who railed against the executive presidency and promised loudly to abolish it are to entrench it instead and with it no

doubt, the arbitrariness and caprice of a monarchy and dynastic rule.

The nature of the regime and its rule are profiled by the defence secretary's vituperative interview, the priorities for constitutional reform in the current context of limbo between the post war situation we are in and the post-conflict one we should aspire to and the reported appointment of who is now frequently referred to as the First Son, 24 year old fresher MP Namal Rajapaksa to head the District Development Committee for Kilinochchi!

More Crown Prince perhaps than First Son, being given war ravaged Killi to dabble in development? Is there a precedent here of Killinochchi becoming the local Duchy of Cornwall?

The gratitude and appreciation of the citizenry for the defeat of the LTTE and expressed in two thumping mandates for the

Rajapaksa family should not blind the citizenry to the dangers of authoritarianism and the corrosion of governance. Nor should we allow fear to silence protest and resistance to this and then wallow in regret for our complicity and appeasement at a later, god forbid, much later date.

Whoever rules, whoever governs and for how long is not the issue. There must always be, as a basic minimum, checks and balances, the rule of law, due process, best practices and standards adhered to, rights protected and duties fulfilled.

And public servants should be public servants, irrespective of who their siblings are. Or else they should go and if they do not, they should be sacked. This is surely the way of a functioning democracy.

The World All Over is Mukier Than Before

Should we be taken aback by a recent report about a father-in-law murdering his daughter-in-law in Canada? Or earlier a father killing the daughter. Should we be surprised by another such event with the difference that a young person killed a girl who resisted his advances? This is not the first time that we have come across these occurrences. There is no dearth of spoilt young men either. Not too long ago, five armed men barged into the house of 22-week pregnant Sunita and her lover Jasbir Singh, strangling them to death. Moments later, the couple's half-stripped bodies stood displayed at the entrance to Sunita's paternal home in Karnal (India), her father winning applause from the community for having restored the family's honour. The day was May 16, 2008. Recently a swami from south India was caught on camera in what the media calls a 'compromising position' with a couple of women. There was a public uproar and he has since been arrested. The swami, in his early thirties, would have gotten away with what is perhaps the result of

a hormonal surge had he not vowed to be, well, a swami. Literally, a swami is someone who is a 'master of his senses'. Popular culture tends to look up to a saint or swami as some kind of divine entity. What does cause distress is that these incidents have taken place in the world over and developed nations that have been known for a healthy social fabric in the past. Something has gone tragically wrong in recent decades.

The world all over is murkier than before. We have been exposed to instances of patricide not very long ago. At times it appears as if nobody is safe in his or her surroundings. Girls especially are the victims of lust and passion of the lecherous. In our churches there have been cases even young children of their being trapped by preachers, of all persons.

Society is made of relationships, which are maintained through the application of ethical and moral codes. Often, we hear an outcry for enforcing "moral order" or for returning to "old-fashioned values". Such talks of morality are essentially driven

from one or the other institutionalised religious teaching. For example, one may come across an impassioned plea to stress on the moral values based on Christian belief. But then, is morality of Christians different from that of the Hindus, Muslims and Buddhists? If yes, then there can never be peace in the world.

Sexual trafficking of women, girls and children is a key area of concern in particular. The UNICEF (United Nations Children's Fund) has estimated that 1000 to 1500 Guatemalan (belonging to Guatemala, a country in North America) are trafficked each year for adoption by couples in North America and Europe; girls as young as 13 (mainly from Asia and Eastern Europe) are trafficked as "mail-order brides" (women who publish their intent to marry someone from another, usually more financially developed, country); large numbers of children are being trafficked in West and Central Africa, mainly for domestic work but also for sexual exploitation and to work in shops or on farms --- nearly 90 per cent of these trafficked domestic workers are girls; chil-

dren from Togo, Mali, Burkina Faso and Ghana are trafficked to Nigeria, Ivory Coast, Cameroon and Gabon --- they are trafficked both in and out of Benin and Nigeria (some of them are sent as far away as the Middle East and Europe).

Don't we feel sick after learning all this? It is an exploitative social order. Our society is suffering from other ills too. Generally there is lack of trust. The majority of us mean no even when we say yes. White-collar criminals (cheats living behind an aura of respectability and high social status) thrive. "You scratch my back and I will scratch yours" is the order of the day. So is the motto of the survival of the fittest. One who is equipped with money regardless of its source is considered the "fittest." It does not matter whether he is downright corrupt and deceitful.

In the world of Buddha and Gandhi all this should sound amazing. Morality is an illusion in present age. Politics is bereft of ideologies. It has become an instrument of grabbing and staying in power. We fiddle with the public money as we tend to think that it does not appear to belong to anybody. Corporate wars are

ruthless more focussed on profitability than on improving products and services.

The films like Corporate, Sarkar, Laaga Chunari Mein Daag and Fashion, among others, bring into sharp focus the direction in which we are heading. Everything comes with a price. Everyone wants to swim with the current. A few who dare go against the flow are dubbed as cynics. Why should we blame individuals alone? Even the nations have been caught selling not only narcotics but also nuclear technologies. Will this ever change for the better? Definitely it will, if all of us stand up and say enough is enough.

A recollection on world Tamil meets

The idea of forming the International Association of Tamil Research (IATR) took shape when most of the Tamil scholars attended the South Asian Linguistic Conference held in New Delhi.

Ka. Po. Rathinam, former MP belonging to the Tamil United Liberation Front (TULF) in Sri Lanka, proposed this and was welcomed by Dr. M. Varadarajan, Fr. Thani Nayagam of the University of Malaya, Salai Elanthirayan of Delhi University and various other Tamil scholars.

The main condition of the IATR to hold a World Tamil Conference was that it should be supported by the Government of the host country and sponsored by its university. It was then possible to hold the first World Tamil Conference at Kuala Lumpur, the capital of Malaysia, in 1966. Tunku Abdul Rahman was the Prime Minister at that time and Thani Nayagam of Sri Lanka was the head of the Tamil Department of University of Malaysia.

The then Chief Minister of Tamil Nadu, M. Baktavatsalam, led a delegation from Chennai with Tamil scholars such as T.P. Meenakshi Sundaram, Ki. Va. Jeganathan, Sanjeevi, V.R.

Nedunchezian and Sa.Ganesan . From Sri Lanka, TULF leader A. Amirthalingam and Rajadurai, MP from Batticaloa, and a small group participated.

Mr. Baktavatsalam announced that Tamil Nadu would host the second IATR World Tamil Conference in Chennai. His successor C.N. Annadurai fulfilled the promise in 1968.

M. Karunanidhi, then the Public Works Minister, played an important role in making the conference a grand success. It was held with the involvement of all the people. Various functions were arranged at Island Grounds

in Chennai, which was named 'Theevu Thidal.'

"I was a student leader of Tamil Nadu and stopped the agitation for a separate State that was announced by the students of Coimbatore Agricultural College. The third Tamil Conference was held in Paris in 1970. Pilliazo was the head of the Department of Linguistic Studies in the College De France there.

The responsibility of organising the conference was undertaken by Fr. Thani Nayagam. Malcolm S. Adiseshiah donated a huge amount in his capacity as the Secretary General of United

Nations Educational, Scientific and Cultural Organisation.

For the fourth Tamil Conference in Jaffna (Sri Lanka) in 1974, I entered the country without the knowledge of Sri Lankan Government although the then Prime Minister, Srimavo Bandaranaike, gave instructions to cancel all visas issued to the Tamil scholars from Tamil Nadu.

The fifth Tamil conference was held in the University of Malaya in a grand manner in 1977. V. David, MP of Malaysia, was the president of World Tamil Movement and I was the vice-president. Dato Samy Vellu, the then Minister from Malaysia, extended full support. I led a delegation of 300 people to the conference from Chennai.

Chief Minister M.G. Ramachandran came forward to conduct the next conference in Madurai in 1981 and gave a facelift to the town.

In 1989, Parasuram Arumugham, a Minister in Mauritius, took special interest in conducting the conference. Actor Kamal Hassan stole the show when thousands of Mauritius Tamils attended the conference. The public meeting was held in the sports ground of Mauritius.

The irony was that although there were Tamil names they could not utter a single word in Tamil.

At least South Africans were able to say "Vanakkam", taught by Govindaswamy, a Tamil teacher who studied in Annamalai University. In 1995, the then Chief Minister, Jayalalithaa, conducted the Tamil Conference at Thanjavur and that town got a facelift in terms of infrastructure and accommodation.

An unpleasant incident took place when the Central Bureau of Investigation stopped Dr. Sivathambi and a few Tamil scholars who came on a tourist visa to Tamil Nadu to attend the conference.

Thereafter the IATR did not evince any interest in holding World Tamil Conferences in India.

Now, Mr. Karunanidhi has put an end to IATR's hesitation, by taking the wise decision of conducting a " Classical Tamil Conference". It paves way to conduct a Tamil conference elsewhere including Singapore, the United Kingdom, Europe and Canada where lakhs of Tamils are living.

Football World Cup 2010 can be used to combat Racism and Discrimination Globally

The Football World Cup 2010. This is an opportune occasion to reflect on the fact that sport is meant to foster social cohesion, bring different cultures together in a celebration of healthy competition, and to overcome the diffidence and even contempt that all too often divide countries and communities in the political and social arenas.

The movie " Invictus" on how Nelson Mandela used rugby to defuse potential strife and build a common national identity was one such reflection. And the choice of South Africa, a country that renounced the institutionalised racism of Apartheid, as the host venue of the 2010 World Cup provides both a perfect opportunity and a platform to renew our efforts to combat discrimination in all its forms.

As a victim of racism and a sports fan, I urge all who play or simply watch sport to use the World Cup as a catalyst to call for global action against intolerance and racism. These are scourges that affect countless women, men and children around the world and that must be challenged at every turn.

Ability to join millions



Indeed, fear, intolerance and xenophobia can all be combated with diametrically opposed values of fair play and cooperation that are so central to team sports such as football. The World Cup is perhaps the highest expression of football's ability to join millions of people from all regions of the world in a common and joyous pursuit.

Undoubtedly, we all have our favourite team and wish it victorious, but let us not forget that the World Cup allows us to connect with others whose different history, culture and traditions we might otherwise never be exposed to. As a result of these contacts, we are all enriched. Our common passion for football reinforces the bonds of community pride, makes explicit our shared

aspiration for excellence, and channels and elevates our instinct of competition.

But let us also be vigilant about racism and other manifestations of intolerance that poison sport - particularly football- that undermine its positive message and that bring it into disrepute. This happens all too often when the supporters of competing teams use intolerant slurs and even violence to vilify and attack their opponents.

Regrettably, even the players themselves have at times been prone to such despicable behaviour. Professional footballers are rightly obliged to uphold the highest standards of sportsmanship, both ethically and under FIFA's code of conduct, which includes provisions on non-discrimination.

Yet on occasions, rich clubs and rich national bodies have escaped more severe sanction by paying derisory fines after serious racist incidents during matches.

National football authorities everywhere must back their strong rhetoric with serious and consistent disincentives. Manifestations of racism or intolerance in or around the stadiums during the World Cup should be swiftly addressed and the perpetrators isolated.

The clear message of the World Cup must be that there is no place for racism and intolerance in sport. I welcome the stand taken against racism by FIFA and UEFA - both organisations continue to build programmes which promote tolerance and campaign against racism. FIFA plans to use the four quarter final matches of the World Cup, in particular, to make an unequivocal statement against racism to millions of people around the world. Before those matches, the captains of each team will read a declaration encouraging players, officials and fans around the world to say "no" to any and all forms of racism.

Pathway out of exclusion The Football World Cup presents a unique opportunity to maximise the potential of this sport to educate ever-expanding constituencies and attract talent irrespective of social status and posi-



tion in life. For many poor athletes, football has offered a pathway out of seemingly endless exclusion. Their accomplishments have inspired others to follow suit. In every society, successful sports men and women are role models whose behaviour is closely scrutinised and even emulated. Young minds are especially influenced by both positive and negative messages received from those they respect, particularly their sports heroes.

Ultimately, the real winners of this year's World Cup will be those who celebrate and uphold both in words and in deeds its values of fair play, honest competition, respect and tolerance both on and off the field. Let's kick discrimination off the field. Let's tackle exclusion. Let's put racism offside.




Project GreenHands receives Indira Gandhi Paryavaran Puraskar

Project GreenHands (PGH) was awarded the Indira Gandhi Paryavaran Puraskar (IGPP) for 2008 by the Government of India on June 5th 2010 from the former President of India, Dr. A.P.J. Abdul Kalam. The award was presented in recognition of the outstanding contributions made by PGH in creating environmental awareness and reversing ecological degradation. The IGPP also includes a cash prize of Rs. Five Lakhs and a silver lotus trophy. In order to commemorate World Environment Day and the receiving of the award, PGH organized the planting of saplings in 32 locations across Tamil Nadu

The IGPP was instituted in 1987 by the Ministry of Environment and Forests. This national prize on environment is named after the former Prime Minister of India late Shrimati Indira Gandhi and is the highest award in India bestowed on individuals and organizations for significant contributions in the fields of environmental protection, conservation, regeneration and awareness creation. Criteria such as replicability of the work, innovativeness, target groups - such as women, rural populations and urban poor, impact of the programs in relation to the resources employed, and the sustainability of the project are considered before a decision is taken on the award.

The World Classical Tamil Conference, held in Coimbatore by the DMK government at the cost of Rs. 400 crore, is born in anti-intellectualism and draws sustenance from the self-serving politics of M. Karunanidhi, the chief minister of Tamil Nadu. The Ninth World Tamil Conference which was planned to be organised by the International Association of Tamil Research (IATR), a well-known global body of eminent Tamil scholars, had been gracelessly usurped by Karunanidhi to showcase his supposed love for Tamil and Tamils.

In 1968, when the first DMK government headed by the late C.N. Annadurai made the Second International Tamil Conference a popular political event with a historical pageant and a cultural exhibition, there was indeed a reason for that. The DMK had just come to power following a highly charged agitation against Hindi as the national language of India - an agitation which was suppressed by the Congress government using the notorious provisions of the Defence of India Rules. The popular participation in the conference was massive. And the academic sessions were exemplary. Thus, the conference was a reaffirmation of the DMK's commitment to Tamil.

Four decades later, Tamil language is no longer viewed by the Tamils as a beleaguered language in need of political defence. Instead, there is a deep sense of self-confidence which marks both the language and its users. The field of cultural production in Tamil Nadu has been bubbling with new energy during the past two decades. Avant garde maga-

zines, the proliferation of publishing houses, an expanded reading public, globally informed debates, and books which both in their content and design can compete with the best in the world, are all hallmarks of the new self-confident Tamil cultural public. As much as other language writings are translated into Tamil, Tamil literary and other writings are translated into other languages and showcased nationally and internationally.

Along with that, the old perception that Hindi is a threat to Tamil has by and large vanished. Every Tamil knows that Hindi is a lost cause even in the Hindi heartland. Even the prophets of 'Hindu-Hindi-Hindustan' are vigorously courting Tamil in an effort to gain a foothold in the state.

In this changed context, the DMK's celebration of the so-called classical status conferred on Tamil by the Union government is somewhat ludicrous. The average Tamilian no longer seeks outside authorisation about his language or its antiquity. It is just taken for granted. In fact, Karunanidhi is belittling the self-confidence of the language by making a show of an inconsequential decision by the Union government.

Despite its irrelevance, the Classical Tamil Conference has its uses for Karunanidhi. His constant boast, that he is the leader of world Tamils, is in tatters after his dubious role in not stopping the massacre of the Sri Lankan Tamils last year. The DMK had, after passing three unanimous resolutions in the state assembly seeking the Union government to ensure a ceasefire in Sri Lanka, reversed its policy to please the Congress (I). Its decision to stick with the Congress was motivated by its sole desire to cling on to power in the state. Given this politics of rank opportunism, Karunanidhi's dominant image today among the international Tamil community is one of a self-serving traitor.

The World Classical Tamil Conference is a desperate attempt by Karunanidhi to reinvent himself once again as the guardian of Tamil and Tamils. His narcissism is writ all over the conference. Self-obsessed as he is, a substantial part of his inaugural speech to the conference was about himself and his so-called love for Tamil from his childhood. The flood of newspaper advertisements on the conference attempts to produce an equiva-

lence between him and the ancient Tamil poet Thiruvalluvar. The academic sessions, which are going to be intellectually enervating, have no less than 20 papers on Karunanidhi and five on his daughter Kanimozhi. If Karunanidhi has claimed that about 5000 scholars from all over India are participating in the conference, he has his own standards of scholarship.

In choosing the well-known Sri Lankan Tamil scholar Kartigesu Sivathamby, with his open sympathies for the Sri Lankan Tamil cause as the intellectual mascot of the conference, Karunanidhi is making an attempt to mend his battered image among the Tamil diaspora. Importantly, Sivatham-

by, who came to attend the International Tamil Conference held in Thanjavur in 1995, was deported at the instruction of the then AIADMK government because of his sympathies for the Sri Lankan Tamil cause.

Sivathamby, given his scholarly standing and his politics, may offer a fig leaf of legitimacy to Karunanidhi. But if Karunanidhi hopes that the conference, with all its garishly designed floats which resemble film sets of the past, will produce an image of him as the guardian of international Tamil community, he is mistaken.




MONSOON FEATURE

"I have never been at a summit where leaders seemed to more deeply feel the necessity of common action and common purpose" said the Right Honorable Prime Minister Stephen Harper, at the end of the G8 summit and it remained with the same spirit at the end of the G20 as well. The entire world was focused, particularly the rest of the world's leaders, finance ministers, investors, terrorist leaders, and the leaders of the leaders. The attention of the intellectual crowd was definitely focused on the summits and this crowd was large in number compared to the crowd of the common men who seemed to focus more on the world cup soccer match and other music and sporting events that add flavour to the warm summer soup. There were some business men in the core of the down town Toronto who were least bothered by the submit and were more concerned about their daily business activities being adversely affected by the pouring rain, coupled with the presence of the police officers on every single meter of the sidewalk and restricted transportation routes. One businesswoman told me that she only read about the recent earthquake in Toronto in the newspapers and it did not change any of her routine business activities. In contrast to her, many others around the world were constantly watching the G8-G20 summits keenly and to them this was a major news event, like the main course of a fancy dinner as opposed to a beer and potato chips.

The media coverage at the initial stage was tuned around Queen's park, the designated area for the demonstrators to exercise their right to express their support and dissatisfaction on whatever issues that they had. There was much concern by them over the fact this summit spent almost a billion dollars for the security, when to these activists nearly a billion dollars was needed to address human rights violations, maternal issues, exploitation of workers by the capitalist system of economics, native rights, anti-terrorism in many forms, and so on. In fact, Canada being successfully ruled by the democratic system of government has always granted permission and has provided adequate facilities for protestors at the expense of the tax payers. Canada is not a country ruled by the dictates of the government to impose its views; no does the government suppress the freedom of expressing the dissatisfac-

tion and grievances felt by the masses towards the government. But this right, guaranteed by our Constitution should not be turned into paving a way for vandalism and damage to public property such as the burning of police cars, breaking of shop windows, and disruption of the comforts of the general public. The arrest of 602 people in the eyes of Torontonians, certainly looked high, but in light of the gravity of the security concerned it is not really an unusual number. Compared with what has been going on in Paris protesting the rise in the age limit to receive pensions for seniors to 62 from 60 and compared with other summit in other countries, the numbers are really not a concern. At this point many of those who have criticized the allocation of almost one billion dollars for security have to realize that there were very valid reasons for this and they should not be overlooked. To those critics I humbly ask-how much is a human life worth-can we really pay too much for safety?

My thanks go to the chief of police Mr. Bill Blair for his tireless work and the Mayor of Toronto David Miller for fully backing the organizing committee, although he was not happy that he was not adequately included in the planning. I also thank the Premier of Ontario for all of his help, especially in passing a regulation in granting more powers to the police such as the ability to interrogate individuals, search without warrant, and deny entry to those deemed to be suspicious who came within 5 meters of the security fence. The powers given to the enforcing officers during the G20 summit in Toronto were only temporary given the nature of the Summit. With all of the support and cooperation the G20 has ended with flying colors and earned a name in history for Canada. Of course the right honorable Prime Minister deserves many thanks as well.

Let me come back to the remarks about the summit made by the right honorable Prime Minister. The mood of the summit appeared to be without any tension; even if the prime minister might have had several unanswered questions about security, he might have buried them deep into his heart and thus hosted this meeting cheerfully.

Most of the heads of state appeared to be younger than those who participated in the G20 in 2006. But their faces showed they had become quite stressed out in sailing their economic ships in the troublesome ocean and they still continued to sail into the troubled economic waters and were unable to provide for the demands of the passengers. These factors, combined with the tsunami high debts, sailed these ships dramatically off course. The lifeline for these countries would be to follow Canada's example.

The nature, objectives, priorities and agendas of the G8 and G20 were different. The G8 had its own particular concern around the overall economy worldwide. The G20 had financial stability as the core of its programs and addressed issues of the developed and developing countries. It also focused on constructing and maintaining a bridge between the two in this summit. Both have turned their attention to recovering from the recession quickly and strongly through international cooperation, rather than protecting the individual economies of each nation, as Obama's protectionist policy in the United States.

In this journey, the Canadian ship though not the biggest and heaviest, still in today's weather conditions, is moving steadily and faster from the troubled waters and Canada has been accepted and recognized as a role model of the world's developed nations. Mr. Harper articulated and insisted to the world's nations to reduce the budget deficits and reduce the debts of member nations within a short period of time without pro-

longing the recession. It has been well appreciated and accepted with overwhelming support. I am sure some of the leaders would have been envious of Canada in this respect. They have been watching the Minister of Finance and have seen that the financial institutions of Canada have been in smooth operation even at the peak of the recession without leaning for support from the government and none of the financial institution was in the verge of collapsing.

The idea of levying taxes to the banks and maintaining a security reserve fund for keeping away from future financial crises was an important lesson learned by the developed nations including America because of the ongoing recession. But such a need has never arisen and the policy of levying a tax left all member nations to act independently and Canada expressed its plan to get an exemption from it and this has singled out Canada and earned a good name for us and has also won the confidence from the investors and Canada will harvest a hearty yield in the future. The short term pain in tightening the belt will bring long term gain.

I have my own doubt about how the concerned nations could implement and use the allocated funds properly. Our good neighbor in the south is taking economic measures to protect its interests and is partially ignoring the value of sharing their economic interest with its good old friend in the north and how could we expect the rest of the world to commit to this.

I am very pleased to witness that many of them have agreed to allocate funds for the maternally troubled women around the world, particularly in the continent of Africa and South America and a portion of Asia. It is upsetting to hear that every day over one thousand mothers were dying on or pre or post natal time. It goes beyond the issue of money. The education levels of women have to be uplifted. We cannot support the customs and traditions and the norms of ethnic groups in those affected countries that allow for male domination and the deprivation of the fundamental rights of women. Abortion is a difficult and contentious issue and it is an issue that the individual countries have to take into consideration by themselves not by others. Mr. Harper made a compromise on this issue with the opposition party members in parliament and some accommodations were made.

The global terrorists who are threatening the entire world, irrespective of where each nation stands and those who are not prepared to dance according to the piper of those organizations are also targeted. Forget about who is a terrorist and the definition of

terrorism. As long as it affects the fundamental rights of others and the right to live in peace we must use all available resources and take precautionary measures against it. Everyone has the right to fight against oppressors but not at the expense of others. In the G20 for example there was much concern and focus given to the issue of nuclear development in Iran and North Korea.

The coolest discussion was on the issue global warming. I think that probably they did not want to add more heat to it by having a serious discussion on it and there was no need to spend more time because of it was thoroughly discussed at the UN meeting in Denmark, not long ago. The second reason was that the decisions that were made in the summit were not yet implemented as had been expected and there is no point in having another elaborate discussion.

Helping the developing nations is another issue that has been taken into consideration. Many of the smaller nations could not balance their budgets and already their government debts have gone beyond their repaying capacity and their needs have become high and the slow rate of economic growth, corruption in the public sectors, sky rocketing unemployment, fast growing population increase and unstable governments and their poverty have made it hard for those nations to overcome from these difficult situations. In spite of all those needs they have been traditionally dependant on the developed nations. Their problems have been addressed well and the voice of the African Union has not been heard loudly in the developed world.

It has been a great success for Canada in hosting both the summits respectively in Huntsville and Toronto and most of the heads of states were very pleased with the arrangements and warm reception. They have enjoyed it. What is next? The drama is over but we do have a lot of homework to do in terms of capitalizing on the positive image that has been painted on the global mural. I am very certain that the steady progress of the overall economy along with the political maturity of Canadians and the abundant blessings of rich minerals and strong Canadian currency will pave a way in making our economy stronger and steady.

Let me conclude by quoting from US President Obama, "The Success of these summits, the G8 in Muskoka and the G20 here in Toronto- is a tribute to Canadian leadership".

AMMACHI IN CANADA

Toronto is indeed immensely blessed as she prepares to receive the Divine Mother Mata Amritanandamayi at Sheraton Parkway Hotel of Richmond Hill on July 19-22. Millions of devotees all over the world lovingly call her Ammachi or Amma. The media refers to her as the "hugging saint", since she receives all the people who approach her with a motherly hug.

Her hug is not an ordinary embrace. Amma says that she transmits her divine energy through the hug. Those who are ready and receptive are profoundly transformed thereby. It is indeed a marvel to watch her hug thousands of people affectionately for long hours, sometimes even up to twenty hours, without leaving the seat even once to stretch or rest.

Ammachi was born on September 27, 1953 in Kerala, India. Parents named her Sudhamani. She did not cry at birth like other children. Instead, Sudhamani had a bright smile and a penetrating gaze at her mother. The child's complexion was dark blue, like Lord Krishna and Mother Kali.

Sudhamani was only six months old when she started walking and speaking easily in Malayalam, the mother tongue of Kerala. The blue complexion started to fade away then, and she remained dark in color.

Even as a little child, Sudhamani composed and sang devotional songs to Lord Krishna with much fervor. Often she sat in ecstatic meditation, completely unaware of the world around her. Such spiritual exercises were unknown to the villagers and the family. Hence they thought that Sudhamani was crazy, especially as she sometimes burst into laughter and shed many tears due to divine bliss.

Sudhamani attended school up to fourth grade only, though she was brilliant and did not forget whatever she heard or read. Since the mother fell ill, parents made Sudhamani stay home and do all the household chores. Waking up very early, she swept the house and the compound, cleaned the cooking utensils, cooked all the meals, fed her siblings and prepared them for school, washed the cows and the cow-shed, found gruel to feed them, and cared for the sick and old in neighboring houses.

From early childhood, Amma's heart responded readily to others' suffering. Sudhamani washed, clothed and fed those who were destitute, old and sick. She was scolded and punished severely at home for such acts, but Sudhamani continued to behave in the same manner without any fear.

The family members and the people around Sudhamani thought that she was an ordinary girl, though strange in her ways. They did not suspect her extraordinary spiritual eminence. Like Bhagavan Krishna and Lord Jesus Christ, Sudhamani was aware that She was the embodiment of Supreme Divine

Consciousness. Amma said that all the divine forms were within Her, and She could manifest any divine form whenever She wanted.

In 1975, at 21 years of age, Sudhamani walked into a neighboring house, where the ceremonial reading of the life of Lord Krishna was going on. It was amazing to see her features and color being transformed to appear like Lord Krishna. Devotees of the Lord started worshipping her, glad that the Lord had taken temporary possession of Sudhamani. Some rationalists who happened to be there were disturbed by this phenomenon. They demanded that Sudhamani should perform a miracle if she were Lord Krishna, though they did not believe in the possibility of miracles.

Sudhamani replied that She came on earth to make them realize the greatest of miracles, namely the presence of God in their hearts, and not to indulge in phenomena which are ephemeral. Since the rationalists continued to insist, saying that they would believe if She performed a miracle, She agreed to do so a week later at the same place.

Word passed around the neighboring villages about the promise of a miracle. More than a thousand people gathered around the house. Some unbelievers perched high up on trees to get a better view, and expose what they deemed would be a fraud.

Sudhamani was again transformed to look like Lord Krishna. She asked one of the doubters to bring a pitcher of water. After sprinkling it on the people as holy water, she asked the man who brought the water to look into the pitcher. The water had turned into pure milk! It was distributed to all the people around.

Then She called another skeptic, and instructed him to put his hand into the same pitcher. To his astonishment, the milk was transformed in to a fragrant pudding (normally made with bananas, raw sugar, raisins and rock candy boiled in milk). More than a thousand people enjoyed eating this delicious pudding, yet the pitcher remained full!

Amma performed many more miracles like curing the seriously sick, and even raising the dead to life. Such physical miracles have only a limited value, since we all have to eventually discard our body. Far more significant are Her miracles of spiritual transformation of the devotees.

It is rather difficult to understand the tremendously powerful attraction that Amma exerted on certain devotees who had hardly heard about Her. Amma says that it is entirely the work of God's grace due to the merits of former lives.

A band of college educated youth who were used to ease and comfort, endured many material hardships in order to be around Amma. They were glad to be often without food, and sleep out in the open on bare ground. Even a tem-

porary separation from Amma was unbearable agony to them.

How can one explain that a respected professor of medicine from the University of California, as soon as he heard about Amma from his brother in Kerala, could cancel his medical appointments and fly to India on the following day, leaving his two small children and a furious and perplexed wife at home? Dr. Prem Nair returned home three days later, only due to the insistence of Amma.

Equally mysterious was the reaction of his wife when she heard Amma singing on a tape that her husband had brought. Mrs. Nair shed copious tears and left immediately with the children to Amma's ashram in Kerala. Amma allowed her to stay there for few months until her husband joined her.

Before meeting Amma, Nair family was not particularly religious or given to any spiritual practice. They were satisfied with material comforts and their social life. Amma turned them around so that now they are intent on God alone, and yearn for Her night and day.

With tears in her eyes, Ila Campbell spoke about her coming to Amma for the first time. She is an Indian woman married to an American, and worked in Brookhaven National Laboratory as a scientist, intent only on making money and living comfortably, and was not at all religious, she said. She was raised with Western values and to look down on Hindu culture, scriptures, religious ceremonies, and Gurus. Reading J. Krishnamurti during her college years confirmed her skeptical attitude.

While on a vacation at her father's house in Mumbai, she saw on TV for a few seconds Amma conducting a religious ceremony at Her ashram temple in Nerul, about three hours away by car from Mumbai. It was announced that



Amma would be there giving a program on the following day as well. The image of Amma with the question: "Who is she?" dominated Ila's mind throughout the day. She could not understand her sudden and urgent need to see Amma that she felt deeply, though she knew nothing about Amma.

Moreover Ila was in bed with a severe cold and fever, and could hardly sit up. Her father was unwilling to drive her since he had a business appointment next day. Then she prayed fervently to be well enough, and get a transportation to attend the program, if Amma wanted to see her. On the following morning she was amazed to find herself completely well, and her father offering to take her, since his appointment had been postponed.

When Ila got near Amma to be hugged, her hair stood on end and the mind went blank. All she could do was to shed profuse tears, feeling that she was finally "at home." Now she finds that all her problems with the family or at work are easily solved due to the grace of Amma, and her only goal in life is to cultivate in herself the compassion and selfless love of Amma.

Saints and holy people from different parts of India came to the



ashram to pay homage to Amma, declaring that she was truly Divine Mother. Her family members witnessing the many miracles and hearing the testimony of saints were finally converted to accept Sudhamani now named Mata Amritanandamayi wholeheartedly as their Guru.

In the beginning Amma encountered vehement opposition and vicious persecution by some family members and other villagers. Several attempts were made to kill her. The miraculous manner in which she was protected convinced most of the opponents that she was truly divine, and they became her ardent devotees later.

One Western reporter asked Amma what she thought about some devotees worshipping her saying that she is God. Amma laughed to say that today they may regard her as God, and tomorrow they may think of her as devil, it made no difference to her, but she knows (not a mere belief) that all the people who come to her are God, and she bows down to them all.

The simple, humble and pure life of Amma is an entirely open book. Disciples are with her day and night. She hardly eats or sleeps, and is ever ready to serve others in any way she can, while she endures much pain.

Amma inspires us to seek freedom from egoism and worldly bondage. Following Her would enable us to realize the truth of our being. God alone is, within us and everywhere. Everything else gets its reality from God. Experiencing God's holy Presence here and now means peace, love and joy.






