### Home prices in Ontario continue to increase

Home affordability for new home buyers is becoming a dream of the past as house prices in Ontario continue to rise based on demand and supply

According to a Real Estate Board forecast, house and condo prices are likely to increase a further 12% this year. A reduction in the availability of homes for sale jacked up the prices by 18% last year as homeowners were reluctant to sell for fear of finding another home at a reasonable price that they could afford.

The demand from first time homebuyers has been on the increase lately as they were reluctant earlier to purchase due to the pandemic. Associated with this factor is the fear of a possible increase in the mortgage rates cou-

### Ontario Invests in Innovations to Help Control the Spread of COVID-19

#### **Ontario Together Fund continues to support** homegrown innovations and manufacturing of domestic medical supplies

January 27, 2022

Economic Development, Job Creation and Trade

TORONTO — The Ontario government is supporting an investment of more than \$2.9 million by five local companies to strengthen manufacturing of domestic medical supplies and support the development of homegrown innovations to help control the spread of COVID-19. The province is investing more than \$1.54 million through the Ontario Together Fund (OTF).

"The Ontario Together Fund continues to support domestic businesses through targeted investments that allow them to develop their ideas and solutions to help us through the pandemic," said Vic Fedeli, Minister of Economic Development, Job Creation and Trade. "Ontario is proud to support these five companies, and we thank them for their innovations that are enhancing the province's capacity to meet ongoing demands on our healthcare system and prepare for future challenges."

McArthur Medical Sales Inc. is a Rockton, Ontario-based company that has developed and commercialized three products to assist hospitals in reducing the transmission of COVID 19 — Flusso By Pass, Flusso TFI and EXHALO Shield. These devices are used in collaboration with oxygen therapy systems and mechanical ventilators to improve patient care and reduce the spread of COVID-19, among other airborne contaminants.

"Support from the OTF will allow us to increase production of our Respiratory Therapist invented devices that improve patient care and staff safety," said Frank Fiorenza, RRT, Product Development Manager of McArthur Medical Sales. "These Ontario invented and manufactured medical innovations have now proven to have positive implications for patients and healthcare staff worldwide."

McArthur Medical Sales is investing \$798,000 to purchase manufacturing equipment and machinery to increase production by five times current capabilities. Ontario is supporting the investment with a contribution of \$379,000

through the Ontario Together Fund.

"McArthur Medical Sales is one of many businesses that have stepped up to change their manufacturing operations to help in the fight against COVID-19," said Donna Skelly, MPP for Flamborough-Glanbrook. "With this investment, the Ontario Together Fund is supporting our government's ongoing response to the pandemic, while improving the province's preparedness for future public health emergencies."

AGS Zephyr Inc., a privately-owned Ontario-based company, founded by Sam Alesio, George Goto and Robert Sowka, specializing in air purification, is investing over \$350,000 into a novel air filtration project which will involve building prototypes, conducting trials and manufacturing the company's Personal Zone Air Purifier (PZAP) product for restaurants, classrooms and commercial, industrial and retail applications.

"The support provided by OTF will accelerate our product design development activities in addition to the ongoing collaboration with Mohawk College and McMaster University, both located in Hamilton," said Sam Alesio, Co-Founder and CEO of AGS Zephyr. "AGS Zephyr's PZAP is an effective filtration device that supports a multi-layered approach to reducing the transmission of viruses such as COVID-19 and influenza within indoor dining environments."

The Ontario government is investing \$88,750 through the Ontario Together Fund to support the company during the development phase of their new product.

Synaptive Medical Inc. is a Toronto-based global medical device and technology company, and a leader in robotic surgical visualization. The company has invented a drape concept to help keep CT scanners free from patient contamination.

"Synaptive Medical is grateful for OTF's support for us to create a drape to shield medical machines (MRIs, O-arm scanners and CT machines) from COVID-19 contamination and spread, said Cameron Piron, President and Co-Founder of Synaptive Medical.

Synaptive Medical is investing



\$205,400 to adapt the current CT drape design into a prototype that is compatible with MRI and O-arm scanners to help shield them from patient contamination, including COVID-19. Ontario is supporting the investment with a contribution of \$153,300 through the Ontario Together Fund.

Mitchell Plastics is a North American auto-parts manufacturer headquartered in Kitchener. The company invested \$578,900 to retool a portion of its Canadian operations to manufacture nasopharyngeal swabs, which included converting a section of its facility into a clean-room environment. Ontario supported the investment with a contribution of \$434,200 through the Ontario Together Fund.

"Mitchell Plastics is proud to have partnered with the Ontario government to respond to the call to action to design and develop this medical device at a time of acute shortage and critical need," said Tim Goldhawk, Managing Director of Mitchell Plastics.

The company can produce 400,000 nasopharyngeal testing swabs per month.

"The team at Mitchell Plastics is very deserving of our government's investment as they've been a great contributor to the effort to meet the challenges of this pandemic," said Amy Fee, MPP for Kitchener South-Hespeler. "Nasopharyngeal testing swabs are, and will continue to be, a vital tool that helps us control the spread of COVID-19."

PAPP Plastics & Distributing Ltd. is a Windsor-based injection molded parts manufacturer with expertise in tier 1 automotive manufacturing, parts assembly and mold manufacturing. The company invested \$971,830 to repurpose one of its facilities to manufacture injection-molded nasopharyngeal swabs. Ontario supported the investment with a contribution of \$490,000 through the Ontario Together Fund.

"When governments called on manufacturers to help answer the COVID-19 emergency, Papp Plastics and our employees enthusiastically responded," said George Papp, Co-Owner, COO/General

Manager of Papp Plastics & Distributing. "We designed parts, made face shields and with the Ontario government support, we were able to ramp up to enable production of millions of test swabs."

Through this project, the company has the capacity to produce 1 million testing swabs per week.

Supporting innovative projects like the ones from these five companies are why Ontario has invested an additional \$50 million in the renewed Ontario Together Fund in 2021-22. The fund is continuing to support local innovators and businesses to further enhance Ontario's domestic supply chain capacity, promote Ontario's MedTech ecosystem and build up our manufacturing sector to ensure the province is well-prepared for future challenges.

The renewed Ontario Together Fund is focused on supporting homegrown manufacturing and innovation to combat COVID-19 and providing other goods critical to the health, safety, and security of Ontarians beyond this pandemic.

Since its launch in April 2020, the Ontario Together Fund has helped businesses with innovative ideas and solutions to retool or adapt their operations to produce supplies and equipment for the health care sector and frontline workers. Some successful Ontario Together Fund recipients include:

Kawartha Ethanol will expand local production capabilities in Havelock to manufacture high-grade, pure ethanol for hand sanitizers and disinfectants.

Abatement Technologies Ltd. will build a new facility in Fort Erie and purchase new equipment to expand its production of air purification and abatement products.

Empack Spraytech, a Brampton-based privately-owned family operated business, will manufacture more than 4 million surface disinfectant wipes in a new 100,000-square-foot Barrie manufacturing facility.

Healthy people are essential for a healthy economy. With Ontario's ambitious rollout of vaccines and booster shot distribution continuing to increase, the government is taking further action to slow the spread of the highly contagious Omicron variant. #### Over 10,000 new affordable homes for Canadians

Every Canadian deserves a safe and affordable place to call home. The COVID-19 pandemic has made it clearer than ever that affordable housing is key to Canada's recovery, as we rebuild an economy that works for everyone. ### Ontario Helping More Communities Protect Against Racism and Hate

Province doubling investment in grant program to support more local projects

TORONTO — The Ontario government is helping more communities combat racism and hate by doubling its investment in the Anti-Racism Anti-Hate Grant Program. An additional \$1.6 million in funding will help support more community-led public education and awareness projects, bringing the total funding for the grant program to \$3.2 million over two

"By supporting the important work in our communities in the fight against racism and hate, we are strengthening our commitment to a more equitable Ontario," said Parm Gill, Minister of Citizenship and Multiculturalism. "Doubling our investment in the Anti-Racism Anti-Hate Grant will also protect our progress in improving outcomes for those facing racism and hate across the province."

The Ontario government developed the Anti-Racism Anti-Hate Grant in

collaboration with community partners for local projects that increase public education and awareness on the impact of racism and hate, in all its many forms. These grants will support eligible organizations, including community-based and not-for-profit organizations, to lead initiatives that help build capacity, connect communities and deepen understanding to address the impacts of racism and hate.

In September 2021, the government announced \$1.6 million for the program. Grants of up to \$40,000 over two years for independent projects and \$100,000 over two years for partnerships between two or more organizations have been awarded to 32 new community programs.

New applications are being accepted until February 14, 2022 for a second round of grants totalling up to \$1.6 million. Existing eligible applicants will be automatically considered for the additional funding. More information on the reopening of the program is available on the grant webpage.

#### **Atrial Fibrillation** (Irregular heart beat)

Diet, exercise, and other lifestyle factors are known to affect your risk of heart disease. The major risk factors for heart disease, as well as the condition itself, are all closely linked to the risk of developing atrial fibrillation. Can a heart-healthy lifestyle prevent atrial fibrillation? Can it reduce symptoms?

There's preliminary evidence that managing the risk factors for heart and blood vessel disease may improve the long-term outlook for people with atrial fibrillation. On a practical level, that could mean fewer episodes of a-fib and improvements in symptoms—in short, a better quality of life for you.

#### Focus on heart health -**Healthy Living**

The ability of lifestyle change to reduce the burden of atrial fibrillation remains an active area of research. In the meantime, take steps to live a healthy and active lifestyle, in addition to medication and other standard a-fib treatments:

If you smoke, quit.

Control high blood pressure.

Get treatment for sleep apnea if you

Maintain a healthy weight.

Don't drink alcohol, or consume only in moderation.

Keep your cholesterol and triglycerides within a healthy range.

Get regular exercise.

Get recommended vaccinations for the flu and pneumonia, especially if you have heart disease.

Make sure to also ask your doctor or pharmacist about any new medications, including over-the-counter remedies and herbal supplements. Sometimes these can interact in a harmful way with warfarin, direct oral anticoagulants, or rhythm-controlling drugs.

Although your ability to prevent or treat atrial fibrillation with a healthy lifestyle has limits, most people are able to control bothersome symptoms long-term with medication, procedures, or both. That said, some people run out of safe or effective options, in which case the a-fib will become permanent.

### India Projects Strong Economic **Rebound After Pandemic**

NEW DELHI —

India's government has pledged to spend billions of dollars on public infrastructure to reboot an economy that is bouncing back from the massive contraction it suffered during the novel coronavirus pandemic. But concerns remain about an uneven pace of growth that has seen big businesses flourish but its vast unorganized sector struggle.

Asia's third largest economy is projected to grow at 8% to 8.5% this year, according to government figures.

The strong economic recovery began last year despite a deadly second wave of COVID with growth estimated at 9.2% in the financial year that will end in March.

"The economy has shown strong resilience to come out of the effects of the pandemic with high growth," Finance Minister Nirmala Sitharaman

She announced that the government would spend \$2.7 billion to build highways and \$6.4 billion on housing for the poor. It will also expand rail networks, ports and airports, manufacture energy efficient trains and extend credit guarantees to small businesses.

Sitharaman said climate action is a priority and promised to focus on electric mobility and solar power in a bid to reduce the country's carbon emissions.

"I am conscious of the need to nurture growth through public investment to become stronger and more sustainable," Sitharaman said.

Economists have welcomed the government's decision to step up spending. "The decision to increase public investment to 2.9% of gross domestic product, is rock solid and good news and should attract private investment into infrastructure," says Santosh Mehrotra, a human development economist and author of the book "Reviving Jobs: An Agenda for Growth.'

The budget increases spending to \$533 billion in the coming year from \$477 billion.

ment crisis we face is huge. Five to six million people join the labor force every year. That is on top of the unemployed we already have. That number was 30 million in the year 2019 and it has only grown post the pandemic by another 10 million," says Mehrotra. "And we also have millions who want to come out of agriculture into non-farming jobs."

The unemployment challenge was underlined last week by violent pro-

> tests by job seekers that erupted in Bihar and Uttar Pradesh.

Several economists point out that while India's economy has rebounded, growth has not percolated down as its vast informal sector, which provides most livelihoods, continues to reel under the impact of long shutdowns imposed when infections spiraled during the last two years. Tens of thousands of small enterprises have shut down. That has widened income

inequalities with an estimated 80% of households losing incomes during the pandemic.

But there is optimism as a third wave of the pandemic driven by the omicron variant begins to recede. India's vaccination program has made significant progress since July last year - 75% of adults are fully inoculated. That is creating confidence in opening most sectors of the economy.

"The economy is in a good place to grow strongly into the next year or two," the finance ministry's principal economic advisor, Sanjeev Sanyal, said while presenting the country's economic survey on Monday.

India's economic growth two years into the pandemic is seen as the fastest among major economies in the world. The revival comes after its economy shrank in 2020 by 6.6% the sharpest dip in 40 years that came after a long and stringent shutdown.

India also said the country's central bank will introduce a "digital rupee" this year using blockchain technology, becoming one of the first major countries to do so and said it will levy a 30% tax on income from virtual digital assets.

## Teleworking during COVID: Risks, benefits and steps to a 'new normal'

More than two years since COVID-19 began disrupting office life around the world, crucial changes are needed to safeguard health while teleworking, two UN agencies said on Wednesday.

In a new technical brief on healthy and safe teleworking launched on Wednesday, the World Health Organization (WHO) and the International Labour Organization (ILO) outline the health benefits and risks of remote work arrangements along with the measures needed to accommodate both the shift, and the ongoing digital transformation.

"The pandemic has led to a surge of teleworking, effectively changing the nature of work practically overnight for many workers", said Maria Neira, WHO Director, Department of Environment, Climate Change and Health.

#### Upside

Among the benefits, the report says, are an improved work-life balance; opportunities for flexible working hours and more physical activity; reduced traffic and commuting time; and a decrease in air pollution across urban areas.

These can all improve physical and mental health, and social wellbeing.

Moreover, teleworking can also lead to higher productivity and lower operating costs for many companies.

#### **Downside**

However, the report warns that without proper planning, organization and health and safety support, teleworking can lead to feelings of isolation, burnout, depression, eye strain, increased alcohol consumption and unhealthy weight gain.

"Which way the pendulum swings, depends entirely on whether governments, employers and workers, work together, and whether there are agile and inventive occupational health services to put in place policies and practices that benefit both workers and the work", said Dr. Neira.

#### Settling into a 'new normal'

As both companies and employees alike have experienced the benefits of home and hybrid work, the Director of ILO's Governance and Tripartism Department, Vera Paquete-Perdigão, said that they are "here to stay and will likely increase after the pandemic".

"As we move away from this 'holding pattern' to settle into a new normal, we have the opportunity to embed new supportive policies, practices and norms to ensure millions of teleworkers have healthy, happy, productive and decent work", she said.

Occupational health services should be providing provide ergonomic, mental health and psychosocial support to

teleworkers using digital telehealth technologies, the report says.

For example, employers should put measures in place to ensure that personnel receive adequate work-related equipment; relevant information and training to reduce the psychosocial impact of teleworking; and establish the "right to disconnect".

#### **Meeting needs**

The report outlines the roles of governments, employers, workers and health services at workplaces to promote and protect health and safety while teleworking.

It also offers practical recommendations for the organization of telework that meet the needs of both workers and businesses, such as developing individual work plans with clear priorities, timelines and expected results.

The agency advice calls on businesses to develop special programmes for teleworking that combine measures for managing work and performance, using effective digital platforms.

### Putting an end to India's oxygen crises

Scenes of relatives desperately trying to find oxygen supplies for hospitalized COVID-19 patients in India last year, alerted the world to an acute, deadly problem. Yet that was not this first time the country's hospitals have been hit by a shortage of the life-saving gas, prompting the question of whether there will be enough supplies, when the next major health crisis hits.

In May 2021, India's hospitals were at breaking point. The country found itself at the epicentre of the global COVID-19 pandemic, and one of the biggest challenges was providing enough medical oxygen for the sickest patients, unable to breathe unaided, as demand rose ten-fold.

By the end of April, there were just under 18 million confirmed cases, and over 200,000 deaths.

#### 'Out of stock'

Some hospitals posted "oxygen out of stock" signs, whilst others asked patients to search for treatment elsewhere.

As news organizations published stories about patients dying from a lack of oxygen, family members decided to take matters into their own hands, hunting for canisters that might save the lives of their loved

To many observers, the crisis seemed to indicate a lack of planning on behalf of the authorities, not least because this was far from the first time that medical oxygen had been scarce during a health crisis, even during the present pandemic.

Just a few months earlier, in September 2020, the country had already found itself in a similar situation: as case numbers soared, medical oxygen production failed to keep pace, amid an exponential growth in demand.

And many people remembered that 70 children had died at a government-run hospital in Uttar Pradesh due to a lack of oxygen in 2017, when a supplier stopped delivering canisters, after complaining of unpaid bills.

India's huge size, and the way its oxygen production industry is set up, were also identified as key factors. Only a small number of India's hospitals have the facilities to produce the gas in-house, and the rest depend on deliveries from private companies.

Oxygen production plants are concentrated in the industrial belt of eastern India, meaning that cryogenic trucks, specially designed to carry liquid oxygen, have to travel long distances to reach regional suppliers, which transfer the gas into smaller containers for delivery to hospitals.

#### **Emergency measures**

The Indian Government, the UN and other humanitarian organizations, responded to the emergency in a variety of ways.

Additional tankers were airlifted from abroad, tankers used for liquid

argon and nitrogen were converted to carry oxygen, and the railways innovated to introduce special "Oxygen Express" trains.

Industrial oxygen was diverted from steel plants to hospitals and the procurement and distribution of oxygen concentrators was stepped up.

The UN focused on getting hold of essential equipment such as concentrators, ventilators, and oxygen-generating plants, as well as implementing other measures to reduce the rate of serious case numbers, speeding up the rollout of vaccination programmes, and improving testing facilities.

respiratory diseases, in India. no one is deprived of this life-saving product?

These questions were tackled in January by Ramana Gandham, Rajaji Meshram, and Andrew Sunil Rajkumar, a trio of health specialists, in a blog published by the World Bank.

Following technical assistance from the international financial institution in four Indian states – Andhra Pradesh, Meghalaya, Uttarakhand and West Bengal – as well as with the central Government authorities, the experts set out a series of options to strengthen the country's medical oxygen policy. always been the case, due to a lack of resources.

The same goes for all storage tanks and delivery systems, such as specialized trucks. Trained people are needed to run the plants, and India has launched an initiative to train 8,000 technicians capable of operating and maintaining them.

The experts found that, during the May 2021 crisis, the issue was not so much a shortage of medical oxygen, but rather the concentration of medical oxygen in eastern India, and the inability of the distribution network to ramp up to meet the ten-fold surge in demand.

#### 'Buffer storage'

One solution to this issue is the creation of "buffer storage" facilities, at strategic locations, so that oxygen can be delivered far more quickly during emergencies.

Since the last wave, the Indian Government, technical partners, and private agencies have worked closely to estimate India's future demand for oxygen.

Many forecasting and modelling techniques have been used to develop a deeper understanding of production, demand and storage requirements.

Digital tracking systems have now been set up, to allow India's states to ensure the delivery of oxygen at different points along the supply chain, monitor consumption and forecast demand.

In Uttarakhand, 30,000 Radio-Frequency Identification (RFID) tags have been distributed to medical oxygen suppliers and hospitals, to be affixed on oxygen cylinders. Delhi, whose hospitals were badly affected by a lack of supply during the May 2021 COVID wave, is also making use of tracking technology.

It is hoped that, by putting these measures in place, the country will be able to swiftly and effectively respond to the next health emergency, minimise deaths, and avoid a repeat of the distressing, chaotic scenes witnessed less than a year ago.

The World Health Organization (WHO) deployed over 2,600 public health specialists working on other diseases to tackle the epidemic in India, and around 820 staff members from the UN Children's Fund (UNICEF) and UN Development Programme (UNDP) helped the authorities to monitor over 175,000 COVID-19 centres across the country.

#### Maintaining a steady flow

But how should India prepare for the next oxygen emergency, given the unpredictable nature of demand for the gas, in a country where the cost of producing, storing and transporting it, is higher than the cost of the product itself?

And how can better distribution be ensured, so that oxygen is available wherever it is needed, at all times, and

#### Hike in production

They recommended a significant hike in the production of medical oxygen, a process that has already begun: more than a thousand new plants are being funded by the Government, producing 1,750 metric tons of oxygen every day, and more plants have been set up with regional and private sector backing.

The specialists recommend supporting hospitals that want to build their own plants, on site, which would reduce the problem of distribution. In some areas, such as Bihar state, companies are offered incentives, such as subsidized land or utilities, and low-interest finance, to set up plants.

Once they're up and running, it's important that the plants are maintained, something that has not




At SHN, a group of compassionate and dedicated team members are continuing their pursuit of progress in mental health and generating positive change throughout our community.

The team also opened the new RAAM Observation Clinic, which focusses on day detox from opioid and alcohol use disorders.

Day Hospital and Day Treatment programs provide support and skills development, while the First Intervention Treatment Team (FITT) is there for



young people when they need support for their first episode of psychosis.

"Despite increasing workloads and pandemic fatigue, our Mental Health and Addictions team have continued to display collaboration, resilience and dedication. Among their many achievements, the team has pivoted quickly to meet the needs and the demands of our community," explained Greenwood.

For example, SHN's child youth counsellors (CYC) and nurses joined the adult team to care for all mentally ill inpatients ages 18 and up; outpatient clinicians, including nurses and social workers, teamed up with inpatient teams to support patient care; and many outpatient groups went virtual, enabling programs to assign available staff to the most-needed area s.

"As the pandemic has forced many of us to rethink the way we connect, we've expanded virtual supports, education, and resources, enabling patients to get the care they need at home," added Greenwood.

Online supports include the Online Psychotherapy clinic and the Mental Health App Library for those living with anxiety and depression.

Janie Leopold, who is a Patient Family Advisor at SHN and a mental health patient herself has utilized these virtual services for her own journey, and continues to take part in conversations to improve the patient experience.

"I am grateful to provide a patient voice and perspective. Through these virtual services, you never feel alone. Though we are virtual now, we are meeting regularly to discuss and improve services for everyone, especially with the added pandemic stresses in life" she said.

Perhaps most impressive, SHN's Mental Health programs never discontinued any essential services during the pandemic! And, while the team provides vital supports for Scarborough and beyond, they're also supporting the needs of staff, medical staff, and volunteers at SHN daily.

SHN will continue to break the silence surrounding mental health by supporting our community and health care workers, and celebrating this team of resilient professionals, who continue to improve lives through exceptional care.

SHN Foundation recently launched the "Love, Scarborough" campaign, supporting their \$100 million fundraising goal. Monies raised will help with the creation of a new Community Mental Health Hub. This Hub will consolidate all of SHN's outpatient adult mental health programs into one central location, and work to remove barriers surrounding mental health care. ## Serving the underprivileged in the Homeland



Boston based Subha Sundaralingam's "Now-Wow' organization provides non-profit opportunities for the wounded, widows and orphans of the war in Sri Lanka's North and East......

In an exclusive interview with Tamil Culture's Ara Ehambaram, Boston based Subha Sundaralingam speaks about her organization "Now – Wow" and its activities, and how it is helping to provide opportunities to widows, orphans and the wounded in Northern and Eastern Sri Lanka who have been affected by the thirty - year old civil war in Sri Lanka

Tell us more about "NOW-WOW" (http://www.nowwow.org/), why you started the organization and the impact that it has had.

"When I got involved in the post-2009 Tamil Diaspora political activities, I had the opportunity to mingle with many other like - minded individuals from all over the world who were likewise committed to serve our homeland at a time when there was a lot of need. One common thread amongst the various organizations arose: "Something needed to be done here and now about our people whose family lives and livelihood has been thrown into shambles".

The case of the wounded and permanently disabled who needed medical care presented itself there in astounding numbers too. There were many who needed help with medication. Many others needed help with their prosthetics and orthotics. There were many more that would need advanced kinds of treatments. Increasing frequency of suicide reports from there underlined the fact that the number of clienteles in need of psychiatric care and psychological counseling would be very daunting to handle.

On the social side, theft and robbery were slowly replacing respect for private property as the new norms of Vanni existence. Murder and violence were increasingly becoming the new mechanism for dispute settlement there. Incidences of sexual violence that was once an infrequent occurence due to fears of harsh punishments became more prevalent. Despite foreign aid for reconstruction sent by the international community, meaningful impact on the local economy and im-

provement of these societal challenges did not change. The social fabric that held a community together was coming apart in bits and pieces.

The dire situation did make us despondent even though some of it was expected as the inevitable consequence of the brutal war. But it gave some of us food for thought also. Cluelessness would be an appropriate term here to discuss our dilemma, because most were lay people, who had neither the political experience nor a societal vision. So, when NOWWOW was formulated with enthusiasm, eagerness, and dedication – these would form the only avenue that we were prepared to bring into this new, challenging yet unfamiliar venture. We could never become an adequate substitute or something complementary to what the international organizations were already doing. Yet, we were committed to do whatever it takes to make a dent in the status quo, even if the impact was going to be a minuscule one.

NOW WOW is a 501(3) C registered organization in the United States. For a start, we worked with a targeted group of the worst affected young mothers with children. We would help them to find self-sustenance, one woman at a time. Our service, which started in small has made a difference in the lives of hundreds of people over the years. We focus on 4 elements of activities and made a difference on the war affected Tamil people in North and East of Sri Lanka.

- 1. Education
- 2. Empowerment
- 3. Employment
- 4. Emergency Relief

#### Tell us about what life was like for you to go from Sri Lanka and your journey here to Boston.

I was born in a village called Annaicottai, where I grew up with my brothers. My father was an accountant with a small hardware shop and my mother was a housewife. Our house had no electricity and I grew up studying in a kerosene lamp. I started my education at Annaicottai Bala Subramaniya Vidyasaalai, studied at Manipay Ladies College and completed my bachelor's degree in Chemistry at the University of Jaffna.

During my lifetime in Sri Lanka the occupation of Sri Lankan Army and Indian Army were high. The days of hiding in our 'L' shape bunker, when the fighter jet arrives, the early morning dog-barking noises and my parents' daily struggle to save my brothers and me from the Sri Lankan armies are unforgettable. When the Indian Army arrived in Kallundai the sound of artillery shells passing through our house, the sound of gunfire and falling the artillery shells on our house were terrifying. We were living in a makeshift refugee camp the Muthanayanar Hindu temple for 3 months with limited meals and toilet

As soon as I completed my bachelor's degree, my parents had arranged my marriage abroad and sent me to Boston, USA. I came to Boston, leaving my entire family and the only world I knew behind in hopes of restarting a new path in my life. Even though I completed my university studies in English, I did not have practice speaking in English - a very common struggle for many of us educated in the British Commonwealth. I remember my first work interview at a department store. The manager asked me "tell me about yourself", I did not understand what he said and was not able to respond to him. The accent, culture and environments were not familiar to me. So, I just smiled, and of course did not get the job. So, to get familiar with English, I started to watch TV so that I can attend the next interview at a bank. I finally landed a clerical position for 3 months, and while working there I started looking for positions in the field of chemistry.

I started a post bachelor certificate course at Northeastern University, Boston and got a job at a teaching hospital as a Lab Assistant. I worked hard to get my license as Clinical Laboratory Scientist in chemistry and was promoted to Medical technologist, pathology team leader, and chemistry lab supervisor. At the same time my daughters were growing up and I faced many challenges in my personal life which I battled with. Now that I think back, although Tamil culture and community are great at many things - we have a long way to go in truly looking at women as equal to men and providing support mechanisms and a community to help Tamil women move passed the struggles of their personal lives. I was very fortunate to have my parents and brothers who stood by me - not every woman is that lucky.

How do you manage your time between running "NOW-WOW", being a single mother of 2 kids while having a full-time job as a Chemistry Lab supervisor at one of Boston's most prestigious hospitals?

When my daughters were younger, I worked part-time so I can focus on my family. As my children got older, I was able to return to the workforce fulltime. When we founded NOW-WOW, my daughters were teenagers, so it was a different type of time management. I believe time management is important to be successful, but at the same times I had to give 100% to my daughters, my job and NOW-WOW, so I worked many long hours. In financial tough times, I remember taking really difficult 16 hour shifts then coming home and cooking food for my kids or helping with activities in the Boston Tamil community.

#### What's one goal that, if you were to accomplish it over the next three months, would feel like a big win for you?

The schoolgirls and young women living in rural villages can't afford to use hygienic sanitary pads. We want to distribute it to them ideally for free or at a very lower cost. For that we have put forward a few ideas to start a small factory. This small factory will also create job opportunities for many underprivileged women.

## Indian subcontinent lost a truly great singer: South Asian leaders on demise of 'empress of music' Lata Mangeskar

Dhaka/Islamabad/Colombo, Feb 6 (PTI)

The Indian subcontinent has lost one of the truly great singers the world has known with the demise of Lata Mangeshkar, top leadership of South Asian countries said on Sunday as they paid their tribute to the "empress of music" who "touched billions of hearts through her golden and unparalleled voice".

Mangeshkar, whose voice stirred millions of hearts everyday and who will forever be counted as one of India's greats with an estimated 25,000 songs in an almost eight-decade career, died in Mumbai on Sunday. She was 92.

In a message of condolence, Bangladesh's Prime Minister Sheikh Hasina said Mangeshkar will remain alive forever in the hearts of the people in the region through her work.

"A great void has been created in the subcontinent's musical arena with the demise of the 'Sur Samraggi (empress of music)'," Hasina said, praying for the salvation of the departed soul and conveying her deep sympathy to the bereaved family.

In a separate message, President Abdul Hamid also expressed his profound shock and sorrow at the death of the legendary singer and expressed condolences to the bereaved family.

Taking to Twitter, Pakistan Prime Minister Imran Khan, who was on a

four-day visit to China, said, "With the death of Lata Mangeshkar the subcontinent has lost one of the truly great singers the world has known. Listening to her songs has given so much pleasure to so many people all over the world." Expressing his condolences on Mangeshkar's demise, Sri Lankan President Gotabaya Rajapaksa said India's "Queen of Music" "touched billions of hearts through her golden and unparalleled voice".

Mangeshkar is a legend whose memory will remain in our midst for centuries through her melodious voice, he tweeted, sharing a photograph of the legendary singing icon.

Mourning her demise, Lankan Prime Minister Mahinda Rajapaksa in a tweet said, "Rest In Peace Nightingale of #India, #LataMangeshkar. Thank you for the decades of entertainment that transcended borders & gave life to the phrase 'music is a universal language".

"I offer my heartfelt tribute to genius Lata Mangeshkar with extraordinary talent," she added.

Dubbed as the 'Nightingale of India', Mangeshkar has lent her voice to many songs in Nepali films, including blockbuster 'Maitighar' which features yesteryear bollywood actress Mala Sinha in the lead role with Nepali actor Chidambar Prasad Lohani.

The Royal College Old Boys' East Coast Foundation (RCOBECF) USA recently mourned the passing away of its oldest member - Dr. Mahendra Somasundaram in New York. Mahendra attended primary school at St. Patrick's College, Jaffna, and then secondary school at Royal College Colombo till 1949. His full education at Royal College was covered by a Governor's Scholarship. He received two double promotions at Royal and so entered the Faculty of Medicine of the University of Ceylon (Sri Lanka) at the age of 17 years.

He won many awards at Medical School including the Je Boey Scholarship for best performance in the 1st MB exam and the Hazare Prize for best performance in Year 3. He was first in his class for the first four years in Medical School. He qualified in March 1955, two years younger than his classmates, graduating with First Class Honours.

Following graduation, he was a House Officer at Colombo General Hospital and then Registrar to the Professor of Medicine for nearly three years He was then posted to Ratnapura Provincial Hospital as a Visiting Physician and left for the UK in 1962. In London he received his MRCP (Member of the Royal College of

In 1965, while working

in the UK, he was recruited as Senior Lecturer in Medicine at the University of Malaya in Malaysia. He developed an interest in Neurology and was awarded a scholarship to the University of Washington, Seattle in 1967 to work with Prof. Emilio Chatrian in Neurophysiology.

He returned to the University of Malaya a year later and in 1970 went back to the US to start a Neurology Residency with two pillars in Neurology, Professor Plum and Professor Posner at New York Cornell University Hospital.

In 1974 I met Mahendra at New York Hospital while attending a neurology conference. At this time SUNY Downstate created a new Department of Neurology with Prof. Henry Schutta from UPenn as

its Chairman. The programme was enhanced by the recruitment of Prof. Roger Cracco from Jefferson to head Neurophysiology and Prof. Arthur Rose from Albert Einstein for Pediatric Neurology. Upon hearing about Mahendra, Dr. Schutta requested that I arrange a meeting with him. Mahendra was promptly hired and made the Director of Neurology at SUNY Downstate - Kings County Hospital Centre in Brooklyn NY.

Mahendra who was known as Dr. Soma by all his residents and students served as a teacher cum clinician for over 30 years. He continued to see patients and teach residents well into his eighties. Gentle, sincere and devoted to his patients, he received many accolades including the prestigious 'Distinguished Teaching Professor' at SUNY Downstate in 1994.

He was described by his residents as a very humble man, much respected and

revered by students, trainees, residents and colleagues. Some of his residents are Chairmen of Departments both in NY and NJ continuing the tradition.

On his 80th birthday Dr. Radha Giridharan, a former resident and colleague arranged a birthday party. It was a 'sold-out' event with speakers extolling his humane qualities and how he touched their lives and shaped their careers. I attended this event with two other Neurologists - Dr. Sanath Nallainathan and Dr. Miran Salgado, both Old Royalists and past-presidents of RCOBECF.

Mahendra Somasundaram M.D has left a tremendous void in the hearts of many colleagues, friends and family and the world of Neurology at large. He is predeceased by his wife Padma and leaves behind three daughters (Narmadha, Pamathi and Manjula) and two grandchildren Jothi and Vikram, the love of his life.

### THE TAMIL NUMERALS

Recently I chanced upon reading an article in 'The Hindu', dated 29th December 2011. The title of the article was 'Ancient numbers on Ramanujan's land'. (Ref-1) It was mentioned that there isn't much written evidence of numerals in manuscripts, as palm leaf manuscripts decay with time and hardly last for more than 200 years. However, two-thousand-year-old Thirukkural, a book of ethics on as its couplet # 392 mentions.

The twain that lore of numbers and of letters give Are eyes, the wise declare, to all on earth that live ---392

Meaning, numbers and letters are both the eyes of the living. Physical eyes will have no sense if one doesn't have the knowledge of numbers and letters.

Further it was mentioned in Tholkaapiyam which is older in its stanza # 655. 4 mentions about numerals. It was also pointed out in that article that the oldest stone inscription featuring a numeral is the Tamil-Brahmi cave inscription from Thondur, near Gingee, in Villipuram district, assigned to about 3rd Century C.E. Fig1.

The numeral 3 engraved at the end of a short two-line inscription in the cave is represented by three horizontal parallel lines.

As for pottery inscription A well-preserved pottery inscription from Alagankulam near Rameswaram has only the numeral incised in fairly large size (Fig.2). The inscription is dated to the 1st or 2nd Century CE.

The figure three gives an idea of the evolution of the Tamil numerals from the Brahmi script through manuscript stage to the present print numerals. (Fig 3)

When the European nations conquered the Island of Sri Lanka, which was called Ceylon, the manuscript numerals were used. The name of the Island being Sri Elyom, became Ceylon in the foreign dialect, Sri becoming C and last letter M becoming N. Please refer to Fig 4. For numerals used by the Tamils during the time when the invaders came to the island.

After being ruled by Dutch and Portuguese, finally it became a colony under the British empire. During the time of Queen Victoria ¼ Cent coins were in use. Please see Fig 5.

It is interesting to note that in the coin issued in the year 1890, the value of the coin in Tamil is given as 'வ சதம்', meaning ¼ cent. 'வ' in Tamil numerals means 1/4. The tradition of using Tamil numerals continues, under the reign of her successor King Geroge the VI, the value of fifty cents is given as "ஞ0' சதம். . Here 'ஞ' refers to five hence it is fifty cents.

This tradition of using Tamil numerals on coins by the British continued until Ceylon got its independence in 1948. As late as 1944 On the ten-



cent coin you can see the Tamil numeral 'ao'. In this numeral, 'a' refers to 1.

Thus, '±0' refers to ten. In 1948
February 4th got its independence and everything changed. The Tamil numerals went out of fashion and the Roman numerals came in. To sum it all up, the year before last when I visited another island Mauritius, I found they have the Tamil numerals on their one hundred Dollar notes. Please see Figure 8.

On the bottom left-hand corner, the value of the note is given as '500'. Here too 5 refers to one meaning '500' refers to 100. Last but not least I have given a poster on a wall for your perusal. They can understandably be proud to proclaim to the world it is 'One Island with many peoples and all are proud to be Mauritians". Well done, Mauritius.



Or if somebody preemptively takes up your parking space, do you go bonkers?

A person with such a might—that holds in them the promise to be able to conquer ignorance—loses their cool because somebody stole their parking space? Because your dog ran away? Because your husband said, "I don't like you anymore"? Your wife said, "Goodbye. I found something better"?

(No, I mean, just, just, just asking.... That's the point of the audit, right? You've got to ask some questions here. Just asking.)

So, time for audit again. For the human being that has this ocean, this ocean of peace, how much of that ocean is reflected in your existence? For this human being who, in them, has these, lake after lake of serenity, how much of that serenity is actually accounted for in your life?

This strength that you have to

win the war.... Everybody, every human being on the face of this earth is born with that exceptional strength—no imagination here; just pure, simple—that special strength needed to overcome ignorance in your life, (not somebody else's life, in your life), how much of that is accounted for in your existence?

Your heart is timeless. Be a part of that timeless heart. That space in which there is that serenity, that space in which there is that peace, in that space where there is that joy, the boundless space that exists inside of you, that is timeless. More you use it, it will not go down.

So, take an audit—and whatever you see in your audit.... You have to perform the audit; I'm not going to make the audit; you have to make the audit of your life, and whatever you're missing, dig in and get it—before you hit that wall.

Because that's the day you will begin to live. That is the day you will actually, really begin to live. Not in this molasses, not in this goo of ideas and imagination—I mean, and don't, don't get me wrong; I'm not, I'm not saying imagination is bad. We all need imagination; that's really good!

In this life, in this existence, one, you have everything you need. Two, it's within you. Three, it's yours. Four, all you have to do—is without any fear of failure, let the river of peace run through you. That's all. That's all. Don't fight with it; let it run; be who you are—and enjoy.

In one way, we're all strangers going on this ocean, this voyage, this voyage that has something to do with time, something to do with those six elements of oxygen and carbon and nitrogen and all of that stuff. Here we are, something to do with millions of years of evolution, something to do with all of that.

But at the end of the day, here you are. And you have to look at what's possible now. Not the journey of imagination, but the journey of experience, to have made it possible to have peace in your life—the greatest achievement. The greatest, the greatest achievement a human being can achieve.

You will get the ultimate recognition for it. The award is peace. The award is joy, your joy, your peace, your life fulfilled.



## What happened to Airlines **Emirates** flight EK231 20th of December 2021??


Tas Emirates Has Emma Eclipsed by its money and lost its value in managing the first and the foremost airline of the modern Dubai? Proclaimed as one of the best in the Mideast, I remember in 1985 this airline fledged its wings and have seen it from walking, running and to blossom in to a promising airline with Maurice Flannagen and later with Tim Clark at the helm. Has it lost its guard down? I know the H.E. Sheikh Rashid is very much involved in this. Whatever it is, things had happened and have been happening with Emirates. This particular aircraft had come from

Zurich about two

days back and was resting and was readied for flight EK 231 Dubai - Washington D. C. The Aircraft was cleared by ATC for takeoff from Runway 30R and was on the roll at 2.30 am, the speed V1 has been reached, the aircraft was on its V2 (Speed for pull up or Rotation of the aircraft) and was still rolling on the runway at almost 265knots, almost at the end of the long runway of 13000 feet, realizing this one of the pilots ( as if God told him" pulled the stick up") and the flight got airborne barely missing all the high rise buildings in Deira, Dubai by less than 200 feet according to initial reports. Being an active aviation enthusiast and worked in this field for almost 50 years I would categorize this a miracle in aviation history. On the same breadth it would have been the worst aviation accident in its history by the sheer negligence, a "Story Book" of human error in aviation log books.

Boeing 777 made its maiden flight in 1994, United airlines took its first delivery. I would say a state of the art aircraft and the "fly by wire" technology, called Triple 777 and about 785 of them are still flying all over the world powered by Pratt & Whitney engines. It is the first to be designed entirely by computer "fly by wire" aircraft. This means that the controls surfaces on the wings and tail are operated by electric signals "by wire" from the controls in the flight deck .. 70 different airlines operate 777, one of the most beautiful of the Boeing family. According to pilots it's a great plane sophisticated, very capable, nice to handle, and one of the safest aircraft in the skies. It's a fully automated aircraft that has many features to help the pilots to fly this

Flight EK231 Dubai (DXB) to Washington Dulles (IAD) with a scheduled departure at 02.25 am, 777-300 ER, was cleared for takeoff



runway 030R attained its initial speed (V1) of 160 knots and reached its rotating speed of 190 knots and reached almost 260 knots but still the aircraft was on the runway, not airborne, just before it ran through the end of the runway and crashed into the houses and the high rise buildings near the airport, one of pilots pulled the aircraft's nose up and was airborne at almost 175 feet over Diera City Centre. Since this was a 14 ½ hour flight to Dulles, there were 4 pilots on board, after 7 hours the other 2 set of pilots will take the Controls because of flight time limitations. There were almost 300 passengers with the crew. Somehow the pilots realized their mistake and corrected in the nick of time avoiding a major disaster in aviation history on ground. Within two days of this incident "Dot Aviation" reported this. From the NOTAM that was issued days after this we can conclude, it was a simple pilot error at the best in the cockpit in modern aviation while being on ground. Preliminary reports indicated that all the 4 pilots were sacked which was denied later. This is what would have had happened. The pilots before takeoff forget to set the Autopilot to an initial climb height of 4000 feet and it was on zero and the flight director was showing the nose of the aircraft in the ground and they were blindly following the flight management control system. This particular aircraft arrived from Zurich (ZRH) two days before and the crew set the altitude to zero after landing. This was not noticed by the crew for the Washington flight. The pilots do a checklist in the cockpit before each and every flight for landing and takeoff. In the good old days it's done manually. Especially in 777, it is built in

the system and the pilots use a cursor like a


laptop Track pad to click through the check

lists. This ensures nothing is missed and



alerts if an incorrect switch or lever selection has been made by pilots. It will be still a mystery how both the pilots had missed this auto pilot setting. According to a friend of mine an experienced pilot of 45 years, lives in Adelaide said that a female pilot was in command at the time of takeoff. I understand that the airline naturally wants the citizens of Dubai at the controls or being checked out as captains or co-pilots but they should not rush into this scenario in a hurry unless they are fully trained and certified and also must have at least minimum 5 years of flying in the right hand side, This is my assumption, maybe I am wrong. Also I learnt after this incident that at Emirates the flight training insist on pilots to rely mostly on automation systems of the plane rather than on their manual skills. I know well pilots do the takeoff and landing manually. Once they attained the cruise altitude or height, they engage the auto pilot for the long sector flights which reduces the work load for pilots. The pilots normally disengage auto pilot when they are almost on final approach and do the landing manually. I am not surprised to see this kind of procedures are still used by pilots in USA and other countries. But some airlines in that part of the world rely on this automation reasons best known to them. I heard there are couple of other incidents after this with Emirates which could have endangered, "the sky of aviation". One flight took off without ATC clearance, another almost near collision of two aircrafts on ground recently.

Personally don't want to see another calamity in aviation.



## THE MARUTHANAMADAM VEGETABLE MARKET

#### Famous for fresh vegetables and fruits

Market

n our return from Malaysia in 1949 my father bought a piece of land along the Jaffna - K.K.S road at Inuvil mainly to settle us away from the densely populated ancestral home and built a house a stone's throw distance away from the Maruthanamadam junction. Those days there were only three houses between Maruthanamadam junction and the Inuvil MacLeod hospital. Inuvil is a red soiled fertile land in which vegetable crops richly thrive spreading over a far stretched lush green landscape.

I remember as a young boy the vegetable market those days functioning in a small plot of land between the gas filling station and the K.K.S road. Hardly any possibility of widening the market area to accommodate more farmers and the continuous inflow of reaped farm products the market was later shifted inside the Uduvil village council area where there was an elongated thatched roof building. In the building was the library where news papers both in English and Tamil were kept on the tables. There was also a table tennis table provided with net rackets and ping pong balls. In the evenings film music was relayed through speakers. It was during our time Radio Ceylon commenced the commercial service presenting continuous film music. Daily in the evenings people arrived there to read news papers and listen to music both being the only entertainments then.

The arrival of farmers with farm produce from other areas and the influx of consumers from neighbouring villages prompted the expansion of the marketing area. As a result the village council office had to be shifted to the Pradesh Sabha in Chunnakam. With the widening of the area the market became popular with abundance of fresh vegetables and fruits.

The active farmers arrive early in the morning with their farm produce and the market becomes a hive of activity. The pealing of the Vairava temple bell early in the morning serves as the time piece for office workers school children and others engaged in various trades to prepare themselves for duty.

The Maruthanamadam junction now is congested with the setting up of new buildings and the plying of vehicles in all directions. The Jaffna - K.K.S road and the Kaithady - Manipay road crossing at the Maruthanamadam junction

causes heavy traffic jam. Furthermore the K.K.S road is the busiest road in Jaffna as most business establishments factories offices and schools are functioning along this road. Furthermore school children especially girls cycling along this road is a common sight. Vegetable vendors with heavy load on their bicycle carriers tractors land masters and even bullock drawn carts are familiar sights along the road.

There are many attractions all along the road. The newly constructed 72 feet majestic statue of Lord Anjaneya in front of the Lord's temple along the K.K.S road at Maruthanamadam can be seen from far off places. Normal poojas for Lord Anjaneya

are performed daily in the morning noon and evening. Also special poojas are held on Tuesdays and Saturdays as these are days considered special for Lord Hanuman.

The Pallappa Vairavar temple close to the junction is revered by everyone.

People leaving Jaffna during their outward journey pay obeisance at the temple for a safe journey. The Thurai tea boutique Thevi vilas and other business establishments set up much earlier in the junction are always busy with brisk business. With the setting up of many other business establishments the Maruthanamadam junction has become a very busy town.

#### Why Can't You Work From Anywhere if You Work From Home?

**B**ret Bonnet, co-founder of the Illinois-based company Quality Logo Products, Inc. was none too pleased when he found out that one of his employees had moved to another state to work remotely without informing the firm.

"The state he moved to came after us for a week's worth of state income tax that we failed to pay as a result," Bonnet recalls by email, noting that while the amount only totaled \$87, with late fees, fines and penalties, the final sum was \$1,700. "After more than 40 hours and countless phone calls/emails, we eventually got this cleared up, but it just goes to show what a headache out-of-state employees can be unless you're a major national corporation.'

Working from home used to be a rare occurrence for most people, but the COVID-19 pandemic has seen many companies really ramp up the remote option to keep things running during unprecedented times. Indeed, it has been largely a success, with enjoying employers increased productivity and happier employees who don't have to commute as much. Major companies like Twitter, Amazon, Zillow and Spotify have announced varying levels of work from home expectations, ranging from occasional office face-time to none at all.

Some states (and even some foreign countries) are enticing remote workers to try them out with all kinds of incentives. Other workers might just want to move someplace more inviting for "work from home." After all, working near the beach or from a mountain cabin sounds better than in a tiny city apartment or a cookie-cutter suburb.

But before you make a move, know this: Just because a job can be done remotely 100 percent of the time doesn't mean you can do it from anyplace you want. So why not?

#### The Tax Issue

state's income and withholding tax requirements differ for individuals out-of-state, as do the laws on business registration, which depend on several factors, including the nature of the business," emails attorney David Aylor, who is based in Charleston, South Carolina. "States have different thresholds when employees working remotely triggers tax changes, so each individual situation needs to be assessed by looking at federal, state, and local laws in both a potential remote employee's and the business's location."

It's not just taxes. Employers may also be liable for workers' compensation insurance unemployment insurance in the state that the employee is working. So, if it's just one person in the company working from that state, it's probably not worth it to take care of all the legal and accounting implications.

"To allow administration to be completed correctly means that the HR and payroll departments would need knowledge of all the different rules in the areas in which employees resided," emails James Crawford, co-founder, CEOand hiring manager e-commerce ofplatform DealDrop. "The expense and time spent in applying all these differing rules can prove to be too complicated to allow the employer to permit working in different regions."

#### Time Zones and Meetings

Even if you work for a large company with locations in all 50 states and several foreign

countries, an employer may still not grant your request to work remotely from another state from which you were hired originally. While many employers are cool with not laying eyes on employees every single day, they may still want to have regular in-person meetings. If your office is in Georgia, but you decide to move to California or Canada, that could be a problem.

"Although meetings can be done via web conference, some employers still expect staff to, at least occasionally, call into the office for face-to-face meetings or team building events," says Crawford. "If the team is spread over different states, or even different countries, this can be highly problematic."

Most companies have set "core hours" during which they expect employees to be active. This gets tricky if too many time zones are crossed. "For example, it might be difficult for remote workers in Los Angeles to work for a company in New York because of the three-hour time difference," says Bowen Khong, founder and head of research at ForexToStocks, an online brokerage review firm, who employs many remote workers for his business. "Clocking in at 5 a.m. PST for an 8 a.m. EST shift isn't desirable and makes the workers less productive."

#### What Happens if You Relocate Under the Radar?

You might be tempted to make the move even if your company forbids it. After all, how would they know that vou left town? You'd be surprised.

"Employers find out this sort of thing via social media, where people forget that their colleagues and employers often have access to their posts. If that employee tries to file their taxes in their current state, the employer may find out about the move via a tax agent when the filing flags their alert system," says attorney Aylor, noting that this deception could be grounds for termination.

"Lying about your location could

also cause the business to improperly file their taxes, in which case they may be liable for tax fraud, a very serious legal dilemma that can bankrupt a business quickly," he adds. "Generally, tax agents won't pursue legal action if steps are taken to right the wrong after they discover it. When it comes to legal matters, you do not want to lie and hope you get away with it — be honest and upfront with your employer."

To avoid such mishaps, employers need to clearly communicate the ground rules when offering a remote position and employees need to ask how "remote" they can be if they're thinking of moving location.

"Before you decide to relocate because you work remotely, be sure that the terms of your employment allow you to do so, and if not, stay put or find a new job," says Khong.




### JAMES WEBB TELESCOPE LAUNCHED TO OBSERVE THE ORIGIN OF THE UNIVERSE

#### High Cost, High Risk, High Hopes James Webb Space Telescope Successfully Launched

The James **▲** Webb Space Telescope (JWST) is an international collaboration among NASA, the European Space Agency, and the Canadian Space Agency. It cost over 10 billion

USD (2016), and the size is approximately over 20m × 14m was launched on December 25, 2021. JWST is a large, space-based observatory optimized for infrared wavelengths, which will complement and extend the discoveries of the Hubble Space Telescope. It will have more extended wavelength coverage and greatly improved sensitivity. The longer wavelengths enable Webb to look further back to find the first galaxies that formed in the early Universe and peer inside dust clouds where stars and planetary systems are forming today. This space-based observatory is named after James E. Webb (1906-1992), NASA's second administrator. Webb is best known for leading Apollo, a series of lunar exploration programs that landed the first humans on the Moon. However, he also initiated a vigorous space science program responsible for more than 75 launches during his tenure, including America's first interplanetary explorers.

#### Webb and Hubble

Webb is designed to look deeper into space to see the earliest stars and galaxies that formed in the

1.5 million km

Universe and to look deep into nearby dust clouds to study the formation of stars and planets. To do dis, Webb will have a much larger primary mirror than Hubble (2.7 times larger in diameter, or about six times larger in area), giving it more light-gathering power. It also will have infrared instruments with more extended wavelength coverage and greatly improved sensitivity than Hubble. Finally, Webb will orbit around the second Lagrange (L2) point, which is about 1.5 million km away from Earth,

and it takes about a month to travel this distance

Webb will maintain its freezing operating temperature, stable pointing, and higher observing efficiency than Earth-orbiting

The most important size of a telescope is the diameter of the primary mirror, which is approximately 6.5m for Webb. It is about 2.75 times larger in diameter than Hubble, or about six times larger in area. The Webb has a mass of approximately 6,500 kg on Earth (in orbit, everything is weightless), a little more than half

the mass of Hubble. The largest structure of Webb will be its sunshade, which must shield the deployed primary mirror and the tower that holds the secondary mirror. The sunshade is approximately the size of a tennis court.

#### **JWST Communication**

The JWST will send science and engineering data to Earth using a high-frequency radio transmitter. Large radio antennas segment of the NASA Deep Space Network will acquire the signals and forward them to the Webb Science and Operation Center at the Space Telescope Science Institute in Baltimore, Maryland, USA.

#### The primary Goals

- JWST has four primary mission goals:
- · Search for the first luminous objects or galaxies formed after the Big Bang.
- · Determine how galaxies developed from their appearance until the present.
  - Watch the appearance of stars from the first stages to the formation of planetary systems.
  - · Measure the material and chemical effects of planetary systems and investigate the

possibility for life in those systems, including aliens.

#### **Detection Distance**

One of the main objectives of JWST is to detect some of the very first-star formations in the Universe. It is assumed to occur somewhere between redshift 15 and 30. At those redshifts, the Universe was only one or two percent of its current age. The Universe is now 13.8 billion years old, and these redshifts correspond to 100 to 250 million years

> after the Big Bang. The light from the first galaxies has traveled for about 13.6 billion years, over a distance of 13.6 billion light-

#### First galaxies after Big Bang

Current hypotheses of galaxy formation suggest that the birth process for these vast systems of stars may be very violent events and will be billions of times brighter than our Sun. Such events may remain visible at highly redshifted wavelengths. Although much of the energy produced is emitted in the ultraviolet, it will be redshifted into the infrared by the time it gets to us because of the extreme distance (in space and time).


#### **Redshift Measurement**

Redshift is a unique astronomical case of a physical phenomenon called the Doppler effect (after Christian Doppler [1803-1853]). The Doppler effect occurs when a source sending out waves (either sound or light) moves to an observer. When the



source moves toward the observer, waves arrive earlier than they would in the stationary case, and the wave peaks come closer together (the sound is the higher pitch or the light is bluer). If the source moves away from the observer, the waves get more stretched out (the sound is the lower pitch or the light is redder). The Doppler effect on sound can be heard when a siren or fast train passes.

Most galaxies are moving away from us because the Universe is expanding, so the light from the galaxies is redshifted. The faster it moves away from us, the larger the redshift. How redshift is connected to the distance of an object depends on the expansion rate of the Universe, the geometry of the Universe, and the energy content of the



Universe. Determining these values is an essential subject of investigation of current-day astronomy. Redshifts are measured by taking spectra of the electromagnetic radiation (X-rays, ultra-violet, visible and infrared light, microwaves, radio waves, etc.) of astronomical objects.

Physical processes within the atoms and molecules that make up stars and galaxies cause the spectra to have recognizable features at specific wavelengths. The wavelengths of these atomic and molecular absorptions or emission lines can be measured very accurately. By measuring the observed wavelength



of an element in the spectrum of a galaxy and comparing it to the non emitted wavelength, astronomers can measure the Doppler shift of the Universe. Galaxies are said to have a redshift of 1 if their spectral features have shifted to twice as long a wavelength. If their features have moved to 3 times longer wavelength, they have redshift

2, and so on. Webb is designed to see galaxies at redshifts of 15 or more, where the ultraviolet light is redshifted into the infrared. In the upcoming article, the author will update the status of JWTS

## MAHAKAVI BHARATI'S WISDOM CONTINUES TO GUIDE HUMANITY

The education system, alongside western culture, did not greatly emphasize the triumphs of states and individuals within the subcontinent. I was inclined to believe the method of life and ideals of those originally residing in the subcontinent were below those of the west due to my minimal exposure to the history of the Indian subcontinent, alongside the inherent superiority complex promoted within western education and culture. This point of view changed as I began to fully understand the influence collective morals, values, and principles have in dictating the progress of a nation and its people.



**C. Subramania Bharati** (December 11, 1882 – September 11, 1921)


Recently, I read *The Coming Age*, a collection of Mahakavi Subramania Bharati's English writings put together by Mira T. Sundara Rajan, Bharati's great-granddaughter. Bharati was given the title, Mahakavi, meaning supreme poet, on account of his exemplary literary capabilities extending beyond Tamil, as he was also fluent in languages such as English, French, and Sanskrit. "Bharati was a nationalist who fought against British rule in India and a social reformer who advocated passionately for women's

equality and the eradication of caste,"

Rajan noted. Although the English writings published in this book have been available for many decades now, this compilation allows a global audience to fully engage in Bharati's teachings and ideology, recognizing how they may continue to guide humanity's progression today.

Bharati's criticism of the way men treated women in society displayed his evolution as a human being. Through interactions with Sister Nivedita, a disciple of the famous Swami Vivekananda, he unlearned the social norms dictating the supposed "place of women." This influenced his advocation for women's equality. Bharati believed women are of greater spiritual evolvement than men. Women acknowledge the evils associated with men's current way of civilizing one another, through violence and imprisonment. He notes that men are afraid to afford equal opportunities to women and look to control their sexuality. Men over time have looked to develop hierarchical relationships in not only their personal life, but also on a societal basis. Exerting power and control to enslave others has been a desire throughout human history. This is seen through the mischaracterization of caste as theorized in the sacred Hindu scripture, the Bhagavad Gita. Political figures within India have attempted to cite that their use of caste is God-given. However, Bharati comments that this theory presented within the Gita has yet to be put into action, as the competitive nature humans have cultivated in part hinders this.

As we continue to progress within the modern age of technological advancement, the competition for material desires and goods continues to spiral out of control. Losing our sense of self, while continuing to mistreat our planet will inhibit our upward evolution as a society, Bharati noted in 1915. Society today faces a seemingly insurmountable task in slowing climate change, induced in large part by the excessive competition us humans have played into. If we truly are higher beings compared to animals, then through the Will within ourselves we must strive to learn to live in harmony with the planet and the greater universe. To learn why we are inclined to promote competition amongst one



another, we must unlearn our unrelenting desire for power.

In his 1915 essay, 'The Siddha and the Superman', Bharati compared German philosopher Nietzsche's Übermensch (Superman) and Hinduism's Siddha (Perfected Man) to reveal the importance the two terms have in revealing "... the modes of thought, ... the historical reminiscences and spiritual aspirations" of different communities of people. Striving to become Siddha is to understand that we should not desire the will to power but desire the Will itself in its entirety. The Will itself holistically encompasses the will to love, the will to be, and the Will of the universe, to live harmoniously amongst one another. Power is present in society as well as our individual relationships. Its inherence within our lives' points to Bharati's insight that we must desire the Will within ourselves holistically, lessening the importance we collectively have placed on power.

Bharati's vision for change has given us a way to reflect on how far we have come, and how far we still must go. Humanity's upward evolution depends upon our ability to live in harmony with the universe. The version of society in which we can all live peacefully depends upon each of us reevaluating our own individual morals, as well as the morals of the society governing us.

### Adjaruli Khachapuri \*

This month, we are featuring a recipe from Georgia, a country close to Syria, which has a rich food history. This dish is quintessentially the most popular dish from the Adjara region of the country; a dish that is fun to make if you are looking to make something for Valentine's Day together with your significant other.

#### Method:

In a small bowl, combine warm water and dry active yeast together with a pinch of sugar and stir. Let it sit for 7 minutes until the yeast activates and is foaming.

In a large bowl, mix together flour, salt and sugar. Pour warm milk, activated yeast and olive oil over the flour mix and knead these ingredients together for 5 minutes. Cover the dough with a clean kitchen towel and let it rest for 20 minutes. After it has rested, knead again for a further 5 minutes. Divide the dough into 4 equal parts and roll each part into a ball. Cover the dough balls again with your clean kitchen towel and let it rest again at room temperature for 35-40 minutes.

Preheat your oven to 200°C/400°F, and whilst you are waiting, combine all the cheeses into a bowl and mix together until all integrated.

Post-rest, roll each dough ball out into circles, on greaseproof paper, with an approximate diameter of 9 inches. Arrange some of the cheese mixture of either side of the circle, a few centimetres from the edge, in rows. Roll the sides up so the cheese is encased along the edge, then gently pinch and twist the top and bottom parts of the dough to form the shape of a boat. Place a generous amount of the cheese mixture in the centre of the khachapuri. Brush the edges with an egg wash and, if using, sprinkle with sesame seeds.

Place in the oven for 15 minutes, remove, make a well in the centre of the khachapuri and gently crack an egg into the well. If using, sprinkle oregano, baharat, black pepper and pul biber on top at this stage. Return to the oven and bake for another 7 minutes, or until the egg is cooked on top. Once removed from the oven, place a knob of butter on top the khachapuri and butter the crust. It is now ready to eat!

Traditional khachapuris have a runny yolk, it is the best part of the eating process! Usually, the crust is ripped and used as a tool to mix the egg and cheese together. Best eaten with hands!







# Royal College OBA transforms hope to under privileged families in Sri Lanka

Toronto, Canada: The theme of helping underprivileged families in Sri Lanka was the project, global members of Royal College Class of 1980 (Tamil Medium) vision, as part of giving back to the country of origin. The project was to build a few houses for underprivileged families and give hope.

This is the first major project initiated by RCO-BA 1980 Tamil medium and wanted to give back to the community as part of social responsibility. A small group of volunteers planned and raised funds. Overseas volunteers knew it's going to be a challenging task to be part of ground reality of Sri Lanka i.e construction, labor, material cost etc. The volunteers tapped into the government of Sri Lanka N-E province poverty and shelter program. The government was willing to assist with the provision of voluntary manpower and procurement of material through the Sri Lanka Army troops deployed in Jaffna.

A selection process vetted and a family from Alvai, Pointpedro in the Northern Province of Sri Lanka was selected for the first house. The family consists of father, mother along with two daughters and son (Age 10, 06 and 07), living below poverty line. The lady was a former member of LTTE rebel movement during the ethnic conflict. She served in the year 2007-2009. She was badly injured during that time and was living in a tin shed house without clean running water, electricity or sanitation. The family has been living for the past 10 years under this unfortunate circumstance. The lady, having undergone rehabilitation by the government, has been living with her family on a single income in Alvai, Vadamaarachi, Northern Province of Sri Lanka.

Newly built house consists of two bedrooms, a large veranda, kitchen and bathroom. In addition, a water tank above the roof, fan and furniture were provided. The construction was completed within 8 weeks due to around the clock manpower provided by the army. The ceremonial handing over of the house took place on Wednesday, January 26th 2022 in the presence of Maj. General Sujeewa Senarath Yapa, the Security Forces Commander - Jaffna

and Mr. Rajendra Theagarajah, a fellow Royalist (Class of '72) and Past resident of Ceylon Chamber of Commerce, along with other government representatives. During the ceremony, dry ration packs, educational materials for children and essential household items for the house were donated by the Commander of the security forces of Jaffna.

Volunteer committee leader, Retired Major General Ravi Ratnasingham said "It was hope for the family of five living in poor conditions, to a spacious brick home. A lifestyle they wouldn't have even dreamt. It was made possible by RCOBA 1980 Tamil medium and Sri Lanka Army".

The second home will be handed over to a family in Point Pedro in February 2022. Construction of the third home has been initiated in the Eastern Province.


# CRADLE OF DEMOCRACY ESTABLISHED IN ANCIENT INDIA AS EARLY AS 920 AD

#### INTRODUCTION

In his speech at the Bhumi Pooja celebration for the New Parliament Building, in December 2020, India's Prime Minister, Narendra Modi, proud of his identity as of Hindu heritage, commented on the inscriptions on the walls of a temple in Uttaramerur near Kancheepuram in Tamil Nadu. These inscriptions that he commented on are on the northern walls of Sri Vaikuntavasava Perumal temple in Uttaramerur, a small village in Kancheepuram district about 90 km from Chennai. These ancient and classic inscriptions from the times of *Parantaka Chola* (920 AD). They describe in specific detail of the village administration was honed into a perfect system.

# THE GREAT SIGNFICANCE OF THOSE INSCRIPTIONS



Magna Carta, "The Charter of Freedom" granted in 1215 by the then King John of England is regarded world over as publicized by the westerners as the oldest and greatest constitutional document of all times, perhaps due to ignorance, deliberate or real. But a better treatise or formulation of freedom of individual or self- government was in effect in ancient India a good 450 odd years before the advent of Magna Carta and nearly 1000 years before the Constitution of the United States of America came into being in 1788. Yet the western world is preaching us that America is the mother of democracy in the world! So, let us here, just see the detailed description of the elaborate democracy that thrived in ancient India at a small village, Uttaramerur in Tamil Nadu.

# THE INSCRIPTIONS AND WHAT THEY SAY:



What the *Sutra* and *Smriti* literature prescribed were strictly followed and practiced. Prof. R. Nagaswamy, a renowned archaeologist, epigraphist and art expert of South India, has demonstrated the coherence between the



injunctions of *Dharmasastras* and ground realities in ancient India, and in Tamil Nadu in particular. He has used two inscriptions: the **manur** inscription *Pandya Varaguna* and the *Uttaramerur* inscription of *Parantaka Chola* to illustrate the same.

Uttaramerur, which has a 1,250year history, is situated in the district of Kancheepuram. It was established by the *Pallava King* Nandivarman II in approx. 750 AD. Subsequently, it was ruled by the Pallavas, the Cholas, the Pandyas, the Sambuvarayars, the



Vijayanagara Rayas and the Nayaks. It has three important temples, the **Sundara Varadaraja Perumal (Vaikuntanatha Perumal)** temple, the **Subramanya** temple and the **Kailasanatha** temple and all of these posses a great number of inscriptions, particularly dating to the reign of **Raja Chola** (985-1014 AD), his son **Rajendra Chola** and the **Vijayanagar emperor**, **Krishnadeva Raya**.

The entire village is constructed according to the canons of the **agama texts**, and accordingly, it has a village-assembly *mandapa* at its centre. The three temples of the village are oriented towards the *mandapa*. There are two 10<sup>th</sup> C.E. inscriptions in the Perumal temple which throw clear light on the system of village administration in ancient India.

The inscriptions dated around 920 AD, in the reign of *Parantaka Chola* (907-955 AD) is an outstanding document in the history of India. It is a veritable constitution of the village assembly that functioned over 1,000 years ago. The inscriptions give astonishing details about the constitution of wards, the qualification of candidates standing for election, the constitution committees with elected members, the functions of those committees, the power to remove the wrongdoer, etc. But it is on the walls of the village assembly (mandapa) itself that we have the earliest inscriptions with complete information about how the elected village assembly functioned.

The primary assembly of **Uttarmerur** was known as a *Sabha* in the case of *Agraharas* and *Ur* (voor) in the case of ordinary villages. It consisted of all the residents of that particular village. Its meeting was usually summoned by the beating of the drum and when the drum was beat, the entire village, including infants

had to be present at the **mandapa**; only the sick and those who were away on pilgrimage were exempt. The most important aim of the assembly was to elect the executive committee. Accordingly, there were *six* important executive committees:

1. Annual

Committee (Samvatsara vaariyam): It was the most important and influential of all the committees. It had 12 members, and the election of this committee preceded that of all the committees. And only those who had (previously) been on the Garden committee and on the Tank committee, could be chosen for the Annual committee.

- 2. **Garden Committee**: It had 12 members.
- 3. Tank Committee: It had six members. Their duty included the maintenance of tanks, irrigation, levying of tank taxes and utilizing the funds so collected for the same purpose. The committee also had to de-silt the village tanks once in three months and strengthen the tank bunds by widening and raising its height. The sluices and the overflow channels were to be maintained properly.
- 4. Gold Committee (*Pon Vaariyam*): Its primary work was to test gold by rubbing it against a touchstone. Usage of rough stones were strictly prohibited because that would lead to greater loss of gold by rubbing. The committee members were expected to recover the gold dust from the touchstone at the end of each day and deposit it with the village assembly. Once in three months, they were obliged to go before the village assembly and swear that they had not committed any fraud in the testing. It was well known that people were so proud of their oaths and sworn statements that they would sacrifice their life rather than break their own sworn statements.
- 5. **Pancha-vaara Committee:** It had six members, and it supervised the five committees (Pancha-vaara) of the village.
- 6. Committee for Supervision of Justice: It was formed to supervise the justice or fairness of the annual elections of the various committees. Thus, this committee convened the annual meeting of the assembly and conducted the elections of the various committees whenever they were necessitated.

According to Prf. R. Nagaswamy, the most astonishing details that the Uttaramerur inscriptions furnish is the process of Secretballot election (*Kuda Olai*) of the said committee members:

The village assembly of Uttaramerur drafted the constitution for the elections. The salient features were as follows:

The village was divided into 30 wards, one representative elected for each. Specific qualifications were prescribed for those who wanted to contest. The essential criteria were age limit, possession of immovable property and minimum educational qualification. Those who wanted to be elected should be above 35 years of age and below 70. Only those who owned land that attracted tax could contest elections. Another stipulation was that such owners should posses a house built on a legally

owned land (not on public poromboke). A person serving in any of the committees could not contest again for the next three terms, each term lasting a year. Elected members who accepted bribes, misappropriated other's property,



committed incest, or acted against the public interest suffered disqualification.

Accordingly, Uttarmerur, a village of 12 streets, was divided into 30 wards/electoral units for the purpose of elections. A meetingpoint was designated in each ward where the residents were to assemble when the drum called for elections. When thus assembled, each resident was to write down on a ticket the name of the person he wished to vote for. When this was done, all the tickets of a ward were filled into a packet. Thus, there would be 30 packets one for each of the 30 wards. Each packet bore the name of its ward on its *covering ticket*. All the 30 packets were then put into a pot (**kodam**) and placed before the **mahajana/sabha** i.e., the village assembly in the mandapa. One of the young boys (who did not know what was



inside the packet) was then called to pick out one of the packets. The tickets in this packet were then transferred to another (empty) pot and shaken, i.e., shuffled thoroughly. The boy then drew one ticket out of the pot and made it over to the arbitrator (**madhyastha**). While taking charge of the ticket thus given to him, the arbitrator received it on the palm of his hand with the five fingers open. He then read out the name on the ticket received. The ticket thus read by him was also read out by all the **purohitas** present in the inner hall. The name read out was then put down (and accepted). 30 names were thus chosen, one representing each of the 30 wards. Such a method gave no s cope for canvassing and other electioneering methods of doubtful utility and ethical values. The conditions of eligibility were a sufficient safeguard against the election of an undesirable person, and the necessary elimination they involved would leave no chance of producing any undesirable result.

The following qualifications were to be possessed by a member to be eligible for nomination by his ward and they are:

1. He must own more than a quarter of taxpaying land (*Kaani nilam*);

- 2. He must live in a house built on his own
- 3. His age must be below 70 and above 35;
- 4. He must know the *mantra-braahmana*, i.e., he must know (the **Veda**) by teaching;
- 5. If he owns one eighth of land, he must be proficient in *one Veda* and one of the four Bhaashyaas by explaining to others;
- 6. He must be conversant with business;
- 7. He must be virtuous and his earnings must be honest and
- 8. He must not have been on any of the committees for three previous years. The following were the factors that would affect an immediate disqualification of the candidate:
- 1. (a) Defaulting persons (those who have not submitted financial accounts) and their relatives, however remote, who are thus specified, namely, the sons of the younger and elder sisters of his mother; (b) the sons of his paternal aunt and maternal uncle; (c) the step brother of his mother; (c) the step brother of his father; (e) his step brother; (f) his father-in-law; (g) the step brother of his wife; (h) the husband of his step sister; (i) the sons of his step sister; (j) the son-in-law who has married his daughter; (k) his father and (l) his son.



- 2. Incorrigible sinners and their relatives however remote for killing a brahmin; drinking intoxicating liquor; theft; adultery with the wife of one's spiritual teacher and associating with anyone guilty of these crimes.
- 3. Outcasts until they perform the necessary expiatory ceremonies.
- 4. Those who are mentally or morally disqualified.
- 5. Those who have (i) taken forbidden dishes of any kind which is equivalent to drinking intoxicating liquor; (ii) become village priest; (iii) Committed incest; (iv) rode on an ass (which was a punishment for some offence and hence implied a conviction disqualifying the candidate); and (v) committed forgery.

The above, were inscribed on the 16<sup>th</sup> day of the fourteenth year of King Parantaka Chola.

Special qualifications were prescribed for the Judges and this is most evident in the Manur inscription: Judge to be elected should have at heart the village's welfare; he should be proficient in Dharmasaastra; he should not have served in any village administrative committee five years before their election and once his tenure of five years is completed, he cannot be a judge for another five years. Furthermore, they were to pass an examination in legal texts to qualify as judges; they must be of sterling character and must have studies at least one Veda. The judge should give accounts of the fines collected when he demits office. Judges were fined heavily (in gold) to be paid to the village assembly if they gave wrong rulings.

Another significant point to be noted is the power of the village assemblies to amend the constitution. The village assembly had first met in the 12th year of King Parantaka Chola (918 A.D.) and drafted a constitution and it was brief and vague in certain areas. So, two years later, a more refined constitution was drafted. It can clearly be seen that this later constitution is

detailed, clear and shows certain amendments to the first one. Therefore, there was freedom to frame constitutions for elections to village assemblies, and such constitutions were written documents, drafted clause by clause with meticulous care and when necessity arose, they could be amended to give fuller participation to all members and express themselves in the affairs of the administration.

Prof. R. Nagaswamy remarks that in its entirety, the Uttarmerur inscription show how in every aspect of life the highest standard of democracy was enforced in the village, in complete correspondence to the Dharmasastras. It shows how the Chola ideal of democratic participation extended to a larger section of society, exerting at the same time constant vigil and scrupulous enforcement of the law, without favours or prejudices. He calls it the *grass root democracy*. It is thus a perfect example of how the theory and practice of Dharmasastras are not divorced from one another.

He also says that he first came to know about these neither from not from the then history books nor from his teachers in school and college, but from a book of *Paramacharya of* **Kancheepuram** that contains his teachings. In fact, Late *Sri T.N. Seshan*, when he was appointed as the Election Commissioner in 1990, was a bit dejected when he was appointed as Chief Election Commissioner and went and met Paramacharya who was 97 at that time. A visibly disappointed Seshan came to meet Paramacharya who 97. Paramacharya immediately sensed the cause of Seshan's disappointment and counselled him to treat the transfer as an opportunity granted by God to serve the Indian public. He had suggested Seshan visit the Uttaramerur temple and read through the details of electoral regulations prevalent in India about well over 1,000 year ago, including qualifications of candidates that can contest elections.

In the words of Sri Seshan, "The credit for Electoral reforms must go to *Kanchi Mahaswami*, but for whom this would not have been possible. At 97, He had such clarity and described minute details of the electoral rules embossed on the northern walls of the Uttarmerur temple and mentioned to me that even implementing a tenth of those reforms, would be a great service to India". The rest is

In the words of columnist, TJS George, "Seshan showed what one man could do to ensure that democracy did not become a hydraheaded monster. In time, Seshan retired in 1996 and the monster was set free".

In conclusion, it was wonderful that India's Prime Minister had shared on national stage, about the inscriptions on the walls of the temple in Uttaramerur temple so that everyone across the country could get the opportunity to know the richness of India's culture. The Vishnu



temple in Uttarmerur is very unique since the same was built by *Viswakarma* and it is the first Ashtanga vimanam to be constructed. The Vimana in the Ashtalakshmi temple in **Besantnagar**, Chennai was designed and built copying this vimanam only.

Uttarmerur is certainly a place to visit to know and understand the richness of India!!!
