

# Debt restructuring and the implementation of a deep reform program are critical for Sri Lanka's economic stabilization says World Bank

Sri Lanka's economic crisis is deepening with unsustainable debt and a severe balance of payment crisis on top of lingering scars of the COVID-19 pandemic. Debt restructuring and the implementation of a deep reform program are critical for Sri Lanka's economic stabilization, says the World Bank in its twice-a-year update, underscoring the need for Sri Lanka to build resilience.

Plunged into its worst-ever economic crisis, Sri Lanka's real GDP is expected to fall by 9.2 percent this year and a further 4.2 percent in 2023.

Also released is an update, which highlights the poverty and welfare impacts of the crisis and the role of social protection in protecting the vulnerable

#### populations.

To this end, the spotlight highlights two key experiences of the Asian financial crisis as lessons for Sri Lanka. Firstly, the short-term measures needed to address structural weaknesses, buffers to mitigate external shocks and build resilience to future shocks. Secondly, critical policies to promote future growth. The country owes more than \$51bn (£39bn) to foreign lenders, including \$6.5bn to China, which has begun discussions about restructuring its loans. The International Monetary Fund (IMF) is discussing a possible \$3bn (£2.5bn) loan.

But it would require a stable government that could raise interest rates and taxes to help fund the deal, so any bailout may be delayed until the World Bank conditions are met.

# "We won": CUPE celebrates defeat of Doug Ford's anti-worker Bill 28

#### Nov 7, 2022

CUPE and Canada's labour movement are celebrating the defeat of Doug Ford's draconian anti-worker legislation Bill 28. The bill would have imposed a regressive contract and stripped 55,000 CUPE education workers in Ontario of fundamental Charter rights.

This morning, however, Ford committed to repeal the bill and head back to the bargaining table, after being faced with the prospect of escalating province-wide labour action in the coming days - representing a massive victory for organized labour and workers' rights.

In Toronto, flanked by dozens of labour leaders representing millions of Canadian workers, CUPE's National President Mark Hancock credited the victory to the power of worker solidarity across public and private sectors, but especially the courage and determination of education workers.

"CUPE's frontline education workers, 70 % of whom are women, stood firm. They took on the Ford government. And the government blinked," said Hancock. "We've shown that when our rights are under attack, our movement is strong - and we will stand up for each other.'

"The work of our members is what repealed this bill. This is unprecedent-

ed," said Laura Walton, president of the Ontario School Board Council of Unions (OSBCU), which represents 55,000 CUPE education workers in Ontario. "The organization of the members moved the government to this place, and the mobilization of our members will ensure that a real deal is achieved at the table."

This isn't the end, it's just the beginning. The work is not over, but it's clear that Canada's labour movement will back CUPE's education workers in Ontario until they achieve a fair collective agreement with the wage increases they deserve.

TORONTO — The Ontario government is providing over \$10 million to help Mitacs — an organization that builds research partnerships between postsecondary institutions and industry - create 2,700 paid internships for postsecondary students which will help them gain the skills they need to secure in-demand jobs after graduation. Through partnerships with Mitacs, the government is continuing to fund thousands of research internships for undergraduate and graduate students,



and postdoctoral fellows. These internships range widely in discipline, with support for key provincial priorities like critical minerals, manufacturing, and health care.

For example, interns with the University of Toronto recently worked on a project with local start-up Quantum Bridge Technologies that focused on building a faster, more secure internet for everyday communication and commerce.

Ontario's latest funding for Mitacs builds on the government's ongoing efforts to help advance Ontario made research and innovation at postsecondary institutions across the province and helps position businesses and students for success.

Despite arguments of overpopulation during the 1960s, time throughout history had shown here and again, that the Earth is equipped to

handle it. The pace of the world population growth has been declining since the 1970s, dropping below 1 percent for the



first time in 2020. Taking it back to the theme of this campaign, the number eight on its side indicates infinity, meaning there are infinite possibilities that emerge from this milestone for Earth.

# India's first solar-powered village promotes green energy, sustainability and self-reliance

During his two-day visit to India this week, UN Secretary-General António Guterres visited a model project site in Gujarat state, designated the country's first solar-powered village. He commended villagers there on the shift towards renewable energy, which he said is not only changing lives in the community, but also combating climate change.

Gadvi Kailashben, a 42-year-old widow, lives in Modhera, home to the centuries-old Sun Temple and now the first village in India that runs on solar energy.

She earns a meagre income from agriculture which she uses to take care of her family. The Government has installed solar panels on her house which has given her much-needed relief from household expenses.

"Earlier, when solar was not there, I had to pay huge amount for the electricity bill - close to 2,000 rupees. However, with the installation of the solar, my electricity bill is now zero. Everything from the refrigerator to washing machine now runs on solar in my house. I am not paying even 1 rupee electricity bill now," said Ms. Kailashben.

"The extra money is now saved in my account. I use that money for daily house expenses, and for the education of my children," she added.

Renewable energy as an income source

Conversion to a clean, renewable energy source is not only enabling the villagers to run more electrical household gadgets to make life comfortable, without worrying about the electricity bill. It is also becoming a source of income for them.

AshabenMahendrabhai, 38, lives with her husband and two children. "We work in our farm and used to pay huge electricity bill for agriculture. Since solar installation in our village, we are now saving a lot of electricity. Earlier our electricity bill used to come around 2,000 rupees. Now it is in minus," she said. Ashaben is not only saving the money that she used to spend on electricity, but the excess electricity generated is sold back to the grid and she gets money in return.

"When the first time the project team came to us with the idea of solar, we didn't understand the concept, so we refused to get it installed. We were not literate to understand what solar energy was and had little knowledge about it. But slowly, the team made us understand the concept and the advantages of solar, how we will save electricity and money, then we got interested in it," she said.

Local farmers PingalsinhKarsanbhaiGadhvi and SurajbenGadhvi, who are married, got solar rooftops installed on their house six months ago.

PingalsinhKarsanbhai feels that this project has not only given them freedom from electricity bills, but the savings will hold them in good stead in old age.

"Earlier we used to get electricity bill of 3,000 rupees and after solar it is zero now. Now we are saving those 3,000 rupees every month," he said.

"These solar panels have benefited the entire village. All the institutions like schools, public institutions, all have benefited from the solar in the village. In my individual capacity I am saving 3,000 rupees. Now we don't require extra energy. The entire house runs on solar."

He exclaimed that "this saving is like a pension for our old age. We are really happy about it."

His wife Surajben was all smiles and eager to recommend it for other villages.

"If this solar is installed across the country it would be really advantageous. It feels like the Sun God is providing us energy through its light. This benefit that our Modhera village has got, should reach the entire country," she said.

Interacting with the villagers of Modhera during his visit, UN Secretary-General AntónioGuterres hailed the efforts of the Government and the residents.



energy. And the fact that solar energy is transforming the lives of the people of this village, making it more healthy, giving them more prosperity, but at the same time, contributing to rescue our planet from climate change that is still riding without control."

Inspiration from the Sun God

Home to the iconic Sun Temple of Gujarat, Modhera village is approximately 97 km from the city of Ahmedabad in the Mehsana district of Gujarat.

With the vision of powering the Sun Temple and the entire village through Sun God (solar energy), this project is the first of its kind, where rural residents are envisaged to be self-reliant through green energy.

-"The idea behind this project is that since the Modhera temple is the Temple of the Sun God, so the entire energy of this town and community should come from solar energy," said MamtaVerma, Principal Secretary, Energy and Petrochemicals in the Government of Gujarat.

The Sun Temple now runs a 3D light show entirely on solar power, its premises run on solar energy and the parking area also boasts electric vehicle charging stations.

#### Renewable energy storage

Armed with a large array of solar panels on the rooftops of houses, on Government schools, bus stops, utility buildings, car parks and even the premises of the Sun Temple, Modhera benefits from the six-megawatt installed capacity power plant in nearby Sujjanpura village.

With the village consumption mere-

to this entire project. One is our ground mounted 6-megawatt project. The second is the 15-megawatt battery storage system and the third is the one-kilowatt rooftops installed on 1,300 houses," the Chief Project Officer of Gujarat

Power Corporation Limited (GPCL), Rajendra Mistry, explained.

"Out of the 1,000 rooftops we have provided in the village, the electricity that comes out is first consumed by the people of the village, and the excess electricity is then given to the grid."

Funded by the Government of India and the Government of Gujarat, the estimated cost of the entire project is \$9.7 million. What sets it apart is the fact that Modhera is also the first village to become a net renewable energy generator.

"This is the first village in India where even during the night, the energy consumed by the villagers comes from the solar component. That's the speciality of this project," said Vikalp Bhardwaj, Managing Director of Gujarat Power Corporation Limited.

Vision for the future

This demonstration project is expected to provide learning to resolve bottlenecks related to renewable energy. If the project proves to be economically viable, the plan is to replicate it in other rural areas in Gujarat.

Said Mr. Bhardwaj: "This kind of project acts as a demonstration project for other villages and towns in India. And similarly, the other villages and towns can adopt this model to become self-dependent, self-sufficient in the energy needs."

Modhera resident Ashaben Mahendrabhai summed up the benefits.

"I would encourage the other villages also to put solar as it is beneficial in all aspects, from saving money to

### **2022 NOBEL PRIZE FOR PHYSICS PROVING EINSTEIN IS WRONG**

### Trio Scientists Share Physics Nobel Prize for Pioneering Work in Quantum Mechanics




The 2022 Nobel prize for physics has been awarded to a trio scientists for pioneering experiments in quantum mechanics, the theory covering the micro-world of atoms and particles. Alain Aspect from Université Paris-Saclay in France, John Clauser from J.F. Clauser & Associates in the USA, and Anton Zeilinger from the University of Vienna, Austria, will share the prize sum of 1.25 million Canadian Dollars (10 million Swedish kronor) for "experiments with entangled photons, establishing the violation of Bell inequalities and pioneering quantum information science."

John Clauser built an apparatus that emitted two entangled photons simultaneously, each towards a filter that tested their polarization. The result was a clear violation of a Bell inequality and agreed with the predictions of quantum mechanics. Alain Aspect developed a setup to close a vital loophole. He could

switch the measurement settings after an entangled pair had left its source, so the scene that existed when they were emitted could not affect the result. Anton Zeilinger researched entangled quantum states. His research group has demonstrated a phenomenon called quantum teleportation, which makes it possible to move a quantum state from one particle to one at a distance.

The 2022 Nobel Prize laureates in physics have conducted groundbreaking experiments using entangled quantum states, where two particles behave like a single unit even when separated. The results have cleared the way for new field of a theoretical test to show that the hidden variables Einstein had in mind don't exist.

According to quantum mechanics, particles can be "entangled," spookily connected so that if you manipulate one, you automatically and immediately influence the other. If this spookiness – particles far apart mysteriously influencing each other instantaneously – were to be explained by the particles communicating with each other through hidden variables, it would require faster-than-light communication between the two, which Einstein's theories forbid.

#### **Quantum Mechanics**

The world of quantum mechanics appears very odd indeed. In school, we are taught that we can use equations in physics to predict exactly how things will behave in the future – where a ball will go if we roll it down a hill, for example. Quantum mechanics is different from this. Rather than predicting individual outcomes, it tells us the probability of finding subatomic particles in particular places. A particle can be in several areas simultaneously before "picking" one location randomly when we measure it.

Quantum entanglement is a challenging concept to understand, essentially linking the properties of particles no matter how far apart they are. Imagine a light bulb that emits two photons (light particles) that travel in opposite directions away from it. If these photons are entangled, they can share a property, such as their polarization, regardless of distance. Bell imagined experimenting on these two photons separately and comparing their results to prove they were entangled (truly and mysteriously linked).

#### Bell's Test

Clauser put Bell's theory into practice at a time when doing experiments on single photons was almost unthinkable. In 1972, just eight years after Bell's famous thought experiment, Clauser showed that light could be entangled. While Clauser's results were groundbreaking, there were a few alternatives, more exotic explanations for his results he obtained.


If the light didn't behave as the physicists thought, his results could be explained without entanglement. These explanations are known as loopholes in Bell's test, and the Aspect was the first to challenge this. Aspect devised an ingenious experiment to rule out one of Bell's test's most important potential loopholes. He showed that the entangled photons in the investigation aren't communicating with each other through hidden variables to decide the outcome of Bell's test. This means they are spookily linked. In science, we must test the concepts we believe to be correct. And few have played a more critical role in doing this than Aspect. Quantum mechanics has been tested repeatedly over the past century and survived unharmed.


Experimenting with Bell inequalities


Alain Aspect developed this experiment, using a new way of exciting the atoms to they emitted entangled photons at a higher rate. He could also switch between different setting so the system would not contain any advance information that could affect the results.




Anton Zeilinger later conducted more tests of Bell inequalities. He created entangled pairs of photons by shining a laser on a special crystal, and used random numbers to shift between measurement settings. One experiment used signals from distant galaxies to control the filters and ensure the signals could not affect each other.

first quantum computers. The Micius satellite uses entanglement to enable secure communications across the world. And quantum sensors are being used in medical imaging and detecting submarines. Ultimately, the 2022 Nobel panel has recognized the importance of the practical foundations producing, manipulating, and testing quantum entanglement and the revolution it is helping to drive.

These remarkable discoveries have helped us understand some of nature's most fascinating and inconsistent properties. The development of experimental tools have laid the foundation for



a new era of quantum technology. Being able to manipulate and manage quantum states and all their layers of properties gives us access to tools with incredible potential. Intense research and


#### **Albert Einstein**

Albert Einstein famously referred to the phenomenon of quantum entanglement as "spooky action at a distance." He was describing a counterintuitive property of specific pairs of tiny particles of matter or light which, when created under particular conditions in a laboratory, will react in tandem even if they are too far apart to affect each other. For example, suppose the polarization of a single photon in an entangled pair is changed. In that case, the other photon's polarization will change instantaneously — even though a significant distance may separate the two photons.


Albert Einstein was unsettled, and he was convinced it was wrong. Rather than outcomes being random, he thought there must be some "hidden variables" – forces or laws that we can't see – that predictably influence the results of our measurements. Some physicists, however, embraced the consequences of quantum mechanics. John Bell, a physicist from Northern Ireland, made a significant breakthrough in 1964, devising At this point, you may be forgiven for wondering why it matters how the microscopic world behaves or why photons can be entangled. This is where the vision of the Zeilinger shines. We once harnessed our knowledge of classical mechanics to build machines to make factories, leading to the industrial revolution. Understanding the behavior of electronics and semiconductors has driven the digital process. But understanding quantum mechanics allows us to exploit it to build devices capable of doing new things. Indeed, many believe it will drive quantum technology's next revolution.

Quantum entanglement can be harnessed into computing to process information in previously impossible ways. Detecting small changes in entanglement can allow sensors to see things with greater precision than ever before. Communicating with entangled light can also guarantee security, as measurements of quantum systems can reveal the spy's presence. Zeilinger's work paved the way for the quantum technological revolution by showing how it is possible to link a series of entangled systems together, to build the quantum equivalent of a network. In 2022, these applications of quantum mechanics are not science fiction. We have the

development are underway to utilize the unique properties of individual particle systems to construct quantum computers, improve measurements, build quantum networks and establish secure quantum encrypted communication.

# THE SIGNIFICANCE OF KANTHASASHTI FESTIVAL

**F**anthasashti an important festival of the Saivites is now being celebrated in all Murugan temples where the statue of Lord Murugan is installed in the main altar or in temples where the statue of Murugan is installed among the other statues away from the main altar. The annual celebration commences in the Prathama Tithi the day following Deepavali during the 'Sukla Paksha'(bright forthnight) and concludes in the 'Sakthi Tithi' of the sixth day of the waxing moon. Accordingly the sixday fasting commences on October 26th and concludes on October 30th.

To cut short an epic story once the three Asuras; Soorapadman Singhamu-

gasooran and Tharakasooran inflicted severe sufferings on the Devas. To destroy the Asuras Lord Murugan emerged as an incarnation out of a spark from the third eye of Lord Siva and received the Divine Vel (Spear) from Goddess Parvathi. Accompanied by Veerabahu Devar the emissary and other Devas at the sacred shrine of Thiruchendur to wage war with Soorapad-man and his demonic army.

During the first five days of the war all the Asuras of Soorapadman got perished. On the sixth day of the war Soorapadman severely beaten and sensing his end nearing went into hiding in a monstrous mango tree. Lord Murugan hurled His Divine Vale and split the tree into two halves. One half got transformed into a peacock which Lord Murugan used as His vahanam (vehicle) and the other half into a Seval (rooster) which became an emblem in Lord Murugan's flag. Hence Soorasamharam (the Divine War) is the victory of good over evil and restoration of Dharma. To celebrate the victory of Lord Murugan over Soorapadman the epic war is enacted annually on the sixth day (Sakthi Thiti) in Thiruchendur Murugan temple and in temples all over. In Thiruchendur a sea of heads could be



seen when devotees from all over the world congregate on the very beach the epic war took place.

In Srilanka Soorasamharam is enacted in all Murugan temples and in temples where Murugan statues have be installed along with the other deities. Devotees observe this festival in full faith, fasting



friends. The following day 'Thirukalyanam' the celestial wedding between Lord Murugan and Goddess Valli and Goddess Theivanai is enacted in temples. Many mistakenly belief that both the Goddesses are wives of Lord Murugan. They are both Murugan's consorts, Valli represents Ichcha Sakthi (the Power of Will) and Theivanai represents Kriya Sakthi (the Power of actions).

The destruction of the three Asuras symbolises the destruction of Mummalangal

the three impurities – Anavam (ego) Kanmam (binding action) and Maya (illusion) thereby purifying the souls and taking them into His fold. Soorapadman too though vanquished was granted a great boon to become the vehicle of Lord Murugan and the rooster the emblem in His flag. Devotees fast on all six days. Some of them stay in the temple and spend time in prayer meditation and listen to spiritual discourses mainly Kanthapuranam recital in verse form for which the meaning is instantly conveyed by a devotee who is well conversant in it. Devotees also recite other devotional texts, Kanthar Anuputhy Kanthar Alangaram Kanthasasti Kavasam etc. One who observes this important Kanthasasti festival with staunch faith strict discipline and complete surrender will be richly rewarded with a peaceful and successful life.

## Air Line Pilot's Stress & Their Mental Health

s I was walking in Downtown Toronto a Acouple of days back saw a few people with Shirts "Mental Health Is Wealth", while I was contemplating penning this article. In any workplace, there is always stress. The pilot's stress in aviation has been ranked as the 3rd in the industry. Being a commercial airline pilot is a great and glamorous job in the eyes of a common man. But we never realize the challenges & stress they undergo. There may be 350 million people suffering from depression according to World Health Organization. It is unfortunate a stigma is always attached to a person who seeks treatment for mental health. As a result, many people are cocooned and forced not to open up. A survey in 2016 by Harvard Public School revealed that a significant number of airline pilots report depression symptoms & suicidal thoughts. It further states, maybe 100's airline pilots currently flying may be depressed, as per an anonymous survey.

Wonder why this kind of survey after almost 117 years after the Wright Brothers. The action of German Wings, pilot Lubitz who crashed in December 2016 intentionally in the French Alps killing all 159 on board opened the pandora's box. The report states that many airline pilots are secretly managing depressive symptoms and flying. Pilots normally don't come forward & report these issues for the fear of losing their careers and may not be covered by their insurance. Assistant Professor of "Exposure Assessment Science", Dr. Joseph Allen, at Harvard, an authority on mental issues confirmed these findings by saying "always a veil of secrecy about mental health issues" in the cockpit of the aircraft. But many of them opened up without disclosing their actual names.



We know the problem exists, as there are lots of unknown unknowns. It is not unusual to find a whistleblower, Carl Eisen, a retired commercial airline pilot. He spoke about his panic attack soon after 9/11 in 2001 while waiting at a mall, after hearing about the attack on the Twin Towers. He experienced depression after this and has to hide this from his employer fearing that he would be losing his license. The FAA has strict rules about mental health that covers personality disorder, psychosis & bipolar disorder from flying. In an interview in 2016, he showed a copy of his first-class medical certificate. It clearly states that "pilots must be in peak physical and mental health" to obtain this clearance. One question stands out: answer "yes or No" to any mental disorder of any kind. New York-based Aviation Medical Examiner Dr. David Feldman confirmed this by saying, if you had a mental issue and were on medication, you would not get a medical certificate. It was off the books. According to Carl, he had to hide his symptoms for the fear of losing his job. After he retired, developed an online course to help pilots with depression, anxiety, etc., through Meditation to overcome this problem. Carl further said many airline pilots contacted him and benefitted from his method to overcome depression.

internal or external. For an airline pilot, both these stresses are there and had witnessed this in my life working with them. Researchers have identified 3 types of stress among pilots: Physical, Physiological, and Psychological. Physical stress: Unpleasant conditions in the cockpit, too much noise, cramped space, humidity, and lack of Oxygen. Unpleasant condition in the cockpit was exemplified in June 2022: an Air France flight, from Geneva to Paris where there was a physical altercation between the pilots on the flight, a dangerous situation even though the flight landed safely after the cabin crew intervened. Physiological: This can be fatigue, hunger, and various other health issues. Psychological stress includes death in the family, financial issues, infidelity, being overlooked for promotion, etc. We saw this issue in April 2022 on, a China Eastern Airlines flight, a senior captain was demoted and made to fly as a co-pilot for a guy, whom he trained. In our great land, we are aware of this issue as it is still going on with Canadian pilots. The crew of Pivot Airlines was arrested and held in the Dominican Republic over alleged smuggling charges according to the media. The best part of

the airline concerned is trying its best to resolve this through the Canadian government. Pilots have to go through so much stress and personally feel really sad. They have to stay focused, and alert over long hours, away from their families and have jet lag which has sleep deprivation. According to American Psychological Association, anxiety and high blood pressure, and stress are all interconnected and play a major role in a person's mental well-being. There is another stress on the shoulders of any pilot which is inherent. That is, the lives of all the passengers and the billion-dollar aircraft entrusted to them by the owners, and they are transported safely.

As we see there is a multitude of stress in the life of a pilot. The management and government agencies are aware of this but their inaction is deplorable and it's not good for the aviation industry. What is the way forward? The Government agencies that oversee this industry should not wash their hands off and say this kind of issue is isolated but must have the fortitude to address it. Federal Aviation Administration is considered the "Pope" in the aviation industry. FAA must enact laws to accommodate pilots with mental issues without demoralizing and treating them as outcasts. The agency should formulate a way to address this issue among the pilots than throwing it under the carpet. Any person with mental issues should be treated with the innermost sympathy, decency, and decorum rather than stigmatizing them. FAA should be more forthcoming and encourage pilots to come forward to address this issue in the face of it. They can prevent this by having medical experts evaluate pilots on their physical bi-annually by Psychologists and keeping this information confidential. Will the FAA and other aviation bodies make mental health mandatory? Can they request the respective governments to pass laws to this effect? Will the International Federation of Airlines Pilot Association and IPLA sign in to this? The last but not least, the Insurance agencies should be brought on board as there will be no joy without them on the same page. It is a long shot but has to be done.

Stress has been said as a biological response in our body to an adverse stimulus which can be

However, the format that film works with can only present so much compared to a book or novel offering a more condensed version on the complexities of these characters. 

Jaffna man is characteristically industrious and that trait is evident in all their actions. My grandfather who migrated from Malaysia bought a plot of land in Nallur to build a house and settle down. In his compound he planted a number of useful trees. Besides trees he also had a variety of crotons and flower plants in the front yard to beautify the place.



#### A. Trees with Medical Uses:

Neem tree is vital for health, and he planted a lot of them along the fences. Neem leaves keeps injurious insects away and the breeze coming through is supposed to be a balm for healthy living. 'Illuppai ' seeds are used to make oil which is a kind of medicine for arthritis pain.

#### **B. Trees with Delicious Fruits:**

Jujube Bot is a thorny tree with tiny

not forget to plant it near the backyard fence. Jamun or Naval Palam is a very tasty purple colored fruit grown in large trees and we had one of them. We used to shake the branches and make the fruits to fall down and we pick them up. We had a variety of mango plants in our compound. They were white columban, black columban, sempaddan, alari, ambalavi, villadu and several others. My grandpa also had the skill of blending one kind of mango branch (Odduthal) on another mango tree so that one may be able to get different types of mangoes from the same tree. Jak is another popular fruit tree grown in house compounds. It is sweet and tasty. There are also variety of kinds varying in taste. Jak vendors come to residential homes to buy them and then sell them at markets. Banana trees are grown in house compounds especially near the wells so that it will be easy to water them frequently. It has the characteristic of propagating itself as shoots come up from its roots and hence the familiar phrase- 'Vazhlaiaddy Vazhlayakka'. The ash plantain provides vegetable for making curries Pomegranate is another thorny tree which bears sweet, colourful fruits. Wood apple is got from a large tree, and it is also a popular fruit in Jaffna homes. The extract of the wood apple is now used to make jam and it is put in bottles and sold by the Marketing department. Orange is grown home compounds and orange juice is a popular drink in many Jaffna homes. It is also eaten raw and is very handy fruit for treating sick people who need nourishment for easy recovery. Lime is another widely grown tree. Lime has a variety of uses and it is mainly used to add taste to curries cooked daily. Gooseberry is a tree grown for its thirst quenching fruits which is very popular amongst youngsters. Papaw is an easily grown fruit tree and is grown in almost all homes. Its fruits have medicinal usage and that accounts for its popularity. Guava is fruit with particularly delicious taste and is said to contain lot of vitamin C. Now it is used for making Jam and is readily available departmental stores. Anna Munna is a green fruit with tiny seeds, quite tasty and popular in Jaffna homes. Breadfruit is

Coconut and Palmyra are popular palms grown in Jaffna homes. Coconut is mainly used to extract coconut milk very useful in making curries. The young coconut water is a popular thirst-quenching drink. One could find bunches of them available in roadsides to be sold for passers-by. It is obtained from a special variety of coconut palm called the Red-Kernal Palm grown in ordinary homes as well as in relatively large plantations. The Palmyra fruit is used to make a variety of food items. Its juice is the source of toddy, which is a popular alcoholic drink in Jaffna villages, also useful for patients recovering from diseases like measles and chickenpox. Its leaves are used for fencing and roofing in

### **NAVAGRAHAS AND THEIR WORSHIP**

#### INTRODUCTION

Navagrahas are the nine planets of Vedic Astrology. The Sanskrit word Nava means and the word Graha means, "to seize" or "to grasp". The planets are called grahas because they are the holders and dispensers of the karmic lessons of life and they are the evolutionary forces that teach us to grow and harmonize with the cosmic order. In the same way that the daily weather can affect our feelings and especially our ability to get things done (karma), on a cosmic scale, the Navagarahas affect the *cosmic* weather from which our local planetary and regional weather is derived. If a planet brings rain, our crops grow. If a planet brings heat and drought, the crop all perish. Each graha has a full compliment of energies, that match human characteristics. For example, Surya (the Sun) is considered a kroora graha, or harsh personality, because he is so hot and too bright that one cannot even look at him directly. At the same time, Soma (the Moon) is considered a saumya graha, or a cooling personality, because the moon brings delight and coolness to the mind and the earth. The Navagrahas are powerful spiritual influences. The Hindu Panchangam (almanac), lists daily times for key festivals and prescribes suggested worship, or the avoidance of certain influences, in order to make our lives easier and help us to keep focused on the spiritual path to a have powerful spiritual influences.

#### THE IMPORTANCE OF THESE PLANETS FOR HINDUS

Navagrahas are very important to Hindus. When a child is born the exact time is recorded. According to that time, the exact positions of the Navagarahas are calculated. These calculations help in preparing the birth chart of the child and is called the *Horoscope*. It is believed that each major event, happiness, illnesses, sorrows and even the time of death can be predicted by the astrologers using this birth chart. This birth chart is consulted at the time of cross points in life. The birth chart helps in choosing the right path. There are households that take to consulting the birth chart for every major decision or when a life-changing question arises. Marriage matches, career choices, proper times (muhurtham) for weddings, griha pravesas (house warming ceremonies) and more often are done only with the help of the birth chart. The birth chart may not always give positive readings. They may also point out impending disasters. This is often due to the malicious positions of the Navagrahas. At certain times, the rival planets may occupy incompatible positions in the birth chart. When such a problem arises, it is important to perform remedial rituals to appease the Navagrahas. The patron Gods of these planets must be worshipped according the directions prescribed by general information or by the astrologers. The pariharas (remedial rituals) that one does will bring great changes in one's life. While this is not compulsory, it is certainly good to do so and the results will only be better because of it. But if the deity that you worship has some rules and dietary restrictions to be followed, they must be followed. Not eating non-vegetarian food on that parihara day is a common rule that must be followed, Any pooja performed without looking at the deity may

cause negative effects. It is a common practice to close one's head or bow the head when pooja is done. This is often done due to respect. But for the pooja to create a positive effect in you, you must look at it while it is happening. The Navagrahas should not be treated with more importance than the other Gods. When in temple, you must always go to pay your respects to the Navagrahas *only* after you have worshipped the other Gods.

#### NAVAGRAHAS

Navagrahas or the nine planets in the solar system have a very vital significance according to the Hindu astronomy. The nine planets are believed to play a huge role in destining your future and success in life. that person's birth. Governing Rasi: Kataka Rasi; Zodiac Sign: Moon; Favourable Colour: White; Gemstone: Pearl; Overseeing Deity: Gowri or Parvathi.

#### 3. Mangala or Mars

Mangala or the Mars is a fierce deity and so is also known as *Angaraka*. Moon has four hands and of which two have weapons, usually, a Staff and a Spear and the other two in Abhaya and Varada positions. His vehicle is a Goat or Ram. He is believed to be the child of Prithvi or Bhumi who is the Goddess of Earth. He is of Tamas Guna and portrays Active action, sureness, and ego. He is the protector of Dharma and a hot planet. He rules the muscular system and controls the Nose, Forehead and Circulatory systems of the body. Governing Rasi: Mesha and Vrischika; Zodiac Sign: Mars; Favourable Colour: Red; Gem Stone: Coral; Overseeing Deity: Karthikeya or Murugan.

The Navagrahas are:

#### 1. Surya or the Sun

He is known as the Sun god and is also called as *Ravi*. In the solar system this planet is usually in the centre facing towards the east and other planets stand around him in eight different directions, but they do not face one another. He travels on a single-wheeled chariot pulled by seven white horses. These seven horses represent the colours of the white light and, also, represents the seven days of the week. This planet is believed to be the lord of planets and, also called as *Grahapati*. The Sun god is the main solar god and is one of the Adityas, the child of Kashyapa and one of his wife is Aditi. Governing Rasi: Simham; Zodiac Sign: Leo; Favourable Colour is Red: Gemstone: Ruby (Maanikkam) Overseeing Deity: Rudra or Siva

#### 4. Budha or Mercury

Budha is usually seen with four hands and rides a chariot drawn by a Lion or a Carpet or an Eagle. In three of his hands, one holds a Sword and the other a Shield and the third a Staff. The fourth hand is in the Varadha Mudra position showing a gesture. His vehicle is Lion. Budha is the child of Chandra or the Moon along with Tara and Taraka. The planet Mercury signifies one's intellect and communication skills. He is also the deity of goods and guard dealers. This planet protects the nervous system of the body. Governing Rasi(s): Mithuna and Kanya; Zodiac Sign: Mercury: Favourable Colour: Yellow: Gemstone: Emerald (Maragatham); Overseeing Deity: Vishnu

#### 5. Guru or Brihaspathi or Jupiter

Guru or Brihaspathi is also called as **Brahmanaspati** who is the teacher of deity and is praised by the Hymns in the Rigveda. He rides a chariot pulled by eight horses. The horses represent the eight branches of wisdom. His character is of Satva Guna and signifies knowl-

edge and instruction (teaching). He is usually known as **Guru**. The Jupiter god is defined as yellow or golden in colour and holds a stick, a lotus, and a set of beads. The planet represents love, spirituality, and knowledge. This planet has control over the thighs, flesh, kidneys, liver, and arterial system in the body. Governing Rasi(s): Dhanur and Meena; Zodiac Sign: Jupiter; Favourable Colour: Gold; Gemstone: Topaz (Pushparakam); Overseeing Deity: Brahma.

#### 6. Sukran or Venus

Sukran is the instructor of the demons and the writer of Sukraniti. He is usually seen with four hands, riding on a golden or a silver chariot pulled by eight horses. He is white in complexion. In three of his four hands, he holds a Staff, Beads, a gold utensil separately, while his fourth hand is in the Varada Mudra. Lord is the son of Brigu and Ushana, an authority over the Daityas, and the leader of the Asuras, recognized with the planet Venus along with the honorific Sukracharya. Sukra Dosha stays precisely for twenty years in an individual's horoscope and Venus is supposed to deliver more prosperity, fortune and a luxurious lifestyle, if it has a good position in the Kundalini of a person and horoscope. The planet signifies love and desire. Governing Rasi(s): Vrishabha and Tula; Zodiac Sign: Venus; Favourable Colour: White; Gemstone: Diamond; Overseeing Deity: Indrani.

#### 7. Sani or Saturn

Sani Graha is a stormy and bothersome deity who builds and destroys fortunes by his impact and location in the solar system for which he is consistently be frightened and specifically worshipped by all those who have faith in the Hindu astrology system. Sani is usually seen with four hands and rides on a chariot drawn by a Buffalo or a Vulture. In three of his four hands, he is seen carrying an arrow, a bow and a Javelin. His fourth hand is seized in Varadamudra position. Sani's Tattva or components are in the air and his direction in the west. He is Tamas in his character and illustrates knowledge in a difficult way, Career and Long Life. This deity is actually a demi-god and is the son of Surva god and his wife is Chhaya. It is believed that when Sani opened his eyes as a baby the sun went into eclipse which helps to clearly recognize the impact of Sani on the horoscope. Governing Rasi(s): Vrishabha and Tula; Zodiac Sign: Saturn; Favourable Colour: Blue; Gemstone: Bluestone; Overseeing Deity: Yama.

four hands and his fourth hand is in Varadamudra position. The God of the North Lunar is Rahu. Based on legends, at the time of Samudra Manthan (the churning of the ocean of milk), the asura Rahu consumed a little of the Nectar (heavenly liquid). But before the nectar could get down his throat, Mohini who is the female our body. The whole science behind a yagna or homam is the connection between microcosm and macrocosm. For example, Mars is connected to the liver and proteins. Like this, there are many connections between different herbs and different materials with cosmic vibrations. It is considered that Navagraha gods and goddesses



incarnation of Vishnu chopped off his head. The head, still, continued to be unforgettable and is recognized as Rahu. However, the rest of his body turned to be Ketu. It is considered that this memorable head rarely gulps the sun or the moon, producing eclipses. Then the sun or the moon gets out through the back of the head, thus putting an end to the eclipse. Governing Rasi: Meena; Favourable Colour: Smoke; Gemstone: Garnet (Gomethakam); Overseeing Deity: Mrutyu

#### 9. Ketu

In the sacred language of Sanskrit, Ketu or Dhuma Ketu holds the meaning of a comet. The texts describe that he has a body that is the tail of a snake, a portrayal which is very much similar to that of a comet. In some pictures, he is commonly seen with a poke patent body, and rides on a Vulture and holds a Mace in his hand. Ketu is the Lord of the Descending or the South Lunar code. Ketu is also a dark planet. Lord Ketu is the portrayal of karmic deeds both decent and evil, religiousness and mystic effects. Governing Rasi: Mesha; Favourable Colour: Multi colour (Chitra Varnam); Gemstone: Cat's eye (Vaidooryam); Overseeing Deity: Chitraguptan. impact human lives and is accountable for all ups and downs, or good or bad that happens in one's life.

#### NAVAGRAHA TEMPLES

There is a cluster of Navagraha temples in Tamil Nadu near Kumbakonam, built during the reign of the Chola dynasty. According to Hindu legends, Sage Kalava was suffering from serious ailments along with leprosy. He with utmost devotion prayed to the Navagrahas to cure him of his ailments. The Navagrahas pleased with his devotion cured him of all his ailments. However, Brahma was extremely unhappy with this as he felt that the Navagrahas did not have any authority to bless people. He cursed the Navagrahas to suffer ailments and sent them to the earth in *Vellukku Vanam*, the white wild flower jungle, the modern time Suryanar Koil. The nine planets were extremely sad by these series of events and decided to pray to Lord Siva to relieve them of their agony. Siva appeared before them and said that the place Vellukku Vanam belonged to them and they would have to grace the devotees worshipping them from the place. Each temple is located, in a different village, and is considered an abode of one the Navagarhas Navagrahas are usually found in most Hindu temples as secondary dieties. But there are certain temples which have been built for them only and are adorned as the main gods there. One such Navagraha temple is on the banks of the river Kshipra, which is famous tourist attraction of Saivites and is situated on the outskirts of Ujjain, in North India. Similarly, Surya and Sani also have temples which are exclusively built for them in some parts of India.

#### 8. Rahu

This planet is believed to be a Demon and not a God. His image is in the likeness of Budha or Mercury in some aspects, but both the deities vary primarily in their character and temperament. He is usually seen on a dark lion, in distinction to the white lion of Budha. Rahu is seated on a throne or rides a silver chariot drawn by eight horses. However, similar to other gods he holds the same weapons, a sword, a Javelin and a Shield in three of his

#### WORSHIPPING NAVAGRAHA

The Navagrahas should be worshipped just once when they are not worshipped on a Saturday. It is never permissible to go around Rahu and Ketu in an anti-clockwise direction. When you are worshipping Lord Sani, never stand directly in front of him. When going around the Navagrahas, you must never fold your hands in any way. In a nutshell, Navagraha Poojas are done when the grahas in your horoscope are in an unfavourable, negative or ineffective position, as well as when evil houses or zodiac signs are present. Don't think that the Navagrahas are just planets, they are specific vibrations in the cosmos and they relate to different parts of



# **Ontario Taking Bold Action to Build More Homes**

Next steps in province's plan will get 1.5 million homes built over the next 10 years



#### October 25, 2022 Municipal Affairs and Housing

TORONTO — Today, the Ontario government introduced the More Homes Built Faster Act, which takes bold action to advance the province's plan to address the housing crisis by building 1.5 million homes over the next 10 years. The proposals in the More Homes Built Faster Act would, if passed, ensure that cities, towns and rural communities grow with a mix of ownership and rental housing types that meet the needs of all Ontarians, from single family homes to townhomes and mid-rise apartments.

"For too many Ontarians, including young people, newcomers, and seniors, finding the right home is still too challenging. This is not just a big-city crisis: the housing supply shortage affects all Ontarians, including rural, urban and suburban, north and south, young and old." said Steve Clark, Minister of Municipal Affairs and Housing. "Our Housing Supply Action Plan is creating a strong foundation on which 1.5 million homes can be built over the next 10 years. Our government is following through on our commitment to Ontarians by cutting delays and red tape to get more homes built faster." The plan puts in place actions to support the development of "gentle density" - housing like triplexes or garden suites - that bridge the gap between single family homes and highrise apartments. For example, it would remove exclusionary zoning, which allows for only one single detached home per lot. Instead, it would allow property owners to build three units without lengthy approvals and development charges.

by reducing government fees and fixing developmental approval delays that slow down housing construction and increase costs. Actions in the plan include:

• Creating a new attainable housing program to drive the development of housing. Sites across all regions of Ontario will be considered, including those in the north, central, east and southwest regions.

• Increasing the Non-Resident Speculation Tax rate from 20 per cent to 25 per cent to deter non-resident investors from speculating on the province's housing market and help make home ownership more attainable for Ontario residents.

• Freezing and reducing government charges to spur new home construction and reduce the costs of housing.

• Building more density near transit, unlocking innovative approaches to design and construction, and removing red tape to get shovels in the ground faster.

November 1, 2022—Toronto—The Canadian economy has experienced one of the fastest recoveries from COVID-19 among advanced economies, but is now facing critical labour market shortages causing uncertainty for Canadian businesses and workers.

Today the Honourable Sean Fraser, Minister of Immigration, Refugees and Citizenship, released Canada's 2023–2025 Immigration Levels Plan. The plan embraces immigration as a strategy to help businesses find workers and to attract the skills required in key sectors—including health care, skilled trades, manufacturing and technology—to manage the social and economic challenges Canada will face in the decades ahead.

# Ontario Delivers Progress Report and Advances its Plan to Build

November 14, 2022 Finance

TORONTO — Today, Minister of Finance Peter Bethlenfalvy released the 2022 Ontario Economic Outlook and Fiscal Review – Ontario's Plan to Build: A Progress Update. It includes the government's first-ever progress report on its plan to build Ontario, as well as new targeted measures that advance its plan to build the economy, address the province's labour shortage and help families and businesses keep costs down.

The government is also providing an update on Ontario's economic and fiscal outlook, highlighting how its flexible and responsible plan is positioning the province to be ready to manage uncertainty and risk as the world faces high inflation and emerging economic challenges.

"Together, we have come so far," said Minister Bethlenfalvy. "From attracting investments and good jobs, to training thousands of skilled trades workers and helping keep costs down for families, we have made significant progress. As we navigate these uncertain economic times, our government is enhancing its plan through new targeted measures that support families, seniors and small businesses."

Highlights of targeted measures that advance the government's plan include:

• Launching a voluntary clean energy credit registry to boost competitiveness, attract jobs and provide businesses with more choice in how they pursue their environmental and sustainability goals, as enabled by proposed legislation.

• Providing Ontario's small busi-

nesses with \$185 million in income tax relief over the next three years, benefiting about 5,500 small businesses through the proposed extension of the phase-out of the small business tax rate.

• Automatically matching property tax reductions for small businesses within all municipalities that adopt the small business property subclass.

• Making changes that would allow a person with a disability on the Ontario Disability Support Program (ODSP) to keep more of the money they earn by increasing the monthly earnings exemption from \$200 to \$1,000 per month. This would allow

maximum financial penalties for repeat offenders of the NHCLA, with individuals now facing charges of \$100,000 and corporations of \$500,000, up from \$50,000 and \$250,000 respectively. Individuals found guilty may also face a sentence of up to two years in prison. This builds on the government's previous efforts to deter unethical builders and vendors, most recently in the More Homes for Everyone Act. The government doubled financial penalties for individuals and corporations who breach the HCRA's Code of Ethics by trying to rip off Ontarians to \$50,000 for an individual and introduced a new fine for corporations at \$100,000. This is the government's next step in holding builders and vendors of new homes to professional standards under the More Homes For Everyone plan.

• Attracted \$16 billion in transformative automotive investments in Ontario by global automakers and suppliers of electric vehicle batteries and battery materials over the last two years.

• Attracted \$2.5 billion in investments over the past year that will support transformation in the steel sector and help make the province a world-leading producer of low-carbon steel.

• Supporting an estimated \$8.7 billion in cost savings and support for Ontario businesses in 2022, with \$4.0 billion going to small businesses, through actions such as lowering payroll costs and providing electricity price relief.

• Unleashing the economic potential of critical minerals, including those in the Ring of Fire, with Ontario's first-ever Critical Minerals Strategy and a commitment of close to \$1 billion to support critical legacy infrastructure such as all-season roads to the Ring of Fire.

# Indian Foreign Minister Heads to Russia for Talks Expected to Include Ukraine Conflict

Indian foreign minister Subrahmanyam Jaishankar is visiting Moscow for talks expected to focus on economic and political issues.

The two-day visit during which the Indian minister will meet his Russian counterpart Sergey Lavrov and Deputy Prime Minister and Minister of Trade and Industry, Denis Manturov, will be the first by a senior Indian official to Russia since Moscow's invasion of Ukraine in February.

Analysts say while most attention has been focused on the softer stance India has taken on Russia's invasion and its continued purchase of cheap Russian oil and coal despite Western sanctions, New Delhi has also been using its leverage based on longstanding ties with Moscow to underline the need to end hostilities.

Ahead of the visit that starts Monday, Indian foreign ministry spokesman ArindamBagchi told reporters that India has always emphasized the need to return to diplomacy and dialogue to resolve the conflict. "I am sure that the external affairs minister would certainly be reiterating it," he said on Thursday.

The minister will be "looking at the economic elements" as well as exchange of views on "regional and international developments," Bagchi said.

India has not publicly called out Russia for the conflict and has ab-



stained from United Nations resolutions critical of Moscow's aggression, but it has repeatedly said that it opposes the conflict and expressed concern about the violence.

"We believe that the conflict does not serve the interests of anybody, neither the participants nor indeed of the international community," foreign minister Jaishankar said at a press conference during a visit to Australia last month.

In September, Indian Prime Minister NarendraModi told Russian President Vladimir Putin on the sidelines of a regional summit in Samarkand that "today's era is not an era of war, and I have spoken to you on the phone about this that democracy, diplomacy and dialogue are such things that touch the world."

Modi said that the world was grappling with major challenges, including food and energy crises that were

hitting developing countries especially hard.

"India would be reiterating the need for some kind of a resolution, some kind of a political settlement during the visit because it cannot be an open-ended conflict," said Harsh Pant, head of the strategic studies program at the Observer Research Foundation in New Delhi. "Because India does not want to call Russia out publicly, private conversations will certainly allow [for] that to happen."

The war on Ukraine has posed a huge challenge for India in trying to balance its decades-long relations with Russia and its growing ties with the West. It does not want to antagonize either side — Russia is a huge arms supplier, while concerns about an aggressive China have prompted India to enhance strategic ties with the United States and embrace the Quad — a grouping of Japan, Australia U.S., and

India.

But standing apart from its Quad partners, New Delhi has refused to support existing sanctions or impose their own on Moscow. It also has strongly defended its growing purchases of crude from Moscow at discounted prices — India has repeatedly said that it takes decisions based on its national interests and as a major oil and coal importer, its people need access to cheaper oil.

Russia became India's largest supplier of crude oil in October surpassing traditional suppliers, Saudi Arabia and Iraq, according to local reports.

However, as the war in Ukraine continues, the pressure on India to ensure that it does not alienate Western countries is growing.

"While New Delhi has been able to make its point to its Western partners for the moment, this window of opportunity will not be forever and there are worries that the longer the war drags out, the space for India in doing so will become narrower," Pant said.

But at the same time, New Delhi's good ties with Moscow also offer leverage, observers say. "There is a sense that India remains one of the few countries that enjoys some level of confidence of both sides, so there is a possibility that India can play a more proactive role than in the past in any potential efforts to resolve the conflict. All of these assumptions will be tested during this visit," he said.

### UN ramps up humanitarian appeal for life-saving assistance to 3.4 million Sri Lankans

Amidst Sri Lanka's worst economic crisis since independence, the UN on Tuesday revised its joint Humanitarian Needs and Priorities (HNP) Plan, appealing for more life-saving assistance to aid 3.4 million people.



importance of strengthening local food production and delivery, saying that "at this point, safeguarding livelihoods is safeguarding lives in Sri Lanka".

Appealing for aid

According to the World Bank's 2022 Development Update, between 2021 and 2022, the national poverty rate rose from 13.1 per cent to 25.6 per cent. The revised HNP complements existing emergency operations being carried out by the UN and partners. The appeal targets immediate food assistance for 2.4 million vulnerable and food-insecure people as well as support, including fertilizers, for 1.5 million farmers. The plan also seeks to provide nutrition support for 2.1 million people, including pregnant women and schoolchildren; safe drinking water for over 900,000 people; and essential medicines and healthcare, including sexual and reproductive healthcare, for 867,000 people. The assistance will enable protection services to continue for vulnerable women and children at risk of violence.

Since June, the UN team in Sri Lanka and NGOs have used the HNP to respond to the Government's request for more support to alleviate the impact of the country's debt and food crisis, and shortages of medicines.

Governments and donor agencies have helped the humanitarian community reach over one million of the country's most vulnerable with cash, food, school meals, medicine, protection, and livelihood support.

"We are immensely appreciative of the solidarity the international community has shown with the people of Sri Lanka, including through their generous contributions to the HNP", said UN Resident Coordinator in Sri Lanka, Hanaa Singer-Hamdy, adding that it must be sustained "if we are to insulate the most at-risk people from the impacts of the ongoing crisis". Plan to help

Aligned with appeals from other UN agencies, the HNP has raised \$79 million for Sri Lanka through various countries and organizations (click here for the full list).

The HNP revision, which extends the plan through 2022, requires \$70 million in additional funds to reach a total of \$149.7 million.

In response to the humanitarian community's updated estimates on the number of people in need across all 25 of Sri Lanka's districts, the extended appeal will improve nutrition for children, pregnant women, and breastfeeding mothers; secure safe drinking water; and protect vulnerable farming and fishing households.

'Safeguarding lives'

Meanwhile, two consecutive seasons of poor harvests, foreign exchange shortages, and reduced household purchasing power have triggered a dramatic increase in food insecurity.

# Marrying a Sri Lankan? Restrictions to be relaxed

03 Nov, 2022 | 10:39 AM Sri Lankan marriage laws in relation to marrying a foreigner are expected to be relaxed according to multiple news reports. Currently, Sri Lankan laws require a citizen of a foreign country to submit a health declaration form, passport page, criminal record check, and a certificate of civil status assuring the said individual is an unmarried person.

Obtaining this certificate is difficult according to some Sri Lankans at home and abroad especially countries where a civil status certificate is not issued by the relevant authorities. Amidst these prevailing requirements comes news reports that these regulations may be eased going forward. News report pertaining to this by ZulfickFarzan of Sri Lanka's premier independent television news network has indicated the laws are going to be relaxed.



The full report appearing on newsfirst.lkdated November 3, 2022 is as follows:

COLOMBO (News 1st) - Sri Lanka is planning on relaxing the restrictions on all marriages between Sri Lankans and foreigners.

P. S. P. Abeywardena, the country's Registrar General noted that Circular No:-18/2021 on registration of Marriages between Foreigners and Sri Lankans will be abolished.

According to this circular, a Health Declaration is necessary for the confirmation of the health conditions from the relevant foreign national.

In addition, a Security Clearance Report indicating the foreign national has not been convicted of any offence

is also necessary, as per the circular.

However, Prime Minister Dinesh Gunawardena had noted that these restrictions must be relaxed.

Accordingly, the Registrar General's Department had informed the Defence Ministry, and the Health Ministry to introduce alternative processes with regard to a Health Declaration, and Security Clearance Report.

Registrar General P. S. P. Abeywardena noted that the Attorney General's Department was also informed of these developments.

Any Sri Lankan citizen who wants to marry a foreigner will have to wait for a 'Security Clearance Report' from the Defence Ministry before proceeding to the registration of the marriage, according to a circular issued by the Registrar General's Department in 2021.

# South Korea Probes Halloween Crowd Surge as Nation Mourns

SEOUL, SOUTH KOREA — South Korean police investigated on Monday what caused a crowd surge that killed more than 150 people including 26 foreigners during Halloween festivities in Seoul in the country's worst disaster in years, as President Yoon Suk Yeol and tens of thousands of others paid respects to the dead at special mourning sites.

Saturday's disaster was concentrated in a sloped, narrow alley in Seoul's Itaewon neighborhood, a popular nightlife district, with witnesses and survivors recalling a "hell-like" chaos with people falling on each other like dominoes. They said the entire Itaewon area was jammed with slow-moving vehicles and partygoers clad in Halloween costumes, making it impossible for rescuers and ambulances to reach the crammed alleys in time.

Police said they've launched a 475-member task force to investigate the crush.

Officers have obtained videos taken by about 50 security cameras in the area and are also analyzing video clips posted on social media. They have interviewed more than 40 witnesses and survivors so far, senior police officer Nam Gu-Jun told reporters Monday.

Other police officers said they are trying to find exactly when and where the crowd surge started and how it developed. They said a team of police officers and government forensic experts searched the Itaewon area on Monday.

"The government will thoroughly investigate the cause of the incident and do its best to make necessary improvements of systems to prevent a similar accident from recurring," Prime Minister Han Duck-soo said at the start of a government meeting on the disaster.

The Itaewon area, famous for its cosmopolitan atmosphere, is the country's hottest spot for Halloween-themed events and parties, which have grown increasingly popular among young South Koreans in recent years. An estimated 100,000 people were gathered



there in the country's largest Halloween celebration since the pandemic began.

The dead included 26 foreign nationals.

One of the Americans killed was Anne Gieske, a University of Kentucky nursing student from northern Kentucky who was doing a studyabroad program in South Korea, the university said in a statement. The other was Steven Blesi, 20, his father, Steve Blesi, wrote on Twitter after earlier seeking information about his son.

Blesi appealed for information after not hearing from his son, asking, "If anyone has any news please share." After a flood of responses offering help and support, he tweeted, "We just got confirmation our son died," followed by "Thank you for the outpouring of love. We need time to grieve."

Australian victim Grace Rached, a Sydney film production assistant, was described by her family as "our life of the party." Her family said in a statement that "We are missing our gorgeous angel Grace, who lit up the room with her infectious smile."

The Japanese dead included Mei Tomikawa, who was studying Korean language in Seoul, according to Japanese media. Her father, AyumuTomikawa, told Japanese public broadcaster NHK that his daughter "really liked South Korea and was enjoying her life there."

Korean police said Monday they don't have any specific procedures for handling incidents such as crowd surges during an event that has no organizers.

Police said they dispatched 137 officers to maintain order during Halloween festivities on Saturday, much more than the 34-90 officers mobilized in 2017, 2018 and 2019 before the pandemic.

Citing those figures, police dismissed as "different from the truth" speculation that a police station in the area was understaffed because it was providing extra security for Yoon, who earlier moved the presidential office to a site near Itaewon. They said police-provided security for presidents has long been handled by two special police units that have nothing to do with the Yongsan police station, whose jurisdiction includes Itaewon.

Some witnesses said the stampede was caused by people in the upper part of the downhill alley pushing others in the lower area. Local media also questioned an apparent lack of safety preparations for the large crowd expected to gather in Itaewon.

Asked about those possibilities, Nam, the police officer, said the investigation would look into all possible causes of the crush.

As of Monday morning, the government said it had identified 153 of the 154 bodies and informed relatives of their identification. Nearly two-thirds of the dead — 98 — were women. It said 149 others remain injured. The death toll could rise because officials said 33 of the injured were in serious condition.

More than 80% of the dead were in their 20s or 30s, and 11 were teenagers, the Interior Ministry said.

Among foreign victims, five were from Iran, four from China, four from Russia, two from the United States, two from Japan, and one each from Australia, Norway, France, Austria, Vietnam, Thailand, Kazakhstan, Uzbekistan and Sri Lanka, according to the ministry.

As the identifications of the dead neared completion, bereaved families were expected to begin funerals for their loved ones. Officials said the government will provide necessary support for funeral procedures.

Yoon on Sunday declared a oneweek national mourning period and ordered flags at government buildings and public offices to fly at half-staff.

The government opened special memorial sites on Monday in Seoul and other major cities. Tens of thousands of people including Yoon and other top officials visited the sites, placed white flowers and bowed deeply. Many people also laid chrysanthemums, bottles of Korean "soju" liquor, candles and snacks near an Itaewon subway station and posted a host of condolence messages.

Following the disaster, many hotels, department stores, amusement parks and other businesses canceled Halloween-themed events.

The crowd surge was South Korea's deadliest disaster since 2014, when 304 people, mostly high school students, died in a ferry sinking.

The sinking exposed lax safety rules and regulatory failures. It was partially blamed on excessive and poorly fastened cargo and a crew ill-trained for emergency situations. Saturday's deaths will likely draw public scrutiny of what government officials have done to improve public safety standards since the ferry disaster.

## 305 Sri Lankans rescued from fishing boat in stable condition: Spokesperson

HÀ N I — More than 300 Sri Lankans rescued from a ship in distress off Vi t Nam are in stable condition and have been provided with temporary accommodation, Vietnamese Foreign Ministry spokesperson LêTh Thu H ng told a press conference on Wednesday. At 6pm on November 6, Myanmar-flagged fishing vessel LADY R3, which was attempting to carry 305 Sri Lankan citizens to Canada, got into difficulties and began drifting about 258 nautical miles southeast of VũngTàu Cape in Bà R a-VũngTàu Province.

The ship sent out a mayday call as the weather conditions worsened.

Upon receiving the distress signal, Region 3's maritime search and rescue coordination centre located the fishing vessel and broadcasted emergency signals to other ships.

Between 3:30 to 5:30 pm on Novem-

ber 7, the Japanese cargo ship HE-LIOS LEADER, en route from Japan to Singapore, approached the LADY R3 and rescued all onboard the fishing vessel.

All of the Sri Lankan citizens have been handed over to authorities in Bà R a-VũngTàu and the Consulate General of Sri Lanka in HCM City. They are now staying in Vũng Tàu City, in Đ tĐ and XuyênM c districts.

According to the spokesperson, after hearing about the incident, the Foreign Ministry informed the Sri Lanka Embassy in HàN i, and is closely coordinating with certain international organisations, relevant agencies and Bà R a-VũngTàu Province to deploy humanitarian aid in line with Vietnamese law and international practice.

She stressed that the ministry is working with relevant sides in the spirit of humanity, responsibility and international cooperation.

H ng noted that Vietnamese maritime forces have successfully rescued foreign vessels in distress in the waters under Vi t Nam's sovereignty, sovereign right and jurisdiction in the past. — VNS



# **Ontario Strengthening Holocaust Education to Counter Rising Antisemitism** Revisions to the Grade 6 Social Studies curriculum will help challenge biases and discrimination at an earlier age

TORONTO — As Ontario marks Holocaust Education Week, Stephen Lecce, Minister of Education, today unveiled a series of reforms to combat rising antisemitism across Ontario schools, including the introduction of mandatory Holocaust learning for the first time in elementary schools.

"We are taking action to counter antisemitism and hate, because those that fail to learn from history are doomed to repeat it," said Stephen Lecce, Minister of Education. "With antisemitism on the rise, we are introducing mandatory Holocaust education in elementary schools, expanding resources and strengthening anti-hate training for Ontario students, educators, and families." Antisemitic events are on the rise in schools across Ontario, with over 50 incidents involving antisemitic hate symbols occurring in the Toronto District School Board alone in the 2021-22 school year. According to the first study of antisemitism and Holocaust knowledge - conducted by Western University and Liberation75 in 2021 — 42 per cent of students surveyed said they have unequivocally witnessed an antisemitic event. This study also found that one in three students think the Holocaust was fabricated, exaggerated or are unsure if it actually happened.



The Ontario government is announc-

ing actions to counter this hate:

• Ontario will implement its first mandatory learning requirement in elementary school on Holocaust education in the Grade 6 curriculum to help younger students gain a deeper understanding of the significance of the Holocaust.

• The Ministry of Education will work with the Ontario College of Teachers (OCT) to develop professional learning, also known as an Additional Qualification, for teachers so they can further support efforts to educate students on the Holocaust. Currently, mandatory learning about the Holocaust and other acts of genocide are included in the Grade 10 Canadian History Since World War I course. The revised Grade 6 Social Studies curriculum, which is part of Ontario's continued modernization of the curriculum, will be implemented in September 2023.

Ontario is also investing in community partnerships to help students learn about historical and present-day discrimination and how to identify and address hate. These initiatives include:

• The launch of the Antisemitism Classroom Toolkit, designed by the Friends of Simon Wiesenthal Center for Holocaust Studies, to provide parents and educators content and learning strategies to combat antisemitism. • Introduction of Unlearn Antisemitism, developed by the Centre for Israel and Jewish Affairs (CIJA), a resource hub for educators and parents to learn about, identify, and take action to address antisemitism.

• Promotion of Antisemitism resources and guides to support parents and students from the United Jewish Appeal (UJA) Federation.

• \$140,000 to Liberation75 to provide Holocaust/antisemitism education resources for educators and supports for students.

# ---- Klepon cake -----

With Christmas around the corner, usually this is the time of year we try the recipes we want to present on our tables for our friends and family. We have an amazing klepon cake recipe from a Balinese cooking class. It's a glutinous rice dessert that is filled with natural sugar and rolled in grated coconut – though it isn't a typical Christmas dessert, we think it looks so festive it deserves a place on the table. Better yet, it only takes 20 minutes to make and even guicker to eat them all!

#### Ingredients:

- $\checkmark$  125g glutinous rice powder (fine)
- ✓ 125g rice flour (fine)
- ✓ 100g jaggery/palm sugar (grated/ powdered)
- $\checkmark$ ½ tsp salt
- $\checkmark 2$  drops pandan essence
- ✓ 175ml warm water

 $\checkmark$  ½ coconut, grated (if unavailable, use desiccated coconut)

#### Method:

To a mixing bowl, add both rice flours, salt, pandan essence and water until a soft dough is formed. Take a teaspoon-sized amount of dough, roll it into a ball and indent it with your finger. Slowly form a small cup shape, big enough to put half a teaspoon of jaggery/palm sugar. Once the jaggery/palm sugar is in place, close the dough up and roll into a ball, ensuring that there are no creases visible. Boil some water in a large enough pan for these klepon balls to cook in, and boil for 5 minutes. Once boiled, drain them well and roll in some grated coconut. If you are using fresh coconut, make sure you steam the coconut for around 5 minutes for better texture. This poem is credited to Kanian Poonkun-L dranar who has also authored the famous poem in Purananooru which was much more philosophical in the sense he proclaims world as his hamlet and humanity as his kin (யாதும் ஊரே யாவரும் கேளிர்). The quote "Yathum Oore Yaavarum Kelir' is at present depicted in the United Nations Organization. Late G. G. Ponnambalam concluded his 1966 address to the 21st session of the United Nations General Assembly by invoking this quote. Indeed, a noble way for the humanity to live by. The bard had lived around two thousand years ago. Though there is a certain difference in opinion as to whether the composers of both are the same or different, because in the days gone by, many a time the poet was known by the name of the village and the profession, thus it may be two persons from the same village and profession. Guess, we need not worry about the singer but let's look into the song itself.

Natrinai is a classical Tamil poetic work and the first of the eight anthologies known as 'Ettuthokai' in Sangam Literature. The Natrinai anthology contains 400 poems. And each poem has 9 to 12 lines, though few are 8 or 13 lines. They contain two categories of poems. One is called akam dealing with matters of love and personal emotions and puram about interaction with the world.

The verse #226 of Natrinai comes under the category of akam. The scene of the poem is set where the friend of the heroine tried to console her, regarding her lover who had travelled to earn wealth. Heroine replies her friend's kind words as a poem of lamentation of her plight.

The poem is authored more like a modern defence lawyer, our heroine spins out her arguments. In those days the fauna is the one that gave medications. As the famous adage, 'Don't kill the goose to get the egg', here too the heroine questions the logistics of harvesting medications to an extent of killing the plant.

Never person extracts medicines to the plant's peril,


She also laments that her lover is treading long and dry track in search of wealth for her to enjoy which saddens her more.


Here is an excerpt from Trustee Sriskandarajah on the recent municipal election campaign:

We at the Board have been able to accomplish many great things these last four years. We have helped navigate the Board through some tough times, including cuts to education and the Covid Pandemic.



## Lights, Camera, Action

How a new state-of-the-art interventional radiology suite is giving doctors at Markham Stouffville Hospital clearer images and getting patients home faster. BY GLYNIS RATCLIFFE

n January 4, 83-year-old William Baker, feeling enormous pressure in his abdomen, ran to the bathroom, where a startling amount of blood poured out of his body. His wife drove him directly to the emergency department at Oak Valley Health's Markham Stouffville Hospital (MSH).

Baker underwent numerous tests until a colonoscopy showed the bleeding had stopped. Seemingly stable, he was discharged home, but a few hours later, it started again, forcing Baker to return to the hospital. Within moments of being brought into the acute care zone of MSH's emergency department, he bled out and lost consciousness entirely. "I didn't know what happened until I woke up with my clothes gone, all wired up and attached to an IV and monitor," he explains. It turns out that Baker had what's known as colonic diverticular bleeding, a type of hemorrhage where the artery that supplies blood to the ascending colon ruptures, causing internal bleeding. While the bleeding often stops on its own, if the vessel does not clot by itself, it becomes an emergency requiring immediate medical attention. Repairs are often handled by interventional radiologists who work out of special operating rooms, such as the new state-of-the-art interventional radiology suite at MSH.

small instruments, such as wires and catheters, through the body to diagnose and treat medical issues. "I sometimes think we're like plumbers looking for a leak," explains Dr. Ramez Hanna, one of the interventional radiologists at MSH.

"We need to send a tiny camera in to look for the source of the leak, and then we can go back in and patch it up." The difference between

regular surgery and IR is how much less invasive it is. Rather than administering general anaesthetic and performing major surgery, the IR team uses mild sedation and local anaesthetic and creates a small incision, all of which are less traumatic for the patient and result in shorter hospital stays and faster recovery times. As imaging technology advances, hospitals like MSH are devoting more space and resources to IR. tions to locate the ruptured vessel. It was an intricate process that involved directing progressively smaller wires into the nearby vessels to find the damaged one, which took more than two hours but was ultimately successful.

#### REDESIGNING IR

While Baker's treatment involved many innovative IR-related technologies, if his issues had arisen just three months later he would have been sent to the hospital's new 2,465-square-foot IR suite, which opened in April 2022. The suite boasts next-generation technology in the form of the GE Allia IGS 7, a hulking but surprisingly nimble imaging system mounted on a transportation time, and the GE Allia allows for each healthcare worker to store personalized positional presets. "It's got a lot of really incredible features," says Dr. Hanna. "For instance, reducing the amount of radiation so you can actually use the machine for longer, more complicated procedures, whether you're trying to find a really difficult artery or get to a difficult spot to biopsy."

Although the government funds many aspects of the healthcare experience, equipment replacements, technology advancements and other upgrades are largely thanks to community donations. The construction of the new IR suite, for instance, was made possible by the generosity of MSH's donors, especially Betty Miller and Family, and the important work of the MSH Foundation.

With the new IR suite, the number of

Interventional radiology, also simply called IR, uses real-time imaging, whether it's through ultrasound, CT, MRI or X-ray fluorography, to help guide When Baker was brought into the IR suite, physicians performed an embolization, which involved putting a tiny wire coil into the ruptured blood vessel to stop the bleed. Michael Wilson, a medical radiation technologist and interventional radiology technical specialist at the hospital, and his team used ultrasound as a visual guide to insert a

catheter into the femoral artery, located near the hip.

From there, they used fluoroscopy – a kind of live X-ray – and contrast injec-

equipment is not tethered to the floor or ceiling; instead, its long arm reaches across the room and can be adjusted to any position around the surgical table, enhancing imaging precision by extending the angles at which images can be taken. "The difference between now and then is the

image quality," notes Wilson. "The new IR suite would have made it much easier for the doctors to be able to identify the vessels, potentially shortening the time the patient was on the table."

Preparation and recovery take place just steps from the procedure room rather than down the hall, which reduces patients that can be treated has jumped to 2,000 each year, from around 1,200. "This room is definitely a godsend. It's given us tremendous capabilities and it's getting used a lot," says Dr. Hanna.

While the new suite would have fixed Baker up more quickly – one of the first patients to use the suite was in and out in 40 minutes – it's ultimately the hospital's expert IR team who is the star of these stories. Baker knew right away that the procedure had worked – while he couldn't feel anything, he was awake enough to know that his doctors had found the culprit vessel and performed the embolization. After a few hours of recovery and a blood transfusion, he was released the following day. "Since then," he says, "my life has been completely back to normal."

## SHN's Paediatric Gastroenterologist gives little girl 'her life back'

Meet six-year-old Osenat Ahmadzoy. A vibrant, athletic and artistic little girl living in Stouffville. This month,



Osenat started Grade 2. Since starting back to school, she has been enjoying riding the bus, making new friends, and learning exciting lessons in class.

But that wasn't always the case.

After suffering for two years with an undiagnosed bowel issue, little Osenat was forced to withdraw from regular, everyday activities—not only affecting her physical health, but her mental health, too.

"I was so sad for her. She couldn't go play with her friends or family or participate in her favourite activities, like swimming," recalled the little girl's mother, Zarina Akhmadova.

"We tried to search for answers and solutions, and finally, we were referred to SHN's paediatric gastroenterology clinic for further investigation by our family doctor," she added.

It took more than dozens of hospital visits and 24 months of distress before the family met a Scarborough Health Network (SHN) paediatric gastroenterologist, Dr. Carol Durno, who would help to change the tide.

"This young girl was so vibrant. She came to the hospital in her best dress with a beautiful, bright smile. Despite her hardships,

she was positive; just an incredible little girl," recalled Dr. Durno. At the first visit Osenat was diagnosed with encopresis, sometimes called fecal incontinence or stool soiling. It is often related to long-term (chronic) constipation. Some children with fecal incontinence have been toilet trained at some point and others have not been completely toilet trained. It can present at any age.





## UTSC and Scarborough Health Network look at ways to strengthen ties in advance of fall conference

When medical students complete their residencies, they're not just getting real-world experience — they're helping keep doctors on their toes.

"Students ask great questions. They push us to know the evidence and remember things that perhaps we have long forgotten or took for granted," says Dr. Sacha Bhinder, interim corporate chief of medicine at Scarborough Health Network (SHN) and lecturer in University of Toronto's (U of T) Temerty Faculty of Medicine.

"When we see that across the entire spectrum of health disciplines, it improves the knowledge base of the staff, physicians and allied health colleagues."

Relationships between universities and health-care providers can strengthen medical research and training, and have a widespread positive impact on community health. It's why U of T Scarborough and SHN, a network of three hospitals and several health-care sites across the eastern GTA, are collaborating on projects to revitalize health-care in Scarborough.

Later this fall, SHN and U of T Scarborough will co-host Shaping the Future of Care (or SFC 2022) a conference bringing together academics, health-care professionals and community members in the eastern GTA. The two-day conference will cover information on the Scarborough Academy of Medicine and Integrated Health (SAMIH), ideas and innovations in health-care, and updates on work to establish Scarborough as a leader in health-care research and education.

SHN has roots with U of T. It's long been an affiliated teaching site for U of T's department of family and community medicine and hosts residencies for medical students. U of T Scarborough's Highland Hall was also the location of a COVID-19 assessment centre and several vaccine pop-up clinics operated by SHN. The institutions are continuing to strengthen ties as Scarborough's health-care system struggles to meet the region's needs.

"This collaboration is an important opportunity at a crucial time for Scarborough," says Irena Creed, vice-principal, research and innovation at U of T Scarborough. "Developing stronger ties between the university and the hospital will help us come together to



address some of the most pressing challenges facing the health-care system."

Recent news about shortages of healthcare professionals highlights the stress currently on the system, which SAMIH will help address. Supported by the SHN, the academy will graduate up to 30 physicians, physician assistants and nurse practitioners (each), 40 physical therapists and 300 life sciences undergraduates every year. Many of those students may choose to complete their residencies in SHN hospitals and healthcare sites. "SAMIH will allow those who live in Scarborough to learn in Scarborough, to receive their degree and training in Scarborough, to practice in and support the very community that they represent. This will organically build a foundation of expertise in medical education and practice across health disciplines," says Bhinder, who is a respirologist with SHN.

Bhinder says the collaboration will allow more students to interact with the diverse range of patients in Scarborough, adding that "it's a valuable collection of resources coming to a community that is hungry for those resources."

The deepening relationship is also part of a larger goal: to create a health district in Scarborough, similar to downtown Toronto's hospital district or Waterloo's tech district. Such an area relies on strong connections between institutions, such as universities, health-care providers and community groups.

The need for a health district was an emerging theme at a day-long U of T Scarborough event in March, which also saw advocates, researchers and health-care experts from the eastern GTA advocate for community-based solutions.

"A health district means institutions work closely together to understand and address the specific needs of the community, across teaching, research and innovations in healthcare," says Creed.

"Scarborough has always had a strong legacy of thought-leadership in healthcare," says David Graham, SHN's interim president and CEO. "That history is now getting recognized with an incredible conference that will mark this time of positive change and help propel us into a bright future as a hub for healthcare study and applied research."

The SFC 2022 conference takes place on November 25 and 26 at U of T Scarborough's Highland Hall. It will feature six topics including lessons from the pandemic, innovations in healthcare education, continuing medical education updates, integrated health, mental health and our community. 
"We tried several outpatient management strategies to manage Osenat's encopresis but they were not successful despite Osenat's best efforts and the support of her family. My recommendation was to admit her into the hospital for a different approach," she continued. "It had been long enough, the family had tried everything, and she wasn't getting any better."

For Dr. Durno, Osenat became more than a patient; she became an inspiration and a symbol of kindness and resilience. "This little one came up from the ward as an inpatient to our clinic in Galaxy-12.She had flowers and was working on a piece of art to thank the Galaxy-12 administration woman who books the patients appointments. Osenat was thrilled as she wasn't having accidents and had no abdominal pain," recalled Dr. Durno. When I walked into the room, she handed me the flowers and I was incredibly moved—since the pandemic, this kind of stuff doesn't really happen. This girl was just ecstatic, grateful and a bright light for our whole team," she added. Through the incredible work by Dr. Durno and Ava, SHN's paediatric Gastroenterology team was able to provide the family with a care plan and follow-up appointments for monitoring. Within a week, Osenat had returned to a normal life. She is now taking trips, her most recent to the United States to visit family. "I was in tears," recalled Osenat's mother. "It had been so difficult and scary. I didn't know where to access care, but every day I thank SHN and Dr. Durno for all their help-my daughter is back."

Dr. Durno admitted the little girl for two nights to run several tests and X-rays.

"After speaking with the radiologist on call, I was able to adjust her medication so she could be cleared out, essentially. By the second day, her abdomen had gone back to normal. Following this, I recommended that she continued to be seen at our gastroenterology clinic at Centenary Hospital. I have an amazing gastroenterology nurse, named Ava. And it's a real team approach when Ava and I see patients together."

SHN's Kids Care program brings together the top expertise, doctors, teams, and specialized services and clinics, acting as a corridor of care for Scarborough and surrounding regions. Its gastroenterology clinic in Galaxy-12 and pediatric endoscopy expertise not only provides consultation and endoscopy, it also provides follow-up care and treatment plans to children with gastrointestinal, liver, and nutritional problems.

## Helpful Tips to Remember as we Turn the Clock Back for Daylight Saving Time



#### **Environment** November 2, 2022

Daylight Saving Time officially ends this weekend on Sunday, November 6 at 2 a.m. Clocks will fall back, giving everyone an extra hour in their day.

While your cell phone and computers will automatically adjust to Daylight Saving Time ending, you might need to change your wrist/smartwatch, car clock and clocks around your home. Now is also the perfect time to remember to:

Check your smoke and carbon monoxide alarms: Test them to see if they are working by pushing the test button. Gently vacuum your alarms to remove dust particles. Smoke and carbon monoxide alarms can lose their efficacy over time, and expire after 10 years. If either alarm is expired, replace it by purchasing a new one at your local home and building store. They can be upgraded to newer models with longer battery life, so you don't have to worry about replacing the batteries for a few years.

Put on your winter tires: With the temperatures dropping, the best time to put on winter tires is when it starts to dip below 7 degrees Celsius. All-season tires can become stiff, which means longer braking distances. In comparison, winter tires are designed for cold climates. They also offer enhanced traction, giving a better grip on roads and reducing braking distances. Be alert on the roads: Morning and evening commutes are about to get darker. When visibility is reduced, other road users can be harder to see. Drivers should slow down, obey speed limits and approach all crosswalks, intersections and transit stops with extra caution. Always stay alert. Whether you're walking, cycling or driving, always be aware of your surroundings to prevent collisions. Drain water from outdoor pipes: Don't forget to drain your outdoor pipes to prevent them from freezing once the temperature falls below zero. If water is not drained from your pipes during the winter, it could freeze and cause your pipes to burst. Remember to keep the heat in your home on to help pipes stay warm.

Clean your dryer hose: Cleaning your lint filter, emptying or replacing your dryer hose, and regularly checking the vent and exhaust can help prevent fires. Now is a good time to look at your dryer hose to ensure no lint buildup.

Inspect your fireplace and chimney: Clogged chimneys can cause house fires and carbon monoxide poisoning. Have both your fireplace and chimney cleaned and inspected. Also, check to see that your chimney flue works so you don't experience drafts. Don't forget to ensure you have a working carbon monoxide alarm.

Protect your home from potential leaks and water damage: Ensure that eaves troughs, downspouts and basement window wells on your home are clear of leaves, debris, and any blockages, and that downspout extensions direct water at least 2 metres or 6 feet away from any building foundations. Window wells can be covered with clear plastic covers to keep debris out. When it rains, check around your home to confirm that there are no obstructions to the flow of water away from your foundation. Fix the grading if needed.

Remove debris from catchbasins: Clear debris from catchbasins to ensure that stormwater can flow freely. Residents can also report any build-up of natural debris, such as leaves, tree limbs or sediment, by calling 311 Get your car winter-ready: Before the snow and icy weather start, make sure your car is ready for winter. In addition to getting your winter tires put on, test your car battery, check your coolant, top up your fluids (e.g. oil, windshield washer and brake fluid), test out your wipers blades and clean your headlights. Finally, make sure you have an emergency preparedness kit. Add items like a flashlight, phone charger, air compressor, jumper cables, a small shovel, tow rope, first aid kit and winter accessories - gloves, hat, mitts, LED flares, multi-tool, snacks, water, ice scraper and snow brush.


