

TORONTO — Today, Premier Doug Ford issued the following statement to mark the start of the New Year:

"As we turn over the calendar to begin a new year, it's important to take a moment and reflect on just how far we've all come over the past twelve months.

I have been so proud to see the Team Ontario spirit on full display as the people of this province got back together and back to business. As Premier, I'm particularly proud of the progress our government has made implementing our plan to build Ontario.

Our government passed new legislation that will help achieve our goal of building 1.5 million homes over 10 years. This next step in our plan will ensure cities, towns and rural communities grow with the mix of housing types they need, so that more families can realize the dream of home ownership.

We've made real progress in building highways, transit and other key infrastructure. But about 258 million children and adolescents around the world do not have the opportunity to enter or complete school; 617 million children and adolescents cannot read and do basic math; less than 40% of girls in sub-Saharan Africa complete lower secondary school and some four million children and youth refugees are out of school.

Furthermore, without inclusive and equitable quality education and lifelong opportunities for all, countries will not succeed in achieving gender equality and breaking the cycle of poverty that is leaving millions of children, youth and adults behind.

In that sense, the international community recognized that education is essential for the success of all 17 of its goals in the 2030 Agenda for Sustain-

## **Spread the Word:** Local Pharmacies now a One-Stop-Shop for Thirteen Common Ailments

Highly trained pharmacists able to prescribe for common ailments with no cost for the visit

December 28, 2022 Health

TORONTO — Ontario is making it more convenient for people to connect to care closer to home by launching pharmacist prescribing for some of the most common medical ailments.

As of January 1, 2023, Ontarians will be able to stop in at pharmacies across the province to receive prescriptions for thirteen common ailments, including rashes, pink eye, insect bites and urinary tract infections with just their health card. This service makes it more convenient to access care by removing a doctor's office visit and will come at no extra cost to Ontarians.

"Stopping by your local pharmacy for quick and easy access to treatment for some of your most common ailments increases your access to the care you need closer to home," said Sylvia Jones, Deputy Premier and Minister of Health. "Expanding the ability of pharmacists to provide care is one more way we're putting people at the centre of our health care system, making it easier, faster and more convenient to access health care in their community."

Pharmacists will be able to offer prescriptions for:

- hay fever (allergic rhinitis);
- oral thrush (candidal stomatitis);

• pink eye (conjunctivitis; bacterial, allergic and viral);

• dermatitis (atopic, eczema, allergic and contact);

- menstrual cramps
- (dysmenorrhea);
- acid reflux (gastroesophageal reflux disease (GERD));
  - hemorrhoids;
  - cold sores (herpes labialis);
  - impetigo;
  - insect bites and hives;
- tick bites (post-exposure prophylaxis to prevent Lyme disease);
- sprains and strains (musculoskeletal); and
  - urinary tract infections (UTIs).



Allowing pharmacists to prescribe for these common ailments will make it more convenient for Ontarians to receive the care they need, while offering patients more convenient choices for how they access and receive health care. With a large, provincewide footprint, pharmacist prescribing will help to increase access to care in rural parts of Ontario.

In addition to providing more convenience, pharmacy prescribing will also help free-up doctors' bandwidth to provide care for more complex needs, helping to reduce wait times for these services.



2023 will be 'critical year' plan to turn around the economy says Sri Lanka President Wickremesinghe in New Year's message

Colombo, Jan 1 (PTI) Sri Lanka President Ranil Wickremesinghe on Sunday said 2023 will be a "critical year" for the cash-strapped country, as his regime desperately scrambles to inject much-needed impetus to galvanise the beleaguered economy.

Sri Lanka was hit by an unprecedented financial crisis in 2022 due to a severe paucity in foreign exchange reserves that also sparked political turmoil in the island nation that led to the ouster of the all-powerful Rajapaksa family.

"We are looking at the New Year 2023 after having undergone the bleakest of times, immense hardships, as well as the uncertainties and hopelessness of the last year," Wickremesinghe said in his New Year's message, as Sri Lanka turns 75 as an independent nation later this year.

"I understand the great burdens that are placed on all of us and the setbacks that a majority of us have suffered due to the country's abject economic collapse," he said.

From April to July, chaos reigned supreme on Sri Lanka, with mileslong queues forming at fuel stations and irate residents coming out in thousands blocking roads with empty cooking gas cylinders. tasked with stabilising the economy and restoring the financial health of the economy, already hit badly by the pandemic.

"We must boldly implement the proposed social, economic and political reforms to build a prosperous and productive Sri Lanka in the coming decade," Wickremesinghe explained.

While explaining the roadmap ahead, the President assured that the worst in the country's financial crisis may be over.

"Yet I believe that we have already gone through the worst of these times," he noted.

Wickremesinghe, 73, thanked the citizens for their patience and courage as the government took the critical steps to stabilise the economy.

In August last year, Wickremesinghe said Sri Lanka's economic woes would last for another year and it will have to think outside the box and look at new sectors such as logistics and nuclear energy to revive the bankrupt economy.

The President also lamented that Sri Lanka was trailing behind some of the other countries that attained independence from Great Britain around the same time.

"Looking back, it is obvious that we have not done as well as other ex-colonies. This is why the youth of our country are calling for a system change – especially at this juncture. This cannot be ignored," he added. Last year, Sri Lanka and the IMF agreed on a staff-level agreement to release USD 2.9 billion over 4 years. But the much-anticipated IMF bailout will have to wait as the country pursues talks with creditors to meet the global lender's condition for the facility.

## Indian Prime Minister Narendra Modi's 100 years old mother passes away

Prime Minister Narendra Modi's mother Heeraben Modi passed away at age one hundred and PM Modi posted a heartfelt message announcing the demise of his mother on his Twitter handle



Heeraben Modi had turned 100 on June 18. PM Modi had paid her a visit during her birthday at her residence in Gandhinagar, where she lived with the Prime Minister's younger brother, Pankaj Modi. She always set an example as the mother of the Prime minister, contributing in every small way she could to Indian society. Only recently, during the Gujarat elections, she was seen casting her vote at a polling station despite her frail age and health conditions- ensuring she exercised her franchise. said that their mother was just 15-16 years old when she got married. The family had financial constraints due to which she never got a chance to study, but she wanted all her children to be well-educated. He also said that they never had any money to pay school fees, but their mother never borrowed any money. He said that she would do some job to ensure that there was money for the children's education.

**Ferry service between KKS and South India** The service is expected to have a positive impact on Northern Tourism to generate foreign exchange

Sri Lankan companies have shown interest in launching a ferry service between South India (Puducherry) and Kankesanthurai (KKS) and is expected to commence in January/Feb-



The Sri Lankan government in May last year declared a debt default on over USD 51 billion in the foreign loan - a first in the country's history.

"Indeed, 2023 will be a critical year in which we plan to turn around the economy. 2023 is also the 75th year of independence from the British Empire," he noted.

National Day, also known as Independence Day is celebrated on February 4 to commemorate the country's political independence from British rule in 1948.

The resignations by President Gotabaya Rajapaksa in July and his elder brother Prime Minister Mahinda Rajapaksa in May 2022 amid massive anti-government protests subsided with the formation of a government led by their ally Wickremesinghe, who is now President Wickremesinghe recently said that India and Sri Lanka held "successful" talks on debt restructuring and the country will also begin discussions with China, as it tries to get assurances from major bilateral creditors to close the crucial deal with the IMF. Via PTI ruary this year.

Two more ferry services from Puducherry to Trincomalee and Puducherry-Colombo too are to be launched increasing the maritime connectivity between the two countries.

The local companies have also tied up with business their counterparts in South India to begin marketing activities for the first ferry service, according to an official of the Ministry of Ports, Shipping and Aviation said.

"There are many quality passenger boats that are used in India and the local operators are also looking at entering into a joint venture with them to lease these passenger ships to the Sri Lanka operation," he said. They plan to have daily ferry services and the new service will carry 300 to 400 passengers per trip that will take about 3 ½ hrs. The distance between the two destinations is 56 nautical miles. The one-way fare is expected to be around US \$60 per passenger and they will be permitted to carry 100 kg of luggage. Minister of Ports,

Shipping and Aviation, Nimal Siripala de Silva said that the Indian Government has extended consent for the service.

Colombo, Jan 2 (PTI) Public service in Sri Lanka is not an eight-hour job, President Ranil Wickremesinghe said on Monday, as he urged public servants to work overtime to make the cash-strapped island a prosperous nation this year.

Sri Lanka was hit by an unprecedented financial crisis last year due to a severe paucity of foreign exchange reserves that also sparked political turmoil in the island nation which led to the ouster of the all-powerful Rajapaksa family.

"Each person's duties (public servants) cannot be limited to 8 hours a day and 5 days a week. Let's all work with commitment. By the end of 2023, I hope to take this country forward with the support of all of you and restore normalcy," news portal newsfirst.lk reported, quoting Wickremesinghe as saying during an event held at the President's Office here on Monday. The President said no public servant can shirk responsibility as 2023 was a crucial year for the country's economy.

Incidentally, Sri Lanka turns 75 as an independent nation later this year.

National Day, also known as Independence Day, is celebrated on February 4 to commemorate the country's political independence from British rule in 1948.

From April to July, chaos reigned supreme in Sri Lanka, with miles-long queues forming at fuel stations and irate residents coming out in thousands blocking roads.

In May last year, the Sri Lankan government declared a debt default on over USD 51 billion in foreign loans – a first in the country's history.

The resignations by President Gotabaya Rajapaksa in July and his elder brother Prime Minister Mahinda Rajapaksa in May 2022 amid massive anti-government protests subsided with the formation of a government led by their ally Wickremesinghe.

Wickremesinghe, 73, is now tasked with stabilising the economy and


restoring the financial health of the economy, already hit badly by the pandemic.

"Five and a half months ago, we took over a historic task at this office. During those five and a half months, we took steps to establish normalcy in the country at a time when the government had collapsed and the economy had also collapsed. However, not all our economic problems are over yet. Nevertheless, today we have the ability to provide fuel, gas, foodstuff and fertilisers as required," Wickremesinghe said.

Last year, Sri Lanka and the IMF agreed on a staff-level agreement to release USD 2.9 billion over 4 years.

But the much-anticipated IMF bailout will have to wait as the country pursues talks with creditors to meet the global lender's condition for the facility.

Wickremesinghe recently said that India and Sri Lanka held "successful" talks on debt restructuring and the country will also begin discussions with China, as it tries to get assur-



ances from major bilateral creditors to close the crucial deal with the IMF.

"We have to move forward by implementing the debt-restructuring programme. Moreover, we have to build an economy that can compete with the new world. The opinion of the majority is that there is a need for a change in the political system of this country," he added.

### India Gears its Health System Up Amid COVID Surge in China

NEW DELHI -

India has stepped up surveillance and is preparing its health system for a possible surge in cases of COVID-19 following a spike in infections in China.

Experts, however, are optimistic that with a large part of its population vaccinated or exposed to the virus, India, which has reported the world's second-highest number of infections, may escape another deadly wave of the pandemic.

The health ministry has asked states to ensure that hospitals are prepared to handle a possible influx of cases and are equipped with adequate supplies of oxygen and ventilators. Officials say the country will also increase the genome sequencing that makes it possible to detect new strains of the virus.

India has not reimposed mask

Health Foundation of India. "More than 90% of the adults are vaccinated with two doses and more than 50% of adults have taken a booster dose. So even if cases rise, the likelihood of a severe wave resulting in hospitalization and deaths is very unlikely."

The government has made it mandatory for travelers arriving from China, Japan, South Korea, Hong Kong and Thailand to produce a negative test report and ordered random testing of 2% of passengers on international flights to India.

Other experts concur with that view.

"The government is being cautious and that is good. But I don't expect any major spread of the present virus driving infections in China or any other variant because a lot of people were infected during the three waves of the pandemic," according to virologist, T. Jacob John. "India will not have a major problem because of the immunity it has gained over the last three years."

However, as the country celebrates

mandates that were relaxed earlier this year but last week Prime Minister Narendra Modi urged people to return to COVID-appropriate behavior and don masks. Authorities are also calling on those who have not taken vaccines to get the shots.

India has been hit with three waves of the pandemic — the deadliest one occurred in the summer of 2021 when the country grappled with a massive shortage of hospital beds and oxygen and reported tens of thousands of deaths.

But the pandemic has waned in the world's second most populous country and in recent months, India has been reporting the lowest number of infections since it began. The country presently has about 3,500 cases. India dropped mask mandates earlier this year as the pandemic waned but experts are advising caution.

Concerns however have resurfaced following the surge in cases of COVID-19 in China since it relaxed its zero-COVID policy this month. Domestic media reports on Thursday quoted health ministry officials as saying that India may experience a spike in cases over the next month. They pointed to the trend of India being hit about 30-35 days after an outbreak in East Asia.

Still, public health experts are hopeful that India is no longer as vulnerable to the virus as it was at the start of the pandemic in 2020.

"India has a fair amount of immunity both from exposure of a large section of the population to the virus and high immunization rates," according to K. Srinath Reddy, head of the Public the holiday season, and people pack markets, restaurants, flights and tourist destinations, experts are reiterating the call to wear masks in public places and crowded areas.

"We need to be alert for a more deadly non-omicron variant emerging. While we may consider it a low probability, we will need to watch out. People should protect themselves against infection," according to Reddy.

India has reported about 44 million infections so far and about half a million deaths. Several experts however have said that those numbers may not be an accurate count of the devastation wrought by the pandemic in the country of 1.4 billion.

## Joint statement from foreign ministers on the Taliban's ban on Afghan women working for national and international NGOs

The following is a statement from the Foreign Ministers of Australia, Canada, Denmark, France, Germany, Italy, Japan, Norway, Switzerland, the Netherlands, the United Kingdom, and the United States and the High Representative of the European Union.

"The Foreign Ministers of Australia, Canada, Denmark, France, Germany, Italy, Japan, Norway, Switzerland, the Netherlands, the United Kingdom, and the United States and the High Representative of the European Union are gravely concerned that the Taliban's reckless and dangerous order barring female employees of national and international non-governmental organizations (NGOs) from the workplace puts at risk millions of Afghans who depend on humanitarian assistance for their survival. We call on the Taliban to urgently reverse this decision.

"Women are absolutely central to humanitarian and basic needs operations. Unless they participate in aid delivery in Afghanistan, NGOs will be unable to reach the country's most vulnerable people to provide food,

medicine, winterization, and other materials and services they need to live. This would also affect the humanitarian assistance provided by international organizations, as international organizations utilize NGOs to deliver such materials and services.

"The Taliban continue to demonstrate their contempt for the rights, freedoms, and welfare of the Afghan people, particularly women and girls, and their disinterest in normal relations with the international community.

"We support the Afghan people's calls for girls and women to return to work, school, and university, and for women to continue to play essential roles in humanitarian and basic needs assistance delivery, and we urge the Taliban to respect the political, economic, social, and cultural rights of women and girls in Afghanistan.

"To this end, we are in close contact with the United Nations, who are urging, also on behalf of all international donors, that the Taliban reverse this decision immediately. This would avoid any disruption and allow the continuation of all humanitarian operations of international and national NGOs."




I did my undergraduate studies in the science stream of kinesiology with a minor in medical sciences at Western University. I was always interested in medicine but wanted a career option with lateral mobility (in other words, the ability to switch specialities), shorter schooling and less costs endured financially. I came to hear about the PA profession when playing a varsity tennis match against a McMaster PA student, which then led me to apply for PA school.

I did my PA training at the University of Toronto and started at SHN's emergency department in January 2021. It was definitely intense to start working on the frontline during a pandemic but the team of PAs and supervising physicians were super supportive to help with the steep learning curve in the emergency medicine speciality.

In January 2022, I switched to orthopaedic surgery to help with maternity leave coverage. I have enjoyed working with the orthopaedic surgeons to manage patients on the surgical floor, as well as assisting in the OR. I still got to keep in touch with emergency medicine by seeing ortho consults and picking up ED shifts to help my PA colleagues with coverage. I will be returning back to the ED in the new year but will still be involved with ortho in some capacity to facilitate patient care between the two departments.

#### What excites or rewards you about being a PA?

I think what makes any job exciting and



PAs in Canada, I became passionate about joining this trailblazing community close to home. I think part of joining the PA profession in Canada comes with the responsibility to advocate for the role, whether it's in the work you do or actively taking on initiatives such as this.

My passion for advocacy started when I opened an Instagram account (@aurthi.pa) the summer before starting PA school, to share my journey as a UofT PA student, showcasing the training we go through and—fast forward over three years—what life as a practicing physician assistant is like now.

Throughout the past few years, I've done interviews to talk about the profession and my training, as well as talks for high school and university programs about the profession. I am only two years into practice and I definitely look up to some of my senior PA colleagues as role models, who've been practicing for five to eight-plus years at SHN—definitely something I thought worth highlighting this year for National Physician Assistant Day!

#### Describe a day in the life of a PA.

A day in the life of a PA will vary depending on the speciality:

• When I was in the ED, I typically worked 10hour shifts, with start times spanning from 8 a.m. to 6 p.m.; the shift work reflects the 24-hour coverage in the ED. We collaborate with the supervising physicians on shift, and a new doctor would come in every couple of hours throughout the day.

Our scope of practice mirrors that of our supervising physician, so we would do anything from seeing a patient and starting the visit with a history and physical; discussing the case with the doctors to order appropriate investigations and treatment options; calling specialists for consults or handover cases for admission; as well as assisting with procedures such as suturing a laceration, casting/ splinting a broken bone, performing incision and drainage for abscess, and more! The awesome thing about working alongside the doctors is that there's to pursue your interests.

For example, I am currently enrolled in the health equity certificate program, which involves a series of sessions conducted by experts in different fields, discussing the impact of social determinants of health and exploring innovative approaches to address health disparities. These sessions have been eye-opening in highlighting the barriers to accessing care in the community I serve and have sparked an interest to pursue further work in this field.

All the staff members from physicians, to nurses and allied health professionals are supportive and great to work with in both the ED, surgical floor, and operating room.

Specifically, the PA group shares a sense of community, where the senior PAs are like mentors; even some of your supervising physicians become friends as you continue to work and grow alongside them. This is important and it helped us deal with the burnout from working long and tiring days in the ED during the pandemic.

#### Is there anything important you would like the

#### community to know about your work?

Considering PAs are a growing profession in Canada, I think it's important to celebrate when a group of well-established PAs in a hospital network impact patient care. I hope showcasing them will help patients and other community members identify PAs as a vital aspect of their visit to the ED departments or the orthopaedic surgical services.

So, next time you visit an SHN hospital, make sure to keep an eye out for PAs. We're part of the SHN healthcare team and are excited to continue making a positive impact in your care!

• My day in the life as an orthopaedic surgery PA: the schedule is more consistent, 8 a.m. to 4 p.m., Monday to Friday; however, there are days I start early to assist in the operating room and stay late to help with consults. I usually start the day with pre-rounding and reviewing patient charts on our clinical information system, Epic, followed by attending bullet rounds with the team of allied health professionals.

I then see patients on the ward, manage them medically, consult other specialists as needed, attend family meetings, and then later on in the afternoon, I help with assessing and discharging same-day surgery patients, which include hip- and knee-replacement patients. I also assist in the fracture clinic as needed, and will also see consults in the ED when they come up, collaborating with the orthopaedic surgeon on-call.

## RETIRED TEACHER FINDS NEW LEASE ON LIFE WHILE LIVING WITH KIDNEY DISEASE

**66** m alive," 65-year-old teacher James Shortt (who goes by Jeff) told a crowd of nephrology healthcare professionals proudly.

After being diagnosed for polycystic kidney disease (PKD), he was treated through the regional nephrology program at Scarborough Health Network (SHN). The program serves more than 6,000 patients from across Scarborough and beyond every year, including Jeff from Thornhill, who is now enjoying his retirement—something he wasn't sure would be possible 20 years ago.

Jeff was recently invited to speak at the launch of SHN's Genetic Kidney Disease Clinic, which provides specialized services and interventions to treat patients whose kidney disease is caused by a hereditary condition. As someone who has seen first-hand the effects of autosomal dominant polycystic kidney disease, an inherited form of PKD, he was able to share his own lived experience and highlight the importance of SHN opening this new clinic.

It all started in his late forties. Jeff was going in for regular health check-ups when he was diagnosed with PKD, even though he didn't notice any symptoms at the time.

"Knowing my family history (my father lived with PKD), my doctor was looking for any abnormalities," he remembered.

"I was scared when I received the diagnosis. I lived through what this disease did to my father back in the 1970s and 1980s; the last four or five years of my father's life were not good. He slept about 16 hours a day because he didn't have the energy to do anything else, and his last six months were spent in hospital. At the end, he was allowed to come home for Christmas and died on January 1, two months shy of his 63rd birthday."

Admitting the diagnosis still scares him today, Jeff is encouraged by how far kidney disease treatments have come since his father's illness. For example, the understanding that some forms of kidney disease are often hereditary means screening for patients begins earlier, which means treatment can begin earlier, too.

For this reason, Jeff's nephrologist Dr. Janet Roscoe, truly a patient advocate, recommends regular check-ups for those who know they have a family history of the disease.

"We want to try to intervene early so we can help these people have a better life for themselves; help the kidneys last longer so patients aren't on dialysis in their formative years, or their early career and when bringing up their children," said Dr. Roscoe.

Since his diagnosis, Jeff has taken an active role in his healthcare journey, from trying to learn and understand his blood readings, to changing his lifestyle, which include dietary considerations such as caffeine and potassium intake.

Even still, Jeff has made some significant life decisions because of his understandable concerns of having the disease, including not marrying or having children.

"If we could intervene even earlier and make a person feel confident they would have a long life and not leave their kids at an early age, that is the whole goal in medical care," remarked Dr. Roscoe.

"We aim to treat and relieve a burden of symptoms and to help that patient have a joyful and fulfilling life." For 25 years, SHN's regional nephrology program has been shaping the future of care. As the largest in Ontario, the program continues to expand to better serve patients—most recently with the introduction of the Genetic Kidney Disease Clinic, made possible with the support of Otsuka Pharmaceuticals. As part of SHN's larger Multi-Care Kidney Clinic, genetic kidney disease patients may also receive counselling, further treatments to slow progression of their CKD, as well as testing or treatments needed to manage their conditions.

In addition, SHN aims to raise awareness about kidney disease, as well as promote research and advocate for patients and their families. Jeff is one of those patients and today, he is thriving.

"When I say that I'm alive it means I am enjoying retirement, I'm two months past my 65th birthday and I am teaching pottery, curling, and enjoying many other hobbies, like using my senior's discount," he laughed.

### FOUR HOSPITALS COMING TOGETHER TO HELP ADDRESS CRITICAL CARE NURSING SHORTAGES

Four GTA hospitals are combining recruitment efforts to create a special team of critical care nurses who can be deployed to help fill staffing gaps, and provide additional patient care capacity.

North York General Hospital, Michael Garron Hospital, Scarborough Health Network (SHN), and Sunnybrook Health Sciences Centre, received support from the Ministry of Health to launch the pilot project, which will recruit and orient nurses to work across the critical care units of the four partner hospitals. "Nursing vacancies continue to be one of our greatest challenges across the system and in critical care, in particular, where vacancies continue to be high," said Susan Woollard. VP. Clinical Services, Quality and Long-Term Care & Chief Nursing Executive, North York General Hospital. "Critical care is one of the safety-nets of our health system and we cannot afford to have this area short staffed. The specialized critical care team across our four hospitals will be one of many solutions we're implementing to ensure patients have access to life-saving care during this extraordinary time."

units are monitored daily and when a need arises, members of the team can be assigned to work at whichever hospital needs help.

"We are pleased to collaborate with our fellow partner hospitals who share a one-team vision and approach to caring for patients and their loved ones during their greatest time of need, said Kevin Edmonson, Director of Michael Garron Hospital's (MGH) Critical Care and Emergency Departments. "As we navigate increasing pressures and demands on Ontario's healthcare system, we recognize that it takes the collective efforts of all our inter-professional teams and health system partners to care for our communities and each other. We look forward to the opportunity to expand our exceptional critical care team together with our partners." When the nurses are not needed in other hospitals, they will work as a member of the critical care teams in their home institution, where they were recruited initially. This is a tremendous opportunity for nurses to get a wide range of experience working with other teams and hospitals,' said Ru Taggar, EVP and Chief Nursing and Health Professions Executive, Sunnybrook. 'An important part of the program is the hands-on mentoring and career coaching that will be provided for every member of the team. There is also an emphasis on wellness for the



Each hospital will recruit five nurses for the team, for a total of 20, who will receive training and orientation to the critical care units across the four organizations. Staffing levels on the



team that ensures there's not only a focus on skill development but also, the emotional well-being of each nurse is a key element of success.'

"Our patients are acutely ill. Proper staffing levels ensure we can provide a level of care for patient conditions that can change rapidly – in a matter of minutes, in most cases," said Sam Michael, a frontline nurse at SHN's Centenary ICU. "The complexity of the patient's condition also must be considered when determining appropriate staffing levels and how impactful it can be when even one team member is missing. The ICU depends on a full team environment for exceptional, life-saving care."

Recruitment for the team began in November and interested applicants should refer to the Human Resources department of the participating hospitals. The pilot will run for a period of two years and it is hoped this model could be replicated for other professions.

## AVIATION AND THE ROLE OF AIR TRAFFIC CONTROL SERVICES

A ir traffic control (ATC) is a Yeoman service facilitated by air traffic controllers who are mainly on ground. They direct the aircraft through a section of airspace which is controlled. The foremost function of an ATC is to prevent collisions, provide efficient flow of air traffic, provide information to the pilots to have a safe flight at all times. We never realize that millions of square kilometers of air space are monitored from a small glass Dome, Cab, or Circle box, by dedicated personnel and is called control towers,

In the good old days, there was no worry about aircraft collisions, or air misses but was to get from point A to B. The most memorable days in aviation evolved in this era. Pilots used landmarks, outline of the country, oceans, small islands, clear skies, stars and the sun as navigation aids. In the early 1920s when there was an increase in air travel mainly for mail services. Postal route planes used bonfires as navigational aids to do their services and were quite successful with their ingenuity. The mail service's success opened the doors for the first "Airways or Air routes" for modern aviation. The people helped the planes by waving flags of different colours to give instructions to pilots. The first rules of Air Traffic Control were formalized in 1926 by the "Air Commerce Act" legislation and thus ATC was born legally. Records Indicate late ARCHIE. W. LEAGUE is usually referred to as the first Air Traffic Controller. In1929,

Archie was employed by the airport operator at St. Louis to prevent collision between aircrafts on the ground. He used the "First and Foremost" tools of Navigation to perfect his

FAA honors his services with an annual "Archie Air Safety Award Some say, New Jersey's William Whitey Conrad was the First Air Traffic Controller. 1930 saw the birth of Rotating Beacon lights and Radios to aid communication with the pilots. 

League joined the Federal service in 1937. He eventually became FAA's Air Traffic Service director and retired as an Assistant Administrator in 1973. from a Control

tower, Area Control centers or from Radar control, 24 hours, 7 days throughout the year guiding all types of aircrafts from single engine to the largest planes. No aircraft can move from an airport without the permission of the ATC or even to start up the engines they must request permission from ATC and cannot fly from point A to B without filing an ATC flight plan. Air traffic controllers ensure aircraft maintain vertical, lateral separation while following strict protocols

First time I saw an ATC tower was in 1956/57 when our Jaffna Central College Primary School was taken on a trip to the Palaly airport by our late teacher Mrs Richards. I was privileged in 1972, third day after joining Air Ceylon flight operations and was taken to the Control tower at Katunayaka airport by our senior flight operations officer PHS. Ajantha to familiarise myself with Air Traffic Control Services since we had to file ATC clearance for the aircraft to proceed on flights. I cannot forget this day. Year 1949 saw the birth of ATC in Sri Lanka. Late S. Sarapanapawan was our first Air Traffic Controller and B.D.M. Karunaratna was the

A inkurunuru which literally means five hundred short ones. This anthology of poems belongs to the Sangam era which is 600 BC to200AD. There are eight anthologies collectively called Ettuthokai. This is the third of them. The Tamilian landscape was divided into five different terrains. The five hundred songs have been divided equally, hundred each for each terrain. In this study we will look into poem number 293 which falls into Kurinji landscape, which is the hilly terrain. This particular poem was composed by a Sangam poet Kapilar.

Kapilar was a great Tamil poet who has contributed about 206 poems in Sangam literature. Kapilar also authored Inna Narpathu, a didactic work of the Sangam literature, comprising of forty verses in Venpa meter (Quatrain). He was a contemporary of Karikala Cholan and King Paari a great philanthropist. Karikala Cholan is known for conquest on many countries, and during his reign, he unified the three kingdoms of Chola, Chera and Pandya kingdoms as one country.

In this episode the hero was tracking the foot prints of a deer, to hunt. He had come to the edge of an over grown lands of the hilly terrain and reached the farm land which is called the Marutha terrain. #### Let us look at the whole poem together:

Like the fragrance of glory-lily of mountain slopes With your beautiful palms you covered my eyes Coyly joined me on the mat, grand like a Peacock with bamboolike slender arms,

Further he is very famed in history for building of great anicut across Kaveri River.

Though a king of a small kingdom, the benevolence of King Vel Paari too is legendary. His fame as a kind monarch, earned him many powerful envious kings as enemies. He was so kind hearted, it is told that he had abended his chariot for a (Mullai) Jasmine vine to lean on.

In this poem Ainkurunooru # 293, the bard has composed the verse as if the hero expressing his thought. It is an accepted form of having a feigned quarrel between the lovers, which will make the union of lovers more pleasurable. The famed Thirukkural which is a book of ethics, too as its last couplet refers to such a feigned quarrel between lovers;

#### A 'feigned aversion' coy to pleasure gives a zest; The pleasure's crowned when breast is clasped to breast. 1330


With your gorgeous palms you covered my eyes நலம் பெறு கையின், என் கண் புதைத்தோயே,

The scent not only alerts our hero who it was who covered his eyes, but also reminds him how coyly she joined him on the bed the previous night hugging him with the long bamboolike smooth arms. 



Due to the power cuts during prime time telecasts, the number of commercials received by TV stations has decreased and in the current economy, they have to bear high costs to produce programs.

Journalists representing newspapers pointed out that due to the increase in production costs including the shortage of paper, there has been a major setback in the publishing industry including newspapers. They also pointed out that because of this situation, the

## SWEDISH SCIENTIST AWARDED NOBEL PRIZE IN MEDICINE

### The 2022 Nobel Prize in Physiology or Medicine for work on human evolution

The 2022 Nobel Prize in Physiology or Medicine was awarded to Svante Pääbo "for his discoveries concerning the genomes of extinct hominins and human evolution." Svante Pääbo pioneered the study of ancient DNA from archaeological samples




and extinct species, including hominins. His work changed how we understand human evolution and has implications for modern-day human physiology. The prize, arguably among the most prestigious in the scientific world, is awarded by the Nobel Assembly of Sweden's Karolinska Institute and is worth 10 million Swedish crowns (\$900,357).

His key achievements include sequencing an entire Neanderthal genome to reveal the link between extinct people and modern humans. He also brought to light the existence of a previously unknown human species, the Denisovans, from a 40,000-year-old fragment of a finger bone discovered in Siberia. Still, it typically takes many years for any given research to be honored, with the committees charged with picking the winners looking to determine its full value with some certainty amongst what is always a packed field of contenders. Svante Pääbo's most cited paper in the Web of Science was published in 1989, with 4,077 citations, said David Pendlebury, from UK-based scientific data analytics provider Clarivate. "Only some 2,000 papers out of 55 million published since 1970 have been cited dis many times." The following are some of the Key Highlights of Svante Paabo's Research.

#### Human Evolution:



and is common among present-day Tibetans. Other examples are Neanderthal genes that affect our immune response to different infections. Discovery of Denisova: In 2008, a 40,000-year-old fragment from a finger bone was discovered in the Denisova cave in the southern part of Siberia. The DNA Sequencing of this bone led to the discovery of a previously unknown hominin, which was given the name Denisova.

### Coexistence of Different Human Species:



The ancestors of modern humans, Neanderthals, and Denisovans co-existed for about 20,000 years, during which they not only interacted wif each other but also inter-bred. In modern humans of European or Asian descent, approximately 1-4% of the genome originates from the Neanderthals. Further, gene flow also occurred between Denisova and Homo sapiens. This relationship was first seen in populations in Melanesia and other parts of Southeast Asia, where individuals carry up to 6% Denisova DNA.

#### Novel Methodology:

It is difficult to amplify and sequence ancient DNA because it is highly fragmented and contaminated by microbes like fungi and bacteria. Over time, DNA tends to degrade and become chemically modified. Therefore, Pääbo decided to study mitochondrial DNA from Neanderthals. Mitochondria, popularly called the cell's powerhouse, is an organelle inside the cell with its DNA. Although the mitochondrial genome is small and only contains a fraction of genetic information in the cell, it is present in thousands of copies. This increases the chance of its successful sequencing.



#### Significance:

The conceptual breakthrough is of paramount importance in understanding human evolution. Dr. Pääbo's research has resulted in the rise of a new scientific disciple called Paleogenomics, which is the study and analysis of genes of ancient or extinct organisms.



day human species, lived in Europe and West Asia – as far as southern Siberia and the Middle East – before disappearing around 30,000 years ago.

#### Impossible Achievement

Homo sapiens are known to have first appeared in Africa around 300,000 years ago, while our closest known relatives, Neanderthals, developed outside Africa and populated Europe and Western Asia from about 400,000 to 30,000 years ago when they went extinct. That means that about 70,000 years ago, groups of Homo sapiens and Neanderthals coexisted in large parts of Eurasia for tens of thousands of years. To study the relationship between presentday humans and extinct Neanderthals, DNA needed to be sequenced from archaic specimens with only trace amounts of DNA left after thousands of years.


In 1990, Paabo managed to sequence a bit of mitochondrial DNA from a 40,000-year-old piece of bone. "For the first time, we had access to a sequence from an extinct relative," the Nobel jury said. Comparisons with contemporary humans and chimpanzees showed that Neanderthals were genetically distinct. Paabo then "accomplished the seemingly impossible," the Nobel committee said, publishing the first Neanderthal genome sequence in 2010. It showed that the most recent common ancestor of Neanderthals and Homo sapiens lived around 800,000 years ago.

Paabo and his team showed that DNA sequences from Neanderthals were more similar to those from contemporary humans originating from Europe or Asia than those from Africa. "This means that Neanderthals and Homo sapiens interbred during their millennia of coexistence," the Nobel jury said. In modern-day humans of European or Asian descent, around 1% to 4% of the genome originates from Neanderthals.

In 2008, Paabo and his team went on to sequence a 40,000-year-old bone fragment found in the Denisova cave in southern Siberia. It contained exceptionally well-preserved DNA. "The results caused a sensation: the DNA sequence was unique compared to all known sequences from Neanderthals and present-day humans." Paabo had discovered a previously unknown hominin, which was given the name Denisova. Comparisons showed that gene flow had also occurred between Denisova and Homo sapiens. When Homo sapiens migrated out of Africa, at least two extinct hominin populations inhabited



Svante Pääbo's discoveries have unlocked new understandings of genetic relationships between modern humans and our ancient relatives. Pääbo's groundbreaking research has led to many novel discoveries about our evolutionary history and what makes us "uniquely human." Notably, he and his colleagues successfully sequenced the entire Neanderthal genome.

These findings led Pääbo to help establish Paleogenomics, a novel field of science based on reconstructing and analyzing ancient DNA from extinct specimens. Pääbo's discoveries have provided good insights into how the gene flow from our ancient ancestors to modern-day humans influences physiological functions such as sleep cycles, immune responses to certain infections, and survival in highaltitude settings. 

## **DR. VAITHILINGAM MAHALINGAM** A LEADER IN SRI LANKAN LIBRARY SCIENCE EDUCATION

f you look at the history of library science education in Sri Lanka – then Ceylon – the late Dr. Vaithilingam Mahalingam would be clearly seen as a leader of it. He was born on July 8th of 1931 in the northern Malaysian city of Sungai Petani. He started his early education in the same city. His parents, Mr. and Mrs. Vaithilingam, were from Urumpirai, Sri Lanka. Upon returning to Sri Lanka, Mahalingam continued his intermediate and higher education at Urumpirai Hindu College. He then went to Calcutta. India to continue his university education. After graduating, Mahalingam returned to Sri Lanka and started teaching at Hartley College in Point Pedro.

His interest in library science led him to pursue higher education in this field. In 1957, he went to McGill University in Quebec, Canada to pursue a master's degree in library science. With his master's degree in hand, he returned to Sri Lanka and joined the Ceylon Institute for Scientific and Industrial Research (CISIR) as a librarian.

In the meantime, librarians who had worked in the fields of science and technologies in Sri Lanka united to revitalize library science education in Sri Lanka. The Free Education Bill brought by then-Minister of Education Dr. C.W.W. Kannangara in 1944 was one of the primary impulses which encouraged the Dr. Mahalingam to revitalize library science in Sri Lanka. The Free Education Bill made free education possible for all in the nation from the grade one to university level. It increased attendance in schools. Schools also worked hard to excel in education. Good education required good libraries and good libraries needed well qualified librarians. It was during this time when nine librarians worked together to form the Cevlon Library Association in August of 1960. Included in that list of librarians were: Margaret Gooneratna, Ishvari Corea, Vaithilingam Mahalingam, Manil Silva, S. C. Block, and W. B. Dorakumbura. When the library association was started there were 60 members. However, only nine were qualified librarians. S. C. Block, the librarian of Ceylon University of that time, was the first president of the Cevlon Library Association, while Mahalingam was the secretary. Mahalingam was also appointed to the newly created position of Library Education Officer. Therefore, Mahalingam became the first secretary and library education officer of the Ceylon Library Association. Sri Lankan library science education was forwarded on two fronts. The first was a diploma level education of library science in the country's universities. The second was

part-time education for those who worked at the libraries. A comprehensive examination for library science students was carried out in 1961 under Mahalingam's leadership.

In 1957 CISIR carried out a year-long training regime in library science for the librarians from several sectors. That training was sponsored by Queens University in Kingston, Ontario, Canada under the Canada-Colombo Plan. Donald A. Redmond, the primary librarian of Queens University, supervised that training. Once Redmond returned to Canada, Mahalingam and his team took over the training activities. From continued training, librarians from public schools, teachers' training college, technical colleges, private schools, and special libraries all reaped the benefits. The technical facilities which were in the hands of CISIR also helped Mahalingam to further enhance library science education.

In 1960, with the support of the Education Department, Mahalingam held a library science seminar. With financial support from Asia Foundation, Mahalingam printed and distributed the Dewey Decimal Classification booklet to all those librarians who participated in this seminar. The Dewey Decimal Classification method allowed new books to be added to a library in their appropriate location based on subject.

To have more librarians and library assistance for public sector, school, college, and technical school libraries, Mahalingam developed a curriculum for training. His curriculum contained beginner, intermediate, and advanced level training. Passing of GCE O/L was set to be the entry requirement for the beginner level training. The first beginner level training in English language took place in Colombo in 1961 by the Ceylon Library Association. In 1963, the same training was carried out in Kandy and Jaffna in English. At the end of 1965, the Library Association had already trained and certified 75 librarians. In 1972, the beginner level training in Tamil language was carried out in Jaffna. In 1965, Mahalingam was awarded a Fulbright scholarship and went to pursue his doctoral study in library science at Columbia University in New York. In 1968, after completing his doctoral studies, he then settled in Canada. The same year, in June, he became the Bracken Health Sciences library at Queen's University in Kingston, Ontario as the Head Librarian. There he headed the Cataloguing Division and the Document Unit.



Later he also worked as the librarian for a year in the Law department. Soon all of the branches of Science Department libraries came under his management. Well loved and respected, Mahalingam was called "Maha" by his colleagues and his students. In 1972, Mahalingam was elected to be the Chairman of the Professional Librarians Association of Queens. After serving Queens University for 18 years, Mahalingam retired in 1986.

I had the chance to meet Mahalingam in person in the summer of 1984. He was the first Tamil person I met in Canada. He was a very simple person. He invited me with full enthusiasm and excitement. When I said I studied library science in the Tamil language in 1978, in Jaffna, he was very happy. Unfortunately, I lost contact with him after that.

After his retirement, he moved to India and immersed himself in spirituality. His faith in Sathya Sai Baba made him the librarian at Sri Sathya Sai Higher Education center. He served there for 20 years.

Though he returned to Canada in 2006, he continued to serve at the library of Sri Sathya Sai Baba center in Scarborough, Ontario in summer and then at Sri Sathya Sai Publication unit and Sri Sathya Sai University back in India during the winter. Once Covid-19 hit the world, he stopped traveling to India, but continued to support the India team over the phone, even at the age of 90. Mahalingam passed away on January 27th of 2022 after accomplishing a remarkable service to Sri Lanka, Canada, and India. Even though his stint was short in Sri Lanka, his footprint in Sri Lanka's library science field is strong. Those who study library science in Sri Lanka or study the history of Sri Lankan library science cannot avoid spelling his name. Moreover, Queens University and Sri Sathya Sai University will also continue to regard his service to the growth of the field of library science.

## When Snow Knocks on Your Door - Keep Your Driveway and Sidewalks Clear

City services | December 22, 2022 Winter may officially be only three months long, but snowfall and cold temperatures can last much longer. Here are some things to keep in mind when clearing snow from your property:

#### Shovel early and often

Shovel early and often to keep walkways clear and limit heavy snow build up. Shovelling periodically during a storm can make heavy snow or significant accumulation easier to clear. Prevent an icy stoop by shovelling snow off it right after a storm, before the snow has a chance to melt and turn into ice. Remember to clear sidewalks that are connected to pathways close to your residence.

#### Watch the temperature

Clear snow from your property before temperatures drop significantly to avoid shovelling icy build-up. Be mindful of wet surfaces where snow has melted in milder weather that may re-freeze when temperatures drop overnight.

#### Take a break

Shovelling can be an exerting task remember not to overexert yourself. Take breaks, stay hydrated, make sure



to dress appropriately and stay warm. Avoid an icy driveway

After the snow is removed from your walkway, sidewalk and driveway, be sure to check if de-icing is necessary. Use salt wisely to minimize the impact of salt on the environment by following manufacturer instructions to apply the right amount, under the right conditions.

Park vehicles in your driveway

After clearing snow from your driveway, avoid keeping your vehicle parked on the street so City plows can clear roads safely and more efficiently.

#### Windrows

A windrow is the pile of snow left at the bottom of a driveway after a plow clears the road. Remember, it's the homeowner's responsibility to clear the windrows and remove the snow from their own driveways. Those who applied for the City's Windrow Program will have a three-metre space in the windrows cleared by the City, which can take up to 36 hours after the end of a snowstorm.

### Check your driveway for cracks

Freezing temperatures can cause pavement to chip as water gets inside and freezes. Fill cracks and/or holes. Also seal hard surfaces to prevent water from getting into them. Resolve any drainage issues on your property to prevent ice from forming.

Be a good neighbour

Help keep your community safe by clearing your sidewalk of snow and ice as soon as possible after a snowfall ends. You can also offer to help your neighbours, especially older adults and people with disabilities, by offering to shovel their walkway, sidewalk and driveway.

### **Opting for a Greener Future:** Investing in Low-carbon and Resilient Solutions in Mississauga

Environment | December 15, 2022 Climate change is affecting Mississauga. In 2019, the City declared a climate emergency because climate change is taking a toll on people, health, infrastructure, services, and ecosystems. Mississauga's 10-year Climate Change Action Plan was endorsed by Council in 2019. The plan sets out to decrease the City's carbon footprint and prepare for the effects of a changing climate. It includes 89 actions, of which more than 70 percent have been completed or are currently underway.

Coming out of COP15 in Montreal, the City of Mississauga has joined more than 40 other municipalities around the globe in pledging their commitment to protecting biodiversity. The City is taking a comprehensive, holistic approach to protecting biodiversity and to supporting the health of our natural systems as is outlined in our Parks and Forestry Master Plan, Climate Change Action Plan, and Official Plan – which aligns with the 15 tangible actions outlined in the Montreal Pledge.

"The impacts of climate change can be felt in Mississauga, and we've already seen warmer temperatures, extreme storm events, and increased flooding right in our own backyard. There's an urgency for continued action to address these impacts and prevent them from growing worse," said Mayor Bonnie Crombie. "At City Hall, we're taking action, including signing onto the Montreal Pledge to protect our biodiversity and strengthen resilience to future climate shifts to protect our health and economy. We will continue to work with businesses, other levels of government and our residents to help safeguard our future and achieve our vision of a low-carbon and resilient community.'

As of December 2022, the City has:

• Installed 59 electric vehicle (EV) chargers for the City's fleet and 22 public EV chargers

Added 38 kilometres of cycling infrastructure

## MADURAI SRI MEENAKSHI TEMPLE

### INTRODUCTION

The iconic Meenakshi Temple is located, in the **L** ancient city of Madurai in the south Indian state of Tamil Nadu. Located in the heart of the 2,500 years old city. Meenakshi Temple was originally built by Kulasekara Pandya in the 6th century BC, but the credit for the present look of the temple goes to the Nayakas, who ruled Madurai from 16th to 18th century. The reign of the Nayaks marks the golden period of Madurai when art, architecture and learning flourished expansively. The riot of colors, however, is a more recent addition. Meenakshi Temple is dedicated to goddess Meenakshi, an avatar of the Hindu goddess Parvati, the consort of Lord Shiva. It has long been the focus of both Indian and international tourist attraction, as well as one of the most important places of Hindu pilgrimage. For the people of Madurai, the temple is the very center of their cultural and religious life. The west tower (gopuram) of the temple is the model based on which the Tamil Nadu State Emblem is designed.

### **HISTORY OF THE TEMPLE**

Madurai Meenakshi Sundareswarar temple was built by Pandayan Emperor Sadayavarman Kulasekaran I (1190 - 1205 CE). He built the main Portions of the three storied Gopuram at the entrance of Sundareswarar Shrine and the central portion of the Goddess Meenakshi Shrine are some of the earliest surviving parts of the temple. There are also shrines each for Natarajar and Surya near the main temple, Ayyanar in the east, Vinayagar in the south, Kariamalperumal in the west and Kali in the north. He also built a Mahamandapam. Kulasekara Pandya was also a poet and he composed a poem on Meenakshi named Ambikai Malai. Maravarman Sundara Pandyan I built a gopura in 1231, then called Avanivendaraman, who later rebuilt, expanded and named it as Sundara Pandya Thirugopuram. Chitra gopuram (W), also known as Muttalakkum Vayil, and it was built by Maravarman Sundara Pandyan II (1238-1251). This gopuram is named after the frescoes and reliefs that depict secular and religious themes of Hindu culture. Maravarman Sundara Pandyan II also added a pillared corridor to the Sundareswara shrine and the Sundara Pandvan Mandapam. It was rebuilt after the 14th-century damage, and its granite structure was renovated by Kumara Krishnappar around 1595. The restored complex now houses 14 gopurams (gateway towers), ranging from 45–50 m in height, with the southern gopuram being the tallest at 51.9 metres (170 ft). The complex has numerous sculpted pillared halls such as Aayiramkaal (1000-pillared hall), Kilikoondu-mandapam, Golu-mandapam and Pudu-mandapam. Its shrines are dedicated to Hindu deities and Shaivism scholars, with the vimanas above the garbhagrihas (sanctums) of Meenakshi and Sundaresvara gilded with gold. The temple was rebuilt by the Hindu Nayaka dynasty ruler Vishwanatha Nayak in the 16th and 17th centuries. The Nayaka rulers followed the Hindu texts on architecture called the Shil*pa Shastras* in redesigning the temple city plan and the Meenakshi temple. The city was laid out in the shape of concentric squares and ring roads around them, with radiating streets culminating in the Meenakshi-Sundaresvara temple. These streets use traditional Tamil Hindu month names, such as Aaadi, Chitrai, Avani-moola, Masi and others. In each of these months, the Hindus started their tradition of taking the temple bronze idols festively through the street of the same name. The temple and the city were once again east facing to greet the rising Surva (sun god). The temple

city grew again around the new temple, with human settlements structured as per their castes, with the royalty, Kshatriyas and Vaishya merchants lived on the southeast side of the temple, the Brahmins in a special quarter close to the temple, while others in other areas and fringes of the city. The work completed by Vishwanatha Nayaka in 1560 was substantially expanded to the current structure during the reign of Tirumala Nayaka (1623-55). Tirumala Nayaka, a Hindu king, took considerable interest in erecting many complexes inside the temple. His major contributions are the Vasantha Mandapam for celebrating Vasanthotsavam (spring festival) and Kilikoondu Mandapam (corridor of parrots). The corridors of the temple tank and Meenatchi Nayakar Mandapam were built by Rani Mangammal. The initiative for some changes to the structure was under the supervision of Ariyanatha Mudaliar, the prime minister of the Nayaka Dynasty.

The temple has its traditional version of history that it calls *Shiva-lilas* (sports of Shiva), and sixty-four of these episodes are painted as murals around the temple walls. These depict the many destructions of Madurai and the temple, then its rise from the ashes and ruins of the destruction every time. years. Thirugnanasambandar, a famous Saiva philosopher, mentioned this temple in the early 7th century and described the deity Sundareshwaraas *Aalavai Iraivan*.

### FEATURES OF THE TEMPLE COMPLEX

The temple complex covers around 45 acres and is surrounded by 12 gateway towers called *gopurams*, the tallest of which is the famous southern tower that rises to 52 meters. Each *gopuram* is a multi-storied structure in the shape of a steep pyramid, covered with thousands of stone figures of animals, gods, goddesses and demons painted in all colors of the rainbow. There are several shrines inside the complex dedicated to goddess Meenakshi, her consort Lord Shiva (also called Sundareswarar) and their son, the elephant god Ganesha. Both the Meenakshi and Sundareswarar shrines have gold plated towers whose tops can be seen from a great distance. There is also a sacred water tank, several halls and innumerable Mandapas. Scattered throughout the complex are staggering number of sculptures and statues of gods, warriors on horses, battle scenes, and even characters from the mighty Indian epic Mahabharata. There are an estimated 33,000 sculptures all over the temple.

### LEGEND ABOUT THE TEMPLE



It is believed that the **Madurai Meenakshi Temple was established by Indra**, the King of Devas. Lord Indra was on a spiritual journey for his wrong doings and on his way to Madurai he was attracted by the Swayambu Lingam and established this temple. In response to his prayes, Lord Shiva, appeared on a Golden Lotus in the nearby pond. The importance of this temple in Tamil Literature goes beyond 2000 The Meenakshi temple also includes altars for Goddess Lakshmi, flute playing Krishna, Rukmini, Brahma, Saraswati, other Vedic and Puranic deities, as well as artwork showing narratives from major Hindu texts.

Meenakshi is a term meaning *fish-eyed*, derived from the words *mina* (fish) and *akshi* (eyes). She was earlier known by the Tamil name *Thadadakai* (fish-eyed one), which was called later as Meenakshi. According to another theory, the name of the goddess literally means *rule of the fish*, derived from the Tamil words *meen* (fish) and *aatchi* (rule). She is also known by the Tamil name *Angayarkanni* or *Ankayarkannammai* (literally, *the mother with the beautiful fish eyes*).

The goddess Meenakshi is the principal deity of the temple, unlike most Shiva temples in South India where Shiva is the principal deity. According to a legend found in the Tamil text **Tiruvilaiyatalpuranam**, king Mala-

yadwaja Pandya and his wife Kanchanamalai performed a Yajna seeking a son for succession. Instead, a daughter was born out of the fire who was already 3 years old and had three breasts. Shiva intervened and said that the parents should treat her like a son, and when she meets her husband, she will lose the third breast. They followed the advice. The girl grew up, the king crowned her as the successor and when she met Shiva, his words came true, she took her true relationships form of Meenakshi.

The marriage of Meenakshi and Shiva was the biggest event, with all gods, goddesses and living beings gathered. Vishnu is believed to be the brother of Meenakshi and gives her away to Shiva at the wedding.

The town of Madurai is ancient and one mentioned in Sangam era texts. These are dated to be from the 1st to 4th century CE. Some early Tamil texts call Madurai as Koodal, and these



portray it as a capital and a temple town where every street radiated from the temple. Goddess Meenakshi is described as the divine ruler, who along with Shiva were the primary deities that the southern Tamil kingdoms such as the Pandya dynasty revered. The early texts imply that a temple existed in Madurai by the mid-6th century. In medieval literature and inscriptions, it is sometimes referred to as Kadambavanam (forest of Kadamba) or Velliambalam (silver hall, where Shiva danced). It was described to be the sangam of scholars, or a place where scholars meet. It is mentioned in the Tamil text Tiruvilayadalpuranam and the Sanskrit text Halasya Mahatmya. It is one of the 275 Paadal Petra Sthalams. Nearly 15000 people visit this temple a day and its yearly revenue is about 6 crores. The temple has about 33000 sculptures. It holds a place in the top 30 list of the Seven New Wonders of the World. This temple is one of the most important attractions of the Madurai city. Madurai is called as the City of festivals and the most important festival is the Meenakshi Thirukkalyanam, a 10-day festival is usually celebrated between the months of April and May and the festival attracts over 10 lakh visitors. According to Hindu mythology, Madurai is considered as one of the holiest places as it is believed that the Lord Shiva married the Goddess Parvati here. Other such places include Kanchipuram Kamakshi Temple, the Thiruvanaikaval Akilandeswari Temple, and the Visalakshi Temple in Varanasi. The main deities of the temple are Goddess Meenakshi and Lord Sundareshwarar. In the center of the temple hall is the shrine of Lord Shiva. There is a huge altar for the God Natarajar and is also known as Velliyambalam. Nearby is a shrine dedicated to Lord Ganesha also known as Mukuruni Ganesha and the idol was found in the temple lake during the excavation. To the left of Lord Shiva is the shrine of the Goddess Meenakshi. The temple also has a consecrated pond named Porthamarai Kulam. The term Potramarai Kulam is a literal translation of pond with golden lotus. The structure of a golden lotus is placed at the center of the pond. It is said that Lord Shiva blessed this pond and declared that no marine life would grow in it. In the Tamil folklore, the pond is believed to be an evaluator for reviewing the worth of any new literature.

The temple has four main towering gateways (gopurams) that look identical to each other. Apart from the four gopurams, the temple also houses many other gopurams that serve as gateways to a number of shrines. The



temple has a total of 14 towering gateways. Each one of them is a multi-storey structure and displays thousands of mythological stories and several other sculptures. The major gopurams of the temple are listed below:

Kadaka Gopuram, a towering gateway that leads to the main shrine that houses Goddess Meenakshi. This gateway was built by Tumpichi Nayakkar during mid-16<sup>th</sup> century. This gopuram has five storeys.

Sundareswarar Shrine Gopuram, is the oldest gopuram of the temple and was built by Kulasekara Pandya. This gopuram serves as a gateway to the Sundareswarar (Lord Shi-

#### va) shrine.

Chitra Gopuram was built by Maravarman Sundara Pandyan II, and the gopuram depicts the religious and secular essence of Hinduism.

Nadukkattu Gopuram, also called as the Idaikattu Gopuram, is a gateway that leads to the Ganesha shrine. The gateway is placed right in between the two main shrines.

Mottai Gopuram, has fewer stucco images compared to the other gateways. Interestingly, Mottai gopuram had no roof for nearly three

say *Meenakshi*. The hall, which is next to the Meenakshi shrine, has sculptures of characters from Mahabharata.

Ashta Shakthi Mandapam, houses the sculptures of eight goddesses. Built by two queens, the hall is placed in between the main gopuram and the gateway that leads to the Meenakshi shrine.

Nayaka Mandapam, was built by Chinnappa Nayakkar. The hall is supported by 100 pillars and houses the statue of Lord Nataraja.

### WORSHIP IN MADURAI MEENAKSHI TEMPLE

According to the tradition, the Goddess Meenakshi has to be worshipped first and then Lord Sundareshwarar. To worship the Goddess, the Devotees have to go through the East Tower via Ashtashakti Mandapam, Meenakshi Nayak Mandapam and Mudali Mandapam, take bath in the Golden Lotus Pool and wear clean clothes. Then worship Ganesha and Nandi at the main entrance of the Swami Temple and then Natarajar. On the first walkway of the Meenakshi Temple, the deities Vandiyammai, Sivalingam, Sun, Kalaimagal, Saints, Somaskandar, various lingams, Pitsadanar, Kasiviswanathar, Ellam Valla Šiddhar, Durga Amman, Kadamba Maram, Kanakasabai Natarajar, Chandikeswarar, Atsaralingam, Mahalakshmi Nadar, Mahalakshmi are to be worshipped. To the north of the main entrance is the temple of Lord Arulmigu Palani Murugan. Devotees pay homage to the deities Agni Veeraputra, Agora Veerapatra, Thandava Murthy and Bhadrakali through the Hundred Pillars Hall next to the Sadayappar and Nandi Mandapas. After going to Thirugnanasambandar Mandapam and worshiping the

four deities there, they should sit for a while. After worshiping the idols of Hanumar, Krishna and other deities, one can go through the Amman Sannidhi. Renowned for its astonishing architecture, Meenakshi Temple was nominated as one of the wonders of the world, but could not make it into the list of Seven Wonders of the World. However, the temple definitely is,

one of the Wonders of

Nayaka Gopuram, was built by Visvappa Nayakkar around 1530. This gopuram is astonishingly similar to another gateway called Palahai Gopuram.

The temple also has numerous pillared halls called *Mandapams*. These halls were built by various kings and emperors and they serve as resting places for pilgrims and devotees. Some of the most important 'mandapams' are given

### below:

Ayiramkaal Mandapam, literally translates to hall with thousand pillars. The hall, which was built by Ariyanatha Mudaliar, is a true spectacle as it is supported by 985 pillars. Every pillar is sculpted magnificently and has images of Yali, a mythological creature.

Kilikoondu Mandapam, was originally built to house hundreds of parrots. The parrots that were kept there in cages were trained to



*India*. It is also one of the main attractions of South India with thousands of devotees thronging it every day. During the Tirukalyanam Festival, which takes place over a period of 10 days, the temple attracts more than a million devotees. Despite many people visiting it every day, the temple is well-maintained and was

named the Best Swachh Iconic Place (cleanest iconic place) in India.


