Ontario Launches its Plan to Catch Up

Plan Starts with Students Back in Classrooms, On Time



July 25, 2022 **Education**

TORONTO — After two years of pandemic disruptions, Ontario today launched its Plan to Catch Up for the 2022-23 school year. The plan, which is supported by the government's historic investments in education, starts with students back in classrooms, on time, with the full school experience including extracurriculars like clubs, band and field trips.

"Our government is looking ahead as we remain squarely focused on ensuring students receive the best stable learning experience possible, and that starts with them being in class, on time, with all of the experiences students deserve," said Stephen Lecce, Minister of Education. "We have a plan for students to catch up, including the largest tutoring program in Ontario's history, a modernized skills-focused curriculum to prepare students for the jobs of tomorrow, and enhanced mental health supports."

Ontario's Plan to Catch Up is squarely focused on the priorities of parents and includes five key components:

1. Getting kids back in classrooms in September, on time, with a full school

experience that includes extra-curriculars like clubs, band, and field trips;

- 2. New tutoring supports to fill gaps in learning;
- 3. Preparing students for the jobs of
- 4. Providing more money to build schools and improve education; and
- 5. Helping students with historic funding for mental health supports.

The province has signed agreements with eight internet service providers to bring access to as many as 339 municipalities across Ontario. The internet service providers were selected through a two-stage competitive process and are part of Ontario's historic investment of nearly \$4 billion to bring access to reliable high-speed internet across the province.



"This competitive process is the first of its kind in Canada and has led to an unprecedented market response and commitment to deliver high-speed internet connections to communities that have been left underserved until now," said Michael Lindsay, President and CEO of Infrastructure Ontario. "We at Infrastructure Ontario are proud to help create a connected, modern and competitive Ontario."

The government has a plan to build Ontario's future with shovels in the ground for highways, hospitals, housing and high-speed internet infrastructure. Ontario's high-speed internet initiatives will help ensure that every home and business, in every community, can participate in today's economy. It will also help create the conditions for economic and fiscal growth, while protecting progress made.



The Prime Minister, Justin Trudeau, today issued the following statement on the 39th anniversary of Black July:

"Today, we remember those who lost their lives or were displaced during the horrific and violent events of Black

"In July 1983, anti-Tamil pogroms erupted in Colombo, following decades of unrest and rising tensions across the country. Known as Black July, these deadly events triggered an armed conflict that lasted 26 years, cost tens of thousands of lives, destroyed homes and businesses owned by Tamils, and sent hundreds of thousands into exile.

"In the months that followed the events of Black July, the Government of Canada implemented a Special Measures program to respond to the violence in Sri Lanka, which helped more than 1,800 Tamils resettle in Canada. I have had the privilege of meeting many Tamil Canadian survivors of Black July and have been moved by their harrowing experiences of loss, displacement, and resilience.

Canada is now home to one of the largest Tamil diasporas in the world, and we thank Tamil Canadians for contributing so greatly to making Canada the strong, vibrant, and inclusive place it is today.

"Today, we acknowledge the people of Sri Lanka, who are suffering during this current economic and political crisis. Following the recent election of the new president, Ranil Wickremesinghe, by the Sri Lankan parliament, Canada strongly encourages Sri Lanka's government to promote democracy and human rights and maintain the rule of law as it works to address this crisis, and undertake the necessary reforms for a peaceful, prosperous, and reconciled Sri Lanka.

Canada also reiterates the need to ensure that the rights to protest and a free press are protected during these difficult times.

"On this day, our thoughts are with all those who suffered and lost family, friends, and neighbours during Black July and the conflict that followed. We are committed to working together to help build a better future for everyone."

TORONTO — Dr. Merrilee Fullerton, Minister of Children, Community and Social Services and Solicitor General Michael Kerzner released the following statement:

"We stand together with our partners worldwide to recognize World Day Against Trafficking in Persons.

This year's theme focuses on the use and abuse of technology and how social media and cellphones are often used by traffickers to lure, groom, recruit, and exploit individuals.

While human trafficking can happen to anyone, we know young women and girls are particularly at risk of being exploited, robbing them of their safety, as well as having a devastating impact on their health and well-being.

The widespread use of social media and online messaging services have intensified globally during the COVID-19 pandemic. Traffickers use this technology to more easily identify and target a person's vulnerabilities, gain trust and form a bond that they will then use to manipulate and exploit their victim. We must use the same technology to reach those at

trafficking.

Our government's \$307 million **Anti-Human Trafficking Strategy** is specifically designed to protect children and youth. It includes digital education tools that, with the help of adult facilitators, can teach kids how to recognize if they are being targeted by a trafficker and where to get help. It also provides culturally specific resources for Indigenous communities.

We must do everything we can to protect potential victims and support survivors by intervening early, holding offenders accountable, and ensuring law enforcement officials have the tools necessary to investigate, charge and prosecute offenders.

Under the leadership of Premier Ford, our government will continue to work with communities and our partners across the province to prevent and eliminate human trafficking while supporting victims and survivors."

anniversary of the Ugandan Asian resettlement

August 4, 2022 Ottawa, Ontario

The Prime Minister, Justin Trudeau, today issued the following statement on the 50th anniversary of the Ugandan Asian resettlement:

"Fifty years ago, Canada welcomed more than 7,000 South Asians expelled from Uganda as part of an international resettlement effort. Today, we honour the resilience,

strength, and courage of Ugandans of South Asian descent and reflect on the many important contributions they have made - and continue to make to Canadian communities across the

"On August 4, 1972, the Ugandan President Idi Amin Dada ordered all South Asians to leave Uganda within 90 days. This appalling decision reflected severe anti-South Asian discrimination and led to the rapid and brutal expulsion of tens of thousands of people – many were stripped of their Ugandan citizenship and effectively left stateless.

"In the face of this humanitarian crisis, Canada acted swiftly and accepted to take in over 4,400 South Asian Ugandans, and thousands more followed later. The government sent immigration officers to Uganda to help with processing, and Ugandans of South Asian descent started arriving in Canada the following month. After a 19-hour flight, the first group of South Asian Ugandans landed at the Longue-Pointe detachment of Canadian Forces Base Montreal, where they were provided hot food, warm clothing, and a new country to

call home.

"In the five decades since, South Asian Ugandans have become a vibrant part of Canada's social and economic fabric. Their many important contributions have made our country stronger, more diverse, and more inclusive.

"On behalf of the Government of Canada, I encourage all Canadians to learn more about the expulsion and resettlement of South Asian Ugandans in Canada and beyond. Canada will continue to honour our longstanding tradition of protecting those fleeing conflict and persecution - no matter who they are and where they are from."

Sarah El-Shaarawi wins 2022 Dalton Camp Award and \$10,000 prize for essay The Similarities Between Red and Yellow



"We were detained for days in cold cells. They took most of our clothes, denied us soap and toothbrushes, and only allowed us to speak to our lawyers.'

TORONTO - Writer Sarah El-Shaarawi has won the 2022 Dalton Camp Award for her essay The Similarities Between Red and Yellow, a powerful reflection on the importance of freedom of the press.

The Dalton Camp Award is an annual \$10,000 prize for the best essay on the subject of media and democracy in Canada. FRIENDS launched the award in 2002, to honour the memory of the late Dalton Camp, a prominent commentator on Canadian public

In The Similarities Between Red and Yellow, El-Shaarawi draws from her own experience as a journalist in Canada and abroad to make the sobering observation that journalists are being threatened and prevented from doing their job in both autocratic countries as well as democratic ones like Canada.

"As a forever student of global politics and global media systems and having worked extensively in some of the region's most associated with oppression and a lack of media freedoms, I have been able to look in on Canadian press freedoms from, perhaps, a different perspective," said El-Shaarawi. "And this has given me two things: first, it has shown me just how lucky we are and how much we should appreciate the freedoms that we have as Canadians, and as Canadians working in the media. And second, it has shown me just how fragile these

systems are and how much they need to be protected."

The winner of this year's Dalton Camp Award for Best Student Journalist essay is Kevin Seeram, a graduate of McMaster University. In his essay The Memeification of Modern Politics: From TikTok to Deepfakes, Seeram reflects on how social media platforms are shaping the current generations' political engagement.

"Given the current climate we find ourselves in, credible, reliable and independent journalism has never been more important," said Marla Boltman, Executive Director of FRIENDS. "Keeping Canadians informed and connected helps strengthen trust between citizens and supports a healthy democracy. We are honoured to be awarding this prize to two writers who have taken the time to think and reflect on the state of journalism in

The winners were chosen from amongst 200 entries, by a five-member jury: Hannah Sung, Jane Hilderman, Kathy English, Danielle Paradis and TemurDurrani.

Ontario's Plan to Build Supporting Stronger Province and Economy

2022 Budget is a plan to help keep costs down for families, support better jobs and bigger paycheques and build more highways, housing, transit and hospitals

TORONTO — As part of its commitment to implement the 2022 Budget and build a stronger Ontario for workers, businesses and families, the Ontario government today re-introduced the Plan to Build Act (Budget Measures), 2022.

"I am pleased to re-introduce the Plan to Build Act (Budget Measures), 2022 bill today so our government can continue delivering Ontario's Plan to Build, supporting better jobs for workers while building more highways, housing and hospitals right across the province," said Peter Bethlenfalvy, Minister of Finance. "With costs rising, our plan also includes measures to help families, including new direct payments to parents to help their kids catch up and increasing Ontario Disability Support Program payments."

To help those who qualify for disability support, the government is delivering on its commitment to increase the rates for income support by five per cent beginning in September 2022, for families and persons under the Ontario Disability Support Program (ODSP). Beginning in September, the government will increase both the ODSP rate and the Assistance for Children with Severe Disabilities Program maximum monthly amount by five per cent. Future ODSP rates will also be adjusted to inflation.

To help fill gaps in learning for students after two years of pandemic disruptions, the government is also investing \$225 million for direct payments to parents. This is in addition to the previously announced \$175 million tutoring support program, the largest of its kind in Ontario's history. The government will have more details later in the year on how families can access this new support.

"No government in Ontario history has invested more in public education, tutoring supports, and student mental health than our government," said Stephen Lecce, Minister of Education. "We are going further by providing direct financial support to parents, in addition to the expanded tutoring supports for students, all focused on ensuring kids get back to class with the full school experience."

The additional investment in tutoring supports and increased ODSP rate will be funded from existing contingencies contained in the government's fiscal plan as presented in the 2022

Building on the Province's record of transparency and accountability, the government also released the 2022-23 First Quarter Finances today, which provides updated information about the evolution of Ontario's economic and fiscal outlook since the 2022 Budget for the 2022-23 fiscal year. Due to higher-than-projected taxation revenues, the government is projecting a deficit of \$18.8 billion in 2022-23, an improvement of \$1.1 billion from the outlook presented in the 2022 Budget.

"We have a prudent and flexible plan which builds on our record of responsible fiscal management, while making the investments that will reduce commute times, support frontline health care and help create good jobs," said Minister Bethlenfalvy. "In a time of economic uncertainty, our government is supporting Ontario workers and families by putting more money back into their pockets."

SE Asian govts urge superpowers to maintain peace after Pelosi Taiwan trip

Indonesia, Malaysia, the Philippines, Thailand and others restate One China Policy recognizing Beijing's stance.

Southeast Asian governments on Wednesday urged China and rival superpower the United States to hold back from "provocative actions" that could inflame tensions, saying they were watching the situation around Taiwan after U.S. House Speaker Nancy Pelosi's controversial visit.

From Manila to Jakarta, Bangkok, Hanoi and other capitals, governments across the region reiterated their support for the One China Policy, under which Beijing is recognized as the sole government of China.

The United States also holds this policy, but maintains close unofficial ties with Taiwan and is obligated to provide defense support. Washington only acknowledges China's sovereignty claim over Taiwan rather than endors-

The foreign ministry of Indonesia, Southeast Asia's largest country, expressed grave concern about the "increasing rivalry among major powers," without naming the U.S. and China.

"If not managed well, it may lead to open conflict and disrupt peace and stability, including in the Taiwan [S] trait," Jakarta said in a statement as it called on "all parties to refrain from provocative actions that may worsen the situation."

"The world is in dire need of wisdom and responsibilities of all leaders to ensure peace and stability are maintained," said Indonesia, which has faced its own territorial tensions with China in waters around the Natuna Islands in the far southwestern reaches of the South China Sea.

In Bangkok, Thailand's Ministry of Foreign Affairs expressed similar concern in the wake of Pelosi's visit to

"We do not wish to see any actions that would aggravate tensions and undermine peace and stability in the region," ministry spokesman Tanee-Sangrat said.

"We hope that all parties concerned exercise utmost restraint, abide by international law and principles of respect for sovereignty and territorial integrity and resolve their differences through peaceful means."

As the military jet carrying Pelosi and her delegation touched down in Taipei on Tuesday evening after a flight from their previous stop in Kuala Lumpur, China's People's Liberation Army (PLA) announced live-fire drills at six locations around Taiwan, some overlapping the island's sovereign territorial waters.

In addition, 21 Chinese military aircraft, including 10 J-16 fighter-jets and two reconnaissance airplanes, flew into Taiwan's air defense identification zone (ADIZ).

While in Taipei, Pelosi visited Tai-



wan's parliament before meeting with President Tsai Ing-wen who called her "one of Taiwan's most devoted

During a brief speech following their meeting, Pelosi praised Taiwan for its resilience.

"America's determination to preserve democracy here in Taiwan and around the world remains ironclad," the house speaker said, adding that the U.S. "will not abandon our commitment to Taiwan."

Pelosi was the first senior-most American official to visit Taiwan in 25 years. In the days leading up to her visit, Beijing had issued stern warnings against it, claiming that the trip would encroach on Chinese sovereignty.

The Philippines, which has also had confrontations with China in the South China Sea and maintains a Mutual Defense Treaty with the United States, said it was tracking Pelosi's visit over concerns that it could escalate tensions with Beijing. The Pelosi-led U.S. delegation left Taiwan Wednesday evening and traveled on to South Korea.

"Our military and our DFA (Department of Foreign Affairs) are closely monitoring the situation as they would in any other similar circumstance," said Trixie Cruz-Angeles, spokeswoman for President Ferdinand Marcos Jr.

"On matters of international relations, reactions are studied. We don't make knee-jerk reactions because they could adversely affect international relations," she said, stressing that "loose words" could impact Philippine-China relations.

Cruz-Angeles said China's envoy to Manila, Huang Xilian, had reminded officials to adhere to the One China Policy.


"There is only one China in the world. Taiwan is an inalienable part of China's territory," Huang said Tuesday ahead of Pelosi's visit.

The Chinese ambassador said he hoped the Philippines would "handle all Taiwan-related issues with prudence to ensure sound and steady development of China-Philippines relations."

Malaysia's foreign minister, meanwhile, said his government wanted to ensure peace, stability and prosperity in the region as officials in Kuala Lumpur seek to maintain good relations with their counterparts in Beijing and Washington.

China's military exercises near Taiwan continue as drones fly over Kinmen islands

China's major military exercise around Taiwan entered day three Saturday, with the People's Liberation Army (PLA) apparently staging a simulated attack on Taiwan's main island, Taipei's Defense Ministry said.

Multiple Chinese military aircraft and vessels operated near Taiwan on Saturday morning, some of them crossed the median line dividing the Taiwan Strait, the ministry said in a

The Taiwanese military sent warnings, scrambled aircraft and deployed defense missile systems to track the Chinese military planes, the statement said.

On Friday night, four Chinese drones were spotted flying over the Kinmen islands near China's Fujian province, the defense ministry said.

During the day on Friday, Chinese military aircraft made a record 68 incursions into Taiwan's air defense identification zone (ADIZ), many of them crossed the median line, which serves as a de facto border between Taiwan and the mainland.

This is the highest number of incursions in one day. The previous single-day record was 56, on Oct. 4, 2021.

By "squeezing the median line," the PLA intends to make its encroachments on Taiwan's air space and waters routine, therefore changing the status quo in the Taiwan Strait and making it a Chinese inner sea," said Shen Ming-Shih, acting deputy chief executive officer at Taiwan's Institute for National Defense and Security Research, a government think-tank.

The unprecedented drills are set to continue until noon on Sunday local time and Chinese media reported that a Chinese aircraft carrier group, featuring at least one nuclear-powered submarine, would take part in the first carrier deterrence exercise.

Details however remain sketchy and the whereabouts of both Chinese carriers, Liaoning and Shandong, were unclear as of Saturday.

USS Ronald Reagan returns

The U.S. Navy's only forward-deployed aircraft carrier, the USS Ronald Reagan, seems to have returned to east of Taiwan from a position near its Japanese home port, several sources said.

The amphibious assault ships USS Tripoli and USS America were also heading to waters near Taiwan, the U.S. Naval Institute reported.

The carrier and other ships are expected to conduct maritime transit through the Taiwan Strait in the coming weeks, according to U.S. National Security Spokesperson John Kirby who added that the U.S. "will take further steps to demonstrate our commitment to the security of our allies in the region.'

On Friday China released a set of eight "countermeasures" in response to U.S. House Speaker Nancy Pelosi's visit to Taiwan, freezing collaboration on three sets of military dialogues with the U.S., as well as from talks on the climate crisis, repatriation of illegal immigrants, counter-narcotics and legal assistance in criminal matters.

The breaking off of the wide range of bilateral talks came after Beijing announced sanctions against Pelosi and her direct family members, accusing her of "vicious and provocative actions."

Pelosi is the most senior U.S. official to visit Taiwan in 25 years.

On Thursday Japan said it had lodged a diplomatic protest after five ballistic missiles fired by China appear to have landed inside Japan's exclusive economic zone (EEZ), which stretches 200 nautical miles (370 kilometers) from the outer limits of Japan's territorial seas.

Beijing rejected the complaint, saying China and Japan have not carried out maritime delimitation in the waters and China's missile test-launch in the area was "consistent with international law and practices."

Ponniyin Selvan: History versus curiosity over onscreen portrayal of mighty Cholas

Ponniyin Selvan is based on renowned writer Kalki Krishnamurthy's (1899-1954) popular Tamil novel of the same name, published in 1955.

While film enthusiasts are eagerly awaiting the release of the history inspired flick PonniyinSelvan-I, a curious question has been raised on the religious signs portrayed in the movie's teaser.

An RTI activist has demanded to know why Chola kings were shown in the movie's teaser as sporting tilak on their forehead and not the sacred ash.

Cholas were Shaivites by faith and they should have been portrayed with the Shaivite sign, the sacred ash, the activist Selvam said in a legal notice. Seeking an explanation and demanding to know if history has been 'hidden' in the movie, the notice was sent to the filmmakers and actors through his lawyer.

PonniyinSelvan is based on renowned writer Kalki Krishnamurthy's (1899-1954) popular Tamil novel of the same name, published in 1955. The novel was inspired by the history of the imperial Cholas. PonniyinSelvan denotes 'Son (the Chola king) of mother Ponni', which is another name for River Cauvery, that made the Chola land fertile.

The film, starring Vikram, Karthi, Jayam Ravi, Jayaram and Aishwarya Rai, is helmed by Mani Ratnam.

A former epigraphist with the Tamil Nadu Archaeology Department and a noted scholar in history, Tamil language and literature, S Ramachandran said the practice of sporting 'Senchandanam' was a part of the 'Kalamukha' Shaivite sect's practices.

A kumkum-like vertical mark on the forehead, the Senchandanam's length and width is often medium.

The researcher, who has written on several historical issues, said there are literary references on Kalamukha sect's practices. In Tamil Nadu, Tiruvotriyur (North Chennai) and Kodumbalur (Pudukottai District) were the two principal places where Kalamukha Shaivism was practised. This was about 800 to 1,000 years before the present times. Led by Mallikarjuna, a Kalamukha monastery thrived in Kodumbalur, he said.

The KodumbalurIrukkuvelir clan, who belonged to the Kalamukha sect were very closely related to the Cholas and there is an inscription as well to substantiate this, he said. Kalki's novel gives importance to the Irukkuvelir people and this is noteworthy, Ramachandran said. "So, a red religious mark is not against Shaivism, the history or Kalki's work," he said.



Circa 10th Century AD, a Chola army general became a Kalamukha saint after a war. He established a monastery in Tiruvotriyur following a visit to Kasi where he took 'Deeksha' from a Kalamukha guru Niranjanar. The general's name was MalaimandalathuNandikaraPuthurElankumaran, and he assumed the name of ChathurananthaPandithan after he chose the path of spirituality.

Worshippers of Goddess Kali also use the bright red mark, Ramachandran told PTI.

"When VijayalayaChola emerged victorious (mid 9th Century), he built a temple for Goddess Kali in Thanjavur as a thanksgiving," he said. Rulers of the valorous Mutharaiyar dynasty have worshipped Goddess Kali.

"It is an astonishing fact that a variety of Shaivite monasteries flourished in Tamil Nadu during the Chola era." Such monastic institutions trace their origins to various parts of the country including regions that now form part of Bengal. Eventually, the Shaivite sect of Kalamukha was assimilated by Veera Shaivism during the 12 Century

"No doubt Chola emperors were ardent Shaivites. Chidambaram Lord Shiva is their family deity. Chidambaram temple Deekshitars (priests) led the coronation events of Chola kings. At the same time, we must never forget that Cholas gave due respect and importance to all faiths," he said.

Cholas built places of worship for Sri Vaishnavism, Jainism and Buddhism. "We have an inscription in Lord RanganathaSwamy temple in Srirangam on Rajaraja-II (12th Century AD) building a math for Sri Ramanujacharya and the monarch's keen interest in supporting Sri Vaishnavism." The Chola kings gave away valuable gifts and bestowed land to support all places of worship including Sri Vaishnavite shrines and they ensured religious harmony, he said.

Raja RajaChola's sister KundavaiPirattiyar built a Jain temple (KundavaiJinalaya, during 10th-11th Century AD) off Polur near Tiruvanimalai and it could be seen today, he said.

Soolamani Varma Vihara, a Buddhist monastery was built by Raja RajaChola-I near Nagapattinam. "We have evidence to say that Raja Raja-I, a devout Shaivite who assumed the title of Siva PadaShekaran and took Shiva Deeksha, did not ignore Buddhism. Cholas gave due importance to Devi worship as well." Hailed as 'the great', Raja RajaChola-I (985-1014 AD) built the famed big temple in Thanjavur, now a world heritage site.

"Belief in Karma, rebirth and the importance given to following Dharma in everyday life are the basic building blocks of all religions born in India. When people appreciate such unifying aspects, it will help them comprehend their specific traditions and theology much better. Importantly, it will strengthen harmony," Ramachandran said. Although Shaivite and Vaishnavite marks are dissimilar, the underlying theme of Indian spirituality is the same, the scholar said.

It may be recalled that AayirathilOruvan, a 2009 Tamil action-adventure movie directed by Selvaraghavan was also inspired by the times (roughly, towards the end of 13th Century AD) of the Chola empire. Ramachandran guided the makers of the film on life and times during the Chola era.

Characters in the Selvaraghavan movie were portrayed as sporting the Shaivite symbol of sacred ash as Cholas were Shaivites. Mother Kali Mahakali and Durga are distinctive manifestations of Goddess Parvathi, the divine consort of Lord Shiva, who is the Mahakal.

In the tradition of Tamil Shaivism, 'temple' denotes the Chidambaram shrine. It underscores the primacy accorded in Shaivism to this temple, located in Cuddalore District of Tamil Nadu. This temple has a shrine dedicated to Lord Vishnu, worshipped as Sri GovindarajaPerumal.

Tamil poet Ottakuthar hails ParantakaChola-I (Circa 907-953 AD) as '... KadhalarPonveinthaKavalan,' praising him for constructing a golden roof for the Chidambaram temple's vimana out of love for the God.

US seeks to dial down tension over Taiwan Strait

In Manila, Blinken called China's halting of cooperation with the U.S. 'irresponsible.'

U.S. Secretary of State Antony Blinken on Saturday said Beijing had acted irresponsibly in halting cooperation with the United States on topics including defense and climate change, as he sought to reassure Southeast Asian countries over raging tensions in the Taiwan Strait.

Meanwhile, China pressed forward with its major military exercise around Taiwan for a third day on Saturday, with the People's Liberation Army (PLA) apparently staging a simulated attack on Taiwan's main island, Taipei's Defense Ministry said.

"Since their missile launches, Beijing has taken an irresponsible step of a different kind: They've shut down eight different areas where our two countries have been able to work together," the top U.S. diplomat said during a press conference Saturday in Manila.

Beijing announced the "countermeasures" on Friday in response to U.S. House Speaker Nancy Pelosi's recent visit to Taiwan, freezing bilateral dialogue on several military-to-military channels as well as talks on the climate crisis, repatriation of illegal immigrants, counter-narcotics and legal assistance in criminal matters.

"The world's largest carbon emitter is now refusing to engage on combating the climate crisis. Suspending climate cooperation doesn't punish the United States; it punishes the world, particularly the developing world," Blinken said.

While Beijing appeared to have halted live-firing exercises around Taiwan, multiple Chinese military aircraft and vessels operated near Taiwan on Saturday, some of them crossing the median line dividing the Taiwan Strait, the ministry said in a statement.

The Taiwanese military sent warnings, scrambled aircraft and deployed defense missile systems to track the Chinese military planes, the statement said.

Blinken, traveling from Cambodia where he attended ASEAN meetings, said that the U.S. government was determined to avoid a crisis and to deescalate the tensions.

"The United States is not going to engage in any provocative actions of our own," Blinken told the Voice of America in an interview late Friday in Phnom Penh, transcripts of which were released to the press Saturday. "We think the seas should be calmed."

"The Taiwan Strait is of vital importance to virtually every country in the region. So much commerce goes through there. If that were interrupted, it would have a terrible impact on the global economy and on everyone's desire to recover from COVID," Blinken stressed.

"So I think it's incumbent upon all countries - the United States, but also China - to act responsibly and not use the visit of a member of our Congress as a pretext for engaging in potentially dangerous and destabilizing actions," he added.

Nonetheless, he noted that the U.S. House Speaker had every right to make the recent trip to Taiwan, and that China's reaction by launching 11 ballistic missiles and deploying its ships around the region "is so disproportionate and so dangerous."

Meeting with Marcos

The U.S. diplomat met with Philippine President Ferdinand Marcos Jr. on Saturday morning, and underlined the two sides' long-standing alliance.

Blinken is the highest-ranking U.S. official to travel to the country since the inauguration of Marcos, the son and namesake of the late dictator whom Washington helped flee into exile in Hawaii after a 1986 "people power" uprising.

"We're committed to the Mutual Defense Treaty. We're committed to working with you on shared challenges," Blinken said, referring to a 1951 pact between Manila and Washington that binds both sides to come to each other's aid in times of aggression from outside forces.

The U.S. government has repeatedly cited that partnership in the face of continued Chinese buildup in the disputed South China Sea region, where Beijing's maritime claims overlap with those of the Philippines and other Southeast Asian countries.

He assured Marcos the United States would honor its commitments to the decades-old joint defense pact. "The alliance is strong and I believe can grow even stronger," Blinken said.

Marcos, for his part, stressed the importance of the alliance amid the volatile outlook in the region even as he stated that Pelosi's visit to Taiwan "did not raise the intensity" of tensions in the Taiwan Strait.

"But nonetheless, this just demonstrates how volatile the international diplomatic scene is, not only in the region," Marcos said. "So again, this just points to the fact of the importance of the relationship between the United States and the Philippines."

He said that the MDT "is in constant evolution" while noting that the Philippines and the United States enjoyed a special relationship linked by shared

Marcos succeeded President Rodrigo Duterte in May after six years of a somewhat rocky relationship with Washington that saw the Philippines pulling away from its traditional ally in favor of Beijing.

After meeting with Marcos, Blinken held a virtual meeting with his counterpart, Enrique Manalo, who earlier this week announced that he had contracted COVID-19. Manalo likewise reiterated the ties that bind the two nations, and the importance of keeping the peace over the Taiwan Strait.

"The Philippines continues of course to look at the big powers to help calm the waters and keep the peace, "Manalo stressed. "We can ill afford any further escalation of tensions in the region." Blinken responded by saying

that Washington was" determined to act responsibly, so that we avoid crisis, we avoid conflict."

Beijing considers the self-ruling, democratic island a breakaway province, to be united with the mainland by force if necessary, and objects strongly to high-level U.S. visits. The United States does not recognize Taiwan diplomatically, as part of a One China policy demanded by Beijing, but retains close unofficial ties with Taipei and is obligated by law to provide it with defense capabilities.

Myanmar situation worsens Meanwhile, Blinken said that the situation in Myanmar had deteriorat-

ed sharply, with the military regime there "totally unresponsive" to international calls for it to resolve the crisis there peacefully.

"Well, I think what we've seen, exactly as you say, is a situation that's gone from bad to worse, including with the heinous act of executing four members of the democracy movement despite pleas from ASEAN, from Cambodia, from many others not to do that," Blinken said, according to the VOA interview.

Blinken urged the junta to implement the five-point consensus that the Association of Southeast Asian



Nations (ASEAN) had drafted earlier for Myanmar to return to the path to democracy. Failing to do so would unleash "more pressure on the regime economic pressure, political pressure," he warned.

"We have to press the regime to allow humanitarian assistance to reach people in Myanmar, and we should look at ways to make sure that weapons don't get to the regime. So we'll look at everything, including additional forms of economic pressure and sanctions," Blinken said.

He said ASEAN was correct to exclude Myanmar's foreign minister in recent meetings, but said moving forward the bloc would have to "look at what that means, including suspension of Myanmar."

"[W]e want everyone concerned to look at the situation and address it in the best way because we appreciate and we've put a lot of value in both the U.S. and China when it comes to trade and technology in the region and want to be friends to both," Minister Saifuddin Abdullah said from Phnom Penh, where foreign ministers from the Association of Southeast Asian Nations were assembling for the **ASEAN Regional Forum Meeting** and meetings this week with the top Chinese, American and Russian diplomats, among others.

'Maximum restraint'

Late on Wednesday, the foreign ministers of the 10 ASEAN members-states prepared a collective statement about "the cross strait development."

The bloc, it said, was "concerned with the international and regional volatility, especially in the recent development [...] adjacent with the ASEAN region."

That situation "could destabilize the region and eventually could lead to miscalculation, serious confrontation, open conflicts and unpredictable consequences among majors powers," the top ASEAN diplomats said.

Elsewhere, officials in Cambodia, the Lao People's Democratic Republic, Myanmar and Vietnam reaffirmed support for One China policy while also calling for peace and stability in the region.

"The Lao PDR reiterates its support for the policy of the government of the People's Republic of China on the national reunification by peaceful means," it said in a Facebook post.

The military government in Myanmar, for its part, reaffirmed its belief that Taiwan is "an integral part of the People's Republic of China" while expressing concern over Pelosi's visit, "which is causing escalation of tensions on the Taiwan Straits."

"Myanmar calls all concerned parties to deescalate the tensions through constructive dialogue and peaceful negotiation for peace and stability across the Taiwan Straits," the junta said in a Facebook post.

China has become the largest source of foreign investment in Myanmar since Western businesses pulled out after the February 2021 military coup.

Like a frontline soldier

In northern Thailand, an analyst at Chiang Mai University lauded Pelosi while casting doubt on some media reports suggesting that her Taiwan visit could have ignited a new cold war.

"As the U.S.'s third most influential figure after President Joe Biden and Vice President Kamala Harris, Pelosi could have laid a milestone on the U.S.'s new approach in Asia. Her trip to Taiwan is a strong political gesture and is vitally important for the relationship of the U.S. and East Asia in the future," Isa Gharti told BenarNews. "She is like the first U.S. soldier who lays milestones to locate flash points.

"By reading some analysis lately, I am surprised that they think this is the start of a new cold war," he said. "I don't think so because the superpowers have yet to get their economies recovered and cannot afford to lose any partners."

Jagdeep Dhankhar elected 14th Vice President of India; bags 528 votes against Margaret Alva's 182 PM Modi meets Jagdeep Dhankhar and congratulates him

PTI - New Delhi, August 6 NDA candidate Jagdeep Dhankhar was elected as the 14th Vice President of India on Saturday as he defeated joint Opposition candidate Margaret Alva.

Dhankhar, a former governor of West Bengal, secured 528 votes while 80-year-old Alva got 182.

The numbers were stacked in favour of Dhankhar as the ruling BJP enjoys an absolute majority in Lok Sabha and has 91 members in Rajya Sabha. The BJP heads the National Democratic Alliance (NDA).

Even before the results were announced, celebrations had started outside the residence of Parliamentary Affairs Minister Pralhad Joshi where Dhankhar was present.

Joyous scenes were also reported from Rajasthan's Jhunjhunu, the hometown of Dhankhar.

Soon after the announcement of the result, Prime Minister Narendra Modi met Dhankhar and congratulated him.

Dhankhar, 71, will succeed M Venkaiah Naidu whose tenure ends on August 10.

As many as 725 MPs cast their ballots in the poll, which is 92.94 per cent of total votes, an official said, adding 15 votes were declared invalid.

Members of Parliament, including nominated ones, are entitled to vote in the vice presidential poll.

While the electoral college comprises 788 members, due to eight vacancies in Rajya Sabha, the actual strength is 780. The Trinamool Congress had



abstained from voting claiming it was not consulted while naming Alva as the opposition pick. However, two of its MPs—Sisir Kumar Adhikari and DibyenduAdhikari—broke ranks and cast their ballots. The party has 36 MPs, including 23 in Lok Sabha.

The voter turnout this time was lower than 98.2 per cent recorded in the 2017 election when M Venkaiah Naidu was elected as the vice president.

The rise of Dhankhar, 71, to become the next vice president has surprised many. Dhankhar, who had been associated with the Janata Dal and the Congress, joined the BJP only in 2008 after a hiatus of nearly a decade when he concentrated on his legal career.

He has championed issues related to Other Backward Classes, including the grant of OBC status to the Jat community in Rajasthan.

The BJP described Dhankhar as "kisanputra" while announcing his candidature for the vice presidential election, a move seen in the political

circles aimed at reaching out to the politically significant Jat community which had participated in huge numbers in the year-long farmers' protests on the borders of the national capital against agriculture reform measures unveiled in June 2020.

Dhankhar will take oath on August 11, a day after incumbent M Venkaiah Naidu (73) demits office.

From pasting party posters to evolving as an epitome of political and ideological loyalty who became one of the BJP's most visible leaders and later India's vice president, Naidu came a long way.

He entered into student politics through the ABVP and played an active role in the movement led by Jayaprakash Narayan.

Born in a humble agricultural family in Andhra Pradesh's Nellore district, Naidu has served as a BJP president, a union minister and a long-time Rajya Sabha member.

Known for his oratory skills, Naidu

often uses interesting one-liners and rhyming phrases to put across his views effectively.

Not many know that Naidu translated former prime minister Atal Bihari Vajpayee's speeches for his audience down south.

As Rajya Sabha chairman, Naidu had to deal with difficult situations on various occasions, including protests in the House by opposition members on issues such as the now-repealed three central farm laws.

For Alva, the vice presidential election has been another comeback. Barring a brief lull in 2008 triggered by her standoff with Congress president Sonia Gandhi over the issue of family entitlement in ticket distribution, the suave and soft-spoken Alva's career has largely been a dream run.

She has had a political career spanning over four decades during which she occupied several positions, including a five-time Congress MP, a union minister and governor.

She congratulated Dhankhar on his victory.

In the past there had been four instances when candidates were elected unopposed to the post of the vice president who is also the chairperson of Rajya Sabha.

In the 1992 vice presidential poll, K R Narayanan bagged 700 of the 701 valid votes while his rival Kaja-Joginder Singh alias "DhartiPakad" managed just one vote in his favour.

WMO warns of frequent heatwaves in decades ahead

19 July 2022

With temperatures expected to remain above normal until the middle of next week, the World Metrological Organization (WMO) warned that heatwaves will occur more and more frequently, into the 2060s.

The pattern is linked to the observed warming of the planet that can be attributed to human activity, raising serious concerns for the planet's future, the UN weather agency said.

Harvests at risk

"We are expecting to see major impacts on agriculture. During the previous heatwaves in Europe, we lost big parts of harvest. And under the current situation -we are already having the global food crisis because of the war in Ukraine - this heatwave is going to have a further negative impact on agricultural activities", warned Petteri Taalas, Secretary-General of the WMO at a press conference to launch the latest extreme weather findings, in Geneva.

In several countries, some economic sectors – including tourism that has only begun to fully recover in the wake of the COVID-19 pandemic - are suffering as a result.

Further warming inevitable

"The negative trend in climate will continue at least until the 2060s, independent of our success in climate mitigation", Mr. Taalas added.

"We have already lost the game concerning the melting of glaciers. We expect that the melting of glaciers will continue for the coming hundreds of years or even coming thousands of years...Sea level rise will continue for the same period".

Mr. Taalas reflected growing concerns over extreme weather patterns, in his sartorial selection on Tuesday, he told journalists, choosing to wear short sleeves and a red and blue tie, in recognition of the increasing number of red alerts flashing up across Europe.

WMO briefed journalists that the European heatwave may not end, until the middle of next week.



Air pollution

The heatwave also acts as a kind of atmospheric lid, WHO explained, trapping pollutants, and degrading air quality, with adverse health consequences, particularly for vulnerable people such as the elderly. In the major 2003 heatwave in Europe, some 70,000 people died.

"Climate change is affecting our health in many ways, not only by heatwaves which are having direct consequences" but also other areas of essential healthcare, such as rising levels of disease, alerted Maria Neira, Director for public and environmental health at WHO.

She explained that reliable access

to food and water is at stake, as with agricultural production levels at risk", and there will be water scarcity for sure"

She said that 99% of the global population is breathing air that does not meet the health standards set by WHO, hugely impacting chronic respiratory and cardiovascular conditions.

Ambition is key

"The best solution to this will be, again, being very ambitious on tackling the causes of this global warming.

"We have been alerting for a long time that climate change is affecting very much human health", she emphasized, which will also impact the struggle to reach net zero carbon emissions, and the crucial transition to clean, renewable sources of energy.

More deaths among the elderly and those with pre-existing health conditions are feared due to the ongoing heatwave in the weeks ahead, and subsequent challenges to health systems, to keep up with rising demand.



SOS for Injured Animals and Wildlife

July 7, 2022

Like people, animals sometimes need rescuing.

While the best course is usually to leave wildlife undisturbed, there are some situations involving animals where assistance is required.

Animals can get injured through fighting with other animals, an accidental fall or collision, or from a severe weather event.

The City's Animal Services section is a key social service that helps to protect wildlife. Animal Services responds to emergencies 24/7, 365 days a year. Their team of experts is dedicated to rescuing wildlife and pets, and to providing food, shelter, care and basic medical care. This is in addition to protecting the community through the City's Animal Care and Control Bylaw enforcement, education, as well as investigating standards of animal

2022 has been an especially critical year thus far. Rescues are on the rise as residents are increasingly reporting incidents of animal injury or distress.

As of June 15, Animal Services has successfully completed 2,418 animal recuses, with 307 animals being transferred to a licensed wildlife rehabilitation centre.

Typical rescues have included:

- -A gosling tangled in fishing wire
- -A coyote with a food jar stuck on its
- -A fox suffering from mange
- -Baby opossums stranded on a busy
- -A skunk and a raccoon stuck in a car engine

Animals with severe injuries are at a higher risk for chronic pain, starvation and dehydration. They are also more vulnerable to predators. So the first few hours after an animal is rescued is always the most critical. De-



prived of water, food and shelter, the animals are often wary and fearful.

While Animal Services is equipped to rescue animals, it is not a wildlife rehabilitation facility. Under provincial legislation, animals cannot be held for more than 24 hours at an Animal Services facility. Wildlife that require rehab are transferred to rehab facilities, approved by the Ministry of Northern Development, Mines, Natural Resources and Forestry where appropriate treatment is provided.

To date in 2022, more than 300 animals have been transferred to wildlife rescues for rehabilitation.

Animal Services frequently partners with numerous rehab facilities around the Greater Toronto Area. This includes Toronto Wildlife Centre, Urban Wildlife Care, The Owl Foundation, Hobbitsee Rescue and Shades of Hope.

Contact Animal Services if you encounter an animal that is:

- -visibly sick or injured
- -suffering or in immediate distress -running in traffic or in danger
- -locked in a hot vehicle
- -wild and bites a pet or person -acting aggressively to people or pets

Mississauga residents and visitors are always encouraged to respect wildlife and their natural habitats. If you see any animal in Mississauga that is injured, hurt or distressed, contact Animal Services at 311 or at 905-896-5858.

Stroke Patient Turns Advocate

Would you recognize if you were having a stroke?

SHN patient Pam Spence missed a telltale sign she had suffered a stroke, but knew something was seriously wrong: her face was drooping on the left side when she found herself on the floor of a gym change room after falling in the shower. She struggled to call for help.

"I was experiencing severe headaches. Nothing would cure it, and it went on for eight hours," she recalled. "I thought they were migraines."

After calling her doctor, she was sent for a vascular ultrasound of the neck, which provides pictures of the veins and arteries.

"I had carotid stenosis (narrowing of the arteries in the neck) on the left side, fully blocked, and partially blocked in the right artery," she said. "I also had an irregular heartbeat."

Narrow arteries can result in high blood pressure, the leading cause of stroke. When the heart is working too hard, damage to blood vessels and organs may occur over time. When this happens, blood clots may develop that prevent oxygen flow to the



brain. Signs that someone may be having a stroke include drooping in the face, difficulty raising arms or legs, and slurred speech.

After receiving tissue plasminogen activator (t-PA), the only drug that can break up a blood clot if received within the four-hour limit, Pam would eventually find herself in

the care of Scarborough Health Network's (SHN) Central East Regional Cardiovascular Rehab program.

Through the lifestyle and self-management program, Pam is one of several thousand people each year who've received life-saving and life-changing care

SHN's Orthopaedic Trauma Centre steps in when senior's stroll ends in bone fracture

While on her usual afternoon stroll on a mild-April day, Virginia found herself reaching out to catch her body from hitting the ground, mid-fall, after tripping on the path. Suddenly, a bone in her arm appeared to be dislodged. At first, she didn't realize what had happened, which she now chalks up to pure shock.

"I wasn't close to home when I fell," she recalled. "There was a lump in my arm, but it was numb, and I couldn't feel anything in that area of my arm, which was a really good thing. I don't know how I would have gotten home otherwise."

Her daughter drove her to Scarborough Health Network's (SHN) General Hospital, where she was put in a temporary plaster

She returned to the Fracture Clinic for an evaluation several days later, and discovered the seriousness of her injury. Her wrist was broken into pieces and she would need surgery to repair it—a journey to recovery that could take several months.

In Virginia's case, it would only take one day for her care team to schedule her for an open reduction and internal fixation at SHN's Orthopaedic Trauma Centre at the Scarborough General Hospital.

Scarborough's Orthopedic Trauma Centre delivers dedicated care for urgent cases

Since opening in July, the Orthopaedic Trauma Centre has performed over 500 surgeries, including 300 day procedures. This new centre has been designed for patients like Virginia who don't need a limb-saving surgery, but require an urgent procedure. Instead of waiting at the hospital to go to surgery, patients can be at home while their surgery is scheduled. This means fewer hospital stays and delays in after-hours care.

"We thought, wouldn't it be better if we had

an ambulatory clinic, or outpatient clinic, for orthopaedic trauma injuries like wrist, ankle, clavicle, shoulder, tibia, foot and wrist fractures," said Dr. Warren Latham, corporate chief of orthopaedics and lead surgeon at

"Patients showing up at the emergency department can complete the forms for having a surgery, then return home and wait for our dedicated trauma team coordinator to call them when their surgery is scheduled. We know that kind of definitive care provides for a better patient experience, better patient outcomes, and enhanced quality of patient care."

In the past, patients endured longer waiting periods and were usually placed on an emergency roster waiting for beds to open up.

"If you broke your ankle, for example, you would come to the emergency department. You might go home with a cast and come back to the Fracture Clinic later that week to see an orthopaedic surgeon, who would decide if you needed surgery on your ankle," explained Dr. Latham.

"Then you would have to be admitted. You would be placed on the emergency roster and have your surgery at night."

With the new Orthopedic Trauma Centre, patients receive defined surgical dates, so they know exactly who their surgeon will be; and, with timely access to specialists in sports medicine, hip and knee, upper extremity, spine, and foot and ankle surgery, they will be assigned the best surgeon for their

SHN has also added several resources, including a hospitalist, physician assistant, physical therapist, and trauma team coordinator to further develop the program, while the orthopaedic trauma room enables flexibility for SHN to add elective cases that were previously cancelled during the COVID-19 pandemic.



For Virginia, all these dedicated roles were critical in providing her with a sense of understanding and safety.

"Everyone was so nice. They introduced themselves to me, let me know what to expect, and everyone let me know what their job was going to be during this process," she

Now in physiotherapy, Virginia is on the road to recovery with her wrist and arm getting stronger and gaining more range of motion. Thanks to SHN's Ortho Trauma Centre team, she's looking forward to getting back the independence she has been missing since her fall.

With a little laugh, Virginia remarked, "I can't wait to be able to put on jeans or tights again!"

from SHN's health professionals.

"While I was in the Regional Cardiovascular Rehab program, I had an exercise therapist checking in on me weekly. The seminars that were offered were excellent," she raved. "I am grateful to all the staff at Scarborough Health Network who have helped me in this journey."

But for Pam, that was just the beginning of her journey. Since the scare at the gym, Pam has been committed to helping others living with heart and stroke conditions.

Pam is not only a past stroke patient, but she has since become a member of SHN's Patient Family Advisory Council. In addition, she is an alumni member of the Regional Central East Cardio Program and living each day as a stroke rehabilitation healthcare advocate.

"I've had the journey, I've lived the experiences, and I know what resources are out there," said Pam. "I truly believe that every stroke and heart patient can return to a functional lifestyle with best-in-class healthcare practices from SHN."

With the support of her family, Pam continues to provide as much information and resources to the public as possible. From setting up information booths at her local shopping mall and library, Pam said she is also open to discussions about implementing stroke best practices across the province.

"I am very lucky," remarked Pam. "I can walk, I can talk, I don't have any cognitive issues. Everything is fine and I am grateful to be where I am today."

Others aren't so lucky. Depending on which part of your brain is affected and the amount of damage, the long-term effects of stroke are often devastating with stroke as the third leading cause of death in Canada.

With nearly a quarter of Scarborough's population experiencing high blood pressure, it's not hard to see why SHN hospitals saw 2,352 emergency department visits and 1,810 patients, like Pam, admitted for stroke-related concerns since the Stroke Centre of Excellence opened at Birchmount Hospital in April 2020.

Scarborough's South Asian, African, Indigenous, and seniors' communities are at higher risk for stroke because of the prevalence of diabetes and high blood pressure among these individuals.

That's also why the Stroke Centre of Excellence is so important. With an Integrated Stroke Unit, patients get specialized medical care from a dedicated team and transition into rehabilitation within the same space, without moving from unit to unit. This means less time spent in hospital and a better quality of life when returning home.

Fortunately, nearly 80 per cent of premature stroke and heart disease is preventable through healthy lifestyle behaviours, and the centre's outpatient Stroke Prevention Clinic helps patients manage their risk factors for stroke. Patients are seamlessly cared for by the same all-star team of specialists who support the inpatient unit.

Increasing prospects of Famine in Many

Countries in the World

The world today is faced with the problem of famine. Large segments of the human family suffer daily hunger and agonizing facts of life. It is said that the world's population has way of limiting itself periodically. Diseases, natural disasters and deadly global warfare is expected to expected to bring about deaths of one-fourth of the world's population.

A. Causes of Famine:

For decades, Western relief agencies and the United Nations directed most of their food relief efforts toward famines across Africa. Yet in more recent years, food insecurity has spread to other regions in Asia, Europe, and Latin America. Earlier this year, the UN called world attention to severe food shortages affecting populations in Afghanistan, Haiti, and Yemen. Widespread drought ad lack of rain is not the only causes of modern famines. Severe or erratic weather related to climate phenomena such as La Nina, can bring torrential rains, freezes and tornadoes that damage crops and create food shortages. Wars that drive farmers off the land as in Ukraine reduce food production, disrupt distribution systems, and destroy stored food. Political opponents are often deprived access to food supplies. Access to arable land has become a tool for political influence in some troubled countries, with favoured parties or groups gaining access denied to opponents.

Structural changes foisted on debtor nations by the World Bank or the International Monetary Fund also generate famine conditions in segments of society. Nations that are encouraged to grow cash crops for exports, instead of raising food, often become unable to feed themselves. The displacement of rural subsistence farmers by large corporations also sends many to poverty and starvation in places like India.

B. Human Negligence of the Earth's Resources:

While political and social battles continue over 'climate change'-disputing whether recent climate extremes are just part of a natural cycle or have been worsened by mankind's poor stewardship over the planet the costs of environmental deterioration are severe and must eventually be paid . Allowing used plastics products to get deposited in the waterways and sea can cause severe hazards to fish and other sea based living things. Fish stocks in the world's oceans are in serious decline, devastated by modern factory -fishing techniques. Meat is becoming more and more expensive to produce, leading to the burst of interest in 'plant-based replacements that are being pushed by environmentalists, as well by multi-national corporations seeking to profit from the crisis.

C. Wars and Famine:

Misguided government policies, amplified by drought, have caused famines in the past. They continue in the present with signs of famines getting worse. The Ukraine in 1932-33 saw an estimated five million farmers die because of famine brought about by Soviet leader Joseph Stalinist policy of forced collectivization of farmlands. And how many Ukraine may die even this year because of the food disruptions brought by Putin's invasion. Several farmlands are destroyed and the wheat production that made Ukraine the breadbasket of the world suffered tremendously by the heinous war-crimes

of Vladimir Putin. An estimated 30 million Chinese starved for some of the same reasons during the nation's 'Great Leap forward' in the late 1950's. Though it is difficult to get a reliable figure from the tightly controlled state, some observers estimate that more than three million North Koreans died between 1994 and 1998 because of their government's draconian policies.

D. Famine in Today's World:

Famine is now widespread in many countries of the world including Sri Lanka, India, Pakistan, Ukraine, Brazil, Argentina, Nigeria and South Africa. In Sri Lanka Corrupt Administrators, irresponsible investments and political upheavals have resulted in acute famine in all parts of the country. There is acute shortage of diesel and petrol and many car owners are without any means of using their vehicles. The cost of transport has risen by leaps and bounds. One has to pay Rs.15, 000/- to get to the air-port from Colombo. The cost of a pound of bread has gone up to Rs.150/-. One cannot buy essential commodities easily in the markets. People have been relegated to a position of starvation. One has to survive on rice and dried fish for all three meals. There have been tremendous political agitations to change the government in order to restore better economic conditions to avoid the famine situation. Deaths from malnutrition on a large scale occurred across India in modern times. In Maharashtra alone, for example there were around 45,000 childhood deaths due to mild or severe malnutrition in 2009. Growing export prices, the melting of Himalayan glaciers due to global warming, changes in rainfall and temperature are the major issues affecting India. Farmers in South India were badly affected by excessive rainfall and severe winds recently. In Pakistan, nearly 4.66 million people experienced high level of food insecurity in 2022. Lack of grains export is driving global hunger to famine levels. According to FAO, the food insufficiency in Ukraine increased to an estimated 49 million in 2022. The Ukraine President said that his country was unable to export enough food because of Russia's blockade of the Black Sea ports, which was preventing exports from being shipped to other countries. Ukraine along with Russia is among the largest producers and exporters of wheat and other essential foods like grains like wheat, barley and oils. Egypt and Zimbabwe get forty percent of their wheat imports from Russia and Ukraine. The number of people living in


hunger in Brazil has surged 73 % in the past two years. A recent survey suggests as six in ten Brazilians are struggling to put food on the table. 60% of the country's 125 million population are now unable to get three square meals per day. Argentina is experiencing great food shortage and the numbers suffering increased from 2.5 million to five million in recent times. Organic food grown in rural schools is to implement 500 active projects in Argentina and nearly 43,000 children benefitted from these projects. In North-Eastern province in Nigeria living conditions, malnutrition and widespread displacement due to impact of the on-going conflict between Boko-Haram and the Nigerian military. Gowza, a garrison town in North-East Nigeria is the home of 60,000 people; many of them are displaced from to other places due to the conflict. Living conditions are difficult, there is little humanitarian aid and there are frequent clashes between the military and the armed groups. In South Africa, people need sustainable supply of clean water for drinking, washing, cooking, and cleaning. South Africa is considered as a water-scarce country and is the 30th driest country in the world. Delayed rainfall, decreasing dam levels led drought in two provinces- Kuwa Zulu and Natal Free State. In Cape Town, the city of Cape-Town experienced severe water shortages from 2018 that led to famine conditions.

E. Fighting Famine in the Modern World:

Cooperation between countries and international organizations like the Oxfam can work towards the successful elimination of poverty and famine in the world. Sri Lanka is in Dire Straits finding help with their ailing economy. Only India has helped instantly and the President had requested Russia to help with the import of fuel. International organizations can help the famine areas with provision of clean water, encouraging proper sanitation, distributing food, planting crops, and ensuring government accountability. Timely action should be taken to curtail famine. In 214, more than 250,000 people in Somalia lost their lives when the world ignored repeated warnings after the failure of rains in the region. Many humanitarian organizations are helping with orphaned children in Ukraine. Children are moved to safe areas where they fed and cared for. Medical assessments are made and proper treatment is given to them to heal them.

The Incident on UL Flight 504 London

Colombo On The 15th Of June 2022

This flight departed London, on the 15th of **⊥** June as a normal flight with 297 passengers



and 10 crew members on board an Airbus 330-300. Everything was normal till the flight was over the Turkish air space which is normally a busy air traffic corridor. Ankara air traffic control informed the captain the UL captain to climb to a height of 35,000 feet from 33,000 feet which they were cruising at. The UL crew spotted another aircraft in the vicinity and promptly informed the ATC, but the Controller insisted again to climb. The UL captain did not budge his ground. Once the ATC realized their mistake, informed the UL flight to maintain its height level. This is what actually happened that day without any major mishap to any aircraft. There was a British Airways flight BA105, G-VIIG, Boeing 777 cruising at 35,000 feet, at a faster speed than the UL flight, and was on its way to Dubai, obviously both were on the same course. Once the UL flight landed at KIA. Colombo. the

crew filed an incident report with the authorities in Colombo. Some or other this news had been leaked to the media which went to town saying this "Would have been a major midair collision. It is not superfluous to say that the SL newspapers had spun this incident and made a mountain out of molehill". Even the SL Pilot Fraternity was not happy with the way this was portrayed by the media, which sooner issued a statement clarifying the incident. I am sure this would not have been done intentionally by the crew as some concluded, giving the benefit of the doubt to the crew. Airbus 330-300 is a state of the art aircraft with all modern navigational data systems for smooth flying and an accident free one . There is a unique feature is installed in almost all the aircrafts that was rolled out after 1970. It is mandated by ICAO that all aircraft with a capacity more than 30 passengers to be fitted with this system, called the "Traffic Collision Avoidance System - TCAS or ACAS was invented in 1970, works on a transponder signal sent by the aircraft. It will show the cockpit crew if any aircraft is in the vicinity up to 5 nautical miles in front and back. All the systems in the cockpit are always complement to each other so that one of the pilots could monitor the panels always. TCAS helped the UL pilots to identify another aircraft in the

area thus preventing the calamity.

I like to recall what I saw written on the wall of the flying club at Ratmalana airport on my first ever visit to a facility after joining the airline 1972, with my ex colleague GAF, retired Sri- Lankan Captain, "The sky is safer than the roads" with this in mind, I categorically say that there was no threat of midair collision at any time as said. As in the words of my good friend, retired Flight Engineer, an authority on almost all the avionics equipment, MR. GALB. JANZ, a professional instructor on aviation in Sri Lanka his primary instruction to the aspiring aviators, is" trust the instruments always and to rely on it". Aviation and Flying is always a tussle between man and machine nowadays. Also remember humans are inherently imperfect. I give due credit to the instruments in the cockpit and to the view of the retired flight engineer.

Aviation ME

I recall an incident that happened in 2002 with a DHL aircraft and a BAL, Bashkirian Airlines Flight 2937, a TU-154 passenger jet, and DHL International Aviation ME flight 611, a Boeing 757 freighter, collided in midair over Uberlingen, Germany, a southern German town on Lake Constance, near the Swiss border, resulting in

the death of 71 passengers from both the aircrafts. The investigators confirmed the cause to have been the confusion over the instructions provided by the pilot and TCAS. DHL crew followed



the instructions of the TCAS, since not being instructed by the ATC. However Tupoley's crew disregarded TCAS instructions and struck with the area ATC instructions. ATC expected one flight to ascend and the other to descend but unfortunately both the aircrafts descended and caused second deadliest midair collision in the aviation history. I would like to travel little further on this unfortunate incident. May be two years after this horrific crash, Peter Nielsen, the air traffic controller that day, I believe a Swiss national, was tracked down by a Russian citizen Vitaly Kaloyev, and was murdered in his apartment as a revenge killing, for the death of his wife and two children who were on that unfortunate BAL flight. It was a really sad story indeed. This incident resulted in a new aviation rule in commercial flying, the TCAS command had to be given priority over the ATC instructions. Based on this incident it is hard to comprehend the reliance on the system too. But again one in a million chance of this occurring.

I like to mention in the good old days, an aircraft in flight was controlled by humans but nowadays is done by pilots typing instructions in to a complex system of computers. The humans and the machine do the job differently. The beauty of it, the human will adapt to the situation. The industry tries to blend the new technology and human qualities to intertwine in the right way so that the safety is ensured at all times. Human fallibility may sometimes lead to disaster but the resiliency always saves the day. I remember reading this in a book "pilots interrupt errors, oversights and reshuffle priorities, they avert problems almost on nearly every flight, without the passengers even knowing that there is something amiss.

On the strength this statement I am privileged and humbled to say that the Vigilante of the Sri Lankan's pilots should be commented and lauded, even though the fraternity may differ, saying it is "Professionalism" and a duty. When a pilot makes an error or causes accident or incident, it is front page news all over the media. I strongly believe that this Particular captain and his copilot should be commented as an English idiom goes, Give The Devil His Due, whether they followed the Protocols or not. I could not conceal my laughter when I read my ex colleague's GAF's article on this issue "professionalism and protocol". I wonder whether if it was followed to its letter in the same establishment previously? I thank them personally for being vigilant. Often we hear that the crew was not alert or asleep in the cockpit many a times nowadays recently an Italian airline.

Answering questions: "I can see where my children are in their lives; my 'picture' has been ripped apart by them." I have responsibility as their father to ensure they're on good tracks. How do I do this?

All right, interesting question. You are with your children in this lockdown and you're seeing that they're not what you thought you were raising. Okay, so let me just try to answer this question. Are your children a product of you telling them how they should be—or do you include them in the decisions that you make for them?

Do you solicit their help by posing what it is that should happen—and explaining to them why that should happen? And asking them for their solutions, for their help to accomplish it. And not only ask them for their solutions, but help them accomplish this; take their advice in stride; accept their advice.

So, so with your children, you tell them what to do—and you expect them to do it. With your friends, however, you do exactly what I told you before, which is you sit down with them; you explain your problem—and

don't do things in a way where they're included in coming up with the solution....

I have seen kids come up with solutions, that cannot even talk properly yet, that young. You just have to ask them, "So, what do you think; how do you think we should do it?" And they will come up with it, you know, "What can we do."

Even if the child is not doing well in school, it's like, "Well, you know, what would it take to start helping you get better at school?" And take their advisement; they'll think about it. Are they not capable of thinking? They are absolutely capable of thinking—and believe me, you'll be surprised; you will be very, very surprised.

So, please, first of all, give some respect to your children—if you want some respect from them—and include them in your decision-making process.

You know, don't become like this, you know—not all politicians are bad but some politicians, you know, they show up—they'll bend over backwards when they want your vote. And then after that, they'll slap you (for I don't know, for whatever the reason is). So, don't become that; don't become that. Be a father. That's what a father means, fathering.


You're a father; you're not a dictator;

Now, it's going to take a little time. Your children are not going to come up with perfect answers the first day—because they don't know. They have to trust you. But do not underestimate your children. Don't think of them as idiots, because you are the father.

So, give them the respect—and they will give you the respect. It takes to give respect to get respect. It takes two to come to the same conclusion for something to move forward.

So, ask them for their advice: "How would this happen; how could this happen?" That's exactly what you do when you go to the hospital. You go to the doctor and you say, "Doctor, my arm is hurting. What could I do to help it?" And then the doctor gives you the advice and you accept the advice.

If the doctor tells you, "I'm going to cut off your arm," and you go, "Well, no, it's just a little scratch. And you know, why do you want to cut off my arm?" And he goes, "Well, I like cutting arms off; thank you," you would say, "No, I don't like you as a doctor; I'm going to go find somebody else."

It takes that trust that you have to form with your family, with your wife, with your children. You want to be the dictator of your family. But believe me, your empire isgoing to backfire.

You, right now, (I don't know how old your children are), but if you're talking about just ripping down the pictures, listen, your entire empire is going to get ripped apart—if you

you're not a slave-owner. You're not there to produce slaves for yourself. You're a father—and fathering means to help your children understand the process of decision-making, of all those things that it takes to be.

And I just see that so many people have created, you know, an impossible task in front of them—because they don't want to, you know, "include, include"—because when you do, then you have a team. When your family—not only then you have a family, but you have a family team.

And when you have that team, then you have teamwork that's going on. And it is wonderful; it's just great. And that teamwork can be so lovely, can be so beautiful. So, that's what you have to work on. So I hope this makes sense.

Question: "Have you any words of inspiration"— this is from Victoria—"Have you any words of inspiration to help me take control of my day please?" Yes. Be confident. Understand what this control is.

f Buddhists take refuge in three different expressions of the awakened mind; the first being Buddha, next Dharma and finally Sanga. Each of these is a precious and necessary element of the Buddhist path, and so they are called the three Gems of the religion. Like wise Valluvar philosophy too has three gems which let's consider in detail.

Hunger and carnal-desire are basic to the survival of all living beings. However, humans who have the sixth sense mind, have developed and established many institutions of which family is the basic institution. These institutions have to interrelate with one another. The duties to be performed as a householder, Thiruvalluvar called it as householders' virtue, and those who wished pursue the path of austere as ascetic virtue. In this multi establishment society to satisfy hunger and carnal-desire all living beings need wealth. The pursuit of wealth and pleasure is based on the foundation of virtue. Thus, the three sections of Thirukkural are Virtue, wealth and pleasure. Let us look at what he has to say about how these paths could be acquired and which is the gem in each section.

Virtue: This is the first section in Thirukkural. For humanity to thrive and exist virtue is the foundation on which the other two are built. As humans are social animals there is the need for interaction with one another. Such a relationship must be based on ethics. The first section of Thirukkural is Virtue, for it is the foundation of the structure of humanity that has to been built. In it he has thirty-eight chapters with 380 couplets. Has also given two options to follow. One is give n the option to lead a householder's life and secondly ascetic life. Thiruvalluvar deals with both of them and gives the code of ethics for both in the section on virtue.

Let's get a look at the gem of this section. When dealing with fellow humans we find many times one tends to find fault with the other. When two get together they tend to twist or exaggerate the other's faults. There is an excellent Tamil acronym which says, "One cannot see his own rear side'.

Humans are a mixed basket of good and bad people. One has to judge and accept the good one, discarding the bad, says Thirukkural. Before a person finds fault on others he should analyse and see what faults he himself has and get rid of it and then try analysing others. This is the primary virtue suggested by Thiruvalluvar.

If all human beings follow this virtue there will be no cause for enmity among people. No cause for war between nations. There is no need to walk towards the destruction of humanity. Even in politics there is no cause for enmity. The valuable time will be spent in correcting their own mistakes and no time before time used to correct others. Further there will be awareness that others are also like self with shortcomings. With such thought they will become blind to other's shortcomings. There is no place for someone who wants to oppose everyone in society.

The gem of all these ideas is condensed in a tweet like couplet #190 with seven words only as follows in the section of Virtue;

> If each his own, as neighbours' faults would scan, Could any evil hap to living man? ஏதிலார் குற்றம்போல் தங்குற்றங் காண்கிற்பின் தீதுண்டோ மன்னும் உயிர்க்கு.

This is the panacea given by St. Thiruvalluvar for all the evils of the world is the first gem. Now that we have the gem of virtue in our heart the poet gives the next gem in the section of wealth. Without wealth

nothing could be achieved in this world.

Wealth: There are 34 chapters with 340 couplets in this section. In couplet 751 of this section Thiruvalluvar says that nothing exists save wealth, that can change man of nothing to a worthy man. Procuring wealth should be done in a virtuous way for it to be worthy. In the process of procuring wealth the social circle widens. He is forced to interact with others when he tries to earn wealth in community living. One should first learn how to earn wealth and develop that ability. With the ability gained applied in the proper virtuous way wealth should be accumulated. They should earn by their own initiative. Even a simple meal earned by one's own effort would taste better than any other food. Wealth is obtained from the society the person belongs to and he will have to fit into it. Thirukkural gives various aspects of social living from education, friendship, to royalty, ministerial duties even going up to all the way espionage etc.!

Anyone who has earned their wealth by their own effort and by just means will benefit from what he gained. Those who made wealth by virtuous means need not fear anyone. Ill gotten wealth will bring misery and sadness to their life. They will not be able to enjoy the jewel of wealth.

The gem in the section on wealth is, that what is obtained by true hard work, and own ability at the same time should not be unjust to others will bring happiness in their life. If life should gain the gm of wealth must be obtained by virtuous means causing no injustice to fellow humans. In couplet 754 St. Thiruvalluvar says:

> Their wealth, who blameless means can use aright, Is source of virtue and of choice delight. அநன்ஈனும் இன்பமும் ஈனும் திறனநிந்து தீதின்றி வந்த பொருள்.

Having gotten the two gems, let's look into the third gem in human life. It is none other than Pleasure. It is the fundamental cause for procreation. The desire for carnal-pleasure is boundless, as it is the driving force of proliferation.

Pleasure: For the world to continue reproduction is fundamental. It is a desire given to all living beings. Till the person is young and strong the desire is there for pleasure. Humanity created the institution of family for this purpose. Thiruvalluvar discusses the carnal relationship in two stages. Before marriage and starting a household and after marriage. Thirukkural couplet # 45 he says if love and virtue is there in a couple, then it is a life of perfect grace and gain. And further on the 50th couplet he says if one leads a virtuous householder's life he will be placed among God after death.

However, as a person ages though the desire for carnal-pleasure may wane away. Thiruvalluvar says the closeness and friendship should not ebb away between husband and wife. It should be like the bond between soul and body to enjoy the gem of pleasure fully. Only death should take them apart. Love is also a form of friendship happening between man and woman. On couplet #1122 he says as follows:

Between this maid and me the friendship kind Is as the bonds that soul and body bind உடம்பொடு உயிரிடை என்னமற்று அன்ன மடந்தையொடு எம்மிடை நட்பு

In 1330 couplets the poet has provided the three Jewels amply explained for humanity to read and benefit. Let's enjoy the three gems to the fullest by reading a Thirukkural.


While the Tamil diaspora community continues to adjust to its new environment, temples will proceed to provide the foundation to leap from and assist in building prosperous lives for generations to come.

Bharathanatyam, an ancient classical dance form stemming from Hindu temples in Southern India, has achieved such an incomprehensible feat. making it easy to understand the flow of the stories.





Val-Morin in Quebec the Subramanya Ayappa temple reopens every year in

the month of April after the winter season. During winter the deities are shifted

from the ashram to the Krishna temple.

Founded in 1963 by Swamy Vishnu- Devananda the ashram attracts people from

all over the world to practice yoga, meditate or pray at the temple connected to the ashram with a long wooden staircase.

For two weeks every summer Hindu devotee from Montreal, Ottawa and Toronto

arrive and take part in these religious activities. Some devotees even come from as far

as Western Canada, United States, Europe and Sri Lanka. They arrive for the annual Kavadiceremony, the largest Hindu festival in North America.

The Kavadi ther (chariot) festival is celebrated every

year in July. Taking part in the kavadi festival is considered as the ceremonial sacrifice performed by devotees of Lord Subramanya. The kavadi bearer goes through strict austerities for purification of the

body and mind.

During the festival Lord Subramanya is brought out of the temple and taken in a procession through the town of Val-Morin in a wooden chariot beautifully designed

with carvings. Vehicles arriving late are blocked from approaching the temple as such devotees had to alight from the vehicles and move forward on foot.

Every year on July 9th the anniversary of the day the deities were first installed in the temple is celebrated with Pooja's and other festivities. The temple inaugurated in 1994 attracts thousands of devotees throughout the year from all cultures and nationalities. It was heart-warming to see devotees distributing meals they had cooked to other devotees after the Pooja ceremony. After partaking the lunch the devotees leave the temple fully satisfied and spiritually enlightened.



The James Webb May Have Found the Oldest Galaxy

Why are James Webb's images such a bigger deal than Hubble's?

NASA has finally revealed mind-blown first Aimages from the space-based observatory from the James Webb Space Telescope (JWST) on Monday, July 11, 22. What makes this image so mind-blowing is how small it is and how large it is at the same time. It's small because this image represents only a tiny portion of the night sky. Imagine you are holding out a grain of sand at arm's length. The area of the sky that grain covers. While it appears to us as a flat image, this image reveals the depths of the universe and is a window via time. JWST also makes measurements about what elements those early galaxies are composed of. An image like this is similar to a core sample of sedimentary rock. It shows the evolution of the universe over time in its many layers.

JWST has found a galaxy that existed 13.5 billion years ago. It is known as GLASS-z13. The Universe dates back to 300 million years after the Big Bang, about 100 million years earlier than anything previously identified, Rohan Naidu of the Harvard Center for Astrophysics told AFP. "We're potentially looking at the most distant starlight anyone has ever seen," he said.

It takes longer for more distant objects' light to reach us, so to gaze back into the distant Universe is to see into the deep past. GLASS-z13 was spotted in so-called "early release" data from the orbiting observatory's main infrared imager, NIRcam. When translated from infrared into the visible spectrum, the galaxy appears as a blob of red with white in its center, part of a broader image of the distant cosmos called a "deep field."

JWST vs HST

JWST conveys a vast improvement over the powers of the Hubble Space Telescope (HST), which,



until the launch of the JWST, was the largest observatory in space. HST's mirror is an impressive 7.8 feet in diameter. JWST's beautiful, gold-hued mirrors combine for a diameter of 21.3 feet. Overall, that amounts to more than six times the light-collecting area, and when it comes to telescopes, more light collecting equals more detail. You can already see the improvements JWST brings over the HCT

The JWST's other advantage over HST is the type of light it collects. Light comes in a lot of different varieties. The human eye can see only a narrow band known as visible light. Still, the universe contains lots and lots of light outside this range, including the higher-frequency, higherenergy forms: ultraviolet light and gamma rays. Then there's the lower-energy light with longer wavelengths: infrared, microwaves, and radio. The HST collects visible light, ultraviolet, and some infrared. The JWST is primarily an infrared telescope, so it sees the light in a longer wavelength than our eyes can see. Infrared light is less obscured by cosmic dust, so the JWST can reveal more stars in this region than the HST could. This seems nerdy and technical, but it allows JWST to look farther back in time than the HST.

Infrared light is often ancient light due to a phenomenon called redshifting. When a light source moves away from a viewer, it gets stretched out, transforming into a longer and longer wavelength, growing redder. It's similar to what happens to the sound when an alarm goes by. The pitch increases as the alarm approach, then decrease as it paths away. Because space constantly expands, the farthest things from us in the universe are moving away from us, their light growing redder and redder before eventually dropping into the infrared spectrum. Infrared is invisible to human eyes, but Webb can capture it in glittering detail.

More Images from JWST

NASA released even more images the next day, showing its impressive capabilities. JWST spots a quintet of galaxies. "JWST shows never-before-seen details in dis galaxy group," NASA relays. "Sparkling clusters of millions of young stars and starburst regions of fresh star birth grace the image." The Carina Nebula is an area of star




formation. "Webb reveals emerging stellar nurseries and individual stars that are completely hidden in visible-light pictures," NASA explains.

JWST observes the remains of a dying star in the Southern Ring Nebula, another stunning image. On the left, the nebula is captured in the near-infrared, and on the right, it is captured in the mid-infrared, each bringing out different details of this disaster. The dim star in the center has been "sending out

rings of gas and dust for thousands of years in all directions," NASA writes.

Work to be done

JWST can find the earliest galaxies formed after the Big Bang, 13.8 billion years ago. The earliest galaxies are so distant from Earth, requiring time for light to reach us. It has been stretched by




the expansion of the Universe and shifted to the infrared region of the light spectrum, which JWST is equipped to detect with unprecedented clarity.

"We searched all the early data for galaxies with dis very striking signature, and these were the two systems that had by far the most compelling signature," said Naidu. One of these is GLASS-z13, while the other, not as ancient, is GLASS-z11. "There's strong evidence, but there's still work to be done," said Naidu.

The team wants to ask JWST's managers for telescope time to carry out spectroscopy – an analysis of light that reveals detailed properties – to measure its precise distance. "Right now, our guess for the distance is based on what we don't see – it would be great to have an answer for what we see," said Naidu. The team has detected surprising properties. For instance, the galaxy is the mass of a billion Suns, which is "potentially very surprising, and that is something we don't understand" given how soon after the Big Bang it formed, Naidu said.

Astronomers are confident that JWST will proclaim a new era of discovery. This is just the beginning of JWST's scientific mission. In the future, scientists hope to use it to see the first galaxies and farther back in time, which held the very first stars and a period called "cosmic dawn," when the cosmos evolved transparent to starlight for the first time. JWST will help them know the end of the dark ages when no light reaches from there and figure out what caused this fog to lift, escorting in the cosmic dawn. This is just the beginning. There's so much more to see.






Ali Sabry Sri Lanka's new Foreign Minister

Shrimp curry with

moringa leaves

Murungai keerai, popularly known as moringa leaves are rich in Iron and help reduce inflammation, blood sugar levels and are rich in amino acids and antioxidants. Here is a recipe you could try making to enjoy the benefits of this superfood.



Ingredients:

- ✓ 500g shrimp, cleaned and deveined (eraal)
- → 1 bunch of moringa leaves, washed, cleaned and roughly
- ✓ chopped (murungai keerai)
- ✓ 2 tbsp Sri Lankan curry powder (kari thool)
- ✓ ¾ tin of coconut milk (thengaai paal)
- √ ¼ tsp turmeric (manjal)
- ✓ 1 tbsp coriander powder (malli thool)
- ✓ 1 tsp garam masala
- ✓ ¼ tsp mustard seeds (kadagu)
- ✓ ¼ tsp cumin seeds (seeragam)
- √ ¼ tsp fennel seeds (perunseeragam)

- √ 1 lemongrass stalk, cut into thirds and lightly bruised
- ✓ 1 pandan leaf, cut into smaller strips (rampe)
- ✓ 2 pink onions, diced (vengaayam)
- ✓ 4-5 cloves garlic, minced (poondu)
- ✓ 2 tbsp gingelly oil (nallennai)
- ✓ 1 knob ginger, minced (inji)
- ✓ Curry leaves (karuveppillai)
- ✓ 2 tomatoes, diced (thakaali)
- ✔ Water, as needed (thanni)
- ✓ Salt, to taste (uppu)
- √ ¼ tsp ground black pepper (milagu)
- √ ½ lemon, juiced (elumichai pazham)

Method:

In a medium sized pot on a medium flame, add mustard seeds, cumin seeds and fennel seeds to warmed gingelly oil. When the mustard seeds start to splutter, add onions, garlic, ginger, pandan, lemongrass and curry leaves and stir. Cook this until the onions become translucent. At this stage, add tomatoes, mix once and cover with a lid for 2-3 minutes. When the tomatoes have softened, add turmeric, Sri Lankan curry powder, salt, coriander powder, garam masala and stir well. Add the moringa leaves, mix again and close the lid for 2 minutes. Check the consistency after this time has passed; if the pan looks dry, add more water. Keep stirring every 5 minutes for a total of 10 minutes, until the moringa has cooked down, making sure the pan is not too dry. When the moringa has cooked well, add prawns and coconut milk and stir again so that all elements of the dish are incorporated. Close the lid and let this cook for 4-5 minutes. depending on the size of your shrimp. To finish off, add ground black pepper, lemon juice and check for salt. Once you are happy with all the levels, the dish is done.

In this context, gathering the facts from reliable sources and making them available at the right time is indisputably a challenging and daunting task. Yet Thiru with a far reaching vision set upon this journey with great determination and signalling fo the for the future.

Thus, a somewhat mini version of Tamil equivalent of Readers Digest was born in this great western nation. It is remarkable that this unique publication is able to maintain its credibility and trust-

dazzled by the immense value of its contents and began to make use of them to their great advantage. It was a time many of the newly arrived people were unable to read the sign boards, unable to find the right number of the bus or the routes and unable to make effective use of the telephone.

Some of them faced big trouble in finding a family doctor or locating a school to admit their children. Just like any new immigrant in any part of the world, the needs of these newcomers began increasing daily. Thus every one of them were more than happy by the timely arrival of this great publication.

That was thirty years ago. Since then much water has flown under the bridge.

Meanwhile this valuable guide journal began to evolve rapidly and its





SUBRAMANIA BHARATHIYAR POET, FRREDOM FIGHTER AND A REFORMER

INTRODUCTION

ubramania Bharathiyar, was born as Chinnaswami Subramia, at Ettayapuram (present day, Thoothukudi) on December 11, 1882, to Chinnaswami Subramania Iyer and Lakshmi Ammal. Bharathi had his early education in Tirunelveli and Varanasi. From a very young age, he was musically and poetically inclined. Bharathi lost his mother at the age of five and was brought up by his father who wanted him to learn English, excel in arithmetic, and become an engineer.

EARLY YEARS

Bharati became a Tamil scholar at an early age. He received little formal education, however, and in 1904 he moved to Madras (now Chennai). There he translated English into Tamil for several magazines and later joined the Tamil daily newspaper Swadesamitran. and worked as a journalist with many newspapers, including The Hindu, Bala Bharata, Vijaya, Chakravarthini, the Swadesamitran and India.

A SOCIAL REFORMER AND A FREEDOM FIGHTER

He was a Tamil writer, poet, journalist, Indian independence activist, social reformer and polyglot. Popularly known as Mahakavi Bharathi (Great Poet Bharathi), he was a pioneer of modern Tamil poetry and is considered one of the greatest Tamil literary figures of all time. His numerous works included fiery songs kindling patriotism during the Indian Independence movement. He fought for the emancipation of women, against child marriage, stood for reforming Brahminism and religion. He was also in solidarity with Dalits and pioneered for equality amongst all castes of Hindus. He was against caste bias. In 1908, an arrest warrant was issued against Bharathiar by the government of British India and that made him to move to Pondicherry where he lived until 1918.

His influence on Tamil literature is phenomenal. Although it is said that he was proficient in around 14 languages including 3 non-Indian foreign languages. His favorite language was Tamil. He was prolific in his output. He covered political, social and spiritual themes. The songs and poems composed by Bharathi are very often used in Tamil cinema and have become staples in the literary and musical repertoire of Tamil artistes throughout the world. He paved the way for modern blank verse. He wrote many books and poems on how Tamil is beautiful in nature. His poetry is known for its appeal to the liberty and strength of the people.

A proficient linguist, he was well-versed in Sanskrit, Hindi, Telugu, English, French and had a smattering of Arabic. Around the age of 11, he was conferred the title of *Bharathi*, the one blessed by *Saraswati*, the goddess of learning by the Raja of Ettayapuram seeing his excellence in poetry. He lost his father at the age of sixteen, but before that when he was 15, he married Chellamma who was seven years old.

During his stay in Varanasi, Bharathi was exposed

to Hindu spirituality and nationalism. This broadened his outlook and he learned Sanskrit, Hindi and English. In addition, he changed his outward appearance. He also grew a beard and wore a turban due to his admiration of Sikhs, influenced by his Sikh friend. Though he passed an entrance exam for a job, he returned to Ettayapuram during 1901 and started as the court poet of Raja of Ettayapuram for a couple of years. He was a Tamil teacher from August to November 1904 in Sethupathy High School in Madurai. During this period, Bharathi understood the need to be well-informed of the world outside and took interest in the world of journalism and the print media of the West. Bharathi joined as Assistant Editor of the Swadesamitran, a Tamil daily in 1904. In December 1905, he attended the All-India Congress session held in Banaras. On his journey back home, he met Sister Nivedita, Swami Vivekananda's spiritual heir. She inspired Bharathi to recognize the privileges of women and the emancipation of women exercised Bharathi's mind. He visualized the new woman as an emanation of Shakti, a willing helpmate of man to build a new earth through co-operative endeavour. Among other greats such as Bal Gangadhar Tilak, he considered Sister Nivedita as a Guru, and penned verses in her praise. He attended the Indian National Congress session in Calcutta under *Dadabhai* Nowroji, which demanded Swaraj and boycott of British goods.

In 1908, the British instituted a case against V.O. Chidambaram Pillai. In the same year, the proprietor of the journal India was arrested in Madras. Faced with the prospect of arrest, Bharathi escaped to Pondicherry, which was under French rule. From there he edited and published the weekly journal *India*, *Vijaya*, a Tamil daily, Bala Bharatham, an English monthly, and Suryodayam, a local weekly in Pondicherry. The British tried to suppress Bharathi's output by stopping remittances and letters to the papers. Both the weekly journals, India and Vijaya were banned in India in 1909.

During his exile, Bharathi had the opportunity to meet many other leaders of the revolutionary wing of the Independence movement like Aurobindo, Lajpat Rai and V.V.S. Aiyar, who had also sought asylum under the French. Bharathi assisted Aurobindo in the Arya journal and later Karma Yogi in Pondicherry. This was also the period when he started learning Vedic literature. Three of his greatest works namely, Kuyil Paattu, Paanchaali Sapatham and Kannan Paattu were composed during 1912. He also translated Vedic hymns, Patanjali>s *Yoga* Sutra and Bhagavat Gita into Tamil. Bharathi came out of Pondicherry near Cuddalore in November 1918 and was promptly arrested. He was imprisoned in the Central prison in Cuddalore in custody for three weeks from 20 November to 14 December and was released after the intervention of Annie Besant and C.P. Ramaswamy Aiyar. He was stricken by poverty during this period, resulting in his ill health. The following year, 1919, Bharathi met Mohandas Karamchand Gandhi. He resumed editing *Swadesamitran* from 1920 in Madras (the present-day Chennai)

Bharathi is considered one of the pioneers of modern Tamil literature. Bharathi used simple words and rhythms, unlike previous century works in Tamil, which had complex vocabulary. He also employed novel ideas and techniques in his devotional poems. He used a metre called Nondi Chindu in most of his works, which was earlier used by Gopalakrishna Bharathiar.

He is known to have said, "Even if Indians are divided, they are children of one Mother, where is the need for foreigners to interfere?" In the period 1910–1920, he wrote about a new and free India where there are no castes. He talks of building up India's defense, her ships sailing the high seas, success in manufacturing and universal education. He calls for sharing amongst states with wonderful imagery like the diversion of excess water of the Bengal delta to needy regions and a bridge to Sri Lanka.

The exposure to political affairs led to his involvement in a faction of the Indian National Congress party that favoured armed resistance against the British Raj.

As a result, he was forced to flee Pondicherry (the present Puducherry), a French colony, where he lived in exile from 1910 to 1919. During this time Bharati's nationalistic poems and essays were extremely popular. Bharati's best-known works included *Kannan* paattu (1917; Songs to Krishna), Paanchaali sapatham (1912; Paanchaali's Vow), and Kuyil paattu (1912; Kuyil's Song). Many of his English works were collected in Agni and other Poems and Translations and Essays and other Prose Fragments (1937). Kuyil Paattu was translated in Japanese by Shuzo Matsunaga (8 October 1983).

Subramanya Bharathi was a Tamil poet, reformer and freedom fighter during the pre-independence era. His used the adeptness at poetry to the best of his ability to coax the masses in the south to join the great Indian struggle for independence. Bharathi's name is counted amongst the

most celebrated bards of the country. Subramanya Bharathi was a Tamil poet, reformer and freedom fighter during the pre-independence era. Also referred to by the name of Mahakavi Bharathiyar meaning, Great Poet of Tamil. Bharathi's name is counted amongst the most celebrated bards of the country. He was an expert at both prose and poetry and used these to the best of his ability to coax the masses in the south to join the great Indian struggle for independence. His time was the most eventful one in the history of India and his contemporaries included the likes of Mahatma Gandhi, Bal Gangadhar Tilak, Sri Aurobindo and V.V.S. Aiyar. Subramanya Bharathi, got attracted to the Hindu spirituality and nationalism during his stay at Varanasi. In 1905, he attended the meeting of the All-India National Congress and on his return also got the opportunity to meet Sister Nivedita, the spiritual daughter of the great Indian philosopher and thinker, Swami Vivekananda. Subramanya Bharathi felt very impressed on meeting Sister Nivedita and this proved to be a crucial turning point in the life. Bharathi began to publish his poems regularly and the themes often delved from complex religious hymns to rousing nationalist sentiments to songs on the Russian and French revolutions. He was simultaneously against social poverty, exploitation and abuse of the downtrodden people and the British ruling over the country. Though he lived a life of utter poverty, he was always positive in his thoughts and action.

His national integration songs earned him the title Desiya Kavi (National Poet). He composed Tamil keertanais on love, devotion, fearlessness, mysticism. His stepbrother C. Vishwanaata Aiyyar and V.V.S. Aiyyar tell us that he himself set his songs to music and could sing them well in a variety of raagas. In Bharata deviyin tiru dasangam, he used 10 raagas. His patriotic songs emphasize nationalism, unity of India, equality of man and the greatness of the Tamil language, set himself to folk tunes. He sang these himself at Congress meetings at the Madras beach. In an article in Sangeeta Vishayam (Issues in Music), Bhaaratiyaar rebukes musicians for singing songs of the Trinity, Patnam Subramania Aiyyar and others without knowing the meaning because the songs are all in Sanskrit or Telegu. Without knowing the meaning, singers are unable to sing with proper expression. He also says songs usually portray devotion and love and not about other emotions like courage, anger, wonder, fear, and hatred. He emphasized that musicians should not sing songs which they don't understand and should learn from Hindustani musicians how to train their voices. Bharathi is considered as a national poet due to his number of poems of the patriotic flavour through which he exhorted the people to join the independence struggle and work vigorously for the liberation of the country. Instead of merely being proud of his country he also outlined his vision for a free India. He published the sensational *Sudesa Geethangal* in 1908. In his early days of youth, he had good relations with Nationalist



Tamil Leaders like V.O.Chidambaram, Subramanya Siva, Mandayam Thirumalachariar and Srinivasachari. Along with these leaders he used to discuss the problems facing the country due to British rule. Bharathi used to attend the Annual sessions of Indian National Congress and discuss national issues with extremist Indian National Leaders like Bipin Chandra Pal, B.G. Tilak and V.V.S. Iyer. His participation and activities in Benaras Session (1905) and Surat Session (1907) of the Indian National Congress impressed many national leaders about his patriotic fervour. Bharathi had maintained good relations with some of the national leaders and shared his thoughts and views on the nation and offered his suggestions to strengthen the nationalist movement. Undoubtedly, his wise suggestions and steadfast support to the cause of nationalism rejuvenated many national leaders. Thus, Bharathi played a pivotal role in the freedom of India. The emancipation of women exercised Bharathi's

mind greatly. Bharathi visualised the 'new woman' as an emanation of Shakti, a willing helpmate of man



to build a new earth through co - operative endeav-During this period, Bharathi understood the need to be well - informed of the world outside and took interest in the world of journalism and the print media of the West. Bharathi joined as Assistant Editor of the Swadeshamitran, a Tamil daily in 1904. Bharathi participated in the historic Surat Congress in 1907, which deepened the divisions within the Indian National Congress between the militant wing led by Tilak and Aurobindo and the moderate wing. Bharathi supported Tilak and Aurobindo together with V. O. Chidambaram Pillai and Kanchi Varathaachariyar. Tilak openly supported armed resistance against the British. In Madras, in 1908, Bharathi organised a public meeting to celebrate Swaraj (independence) Day. His nationalistic poems Vanthe Matharam, Enthayum Thayum and Jaya Bharath were printed and distributed free to the audience. Bharathi is referred to as the National Poet of India.

In 1908, Bharathi gave evidence in the case which had been instituted by the British against V.O. Chidambaram Pillai. In the same year, the proprietor of the journal India was arrested in Madras. Faced with the prospect of arrest, Bharathi escaped to Pondicherry which was under French rule. From there he edited and published the weekly journal India, Vijaya, a Tamil daily, Bala Bharatha, an English monthly, and Suryothayam, a local weekly of Pondicherry. The British tried to suppress Bharathi's output by stopping remittances and letters to the papers. His poetry expressed a progressive, reformist ideal. His imagery and the vigour of his verse symbolise Tamil culture in many respects. Bharathiyaar famously espoused greater freedom and respect for women: will destroy the idiocy of denigrating womanhood. "Bharathi also fought against the caste system in Hindu

society. Although born into an Orthodox Brahmin Family, he gave up his own caste identity. One of his great sayings meant, 'There are only two castes in the world: one who is educated and one who is not.' considered all living beings as equal and to illustrate this he even performed upanayanam to a young harijan man and made him a Brahmin. Bharathi also scorned the divisive tendencies being imparted into the younger generations by their elderly tutors during his time. Bharathi openly criticised the preachers for mixing their individual thoughts while teaching the Vedas and the Gita.

SUBRAMANYA BHARATHI LANGUAGE

Bharathi was devoted towards his mother tongue Tamil language and was proud of its heritage. Bharathi was fluent in many languages including Telugu, Bengali, Hindi, Sanskrit, Kutchi, French and English and frequently translated works from other languages into Tamil. Bharathi had a voracious appetite for learning ancient and contemporary Tamil literature especially ancient poems. Mahakavi has delivered his last speech at Karungalpalayam Library in Erode, which was about the topic Man is Immortal. The last years of his life were spent in a house in Triplicane, Chennai.

DEATH

He was badly affected by the imprisonments and by 1920 when a General Amnesty Order finally removed restrictions on his movements, Bharathi was already struggling. He was struck by an elephant named Lavanya at Parthasarathy temple, Triplicane, Chennai, whom he used to feed every day. When he fed a coconut to Lavanya (the elephant), the elephant got fired up and attacked Bharathi. Although he survived the incident, his health deteriorated few months. He died early morning on 12 September 1921 at around 1 am. Though Bharathi was considered a people's poet, a great nationalist, outstanding freedom fighter and social visionary, it was recorded that there were only 14 people to attend his funeral. He delivered his last speech at Karungalpalayam Library in Erode, which was about the topic Man is Immortal. The last years of his life were spent in a house in Triplicane, Chennai. The house was bought and renovated by the Government of Tamil Nadu in 1993 and named Bharathi Illam (Home of Bharathi).

INDIAN PM MODI'S THOUGHTS ON BHARATHIYAR

Prime Minister Narendra Modi recalled Bharati's rich scholarship and multi-faceted contributions to the nation, while also hailing his ideals on social justice and women empowerment. India is proud to be home to the world's oldest language, Tamil. On the 100th punya tithi (anniversary) of Subramania Bharati, (I am) honoured to announce the setting up of Subramania Bharati Chair of Tamil studies at Banaras Hindu University, in Kasi said the PM after inaugurating the Sardardham Bhavan in Ahmedabad via video conferencing. Importantly, the announcement by the PM came a day after the Tamil Nadu government declared that the poet's death anniversary will be observed as Mahakavi day. The philosophy of Ek Bharat, Shreshtha Bharat envisioned by Sardar Vallabhbhai Patel has been shining with full divinity in the Tamil writings of Mahakavi Bharati, PM said in his address. He noted that Bharati drew inspiration from Swami Vivekananda and was influenced by Sri Aurobindo. Prime Minister Narendra Modi paid tributes to Tamil poet and writer Subramania Bharati on his 138th birth anniversary as he addressed the International Bharati festival. Lauding his work as *fearless*, PM Modi said that today's youth can learn so much from Bharati's work, especially being courageous. One can only marvel at his work, poems, philosophy and his life, said PM Modi. He also said, Mahakavi Bharathiyar's definition of progression had a central role for women. One of the most important vision was that of independent and empowered women. He wrote that women should walk with their head held high while looking people in the eye. We are inspired by Bharathiyar's vision of independent and empowered women and we are working to ensure women-led empowerment, said PM Modi. The prime minister quoted a few lines from the works of the revered poet. He read out the lines in Tamil and also the translation in Hindi. "Several years before our independence, Bharati had dreamt of a vision for India. He had said that India would show the whole world a way to get rid of all kinds of bondage".
