# CANADA NEWS Subscription Canada accepting so many immigrants?

As of 2021, "people who were, or had ever been, a landed immigrant or permanent resident in Canada" — grouped together for simplicity as "immigrants" — represent 23% of this country's total population, the highest proportion recorded since Confederation in 1867.

The highest among all G7 countries, Canada has also now topped its previous record set in 1921, when immigrants made up 22.3% of the country's population.

According to population projections from Statistics Canada, if current demographic trends continue, "immigrants could represent [anywhere] from 29.1% to 34.0% of Canada's population by 2041."

Such projections are further reinforced by Canada's annual Immigration Levels Plan for 2023-2025, which was released on November 1, 2022. According to current immigration targets, Canada is aiming to welcome 465,000 immigrants in 2023, 485,000 newcomers in 2024 and a milestone 500,000 new Canadian permanent residents in 2025.

Seeing all these significant numbers, you may wonder: why is Canada accepting so many new immigrants?

Let's look deeper into this subject, starting with an understanding of current Canadian population trends.

To appreciate why immigration is becoming so prolific across Canada, two crucial factors — the aging of Canada's natural population and the country's low fertility rate — must be understood. These demographic trends are causing Canada's labour market to shrink, negatively impacting the country's economy in many ways.

Canadians are aging quickly

According to the 2021 census, from 2016 to 2021, the number of children under the age of 15 grew at a pace six times slower than the number of people aged 65 and older. Moreover, the percentage of persons aged 65 and over in Canada has risen to 7 million, representing an increase of 18.3% between 2016 and 2021. This age group of Canadians now represents 19% of the total population. This reality, Canada requires increased immigration to offset labour shortages created by an aging population and low birth rate. Explore what's happening with the Canadian labour market and why immigration might be the answer



along with the fact Canada's largest-ever five-year increase in persons aged 65 or older (+20%) came in the census reporting period immediately preceding the most current census (2011 to 2016), signals that Canada's population is clearly aging rapidly.

Canadians are having fewer children

Adding to the concern surrounding downward trends in natural Canadian population growth is the reality that Canada's fertility rate is below the population replacement level. The current population replacement level stands at 2.1 children per woman. Following a trend that has continued steadily since 2009, Canada's fertility rate has steadily declined over time, reaching a record low of 1.4 children per woman in 2020. In 2020, Canada also experienced the lowest number of births since 2007 and the greatest year-over-year decrease in births (-3.6%) since 1997.

Solution: Canada needs immigration in order for the country to thrive

Canada needs immigration for continued economic development and growth.

A country's inhabitants are what drive national spending and consumption, for which every country requires a strong labour force to ensure consistent production of goods and delivery of services. A weak population and lacking labour force will constrain production and subsequent spending, which is detrimental to a country's economic wellbeing.

Thankfully, heightened immigration can help Canada better avoid such problems in this country.

Due to the issues addressed above, Canada relies heavily on immigration for population growth. In fact, nearly 80% of the country's population growth during the last census reporting period (+1.8 million between 2016 and 2021) "was attributable to new arrivals to Canada either as permanent or temporary immigrants." Over that time, Canada's population "grew ... almost twice as fast as other G7 countries." This immigration-driven population growth has been significantly beneficial for Canada's labour force, as evidenced by the reality that immigrants in this country accounted for 79.9% of national workforce growth between 2016 and 2021. Heightened immigration also means that Canada will be able to work toward addressing what the Financial Post argues is a "historic" employment shortage.

Citing a report from RBC economists Nathan Janzen and Claire Fan, the Financial Post notes that Canada's current labour market circumstances are "limiting over half of [all] Canadian businesses from increasing production compared to 40% before the pandemic and 30% a decade ago." Thankfully, "an influx of immigration", including a focused effort toward "putting newcomers' skills to work and integrating this talent into the Canadian workforce" can provide a much-needed boost to workforce productivity.

Ultimately, as a result of the boon that immigration will provide to Canadian labour force growth, immigration will consequently help accelerate economic growth across the country. As more new immigrants become employed, earn money, and subsequently spend money that goes back into the economy, Canada's economy will continue developing positively. Additionally, as more newcomers to Canada continue to join Canadian citizens in paying taxes and spending money on housing, transportation, and other necessities, heightened levels of immigration will directly contribute to national economic growth.

# International Day to Combat Islamophobia 2023: From our Canadian government to the classroom, call out and combat Islamophobia and other forms of racism and discriminations in Canadian society

Recently, on January 26, 2023, Prime Minister Trudeau announced Amira Elghawaby as Canada's first Special Representative on Combatting Islamophobia.

Ms. Elghawaby, herself, is an award-winning journalist and human rights advocate. A founding board member of the Canadian Anti-Hate Network and past board member at the Silk Road Institute, she has had an extensive career supporting initiatives to counter hate and promote inclusion. These include roles with the Canadian Race Relations Foundation as well as the National Security Transparency Advisory Group.

As Canada's Special Representative on Combatting Islamophobia, Ms. Elghawaby will serve as a champion, advisor, expert, and representative to support and enhance the federal government's efforts in the fight against Islamophobia, systemic racism, racial discrimination, and religious intolerance.

This is a timely announcementas the United Nations marks International Day to Combat Islamophobia on March 15.

Accordingly, the UN defines Islamophobia as a fear, prejudice and hatred of Muslims that leads to provocation, hostility and intolerance by means of threatening, harassment, abuse, incitement and intimidation of Muslims and non-Muslims, both in the online and offline world. Motivated by institutional, ideological, political and religious hostility that transcends into structural and cultural racism, it targets the symbols and markers of being a Muslim.

Many Governments have taken steps to combat Islamophobia by establishing anti-hate-crime legislation and measures to prevent and prosecute hate crimes and by conducting public awareness campaigns about Muslims and Islam designed to dispel negative myths and misconceptions.

Moreover, in response to the alarming trend of rising hate speech around the world, Secretary-General António Guterres has launched the United Nations Strategy and Plan of Action on Hate Speech.

Along these lines, here in Canada, this policy direction by the Prime Minister enables Ms. Elghawaby to promote awareness of the diverse and intersectional identities of Muslims in Canada and provide advice to the government in the development of inclusive policies, legislative proposals, programs, and regulations that reflect their realities.

Based on these latest Canadian developments, this has become a significant issue that very much gets at the points highlighted by UN Secretary General Guterres. Apart from this appointment, it speaks to a larger issue of racism in not only Canada, but the rest of global society, that can be addressed, first and foremost, in the classroom.

Teachers and educators can themselves create an environment of acceptance and celebration. A way at this, as emphasized by the UN, is recognizing that interpersonal styles can be driven by culture, as well as personality, is key.Readers themselves can learn more about Islamophobia through the NCCM Recommendations National Summit on Islamophobia, and advocate towards their political representatives from all levels of government.

# Government of Canada invests \$798,500 to support the mental health of educators

Funding commitment will address posttraumatic stress disorder and trauma in those most affected by COVID-19

The COVID-19 pandemic has created significant challenges for educators, who have faced school closures, isolation, and a constantly changing work environment while rising to the challenge of teaching our children and youth. This has had a profound impact on their mental health and well-being, which is why the Government of Canada is committed to investing in educators' mental health throughout our recovery and beyond.

Today, the Honourable David McGuinty, Member of Parliament for Ottawa South, on behalf of the Honourable Carolyn Bennett, Minister of Mental Health and Addictions and Associate Minister of Health, announced \$798,500 in funding for the Canadian Teachers' Federation (CTF) to promote mental health and prevent mental illness for essential workers in K-12 schools, including educators and administrators, most affected by the COVID-19 pandemic.

This project will help to enhance the capacity of individuals, staff networks, and school leaders to address mental illness and trauma. The CTF will



deliver and assess the project at three pilot sites across Canada, and deliver a virtual group intervention through webinars and community discussion boards. Wellbeing will be assessed

through a survey with all education workers and teachers, which will integrate standardized mental health assessment tools.

Today's investment builds on the important announcement the Government of Canada made in February of \$198.6 billion over 10 years to improve health care services for Canadians, reduce surgical backlogs, support health workers, and improve integrated mental health and substance use services. We will continue to do whatever it takes to ensure that all Canadians have the mental health and substance use supports they need – wherever they live and wherever they need them.

# Affordable housing is top priority for provinces and territories: looking to federal government for meaningful engagement and investment

Issued through the Chair of the Provincial-Territorial Forum on Housing, Minister Responsible for Saskatchewan Housing Corporation Gene Makowsky, on behalf of all Provincial-Territorial Ministers Responsible for Housing.

Provinces and territories (PTs) are calling on the federal government to increase funding in a long-term, flexible, and collaborative manner to support the delivery of affordable housing programs both now and into the future.

Communities across Canada continue to face elevated home prices, increased rates of homelessness, and challenges related to housing affordability, adequacy, and supply. Rising costs in the construction industry have also significantly increased the cost to build and repair homes. While these challenges have strained PT resources, PTs remain committed to working with the federal government to maintain and expand affordable housing in



their jurisdictions.

The Parliamentary Budget Officer estimates that the federal government will spend \$45.9 billion over ten years on housing until the end of Canada's National Housing Strategy in 2027-28 in new and pre-existing spending. In comparison, PT governments have invested approximately \$20.1 billion over the last four years in housing, including building new homes, making improvements to existing affordable housing, providing services and supports to keep people in their homes, and addressing homelessness.

PTs are on pace to surpass federal investments in affordable housing by the end of the National Housing Strategy in 2027-28. While the federal National Housing Strategy has been marketed as a "\$82+ billion plan", this figure includes both loans and costmatched spending by PTs, neither of which are true costs to the federal government. In addition, federal funding supports often lack operational funding to keep housing viable after it is built, leaving PTs and other housing partners responsible for ongoing costs. PTs are the largest providers of affordable housing in Canada. With their understanding of local needs and circumstances, PT governments are best positioned to identify and allocate funding to areas that will have the greatest impact. PTs call on the federal government to work with them and provide financially sustainable and flexible funding that is responsive to local needs.

To support better outcomes on the funding and delivery of affordable housing, PTs request:

• Increased and more flexible federal funding to complement existing PT programs and address local priorities to meet Canada's current housing challenges.

• Meaningful and proper engagement to develop housing solutions and outcomes that meet the unique needs and priorities of each jurisdiction.

Accessing affordable housing is a challenge for many Canadians. PTs welcome improved collaboration, greater flexibility, and increased funding, which will enable them to respond to this growing need.

# **Ontario Investing in Critical Infrastructure**

Public-private partnerships strengthening communities and supporting economic growth

TORONTO — The Ontario government is investing more than \$159 billion over the next decade to support infrastructure, including transit, highways, schools, hospitals, and long-term care projects. To build many of them, the government is leveraging Infrastructure Ontario's (IO) public-private partnership (P3) delivery model and other innovative approaches to help strengthen communities and support economic growth. IO's latest Market Update, released today, lists 38 major infrastructure projects, with an estimated value of \$35 billion (in design and construction costs).

The Market Update is a list of public projects in the pre-procurement and procurement stages for which Ontario has committed investments. The list helps potential local and global private-sector partners organize their time and resources to make sure Ontario gets robust, innovative, and competitive bids for its public infrastructure projects.

"The challenging work being done by the province's construction sector has been critically important, and our government appreciates and values how partners are working together to help us build Ontario," said KingaSurma, Minister of Infrastructure. "Our government is continuing to invest in the delivery of major infrastructure projects that are crucial to this province and that are supported by the hard-working people of Ontario. We continue to engage with key stakeholders to identify solutions to overcome challenges and together we will bring these projects to life to help create great jobs and support our economic future."

# Working together to improve health care for Canadians

February 7, 2023 Ottawa, Ontario

As Canadians, we place a lot of value in our universal, public health care system. Unfortunately, it hasn't been living up to expectations. Across the country, patients seeking emergency care are finding their emergency rooms overwhelmed or even closed. People are waiting for surgeries that are postponed or cancelled. The health care system and the workers who uphold it are under enormous strain, a situation that was exacerbated by the pandemic, and needs immediate action to deliver better health care for Canadians.

Today, the Prime Minister, Justin Trudeau, and his provincial and territorial counterparts met to work together on improving Canada's health care system. Prime Minister Trudeau and premiers discussed shared health priorities to deliver real results for Canadians as well as the importance to uphold the Canada Health Act to protect Canada's publicly funded health care system. Canadians must have equitable access to medical care based on their needs, not their ability to pay. At the working meeting with premiers, the federal government announced it will increase health funding to provinces and territories by \$196.1 billion over 10 years, including \$46.2 billion in new funding. This funding includes the following elements: • An immediate, unconditional \$2 billion Canada Health Transfer (CHT) top-up to address immediate pressures on the health care system, especially in pediatric hospitals and emergency rooms, and long wait times for surgeries. This builds on previous CHT top-ups that total \$6.5 billion provided throughout the pandemic.

• A 5 per cent CHT guarantee for the next five years, which will be provided through annual top-up payments as required. This is projected to provide an additional \$17.3 billion over 10 years in new support. The last top-up payment will be rolled into the CHT base at the end of the five years to ensure a permanent funding increase, providing certainty and sustainability to provinces and territories. With this guarantee, the CHT is projected to grow by 33 per cent over the next five years, and 61 per cent over the next 10 years.

• \$25 billion over 10 years to advance shared health priorities through tailored bilateral agreements that will support the needs of people in each province and territory in four areas of shared priority:

o family health services;

o health workers and backlogs; o mental health and substance use; and

o a modernized health system.

These additional federal invest ments will be contingent on continued health care investments by provinces and territories. This funding builds on the \$7.8 billion over five years that has yet to flow to provinces and territories for mental health and substance use, home and community care, and longterm care. • \$1.7 billion over five years to support hourly wage increases for personal support workers and related professions, as federal, provincial, and territorial governments work together on how best to support recruitment and retention.

work with Indigenous partners to provide additional support for Indigenous health priorities:

• \$2 billion over 10 years to address the unique challenges Indigenous Peoples face when it comes to fair and equitable access to quality and culturally safe health care services. The government will work with Indigenous partners to prioritize investments.

These investments, on top of already significant funding, will help build a health care system that includes:

• access to high-quality family health services when they need them, including in rural and remote areas, and for underserved communities;

• a resilient and supported health care workforce that provides high-quality, effective, and safe health care services;

• access to timely, equitable, and quality mental health, substance use, and addictions services to support Canadians' well-being;

• access to a patient's own electronic health information that is shared transparency on results, and to help manage public health emergencies. Canadians should be able to access their own health information and benefit from it being shared between health workers, across health settings, and across jurisdictions. That is why provinces and territories are also asked to agree to adopt common standards and policies related to data.

The Government of Canada recognizes that provinces and territories have their own unique circumstances. As such, bilateral agreements are intended to be flexible, and provinces and territories will have options to tailor these agreements to address the unique needs of their populations and geography. As part of these agreements, provincial and territorial governments are asked to develop action plans that will outline how funds will be spent and how progress will be measured. Investments are to be centered around the following four shared health priorities: family health care; health workforce and backlogs; mental health and substance use; and modernizing the health care system with standardized information and digital tools. # G20 Foreign Ministers Meet in India Under Shadow of Ukraine War

#### NEW DELHI -

Foreign ministers of the Group of 20 are convening in the Indian capital, New Delhi, amid deepening geopolitical tensions sparked by the war in Ukraine that pose a challenge to efforts at consensus among the world's biggest economies.

The scheduled attendees include U.S. Secretary of State, Antony Blinken, Russian Foreign Minister Sergey Lavrov and Chinese Foreign Minister, Qin Gang among others.

Besides the Ukraine war, tensions between Washington and Beijing have also flared after the U.S. shot down a suspected Chinese spy balloon over its east coast last month.

India's foreign ministry said the war in Ukraine will be an important part of the talks that will take place on Thursday.

"Yes, given the nature and the developing situation in the Russia-Ukraine conflict, naturally that will be an important point of discussions," India's foreign secretary, VinayKwatra, told a news conference on Wednesday. India holds the G-20 presidency this year.

However, analysts said the foreign ministers meeting could see a replay of tensions that overshadowed a meeting of the group's finance ministers hosted by India last week. That meeting concluded without issuing a joint statement following objections by China and Russia to language that sought to condemn Moscow's aggression.

At the foreign ministers gathering, the United States and its allies will push the group to adopt a firm stance on the Ukraine war.

The European Union said the success of the meeting will be measured by what it could do about the Ukraine conflict. "This war has to be condemned," JosepBorrell, the European Union's high representative for foreign affairs and security policy, told reporters in New Delhi. "I hope, I am sure that India's diplomatic capacity will be used in order to make Russia understand that this war has to finish.

Russia. for its part, said it considers the G-20 a prestigious forum "where balanced consensus decisions should be made in the interests of all humankind."

A statement issued by the Russian Embassy in New Delhi late Tuesday slammed the U.S. and its allies, saying their "destructive policies" have already "put the world on the brink of a disaster, provoked a rollback in socio-economic development and seriously aggravated the situation of the poorest countries."

Analysts said that given the deep divisions, India faces a tough challenge in forging a joint position at the end of the talks.

"It looks like it is going to be a difficult ride. The meeting will see a greater contestation over Ukraine," according to Harsh Pant, vice president for studies and foreign policy at the Observer Research Foundation in New Delhi.

Pointing out that China and Russia blocked the joint statement at the meeting of G-20 finance ministers last week, Pant said the presence of the U.S. foreign secretary along with the Russian and Chinese foreign ministers at the same forum "will call for a difficult balancing act by India to deliver a G-20 outcome."

Despite the diplomatic challenge it faces, India expressed optimism the meeting will focus on problems being faced by many countries such as food, energy and fertilizer security – issues New Delhi has been pushing during its G-20 presidency.

"What is the understanding they develop, not just on Russia-Ukraine conflict but also the impact of that on the rest of the world, the challenges the developing countries face, those are equally important to focus on," Kwatra said.

In all, representatives of 40 countries, including some that are not members of the bloc, such as Bangladesh, and multilateral organizations are due to participate in the meeting.

A gathering of foreign ministers of the Quad countries – the United States, India, Australia and Japan – is scheduled on the sidelines in New Delhi. The Quad is an alliance of countries that want to check China's growing assertiveness in the Indo-Pacific region.

# SRI LANKA AMENDS POWERS OF ATTORNEY LEGISLATION

On October 25, 2022, Sri Lanka amended its existing Powers of Attorney law. According to the latest amendment, a Power of Attorney executed outside Sri Lanka before October 25, 2022 must be registered with the Registrar General in Sri Lanka within six months of the new amendment coming into effect. If not so registered, that Power of Attorney may become null and void.

Any Power of Attorney executed outside Sri Lanka after the said amendment coming into effect, must be registered with the Registrar General in Sri Lanka within three months of execution. The Power of Attorney has to be submitted for registration along with other documents as required under the new amendment.

New Delhi also provided guarantees to the International Monetary Fund (IMF) to help the country secure a USD 2.9 billion bailout package.

# Gaadi: Children of the Sun is a highly simple film with a highly complex take on social liberation

Auteur theory is considered a school of thought in film making that considers the director as the major creative force behind a motion picture or film. This is something that immediately pops into the mind based on the feel and commentary on the film, Gaadi: Children of the Sun.

Released in 2023 and directed by Prasanna Vithanage, the film centers on a woman named Tikiri, played by actress Dinara Punchihewa, who is stripped from nobility and forcibly married to an outcast, Vijaya, acted by Sajitha Anuththara, by the monarchy in pre-colonial Sri Lanka in 1814. Born and nurtured into nobility, she fights to keep her dignity by rejecting to succumb to the destiny that falls onto her.

The film truly captures the essence of an auteur at work in Prasanna Vithanage purely based on the acting itself. One clear observation is that there is little to no dialogue spoken throughout the film. Language is expressed through the raw actions, emotions, and facial expressions of its characters especially the two main characters leading us on a straightaway journeyin the film.

There is a clash between two very different worlds based on the identities between Tikiri and Vijaya when they are forced to marry due to the dubious, complex politickingby the one of the leaders of the Kandyanaristrocracy. One of these individuals coming from a place of high social standing, whereas the other occupies low social standing or caste as commonly known in this part of the world. Even the scheming of Ehellapola Adigar, an aristocrat aligned with the British Empire, played by Ravindra Randeniya, from his short dialogues demonstrates his manipulative ways. Both Adigar and Shyam Fernando, who plays the aristocratic husband of Tikiri, speaks little as he boosts himself for power in the Kingdom as an exchange for ridding their land of a





directorto highlight a subtly growing relationship of love between Tirikiri and Vijaya. The film is a protest, a spark of social commentary for the viewer to contemplate on the ills of social prejudice, discrimination, and injustice during this period in Sri Lanka and being human rather than being defined byidentity. These techniques bring in the audience as inhabitants of the world projected to them onscreen, where they can hopefully empathize with a message that identity is a narrow tribal mentality and how we are all humanlooking for some form of social liberation.

One can see this as the film comes full circle in detailing the injustice to the outcast community in general and in both pre- and colonial Sri Lanka from beginning to end. Itchanges from anescapist attitude of Tikiri, seeing the outcast label as aprison toan attitude that fully embraces this new identity label upon witnessing the beauty of it through her husband, Vijaya. A motif to this end was her choice of clothing at the beginning of her forced marriage where she keeps herself clothed as a form of protest against the outcast community. But towards the end of the film, she deliberately removes them, which, at the same time, indirectly symbolized the corruption of the Kandyan aristocracy, towards the look of her new identity, a truer sense of liberation, rather than imprisonment. In other words, she saw value in the lifestyle and culture of the outcast community in precolonial Sri Lanka that bothshe and Vijaya could progress.

The auteur, Prasanna Vithanage, is having a conversation with audiences tocriticize the concept of caste and identity overall based on how it pushes us into a game of divide and conquer. An issue that is seen in politics today in Sri Lanka and in various countries across the globe. It is used as a smokescreen to blind us from how weare all human beings who can rise above the politics driven by identity labels, and be a part of something

king with South India ancestry.

These emotions and the lack of dialogueshowcase the cold, harsh realities for both characters from the start in this predicament. Yet, the auteur brilliantly utilizes both editing, conducted by Sreekar Prasad, and cinematography as film techniques to present a slowly budding relationship.

Although not specifically focused on the relationship, the fear and anxiety illustrated from the facial expressions of Tikiri and the other noble women was excellent. One could even say the fear jumped off screen an onto the viewer too. The pounding on the door of the home by the soldiers of the current Kandyan kingdom sounded real to the point where I as a viewer turned to look if someone was actually knocking on something in the theater or outside of it. The sound edits here during this scene were just that creative by the auteur, Vithanage.

Despite the heavy subject matter, there were lighthearted moments in the film such as when Vijaya talks to the buffalo he successfully hunts about the trials and tribulations he experiences in this forced marriage. It may seem out of place, but, based on the laughs from some members of the audience, signals Vithanage'sattempt to find just the right balance between seriousness and lightheartedness so as not to depress the viewer too in a film such as this that demonstrates the full potential of the medium being an extension ofart.

The cinematography of pre-colonial Sri Lanka, handled by Rajeev Ravi, evoked a feeling of immersion in the jungles of Sri Lanka through its unique sounds. This was paired with a very selective useof music by the greater.

This film was produced by Sandya Salgado. It is currently being screened in Sri Lanka and worldwide. I had the opportunity to see it in Whitby, Ontario. Even though I have Sri Lankan ancestry, I cannot understand Sinhalese, but was grateful for it being subtitled in English. It allowed a viewer like me living in Canada feel connected to a slice of the culture and history of Ceylon and Sri Lanka overall. # **Compassionate Care**

iana Ip and her husband had been trying to conceive for yearsfirst naturally and later through fertility treatments-when she found a lump in her breast in October of 2021. The discovery came at an especially precarious time: she had one embryo left and was six weeks away from her final fertility treatment.

Like many women, Ip was in the shower when she first felt the small, hard lump just under the skin of her right breast. It didn't hurt, but she was sure it hadn't been there the day before. "Initially my doctor told me, 'You're young, you don't have a family history [of breast cancer]," Ip recalls, adding that the results came back as "likely benign."

Health Centre at MSH, she likely would have had to see one doctor, get a mammogram or ultrasound, wait for results, then get a biopsy and wait for those results-all at different clinics. It's a weeks-long process that would be anxiety-

inducing for any person. That lengthy, complicated process is what motivated Dr. Pallister, in 2007, to advocate for patientcentred care at MSH and create a one-stop-shop model for breast cancer care.

The newly relocated Breast Estimated number of Canadian women Health Centre opened its diagnosed with doors in May 2022 and is a breast cancer in 2022 welcoming space meant to help patients remain comfortable and calm during challenging 5,500 times, and to further support the care model Dr. Pallister created. Its construction was made possible by the generosity of MSH's donors, especially the Wright family, and the important work of the MSH Foundation. "[Patients] can come in and see the surgeon [and] the nurse practitioner and get all the necessary X-rays and a biopsy that same day, and then be seen within a week for results and a surgical plan if necessary," explains Dr. Pallister. The short turnaround time between appointments is in stark contrast to the more common experience of waiting for weeks between the initial diagnosis and seeing a surgeon, she adds. Another unique element of the Breast Health Centre is its design and layout.

Located on the main floor of the hospital, the centre features natural light and beach-like floor tiles, with a fireplace in the waiting area and nature-themed murals in the exam rooms.

"We tried to create a relaxing space

for patients," says Poobica Kumaran, a breast cancer nurse navigator at MSH. "I've had great feedback from patients telling me they feel like they're at their cottage."

#### LISTENING TO CONCERNS

When Ip first met with Dr. Pallister in January 2022, she relayed her worries about simply monitoring the lump every six months, especially given her upcoming final fertility treatment and what a cancer diagnosis might mean if she became pregnant. "I didn't know if it was me overreacting, or if it was anxiety," she says.

room, wiping tears from her eyes and thinking about how her friend had reassured her that Dr. Pallister would take care of her.

#### NAVIGATING THE SYSTEM

Once Ip received her diagnosis, the experts at MSH's Breast Health Centre launched into action. Kumaran, who is the main point of contact for all patients at the centre, guided her through the hospital journey.

"As the nurse navigator, your role is to educate, navigate and make sure you're there to support your patients," Kumaran explains. "It's like a maze, and there are lots of things going on in the patient's mind with a diagnosis of breast cancer, so it's nice to have someone say, 'This is tough but we're

But Ip continued to worry about the lump, subconsciously feeling for it, the same way you keep going back to a loose tooth. According to Statistics Canada, one in eight Canadian women will be diagnosed with breast cancer in their lifetime, so it was only natural for Ip's anxiety to kick into high gear.

Then, a friend, who is a breast cancer survivor herself, recommended seeing Dr. Crystal Pallister, a general surgeon at the Breast Health Centre at Oak Valley Health's Markham Stouffville Hospital (MSH), to get a second opinion. That's how Ip discovered that the lump was, in fact, malignant.

"I am so grateful that [Dr. Pallister] was willing to look at it," she says.

#### PATIENT-CENTRED CARE

If Ip hadn't been referred to the Breast

Dr. Pallister was sympathetic to Ip's fears. She agreed to remove the lump that day and send it for testing. "I said no problem, let's just do it. I was very surprised that it was cancer, but my experience is that you never

know," she explains. "If someone says, 'This doesn't feel right,' who am I to say keep it in?"

Ip received the news that it was stage one invasive ductal breast cancer the day before her 40th birthday, which was just a week after her lumpectomy. She remembers sitting in an exam going to help you through the journey."

Kumaran scheduled Ip for a second surgery in February 2022 with Dr. Pallister to confirm the cancer hadn't spread. They were all relieved to find out it hadn't. And after additional consultation with her oncology team and husband, Ip, who is now cancer free, decided to opt out of radiation, in the hopes that when she had her final fertility treatment it would be successful.

It turned out she didn't need it after all, as Ip and her husband conceived naturally in May. Dr. Pallister, Kumaran and the entire team at the Breast Health Centre celebrated this development and can't wait to meet her baby, due to arrive in the new year.

"This is a miracle baby," Ip says quietly. "And I do consider Dr. Pallister to be like our angel."

# Mississauga Businesses Receive Over \$900,000 in Tourism Recovery Support



# SHN part of world-first trial for new surgical technology

Scarborough Health Network (SHN) is leading the way when it comes to diagnostic and screening procedures.

The Network is one of two sites in the world to take a cutting-edge piece of technology currently used in operating rooms and trial it in a new clinical setting: endoscopy. The aim is to improve the quality of care for patients not only here in Scarborough, but across hospitals that provide this service.

Called the "Neptune S," the new machine from medical technologies company Stryker is the only completely closed fluid waste management system, designed for hands-free clean-up, and streamlined and failsafe specimen collection. This means there is zero risk of patients or staff being exposed to the contents inside of the system. It has developed a strong track record as a tool in surgery, but has never before been used in endoscopy.

Currently, SHN offers a full range of upper gastrointestinal (GI) and colorectal procedures across three hospitals (Birchmount, Centenary, and General) to provide a full spectrum of GI care. Through several leading inpatient and outpatient services and endoscopic procedures, SHN provides an innovative and refined endoscopy program that delivers advanced diagnostic and therapeutic intervention.

Daniel Smith, manager of endoscopy, day surgery and surgical clinics at SHN's General Hospital, emphasized the importance of trials in medical advancement, explaining patients travel to SHN from across the province to receive these types of diagnostics and screening procedures.

"SHN is committed to staying at

the forefront of providing the safest, highest quality care. It speaks to our level of expertise and our dedication to patient results and outcomes," he said.

During a typical endoscopy procedure, a doctor can view and take samples from the inside of a patient's body by using a flexible tube with a camera and biopsy tools on the end of it. Currently, the specimen is collected using a wall-mounted suction device, where nurses must stop the flow of suction to collect the specimen as it comes out of the body and risk missing it, which means having to manually go through the fluid contents of the suction bag to find it.

"Neptune S" eliminates this problem, while at the same time reducing disposable waste. It only requires users to throw away the "manifold," a machine insert (like a filter) that collects the samples, rather than the bag containing the full fluid contents of the procedure as with conventional suction devices. This is possible because post-procedure, the machine is connected directly to the septic lines of the hospital building for cleaning, providing a benefit to nurses who do not have to interact with any fluids.

"This technology was built by nurses, for nurses, and it shows," added Smith.

"In trialling this equipment, my staff are reporting greater suction that helps move the scope through the patient's body, and are relieved with the built-in trap's ability to eliminate the possibility of losing a sample and the cross-contamination that occurs by doing anything manual."

Sabrina Alves, product manager of surgical technologies at Stryker Canada, noted the company will take SHN's learnings from using these machines to perfect the next generation of the machine.

"The opportunity to perform this limited launch at SHN enabled us to observe over 100 procedures in a real-world setting and gain valuable knowledge on the work process of endoscopy suites. We look forward to applying our insights to future product development to make surgical procedures more streamlined and efficient for everyone."

# HEALTH & WELLNESS SHN INTRODUCES CLOSER-TO-HOME, HOLISTIC CLINIC FOR PATIENTS WITH **AORTIC VALVE DISEASE**

Carborough Health Network (SHN) has Dlaunched a new Structural Heart Disease Clinic, providing heart valve disease patients in the eastern Greater Toronto Area (GTA) and surrounding communities with access to highlyspecialized cardiac care closer to home.

Located at SHN's regional cardiac care centre at Centenary Hospital, the Structural Heart Disease Clinic supports patients suffering from aortic stenosis - one of the most common and serious heart valve disease problems - throughout their journey of care, including:

· Consultation and specialized diagnostic testing:

Valve repair treatment, known as a transcatheter aortic valve implantation (TAVI), which is performed by an SHN cardiologist at a cardiac facility at Sunnybrook Health Sciences Centre;

• Post-procedure care and recovery (at Centenary); and

Ongoing follow-up care.

Leading the clinic is a multidisciplinary team with extensive expertise in interventions, imaging, and clinical cardiology. This includes Dr. Ram Vijayaraghavan (Medical Director of SHN's Cardiac Catheterization Lab), CT imaging cardiologists Dr. Paul Galiwango, Dr. Nisha D'Mello, Dr Natalie Ho, Diagnostic radiologists, Dr. James Woo, Dr. Nancy Jiang and nurse practitioner Janet Traverse.

Aortic stenosis is the narrowing of the heart valve that opens and closes to let blood pump out of the lower left heart chamber and into the aorta, which is the main artery that carries blood to rest of the body. While aortic stenosis may be caused by birth defect or infection, it generally affects older people due to ageing and the buildup of calcium deposits over time. As the valve becomes narrower and unable to work properly, there is reduced or blocked blood flow from the heart to the aorta and throughout the body. This can bring about symptoms such as chest pain, rapid heartbeat, trouble breathing, feeling dizzy, swollen ankles or feet, difficulty sleeping or doing normal physical activities, and could possibly lead to heart failure.

Previously, patients in Scarborough and the GTA East would have to go out of region for care. Now, through SHN's Structural Heart Disease Clinic, they have access to several diagnostic investigations to assess the state of their aortic valve and root, aortic arch, abdominal aorta, iliac and femoral vessels, and determine options for treatment. Specialized testing is done to view inside the body and map out the aorta and blood vessels - including a computerized tomography (CT) scan of the heart and possible repeat aortograms (a kind of catheterization procedure). In November, the clinic team achieved an incredible milestone, performing SHN's first TAVI CT scan, which helps cardiologists with determining suitability and planning for a TAVI valve replacement procedure. This diagnostic imaging test requires an advanced CT machine with sophisticated software in order to get images of high enough quality to obtain accurate measurements and mapping. Cardiologist Dr. Paul Galiwango praised the team and new clinic, which made this diagnostic procedure possible more locally for patients. "At SHN, we're lucky to have a state-of-the-art CT scanner that can do cardiac imaging, and have invested in the right software and technology to be able to perform TAVI scans," explained Dr. Galiwango. "Historically, this type of scanning has not been available in our region. But now with our structural heart program, we are doing the workups here at Centenary, including echocardiograms and the TAVI CT scans."

For Dr. Galiwango, CT scans are a critical part of this treatment and care journey – without it, the TAVI procedure itself would not be possible.

"It helps us to determine if the patient is a candidate for TAVI, and also plan the procedure in terms of the type and size of valve implant, and what the safest access route will be to get to the heart.'

Then through a partnership between SHN and Sunnybrook Health Sciences Centre, patients under consideration for TAVI will have their case reviewed by a joint team. Appropriate patients will be booked for their TAVI intervention procedure, which happens at Sunnybrook a few weeks after their CT scan at Centenary.

The TAVI procedure is performed by Medical Director of SHN's Cardiac Catheterization Lab Dr. Ram Vijayaraghavan, who is an interventional cardiologist and has trained with his counterpart physicians at Sunnybrook Hospital.

we're giving patients their lives back," said Dr. Ram Vijayaraghavan.

"There was a time when patients living with valve disorders faced two difficult options: deteriorating heart health or high-risk surgery. But that's changing. TAVI is now the most common way to treat aortic stenosis. It's a minimally-invasive procedure as opposed to the alternative open heart surgery, and the recovery for TAVI is much shorter. People are going home the next day and feeling better within a couple of days.'

To date, the Structural Heart Disease Clinic has cared for over 80 patients - accelerating their assessment, diagnosis, and treatment, and supporting their care journey closer to home. Looking ahead, SHN will continue to develop, hone, and expand both local expertise in advanced cardiac imaging and our cardiologists who have the skillset to do TAVIs at partner hospitals, like Sunnybrook – with an aim of ultimately being

# WAS IT A MYSTERIOUS AIRCRASH OR A PREMEDITATED ACT, IS STILL A MYSTERY???

People may laugh at my insinuation but what happened 40 years back, on this day February 1983 over Straits of Malacca has been still a mystery and is personal to me. When something happens in your backyard it becomes more personal. Lots of pundits had written so many articles on this but this is on a different note.

Upali Wijewardena was a maverick, flamboyant and an unorthodox Sri Lankan businessman, born with a silver spoon to well connected family. But his entrepreneurship, business acumen and THE WILL to succeed made him a millionaire at the age of 26. I would say a rising star and appropriately used "SUN" as his logo. I had spoken to him twice at Katunayaka airport when he used to fly out on Singapore Airlines in 1974.His face was like the SUN, radiated lots of energy and as the saying goes "Face is an index of Mind". That was my impression of this maverick. He had the typical American Dream,



and a Midas touch in his endeavours. As his business enterprise took wings globally, so did the founder. He started Upali aviation initially with the Bell Helicopters, Cessna Citation and expanded. Upali tired of flying on commercial airlines, bought his own private plane in the early 80s, Lear Jet 35A, made by Canadian Aero space company, of Bill Lear, out of Wichita, Kansas. Captain S. 





# **Tamil Community** in Toronto loses a Community Leader

Mahendran Thurai (Jan 29, 1936 – March 12, 2023)

Beloved father, husband, brother, uncle, grand-uncle, teacher, and community leader Mahendran Thurai passed away on Thursday, March 12th at the age of 87. He is survived by his dear daughter, Lakshmi Thurai, and his loving wife of nearly 50 years, Dr. Indrani Thurai.

Mahendran was born in Udivil, Jaffna on January 29th, 1936. His three brothers and sister, all of whom he was very close to, spent their childhood in Colombo, Moratuwa, and Jaffna, Sri Lanka. He emigrated to Canada in 1967, where he became a pillar of Toronto's early Tamil community. Throughout the 1970s and 1980s, Mahendran played a key role in establishing the first foundations of Tamil presence in the city.

Mahendran's efforts to help his community has had a lasting impact on Toronto's rich multicultural heritage. As one of the leaders of the Society for the Aid of Ceylon Minorities (SACEM), he helped secure 10 million dollars in federal and provincial funding to construct one of Toronto's first housing co-operatives at Lansdowne & Bloor in the early 1980s. Eighty percent of the 129unit building was reserved for Tamil refugees, Tamil emigrants to Canada, and Tamil-Canadians. At a time when our community was still finding its footing, the Tamil Co-op Homes provided essential services in Tamil, assistance navigating government services, advice on settling in Canada, English and French lessons, and a community event hall. It was, and still is, a place where Toronto's growing Tamil population could build a community together.

While the area around the Tamil Co-op Homes has since gentrified, the building still provides affordable housing for Tamils in a historically-diverse neighborhood. Mahendran's efforts were key to the establishment of this important historical site for Toronto's Tamil community and Tamil-Canadian identity. The Co-op, and all the lives it has supported and changed, are a part of his legacy. In 1983, Mahendran was part of a delegation of Tamil community leaders who lobbied the federal government to relax the visa requirements for Tamils fleeing the rising unrest in Sri Lanka and looking to settle in Canada. His commitment to his community contributed to the Canadian government's more welcoming stance towards Sri Lankan Tamils in the early 80s, and laid the building blocks for how far our Tamil-Canadian community has become today.




# Leaders for Change Award: Arul S Aruliah

**Canadian Tamil Congress** (CTC) held their Thai Pongal& Tamil Heritage Month Celebration on January 28, 2023. At this CTC's 16th annual event, Lifelong community activist Mr. Arul S. Aruliah was presented with the year 2022's Leaders for Change Award.

Honouring the award recipient and recognition, CTC's annual publication "Voice 2023" also published at the event, carries the following profile and contributions of Mr Arul S Aruliah:

This year marks the 40th anniversary of Black July, and correspondingly the exponential growth of the Tamil community. The community grew from a modest 3,000 Tamils in 1983 to the current 300,000 strong community from coast to coast to coast. This growth is, in part, due to the work of Mr. Arul S. Aruliah and his colleagues, who worked tirelessly, to first shed light to the anti-Tamil pogroms, and then worked with the government of the day to establish a Special Measures Program that allowed over 1,880 Tamils to settle here. This year, CTC is proud to recognize Mr. Arul S. Aruliah, with the Leaders for Change Award.

Mr. Aruliah is an unassuming leader within the Tamil community. He volunteered to support his community by every means possible. After establishing the Special Measures Program for Tamils, he worked with his colleagues to support Tamil refugees as they arrived in Canada in droves. He would often go to the Toronto Pearson Airport and help release new refugees who arrived seeking asylum. He would have a roster of established Tamil-Canadians to support the release of new commers.



major organization of the time. He undertook many of the refugee assistance projects through its immigration and refugee affairs committee. He was instrumental in transforming the role of the Tamil Eelam Society of Canada from primarily an advocacy organization in the 1980s into a settlement agency in the 1990's.

His work on refugees continued as he joined York University's Centre for Refugee Studies as managing editor of Refuge, its marquee publications until 1995.

Mr. Aruliah was born in the island of Pungudutivu, Northern Province. He went to the United Kingdom for higher education. After completing his undergraduate degree, he came to Saskatoon in 1973 for higher education. He moved back to England to study Process Engineering and Economics at Loughborough University, and worked for Rank Xeroxat Welwyn Garden City, before returningto Canada. He worked at the Ontario Research Foundation, Mississauga, and later as a research engineerat the University of Toronto on its Fuel Cell-Hydrogen Project in the mid-1980s.

From 1983 to 1990, Mr. Aruliah continued to volunteer in the area of refugee and immigration settlement. He held several leadership roles with the Tamil Eelam Society of Canada, the

Mr. Aruliah was also one of the first points of contact in the 1980s for the media in representing the Tamil community. Solely focusing on the human rights abuses in Sri Lanka, the community was seen through persons like him and his colleagues through frequent meetings with government officials, politicians and media. He was continuously on the frontlines offering a Tamil- Canadian perspective on issues specific to the community.

Many observers of that era credit his efforts to be continuously available for the people,

the arrival of Tamil refugees who were rescued off the shores of Newfoundland by the fisher folk, he went there, with his colleagues from Montreal, to provide assistance. The Canadian government's response then, under Prime Minister Brian Mul roney, was swift and principled and unrivalled.

Mr. Aruliah started worked in the early 1990s in founding a co-operative home in Mississauga, an 80-unit cross cultural co-op building, Yarl Co-operative Homes, that opened in 1995.

Mr. Aruliah and his partner, Pathma - who was recognized by the Peel District School Board for teaching of the Tamil language for 35 years --have been life partners for over fifty years and they have two children, both practicing as legal counsels, and a granddaughter.

# In a sylvan setting of abundant palmyrah trees, guess what you'd find.

Women making a living from Palmyrah products, The craft seemed to be in danger of dying out for a while, but is reviving again now. Locals who switched to the plastic and stainless steel stringhopper and puttu moulds are switching back to the healthier natural products now.

Nobody buys baskets and hats in the region made of palmyrah - they are sent to Jaffna and perhaps eventually Colombo to be sold.



Sprightly 76 year old aachie came in with a cane to do her share. She said she learnt palmyrah product weaving from her grandmother but attended a training last year too, at the age of 75 to learn some more.

She apparently won an award at an exhibition last year for



her mat weaving skills. "I can make a stringhopper mould in 15 minutes and sell each at Rs.40. We sell sets of 10 of these, so that would be Rs.400.

The puttu mould (Neethu petti) doesn't fetch much. Just  $\mathrm{Rs.50."}$ 



This disabled young man runs his own cycle repair workshop from home. He uses his hands to move speedily across the floor as his legs are shriveled and cannot function.

His mother apparently fell into a bunker and hurt herself while pregnant with him, damaging his development in utero.

Very positive attitude. When asked about feeling left out at school, sports, bullying etc, he said he participated in sports like shot put, had friends at school who cared for him and his teachers were all good to him.

Either he has a uniquely Sri Lankan experience of school life or he chooses to ignore the negatives.

Asked for his ambitions in the future, he said he wanted to expand his business and employ fellow disabled people. He is a member of a disabled persons society in his area that has 340 members.

# Tribute to PROFESSOR RATNAM VIGNESWARAN

## Former Vice Chancellor, Professor of Mathematics, University of Jaffna

It is with a heavy heart I settle down to pen this tribute to one of my close relatives Prof. Ratnam Vigneswaran who left us thunderstruck on hearing his untimely demise. Vigneswaran was not born with a silver spoon in his mouth. Brought up in an agricultural environment he lost his father at a young age. Through sheer hard work and under the constant care of his mother he had reached the level of academic excellence.

He began his primary education and part of his secondary education at Inuvil Hindu College. In order to enhance his educational career further he was admitted in grade eight at Jaffna Hindu College one of the leading National Schools in the country. It was in this acclaimed institution his educational programme began to blossom. Being an assiduous student he studied diligently burning the midnight oil performed well in the A/L exam and gained admission to the physical science course in the University of Jaffna. On the basis of his creditable performance in the first two years he was admitted to follow the mathematics special degree course his long felt desire and passed out as a mathematics special graduate. He got his first appointment as a temporary lecturer in statistics

in the Eastern University (1982-1983). Later he was appointed as a temporary lecturer in mathematics (1984 – 1986). In 1987 he was appointed as permanent lecturer in the same field. Continuing further he won a scholarship to the University of Sussex and completed his Phd programme (1988 – 1991). Relentless in his quest to study further he won the

Commonwealth Scholarship (2001- 2002) and successfully did his Post Doctoral Studies.

On his return to SriLanka he resumed his services as lecturer in mathematics in the Eastern University in 1992. After successfully serving there for twenty years (1984 - 2004) he was transferred to the University of Jaffna in the same capacity as lecturer in mathematics. In 1992 he was promoted to the position of Senior Lecturer grade 2. Thereafter fortune continued to smile on him; he was appointed as the Head of the Department of Mathematics in 1994, Associate Professor in 2009 and Dean of the Faculty of Science in 2016. Vigneswaran was always a simple, unassuming and easily accessible person. His doors always remained open for the staff and students of the university. Once during my visit to meet him in his department a batch of students arrived there to solve a problem. Vigneswaran received them politely, gave a patient hearing, discussed the problem and sort it out favourably.

Vigneswaran beside his educational pursuits is also a highly religious person. He was always a strong believer in his ingrained faith Saivism. His devotion to Lord Murugan is unsullied. I had seen him attending pooja daily at 5.30 am at Inuvil Kanthaswamy temple. Having full of faith in Lord Murugan he constructed an attractive 'Gopuram' (tower) in the southern entrance of the temple above the Arumuga Swamy shrine. I always admired the way he sported stripes of Viputhi (Holy Ash) on his forehead wherever he went. Through sheer hard work he had been successful in his educational pursuits and had risen to eminence as an educationist at the tertiary level. The way he was received, given a rousing welcome and taken in a grand procession by the people of Inuvil his ancestral home is ample proof of his popularity Vigneswaran is no more. He has taken eternal rest at the Holy Feet of Inuvil Kanthan his chosen deity. His educational pursuits, his administrative ability, his simple nature and his impeccable faith in his religion will always remain edged in our memory.

# Value of Life, Abortions and the Decline of Western Culture

Western culture is sliding towards sodom due to the current lifestyle that promotes more intimate relationships between men and women. The social media provides all the necessary material that promotes these activities. Human beings tend to follow the crowd, no matter where it leads or who is leading. People turn to bloggers, podcasters and social media in general for information and validation. Much of the academia has been taken over by propagandists who promote casting off all restraint.

#### A. Assisted Suicides:

Growing up has always been challenging, as individuals search for where they fit in the grand scheme. But today, it is worse, as there are plenty of peers and opportunists to show you the way, to validate you with social media, no matter how destructive. Many decry the devaluing of human life and worry about the growing culture of death in western civilization. Others celebrate what they see as a growing willingness to ensure death with dignity and embrace suicide as the ultimate display of human autonomy and free will. Choosing death is turning out to be an increasingly popular way of life in Canada. And this is even after Canadian lawmakers in 2016 restricted assisted suicides-made legal by Canada's Supreme Court the year before- to only those with terminal illnesses, for whom natural death was reasonably foreseeable. In just six years, from 2016 to 2021, the number of Canadians choosing assist those dying grew tenfold, from 1,018 to 10,064.-meaning that in 2021, individuals in Canada asked for assistance in killing themselves at a rate of 27 per day. Similarly in 2003, the rate of those dying via euthanasia in Belgium was 235 per year. That number has grown more than ten times greater in less than 20 years: In 2021, Belgium reported 2,699 cases of euthanasia-more than seven people every day-from a population about a third the size of Canada. Belgium law stipulated that those choosing death had to be legal adults, conscious and capable of making their own decisions, and suffering from a hopeless medical condition that involves constant and unbearable physical and mental suffering that cannot be relieved. But, over some time Belgian authorities felt that what qualifies as 'unbearable physical or mental suffering has expanded in troubling ways. In 2012, two deaf 45 year old twin brothers, diagnosed with glaucoma, were euthanized because regulators decided their fear of going blind constituted 'unbearable mental suffering. In 2014, the regulation was extended to include minors who with their parent's consent, wish to die. Since then children as young as nine years old have been euthanized.



## B. Increasing cases of Legalized Suicides:

Sure enough, Canada has followed the Belgian trend. Last year, the 2016 standard was replaced with the looser standard that the individual be experiencing "unbearable physical or mental suffering" that "cannot be relieved under conditions that you consider acceptable." Concerned observers have already noticed that an increase in suicides among Canada's poor or disabled who find the cost of living too high, such as the famous case of a 51 year old woman suffering from environmental allergies, who chose suicide because she could not get assistance to relocate. In the US too Dr. Jack Kevorkian, a Michigan doctor who in the 1990's started by assisting several dozen people in committing suicide- became emboldened enough to actually kill a patient, for which he served eight years in prison. Today assisted suicide is illegal in Michigan, but several states-including several that also legalize expansive rights to abortion, such as California, Oregon, and Washington along with Maine, New Jersey, and Vermont on the east coast- have legalized this practice, which many considered barbaric not long ago. New research released recently in the US adds to a growing evidence showing a link between more restrictive abortion policies and higher maternal and of mortality.

fanticide infuriated many. The pro-abortion activists have vandalised and fire-bombed churches and crisis pregnancy centers, leaving spray painted messages such as "if abortions aren't safe, you aren't either". Many countries-especially Muslim countries take a different step to avoid unwanted pregnancy. For example in Indonesia extra -marital sex is deemed as a criminal offence. In Afghanistan, the Taliban insurgents are demanding that women must wear hijabs and even be prevented from going for higher education.

#### D. The Value of Human Life.:

Though human life is priceless, terminal illnesses inevitably brings pain, debility and financial devastation. One should not deny the harsh reality that we should ease the burdens of those suffering from terminal illnesses. Valuing human life is morally essential for civilized livelihood. All human lives have value for each and every one. The sanctity of life is the idea that human lives are inherently more valuable than any material thing there is. The fact that we value human life is due to our religious traditions. Philosophers like Aristotle refer to human rationality as the reason for the value of human lives. Religions differ highly across geography and time, but a commonality is that most religions teach us that we should value life because it is either valuable to God or instrumental to re-birth. The sanctity of human life has great purchase across all world religions. Aristotle believed that all living beings weighed by the kind of soul they had. He said that we should value our human life due to our inherent capacity to reason. We teach each generation that human life is beyond all else. We establish it as the sacred myth of our time-a myth we need to constantly maintain if we want it protected. We should also safe-guard it from the ill-effects of contra-culturalism. Life is worth living -if lived well.

## C. The Right to Abort and the Right to Life:

Human rights activists believe that they have the right to abort. In February 2012, ethicists Alberto Giubilni and Francesca Minerva published an article demonstrating that ethical reasoning that would allow the murder of a child in its mother's womb grants the right to kill a child after it has been born and has become a growing infant. An associate degree is a two-year undergraduate degree awarded by community colleges, vocational schools, and very few colleges and universities. A bachelor degree is awarded at 4-year universities. A graduate degree is an advanced degree that focuses on a specific academic field of study or professional discipline. A master's degree is a degree more rigorous than a bachelor's degree, but it typically only takes about two years to complete, compared to the 4 years for a bachelor's degree. A doctoral degree is a degree similar to a master's degree but can take between two to six years to complete. Most doctoral programs are very challenging and need full time commitment. There are four types of doctorate degrees. There is a professional doctorate, research doctorate, higher doctorate, and honorary doctorate. A professional degree is another common degree. It is needed to become licensed to work in a specific field. For example, you need a



medical degree to become a medical doctor, or a law degree to practice law. Finally, a specialist degree is one someone pursues after completing a master's degree. # SOME REJECTED PAPERS WON THE NOBEL PRIZE

#### The Peer Review and Rejection is Part of a Healthy Process but not the End of the Research

There are few things more disheartening than f L spending several months or years working on a paper, only to have it rejected by your journal of choice - especially when you feel like you are onto something important. Plenty of world-famous researchers went through rejection before finally publishing their papers, including a few papers that later won a Nobel Prize. It is not to say the publication system failed these researchers. The rejection process is part of a good, healthy peer review. Peer review involves having a group of independent researchers reads every paper submitted to a journal to ensure that the methods and conclusions are solid. They will often suggest revisions and can only accept a paper if they think more work needs to be done or if it's not the right fit for the journal.

Following the rejection, the end product is usually better than it would have been or ends up in a more appropriate journal. Hearing about the renowned pieces of work that faced setbacks before going on to revolutionize the field is a comforting reminder that rejection is not necessarily the end of your research. Sometimes, it is just the beginning. The community does not always accept Nobel prizewinning ideas. By definition, they are paradigmshifting and revolutionary. Accordingly, many breakthroughs that are in our textbooks today were initially rejected, if not ridiculed, by the scientific community.

#### Hans Krebs

Nobel Prize in Medicine (1953) awarded to Hans Krebs for discovering the citric acid cycle (aka the Krebs cycle). Rejection: Even scientists with textbook processes named after them have faced rejection. There wasn't anything wrong with Krebs' paper,

but Nature had such a backlog of submissions at the time that they could not look at it. "This was the first time in his career, after having published more than 50 papers, he had rejection or semirejection," Krebs wrote in his memoir. The paper "The role of citric acid in intermediate metabolism in animal tissues" was published in the Dutch journal Enzymologia later that year.

phrase sufficiently pompous for the editors of the Physical Review. He said that he hated the Physical Review Letters, and almost twenty years ago, I decided never again to publish in that journal. Sometimes it's not the content of a journal article that has it rejected, but the headline. In the end, it didn't matter what the headline was, seeing as Gell-Mann was awarded the 1969 Nobel Prize in Physics.

#### **Rosalind Yalow**


Nobel Prize in Medicine (1977) was awarded to Rosalind Yalow for the invention of the radioimmunoassay (RIA). Rejection: For years after winning the Nobel Prize, Yalow proudly showed the rejection letter in her public presentations. The letter indicates



that "I regret that the revision of your paper entitled "Insulin metabolism in human subjects: Demonstration of Insulin transporting antibody in the circulation if insulin-treated Subjects" is not acceptable for publication in the Journal of Clinical Investigation. The Journal of Clinical Investigation sent it because the reviewers were suspicious that humans could make antibodies small enough to bind to things like insulin. She proved them wrong, and now RIA is a common technique used to determine body antibody levels. It releases an antigen tagged with a radioisotope and tracks it around the body.


#### John Polanyi

Nobel Prize in Chemistry (1986) awarded to John Polanyi for elucidating the dynamics of elementary chemical processes. Rejection: Physical Review Letters rejected the paper as lacking scientific interest. Shortly after, they rejected Maiman's



#### **Richard Ernst**

Nobel Prize in Chemistry (1991) awarded Richard Ernst for developing highresolution nuclear magnetic resonance (NMR) spectroscopy. Rejection: "The paper that described our achievements was rejected twice based on invention was insufficient. by the Journal of Chemical Physics and finally accepted and published in the Review of Scientific Instruments." NMR spectroscopy revealed details about molecules' structure and dynamics - something convenient for chemists and biochemists. The first paper outlining the technology, "Application of Fourier Transform Spectroscopy to Magnetic Resonance," received little attention.



word on why, but the journal was upset to miss out on that knowledge. PCR was three years later proclaimed Molecule of the Year." PCR is used daily in labs worldwide to amplify DNA strands.

#### Paul Boyer

Nobel Prize in Chemistry in

1997 was awarded to Paul Boyer for identifying the mechanism for synthesizing adenosine triphosphate (ATP). Rejection: Boyer had been greeted with disbelief when he theorized that the previously mysterious process is the work of a


"beautiful little machine" that operates within enzymes on the molecular level. His proposed resolution of a significant unsolved problem in biochemistry threatened to "change the paradigm," Boyer remembers, and "the leading journal" in his field, "The Journal of Biological Chemistry," declined to publish his work.


#### Herbert Kroemer

talked into not fighting the denial but submitting it to the Proceedings of the IEEE, where it was published but ignored. He also wrote a patent, a better paper than the one in Proceedings of the IEEE."

Today, authors can upload their manuscripts to places and communicate their ideas before formal publication. This allows new and potentially breakthrough ideas to be discussed transparently. Good science is a science that can be scrutinized transparently. Journal rejections are typical, irrespective of the researcher's academic career. Information about individual journals' acceptance or rejection rates is seldom available. Thomson Reuters completed a study in 2012 on this aspect of journals in the publishing industry, the global averages across manuscripts, and it included data about over three million manuscripts submitted in 2005-2010. The overall acceptance rate decreased slightly from 40.6% to 37.1%. Nobody likes to have an article rejected. Even if you dislike it, you get used to it since it is common for most researchers who want to publish in indexed scientific journals. This article indicates rejection is only sometimes correct, and your work is valuable. It is essential to believe in yourself and not take it personally.







# New to Waterloo region, this woman says she's excited to celebrate Pongal with her new community

SyamalaSubashini T Sivasankaran remembers celebrating Pongal in Chennai, India, "with great excitement.".

This year, that excitement remains even though it will be Sivasankaran's first time marking the new year in Canada.

As a new resident in Waterloo region, having moved to the area in the summer of 2022, she says she did have concerns about the celebration being different in Canada compared to India.

"I did have a thought: What if I don't see my community? How do I celebrate? I had all those questions, but I was lucky enough to find the community over here," she said in an interview with Craig Norris, host of CBC Kitchener-Waterloo's The Morning Edition.

"I was so happy to know that every single festival is celebrated with the same energy, with the same excitement."

Pongal begins Saturday and ends on Tuesday. It is a Hindu harvest festival celebrated by the Tamil community.

RajiviNadaraja, the secretary of the Tamil Cultural Association of Waterloo region, says local events are a great chance for the community to participate in traditions taking part in India, where some family members may still live.

"But it's also to show our community and build that inclusive community that knows and understands what our culture is and what beautiful traditions and culture that we have," Nadaraja said.

January is Tamil Heritage Month Pongal celebrations are also part of how the community marks Tamil Heritage Month, which Nadaraja says is a chance for all people in the region to learn about their culture.

"Our culture is beautiful and it's

incredibly diverse. There's so many forms of art, music. So it's very nice for our children to understand that we're part of that heritage," Nadaraja said.

It's nice to be able to mark these events, too, Nadaraja said, because many Tamils were forced to leave their home countries due to civil unrest.

"There's lots of struggles coming to Canada, building a life here and trying to still have our culture and experiences, but then build a new life here for our children so that they can then contribute to the landscape of Canada," Nadaraja said.

Sivasankaran says the festival is food-focused and a chance to thank farmers for the food on their tables. Pongal is also the name of a rice and lentils, similar in texture to a porridge, which is served for meals but also given as an offering.

"It's a way of saying thank you to the farmer and the sun," she said. "You need to be thankful every single stage of your life, every single meal that you get," Sivasankaran added and said that's a message she tries to instill in her children.

"It's not easy coming here. It has been challenging for me as a new immigrant coming all the way from India. I keep telling them if you don't get what you have eaten back home ... try to be thankful of what you get

here, because that's again being grown by a farmer, it doesn't come just like that on a tree," she said. "It's someone's

# Fact Check-Video showing Tamil celebration in Waterloo, Canada, does not involve UK government officials and staff

#### By Reuters Fact Check

A video being shared on social media shows celebrations of Pongal - a Hindu harvest festival celebrated by Tamil communities in south India and Sri Lanka, and by the Tamil diaspora taking place in the Canadian city of Waterloo, Ontario. It does not involve officials or staff from Britain's defence ministry or the UK Prime Minister's office.

One Facebook user, whose video has been viewed more than 18,000 times (here), posted footage of a group of people sitting at a long table eating food off what appears to be banana leaves. Some are wearing suits and two are seen in police uniforms.

The caption reads: "Viral Video of UK defense & PM's office staff celebrating Pongal/MakarSankranti festival. A welcome change."

Similar posts can be seen on Face-

- Berry Vrbanovic, while Tim Louis, an MP from the area, can be seen at 0:18. Both have mentioned the event on their respective verified Twitter accounts (here and here from 0:52 onwards).

Chief of Waterloo Regional Police Mark Crowell, seen in uniform at 0:21, also posted a photo on Twitter (here).

Other outlets have also addressed the claims (here, here and in Hindi here).

#### VERDICT

Miscaptioned. The video shows celebrations taking place in the Canadian city of Waterloo, with no British government officials or staff attending.

# Federal, provincial and territorial immigration Ministers meet to plan for the future of Canada's immigration system

March 10, 2023 Halifax, Nova Scotia

The Forum of MinistersResponsible for Immigration (FMRI) met today at the Canadian Museum ofImmigration in Halifax, Nova Scotia to continue their discussions onthe future of immigration in Canada. Ministers focused on advancingjoint initiatives to respond to pan-Canadian immigration prioritiesand were pleased with progress made towards improving theeffectiveness of Canada's immigration system to meet economic andregional needs.

In follow-up to the meeting last July, Ministers discussed increasingprovincial/territorial (PT) involvement in economic immigrant selection, increased allocations in the Provincial/TerritorialNominee Programs (PNPs), finding ways to improve applicationprocessing times, reducing duplication and providing greater agencyover PNPs. Ministers welcomed IRCC's first ever Multi-Year AllocationPlan, which includes an unprecedented 44% growth in PNP allocations for 2023. The plan also includes notional allocations for 2024 and 2025. Ministers also had productive conversations about settlement and integration efforts, Foreign Credential Recognition (FCR) and Canada'shumanitarian response to the developing situation in Ukraine.

**Canada's Immigration Ministers** condemned Russia's invasion of Ukraineand discussed how Ukrainians and their family members who are fleeingRussia's aggression and violence have been welcomed and supported.Ministers reviewed the initial results of the Ukraine Rapid ImpactEvaluation, taking stock of the policies and supports put in placerelated to Canada's immigration response. Ministers discussed theimpacts of the response on PTs, communities and municipalities, aswell as immigration stakeholders. Ministers continued to emphasize the need for a collaborative multilateral approach to cost and information sharing to ensure newcomers are welcomed in a coordinated and comprehensive manner. PT Ministers urged Canada to clarify the time frame of the Canada-Ukraine Authorization for Emergency Travel(CUAET) and to extend temporary measures, including the Canada-UkraineTransitional Assistance Initiative and temporary hotel accommodations, to assist displaced Ukrainians arriving in Canada. Ministers raised he need to have future discussions on pathways to Permanent Residencyfor Ukrainians for those who seek to remain in Canada or are unable toreturn home to Ukraine. Some Ministers raised the high volumes of asylum claimants crossinginto Canada between ports of entry and reflected on their capacity tomanage the new arrivals. The importance of



continuing to work togetherin supporting vulnerable people who come to Canada to seek asylum wasnoted.

Ministers discussed collective priorities on FCR, particularly as itrelates to internationally-educated healthcare professionals (IEHPs), with a focus on the important role of immigration and the FMRI inresponding to labour shortage issues, with PTs collaborating towardsbetter credential recognition for new Canadians. Ministers agreed tocollectively focus on key areas including in the selection stage, understanding the complex regulatory environment, advancing thequality of FCR pre-arrival information sharing and enhancing federal, provincial and territorial (FPT) collaboration, particularly with the-Forum of Labour Market Ministers.

Ministers recommitted to working together to deliver a more agile, client-centered economic immigration system where there is increasedPT involvement in the selection of economic immigrants. Ministersnoted the distinctive and essential FPT government roles and responsibilities that contribute to Canada's immigration system, and he need to maintain complementary and flexible programs. PT Ministersreceived updates on the development of category-based selectionthrough the Express Entry economic immigration platform and jointopportunities to reduce duplication in application processing, including streamlined assessments of PNP applications. Ministersdiscussed the necessity of improving federal immigration processingtimes for both temporary and permanent pathways. The FMRI placed acollective focus on ensuring the effectiveness of the immigrationsystem in meeting economic and regional needs and continued torecognize that PT knowledge of regional labour market needs is anadvantage that must be leveraged. Ministers considered how to continue to advance FPT collaboration onimmigration targets and regional economic immigration, including

keyprograms such as the PNP and Atlantic Immigration Program (AIP). ThePNP remains the primary tool for regional immigration and addressingemployers' labour market needs. Ministers agreed that the regionalization of immigration remains important and that, asimmigration targets increase, absorptive capacity of communities towelcome newcomers needs to be examined.

Ministers reflected on past service delivery models, the currentapproach, and what may be needed in the future for the delivery ofsettlement services, with an emphasis on exploring opportunities tobetter support outcomes and retention, including greater PTinvolvement and ada's current and future prosperity. Minister Fraser invited hiscolleagues to contribute to the recently launched StrategicImmigration Review.

Note: As requested by the Government of Quebec, the Quebec ministerresponsible for immigration holds observer status at theFederal-Provincial/Territorial Ministers' Table. Under theCanada-Québec Accord, Quebec assumes sole responsibility forestablishing immigration levels, and for the selection, francizationand integration of immigrants. In areas under its responsibility, Quebec develops its policies and programs, and legislates, regulatesand sets its own standards.

stock of currentfederal and PT roles in settlement services, recognizing bothsuccesses and challenges, as well as opportunities going forward. Ministers noted the value of locally-informed, flexible and responsiveservices that support immigrants' integration and retention in theirPT of landing. Ministers agreed to discuss service delivery models andthe role of the federal, provincial, territorial governments at thenext FMRI meeting.

Ministers agreed to take steps to ensure public support forimmigration remains strong, and to continue to work together to ensure that long-term FPT immigration and settlement goals contribute toCanticipated as observers due to aprovincial election.

## COMMUNITY WATCH CAREER GUIDANCE WORKSHOPS FOR HIGH SCHOOL STUDENTS MARKHAM 2023

The annual Guidance for Higher Studies workshops for High School Students organized by the Association of Sri Lankan Graduates of Canada (ASGC) in partnership with the York Region District School Board (YRDSB) was held on Saturday February 11, 2023 to promote higher education among youths. This extremely useful event for high school students and their parents were conducted from 10 am till 2 pm at Milliken Mills HS. These workshops were designed to serve as a forum for dissemination of information, exchange of ideas, and sharing of academic and professional experiences. The moderators and the panelist are selected based ontheir success in their chosen profession and their ability to relate to youth. 


# RAJA RAM MOHAN ROY, A SOCIAL REFORMER



22 May 1772 to 27 Sept 1833

#### INTRODUCTION

Raja Ram Mohan Roy was born in Radhanagar in Hooghly District in the present West Bengal, on May 22<sup>nd</sup> 1772. Ramakanto Roy and Tarini Devi were his parents. He was an Indian religious, social and educational reformer, who challenged traditional Hindu culture and pointed the way for the development in Indian society under the British administration. He been referred to as the founder of the modern India. **EARLY YEARS** 



His father despite being a highly conservative man, encouraged his son to seek higher education. In his village school he studied Bengali and Sanskrit. His parents then sent him to Patna to enroll in a Madrasa to study Persian and Arabic, as they were the court tongues of the Moghul Emperors at that time and they were also in high demand. He read the Quran, the Arabic translation of the works of philosophers like Euclid, Plato, Aristotle and also, the works of Sufi mystic poets. By the age of fifteen, he had learnt, Bengali, Persian, Arabic, Latin, Tibetan, Greek languages and Sanskrit, besides Hindi and English. At the age of 14, he wanted to become a sanyasi and his mother vehemently opposed the idea and so he abandoned it. He then went to Varanasi and studied the Vedas and the Upanishads and Hindu Philosophy deeply. He also studied Christianity and Islam. At the age of 16, he wrote a rational critique of Hindu Idol Worship. After finishing his schooling, Ram Mohan worked a s a clerk for the East India Company. Under Mr. John Digby, he was employed at the Rangpur collectorate. Later, he was promoted to the position of Dewan, which was reserved for native officers in charge of revenue collection. From 1809 to 1814, he served in the Revenue Department of the East India Company and also worked as a personal Diwan to Woodforde and

Digby. He first encountered English considerably later in life and picked up the language to improve his work opportunities with the British. Being a voracious reader, he consumed English journals and literature, gleaning all the information he could. While ancient literature like the Vedas, Upanishads and the Quan had taught him to value philosophy, he felt he had not received a scientific or rational education. So, he pushed for the establishment of an English-language educational system that would cover, mathematics, physics, chemistry and even botany among other science topics. He went to Calcutta in 1815 and immediately, launched an English college with David Hare, in 1817, with the help his savings because he saw education as a tool for enacting social reforms. He opposed the government's decision to solely open Sanskrit schools and he wanted his pupils to acquire the English language and scientific topics. The college went on to become one of the top educational institutions in the nation and produced some of India's brightest minds. He asserted that if Indians are denied the opportunity to learn modern topics like mathematics, geography and Latin, they will fall behind. His idea was adopted by the government and put into practice, but not before he passed aaway. This revolutionized the Indian educational system. He founded the Anglo-Vedic school in 1822 and the Vedanta college in 1826 to blend the traditional theological principles with contemporary intellectual teachings.

#### **HIS ACCOMPLISHMENTS**

Though he was born in a wealthy Brahmin family of Bengal. He felt that the society was trapped with social and religious inequities. He was a humanist and a democrat and couldn't tolerate the atrocities happening at that time against women. He became an activist foe education for women, widow remarriage,

divorce and other social evils. So, from 1814 onwards, he devoted his life to religious, social and political reforms. Some of his untiring work in these areas lead him to achieve various social reforms. They include the Abolition of Sati Pratha, Child Marriage, polygamy, Dowry system, Inheritance of property for women and Caste system. Ram Mohan Roy was appointed as an Ambassador to then Mughal Emperor to represent their cases to the East India Company and to the English King. In 1830, the then Mughal Emperor Akbar Shah II, bestowed upon Ram Mohan Roy the title of *Raja* to the court of King William IV. From that time on he was called Raja Ram Mohan Roy.

practice of Sati in ancient times was voluntary, but during the medieval period, it might have been forced on some widows. There is no doubt that this custom was inhumane and barbaric, but many Hindu-haters used this to preach against Hinduism, conveniently ignoring the fact that many other cultures like Greek, German, Slav, Scandinavian, Egyptian and Chinese also practiced it.

Growing up Ram Mohan Roy had witnessed the heinous tradition of Sati where widows as young as 12 years of age were forced to jump on their dead husband's pyre. It all started when his sister-in-law got forcibly burnt at the pyre of his brother. He vouched to abolish the tradition and to do so he visited the cremation grounds to persuade widows against immolation. He formed watch groups to protect women, sought the support of other elite Bengali classes and published articles to show that Sati was not required by Hindu scripture but was a patriarchal practice that reduced the purpose of woman's existence to just being a wife. He even travelled to England to ensure that Lord William Bentinck's Sati Regulation Act of 1829 banning the practice of Sati was 19th century. He used his pen to emerge as a true changemaker for women in the Indian society of the 19th century. He published Sambad Kaumudi, a Bengali weekly newspaper that actively campaigned for the abolition of the Sati. Inheritance of property for women and inter-caste marriage were also some topics that were undertaken by him. The

> efforts of Raja Ram Mohan Roy resulted in the freedom of Press and anatomy to newspapers in 1835.

This horrible behaviour repulsed Raja Ram Mohan Roy, who spoke out against it. He voiced his opinion openly and addressed the East India Company's top officials. Through the ranks, his persuasive argumentation and perseverance

eventually got to the Governor General Lord William Bentinck. The Bengal Code Regulation XVII, A.D., also referred to as the Bengal Sati Regulation, was passed in response to a great deal of opposition from the orthodox religious community and thanks to Lord Bentinck's sympathy with Roy's intentions and feelings. The law made it illegal to practice Sati Daha in Bengal Province, and anyone found doing so would be prosecuted. Raja Ram Mohan Roy will thus be remembered as a genuine benefactor of women who not only worked to end Sati tradition but also spoke out against polygamy and child marriage and demanded that women have the same inheritance rights as men. He was a fierce opponent of the severe caste divisions that prevailed at that time.

#### **ABOLITION OF SATI PRATHA**

Sati Pratha was a Hindu custom in which the widow of the dead man immolated herself willingly or forcibly on his funeral pyre. The

rejoiced a liberal concept of love and they had freedom to choose a partner and enter into romantic relationship with each other without any fear of scandal. However, from the Middle Age, as states and governments developed the political system elaborated and modified the Indian society gradually. It transformed the lifestyle and opinion of its people from a simple to more complex form, restricting significantly the notion of liberty. Women lost their rights and had for a boy is 25 years or more and that of a girl is 18 years or more. However, from the Middle Ages to the present day the custom of child marriage against Vedas persists in India. There are many reasons to believe that this custom actually originated in the medieval time when the political climate was unstable and law and order were not yet fixed on the national level. Arbitrary powers were concentrated in the hands of a hierarchy led by a despotic monarch. Hence. Parents would seek to get over with the responsibilities of their daughters by getting them married very young.

More than 40 per cent of the world's child marriages take place in India, even though the legal age for wedding is 18, reported UNICEF. Child marriage is of course banned in India and the Indian government has taken a strong step to tighten laws against child marriage, but unfortunately this custom continues to exist in spite of legal interdictions. According to the new bill, Prohibition of Child Marriage Bill 2006, the

to obey rules and respect the code of behaviour. They were now subject to family discipline and the honour of their clan. Since young women were considered irresponsible and irrational in love, parents married them early before they got caught into any scandal. Though, the age at which the girl was to be married differed and it was rare for girls younger than 12 to be married. Nevertheless, girl brides became younger towards the Medieval period, and it became increasingly common for girls as young as six or eight to be married in Indian society. As per the Hindu philosophy, marriage is not just a process of coming together of the individuals, but it is also a holy bond and a commitment which lasts a life time. Even the holy scriptures of the Vedas the sacred Hindu texts suggest that an individual should enter the phase of Grahasta (household) after his or her student life. Thus, it can be said that marriage is almost a mandatory custom in the life of all the Hindus. According the philosophy of the Vedas, there is a restriction on child marriage. The age

priests, the police or leaders will be jailed and fined if they are found indulged in this illegal practice, declared Renuka Chowdhury, Minister for Women and Children. This bill gives protection to many children forced into marriage every year in the rural parts of the country.



a forerunner of the Brahmo Samaj. The three main tenets of this new movement were monotheism, disassociation from the scriptures and rejection of the caste system. Brahmo religious rituals were established following Christian or Islamic prayer customs after being completely cleansed of Hindu ceremonialism. With time, the Brahma Samaj developed into a potent force for social change in Bengal, particularly in the area of women's education. It is considered to be one of India's first socio-religious reform movements and believes in the fatherhood of God and brotherhood of mankind. It forbids idol worship and opposed to meaningless rites and rituals. Raja Ram Mohan Roy believed in one supreme God and preached to love human beings, stop animal sacrifice and offerings. Brahmo Samaj strongly fought against the caste system, dowry, racism, polygamy, infanticide, the seclusion of women and the purdah system.

#### CONCLUSION

Raja Ram Mohan Roy used his pen to emerge as a true changemaker for women in the Indian society of the 19th century. He left the job of the East India Company and fought two battles. The first was for the independence of India and the other against the citizens of his own country. Though he was termed as the chamcha (friend) of the British by the people who possess half his intellect, Raja Ram Mohan Roy encouraged feminism, male feminist and free thinkers. His glorious deeds will be cherished now and for years to come. He was one of the key personalities of Bengal Renaissance. He re-introduced the Vedic philosophies, particularly the Vedanta from the ancient Hindu texts of Upanishads. He made a successful attem to modernize the Indian society. In his address, entitled, *Inaugurator of* the Modern Age in India, the great Rabindranath Tagore referred to Raja Ram Mohan Roy as *a luminous star* in the firmament of Indian History. He visited England as an ambassador of the Mughal King Akbar Shah II, and petitioned the Imperial Government to raise the royalty paid to the Mughal Emperor. While there he passed away from meningitis on September 27, 1833, in Stapleton, Bristol. He was laid to rest in Bristol's Arnos Vale Cemetery. In honour of Raja Ram Mohan Roy, the British government recently named a roadway in Bristol as Raja Rammohan Way.

#### **BRAHMO SAMAJ**

Among the countless achievements, Raja Ram Mohan Roy's greatest achievement was that of setting up the *Atmiya Sabha* in 1828. The Atmiya Sabha changed its name to *Brahma Sabha*,




