

VETERAN SRI LANKAN TAMIL POLITICAL LEADER R. SAMPANTHAN PASSES AWAY



Mr. Rajavarothiam Sampanthan 5 February 1933 - 30 June 2024

The veteran politician advocated for Tamil rights within a united ■ Sri Lanka, and his demise leaves a void in the country's quest for reconciliation. Honourable Rajavarothiam Sampanthan was a Sri Lankan politician and lawyer who led the Tamil National Alliance from 2001 until his death on June 30, 2024. He was a Member of Parliament from 2001 until his death, and previously from 1977 to 1983 and from 1997 to 2000. He was the Leader of the Opposition from September 2015 to December 2018.

UK GENERAL ELECTION

The Labour Party has won a landslide victory in the July 4, **2024 General Election**

The Labour Party has taken 412 seats giving it a majority of 174.

It is the worst Conservativeresult in terms of seats in history, with the party on 121. The Liberal Democrats have their highest tally since 1923, taking 72 seats.

The SNP have nine seats. Reform UK have five and Plaid Cymru and the Green Party have four each.

Some 23 seats were won by other parties, all in Northern Ireland, and independent candidates.


The biggest gap on record emerged between the share of the vote won nationally by parties and the number of seats they have gained.

The Rt Hon Keir Starmer became Prime Minister on 5 July 2024. He was elected as the member for Holborn and St Pancras in May 2015. He was elected leader of the Labour Party in April 2020.

Number of 'Struggling' Canadians on the Rise Despite Slowing Inflation: Report

One-in-three Canadians (32 percent) now fall into the "struggling" category, up from one-quarter two years ago, said the Angus Reid Institute (ARI) in its July 9 report. In addition, the number of Canadians in the "comfortable" category has decreased to 23 percent, down from 29 percent in 2022.

Economic stress is not evenly distributed across the country, the report says.

Canadians experiencing economic distress are most prevalent in major western cities such as Regina, Saskatoon, Edmonton, and Calgary, as well as suburban Toronto, while Montreal residents are most likely among urbanites to be categorized as "thriving."

Nearly half (46 percent) of respondents in Saskatchewan and Newfoundland and Labrador were classified as struggling.

The findings come as the annual inflation rate stabilized, with the Consumer Price Index declining to 2.9 percent year-over-year in May, down from 3.4 percent in May 2023, according to Statistics Canada data.

The researchers attributed an unexpected increase in the inflation rate in May—to 2.9 percent, up from 2.7 percent in April—primarily to rising shelter costs. Despite a consistent downward trend in the inflation rate over previous months, Canadians continue to perceive that overall prices are climbing.

"While inflation may be decelerating, Canadians continue to feel that



everything is getting more expensive around them," the ARI report stated.

Concerns about housing affordability rank high among Canadians, with 33 percent surveyed by ARI expressing this view. Among those grappling with housing costs, over 44 percent say they are having a "tough" or "very difficult" time managing these expenses, marking a two-percentagepoint increase from last year and a seven-point increase compared to 2022. This percentage increases to 47 percent among homeowners with a mortgage and jumps to 56 percent among renters.

Preceding housing cost concerns, three-in-five Canadians (60 percent) consider cost of living as their paramount worry, followed by health care at 41 percent.

Researchers noted that Canadians have also reported grappling with rising costs of essential goods and

services. Despite data from Statistics Canada showing a decline in fresh produce prices since January, 87 percent of Canadians believe that the cost of produce has actually increased, the report said.

The survey also showed widespread economic pessimism among Canadians, with only 18 percent expecting their financial situation to improve over the next year. In contrast, 34 percent anticipate their finances will worsen, while 39 percent expect no significant change.

ARI conducted the online survey from June 14-20, polling a total of 4,204 Canadian adults who are members of the Angus Reid Forum. The report carries a margin of error of plus or minus 1.5 percentage points, 19 times out of 20.

Happy July to the readers of the Monsoon Journal!

This month's issue is pleased to present a variety of stories that touch upon many recent elections and politics happening across the globe. For instance, the Conservative Party of the United Kingdom under Rishi Sunak were defeated by the UK Labour Party, led by Keir Starmer, in the UK parliamentary general election. France itself saw its highest voter turnout since 1981. Over in Europe, Emmanuel Macron, Prime Minister of France, is now encountering a highly sensitive political environment with the setup of a left-wing coalition after their parliamentary election results.

The electoral match between Joe Biden and Donald Trump will certainly test the pulse of voters as they not only decide their future, but also the impact of populism in today's politics. These elections serve as an example as to why voting is a right that should not be taken lightly. It really has a power of determining the kind of town, state, or country that voters, as people, want to make a life in.

The appetite for change is strong among voters, but, at the same time, it is important to educate ourselves on the issues that matter to us. As stated previously in past issues of the paper, voting is more of a duty, rather than a right, to your people, to society, and to the community. 
to both the Tamil community and the broader public in Canada.

GTF pays tribute to Tamil Elder Statesman Mr. R Sampanthan on his passing

19TH YEAR IN CIRCULATION

The Global Tamil Forum (GTF) **L** is deeply saddened by the passing of the Tamil elder statesman R. Sampanthan on June 30, 2024. We express our heartfelt condolences to the family and friends of the departed leader and all those mourning the loss of Mr. Sampanthan.

Mr. Sampanthan had a long and illustrious political career. He has been a Parliamentarian for nearly 50 years, the Leader of Opposition in the Sri Lankan Parliament between 2015 to 2018, and led the Tamil National Alliance for the last 23 years. Mr. Sampanthan was an ardent advocate for Tamil rights and dedicated his political life for pursuing a just solution for the Tamil national question.

From the time of Sri Lankan independence (1948), Tamil polity has been blessed with great elected leaders. From fifties to seventies, as the Sinhala Buddhist nationalism exerted its dominance at the expense of minority communities, Tamil community was ably led by late S.J.V. Chelvanayakam, who coalesced Tamils into a strong united front, adopted Gandhian methods of resistance against oppression, and made attempts at negotiating self-rule arrangements for the Tamil-majority Northern and Eastern Provinces. This tradition of strong, committed leadership continued under the late A. Amirthalingam during the seventies and eighties, a period during which armed resistance to state oppression and violence emerged and eventually dominated all aspects of Tamil politics. Mr. Sampanthan became the prominent, elected Tamil leader during this tumultuous war period.

The civil war that ended in 2009 presented unprecedented challenges for the Tamil community – the community lost, not only immense number of lives and property, but hope itself. The victorious majoritarian leadership did not waste time in using the opportunity to marginalize Tamils even further. The international community looked upon the Tamil leadership with ambivalence about their past and future



political agenda. This crucial period was ably navigated by Mr. Sampanthan, who solidified and rebuilt the Tamil political leadership through carefully calculated initiatives and a pragmatic political program. An important highlight of this era was the crucial role Mr. Sampanthan played in the political transition in 2015, which provided much needed breathing space for Tamils to recover from their losses and to regain a sense of normalcy.

Mr. Sampanthan's uniqueness comes from the fact that he could strongly articulate for Tamil interests, while fully conscious of the interest of the country and the concerns and fears of the majority community. There were innumerable occasions when Mr. Sampanthan eloquently argued for a political solution building on Sri Lanka's constitutional history and the many promises the Southern Sinhala establishment made in the past but failed to keep. In the same breath, his demands for equal rights for Tamils never left unsaid that they were within a 'united, undivided and indivisible' country.

When Sri Lanka showed no inclination of addressing the serious crimes committed during the war, it was Mr. Sampanthan who provided the pivotal leadership in ensuring that Sri Lanka would be subjected to UNHRC resolutions and oversight (from 2012 onwards) for promoting human rights and reconciliation in the country.

Equally, when Sri Lanka was paralyzed by a constitutional crisis (2018), Mr. Sampanthan provided

principled leadership to overcome the crisis with the interest of the country at heart.

It is such qualities that made Mr. Sampanthan a highly valued leader, both in Sri Lanka and among the international community. GTF have witnessed on many occasions the high praise bestowed on Mr Sampanthan – by leaders of all communities in Sri Lanka, and by political leaders and diplomats from many countries.

A sentiment often expressed – both in Sri Lanka and internationally – was that the national question in Sri Lanka had to be resolved during Mr. Sampanthan's lifetime. Undoubtedly, that epitomises the respect and admiration with which Sampanthan was held, and will firmly place him in the pantheon of great elected Tamil leaders from Sri Lanka. But the hard fact is Mr. Sampanthan is no more, but Sri Lanka is yet to address its decades old national question to the satisfaction of all communities.

For many decades now, Sampanthan was the face of Sri Lanka's Tamil community and its struggle for recognition, justice and equality. After such a dominant presence, replacing him with a new and capable leader will be a huge challenge. GTF hopes the new leader will follow on the footsteps of Mr. Sampanthan – relentlessly articulating for Tamil interests, while integrating those with the wellbeing of the country as a whole.

On the other hand, all communities in Sri Lanka, and particularly those from the majority community, need to reflect deeply why they have failed to find a just and lasting solution to the national question over such a long period.

Perhaps the time is now. Working towards a just and equitable outcome with goodwill and honesty to what the late Mr. Sampanthan often referred as "the National Question" will be the ultimate tribute the country could pay to Mr. Sampanthan.



Uma Kumaran, British Tamil, Elected MP for Stratford and Bow in the U.K.

19TH YEAR IN CIRCULATION



 Γ n a landslide victory for the Labour Party, Uma Kumaran has been elected as the Member of Parliament for Stratford and Bow, following the General Election which took place on Thursday 4 July 2024.

Her election marked a significant milestone as she became one of the first British-Tamil MPs after a landslide victory for her party.

Ms. Kumaran, born in East London, has roots in Sri Lanka. Both her parents are Tamils who fled Sri Lanka in the '80s during the Sri Lankan civil



Ms. Kumaran is a former Director of Diplomatic and International Relations for the Co-Chairs of the C40 Cities Climate Leadership Group. In this role, she collaborated with nearly 100 global mega city mayors, governors, their teams, the United Nations, Bloomberg Philanthropies, and several leading advocacy organizations to campaign for stronger, bolder action to tackle climate change.

Ms. Kumaran also served as the



Deputy Director of Parliamentary Affairs for the Leader of the Opposition, where she played a key role behind the scenes preparing for Prime Minister's Questions (PMQs). Additionally, she was an adviser to the Mayor of London, Sadiq Khan.

With over 16 years of experience in political strategy and highlevel advisory roles, Ms. Kumaran has worked for the last Labour Government, in local government, and at the heart of London government in City Hall. Her early career included positions within the NHS and volunteering as a hospital radio DJ.

Ms. Kumaran first contested in the 2010 local elections in Harrow, London, as one of the Labour Party candidates, but was not elected.

Why Has Canada Slept?

Wake Up Canada - The Aviation Industry

The origin of Canadian Aviation dates back to 1840, to New Brunswick, St.
John with the first manned flight in a balloon that began in 1840. The Wright Brothers's aviation thirst in 1903, at Kitty Hawk, North Carolina, inspired our Alexander Graham Bell, and the Canadian aviation industry took its first step, with Bell's Silver Dart in 1909. I believe there were no great strides till the end of the war, after the Silver Dart's flight.

As the war ended, and since lots of Canadians played a great role in the war, and the training they had with RAF, brought in a new passion and flavor for the Aviation industry. The timeline of the Aviation industry is phenomenal.1915 saw the first production of aircraft in Canada, Curtiss Aeroplane, of New York, set up a small plant in Toronto, and started to make JN-4 training aircraft, built almost 20 planes, exported to Spain and the aerospace industry was born in Canada. Aviation played a major role in opening up the North.1937 saw the birth of a subsidized national carrier "Trans Canada Airlines, which later became Air Canada". In a way. WW2 accelerated the aircraft manufacturing sector, and the aerospace industry started to evolve into a major component of our economy. Boeing's Jet age brought in a new mode of transport to Canadian's lives, and the airline industry started to garner more interest with Canadians.1937 was a moment of pride for Canadian aviation, since the Government of Canada, formed Trans-Canada Airlines, and in 1964 this venture became Air Canada. Department of Transport Act was created in 1937, and thus aviation was placed under the DOT as in USA (FAA functions under DOT umbrella).1937 was another memorable moment, as the first coast-to-coast passenger service took place between Vancouver and Seattle. This was a flight of 55 minutes with 2 passengers and mail on board the Lockheed L-10A. Aviation activities and interest started to grow in aviation, which resulted almost soon after the war. An authorative body was created by the United Nations, International Civil Aviation Organisation, ICAO, and is headquartered in Montreal to monitor the aviation sector of the world with a set of universal standards of rules and regulations. Canada is one of the original 52 member states and signatory for this convention. Another aviation big name too, is headquartered in Montreal, Quebec, IATA- International Air Transport Association. IATA is a trade association of the world's airlines founded in 1945 in Havana, Cuba. The year 1990 gave birth to the Transportation Safety Board which was created by the Canadian Transportation and Safety Board Act on March 29th. NavCanada was entrusted with the task of Air Navigation in Canada and The Canadian Aviation Regulations became a Law in 1996 for Air Navigation. Safety Management Systems, SMS was created in 1999, which sets Canada being the first in the world to implement SMS, as a new way to eliminate safety risks in civil aviation.

From the above profile of Canadian Aviation anyone can see how our aviation industry has evolved from 1909 and progressed to be the 5th largest aerospace industry of the world. I feel personally that what Canada has achieved is great, but why can't they strive to project themselves as a global leader in the aviation and aerospace industry? rather being complacent. Canada have people from over 160 countries who live here and call it their home. We are a multifaceted, multilingual, and multitalented nation and should be able to pool all the resources and build an aviation and aerospace industry unparalleled to any

country. We should not be happy having only one small aircraft manufacturing company, Bombardier in Quebec. Why can't we build an aircraft with long range capabilities, and be better than the Boeing company? We should not be in the shadow of our Big Brother, as far as the Aviation Industry is concerned. We should strive to achieve more and more.

Boeing has been outsourcing its aircraft parts needs, and also the airlines, outsource their MROs, maintenance and repair overhauls, to South American Countries. If our Federal and the Provincial Governments can work together we could get them to move to Canada for all these services and they are bound to get the best of the best services, from our qualified technicians without the safety being risked or compromised. The Boeing company is in crisis because of substandard work. This could be avoided if Boeing Company works with our aviation experts through the government negotiations. This will increase employment and monetary benefits for us. Aviation industry is a big money spinner and we should use the full potential to attract major aircraft manufacturers to all the Provinces in Canada.

According to Dr .Suzane kearns, PhD,an Associate Professor at the University of Waterloo for Aeronautics, Quoting her, "We will face a shortage of qualified pilots by or before 2036, which might jeopardize our aviation sector with far reaching consequences for our aviation industry, and economy. She forecasts, we may require more than 3000 new pilots by 2025". We have to start training more pilots and restructure the training programmes for the flying schools to attract more cadet pilots. The cost factor may play an important role to turn away lot of anxious youngsters who wants to learn flying and make it a career. Federal and Provincial governments must weave a web, to lure more students


to take up flying and provide them loans payable after 10 or 15 years. Also, instead of the private flying schools, we must have government funded schools to train pilots, engineers, and other aviation professionals as soon as possible, if we want to be a leader in global aviation. If countries with less human potentials can rise up to this challenge why not Canada? I am selfish in suggesting this. Our Pilots who graduate here must serve with Canadian airlines at least for 10 years. They are attracted to other major carriers for attractive salaries and benefits. Mr. Mohan Nithy, a co-owner of MAP Aviation Flying School at Peterborough says, "all the pilots are attracted to other countries because of the lucrative salaries". Also I call upon all the CEOs of the Canadian airlines to bury their greed, pay handsomely to the Pilots and Cabin crew, who are real money spinners for this country and for the airlines.

I don't want to shy away from a strong criticism by a respected agency regarding our aviation portfolio. It is a scathing report, and downgraded our status from level A to C, which shows Canada's abject failure, not to consider aviation as of paramount importance to the second largest country, in the world Canada. After 115 years in aviation, this connotation is highly unacceptable. This confidential report by the UN agency, ICAO, was published by the Canadian press on Dec 7 2023, was written by Christhoper Reynolds, Quotes "Canada has received a C grade on flightsafety oversight, down from A+, almost two decades back. The three areas the agency was concerned namely aircraft operations, airports and air navigation". They were critical of these areas, Air Navigation, is managed by NAV Canada, responsible for managing the 18 million square kilometers of Canadian civil airspace and the North Atlantic oceanic airspace. NavCanada is privately owned, and managed by a non profit organization, provides all the Air Traffic services, Aeronautical information, Air navigation technology, Train Air Traffic Controllers, and provides an excellent service. But they must be proactive and recruit more ATCs, reduce their workload, and hours of duty from 8 at least to 6 to 7 hours instead of 8 to 10 hours, to minimize fatigue which would eventually affect air safety. But the biggest concern of the report is about airport operations and the oversight of all these facilities. The shifting of oversight responsibilities to private management services will be a cancer to our aviation industry. DOT of Canada, must directly supervise all these functions rather than allocating to A,B,C,D, & other Aviation services as a cost cutting measure. This will put the quality of aviation to an abysmal level. Palming off the airport security, scanning the baggage, and the dangerous goods to private security is highly unacceptable. All the airport facilities should be managed by the Government of Canada, and with the assistance of the Provincial Governments. We remember the Gold Heist 2 years back from the AirCanada Bond room, with fake clearances. The present



system of management is alarming as successive Provincial Governments are more interested in cost saving \$, than in saving Human Lives and Humanity. Human Lives are not Expendable at any cost.

Being in aviation for 5 decades, and counting more by my passion, to uplift an industry that is dear to my heart, I always strive my best to speak my mind even if I am pilloried. Canada's largest airport, Malton Airport, renamed Lester Pearson in 1984, had the first passenger flight, a DC-3, an American Airways, from Buffalo New York, in 1938, August 29th, was a good one. Lester Peareson is in operation for more than 50 years, and I strongly feel and urge both the Governments, to consider having a brand new, real state of the airport, that

could last for another century, with room for modifications at all times, even if we have to relocate the present one with a large landscape of 50 square kilometers or more. Look at the airports around the world that are inspiring, and our one is a "far cry" for me. In 1975 England's Heathrow had 3 terminals only, and started digging for the 4th and 5th, and witnessed while I was there. Singapore's Changi airport, was built on reclaiming the land from the sea which started in 1976, and happened to be there too on familiarization with Singapore Airlines Flight Operations, for 2 weeks, and witnessed it. It has 5 terminals, and has every facility, that a modern city should have. What a marvelous design by Netherlands Airport Consultants. I envision the day where we will have our Subway train docks into our airport terminals to provide easy access.

The Canadian Airlines that are operating here, also bring disrepute to our country's aviation industry to a large extent, by their callous disregard, Corporate greed, and avariciousness of the executives. This sort of behavior should be rooted out and the Federal governments and the Provincial governments should impose strict laws to prevent the abuse of the flying public's rights. They should follow the dictum "That The Customer Is Always Right, Even If It Is Otherwise", this will enhance reputation, and will speak volumes of our aviation industry. The Government and the CEOs use the airlines as "Cash Cows", instead as a service to the flying public.

My humble submission is this. The FREE FALL of Boeing Company, had a cousin the FAA, who enabled it inadvertently, by relinguishing the oversight duties, for which the FAA was established in late 1950s. Our DOT and NAV must work, hand in hand to reboot the aviation industry to the highest level, and to regain the trust of the world. It is absolutely true we didn't have any major accidents, but incidents were there, that could have been fatal but, thanks to God. I don't want to envision that scenario. There were few, but the ingenuity, and the resilience of our pilots saved the day. Wright Brothers gave birth to aviation for the Right reasons, And The Bright Brothers Who Hold The Mantle Of Canada, Must Do It Right, Serve It Right, To Protect The Citizens Of Canada. Canada Pull Up Your Socks, and I don't want you to be Nose Diving. My Earnest Appeal, In The Name of Aviation, As We Proudly Celebrate 157 Years of Canada's Birth, I Don't Want the Aviation Industry Dying Slowly.



The word Kurunthokai in Tamil literally ▲ means collection of short ones, and it is a classical Tamil poetic literature of Sangam era, dated BC 300. It falls second in the Ettuthokai, meaning eight anthologies. The poems in this anthology fall into the category of *aham* meaning matters pertaining to emotions or personal relationships like love. These poems are short from four to eight lines except two of them have nine lines.

The poem number 95 Kurunthokai was authored by the poet Kapilar, who had composed 206 poems in Sangam literature. Interestingly another great saintly poet who is hailed as the lawgiver of the Tamil race and to the world, St. Thiruvalluvar, in his famed book Thirukkural, calls the lass as a wondrous fire of different nature, which cools when near and warms when she moves away, in his couplet 1104;

Withdraw, it burns; approach, it soothes the pain;

Whence did the maid this wondrous fire

நீங்கின் தெறூஉம் குறுகுங்கால் தண்ணென்னும்

தீயாண்டுப் பெற்றாள் இவள்.

In the above couplet St. Thiruvalluvar portrays a woman as a different sort of fire, and goes on to say this fire performs opposite of what happens in the presence of normal fire. We all will agree that normally when one gets closer to the fire they will feel the warmth, and as he moves away it will progressively become cooler. St. Thiruvalluvar says as opposed to that notion when the lad moves away from the lass his heart will burn with desire, and as he gets closer, he will feel way cooler as his thirst of his heart is quenched.

Likewise, to this couplet from Thirukkural, in the poem Kurunthokai # 95, poet Kapilar observes that the lass makes our hero cooled down when he gets closer to her. The episode of this poem is composed as if a young hero voicing to his friend about his feelings of love. The whole event of this poem is comparing the effects of inanimate substance to human feelings and presence. Like inanimate fire bows down to the might of water, the burning emotions of a youth bows to the countenance of a young lass. The poet makes the clash between water and fire, to flash in front of our eyes. The episode took place in Kurunji terrain, meaning mountainous region. He starts by describing the terrain with the first line saving from a sky-high mountain cascades the clear white stream of water.

From Sky high mountain cascades the clear white brook.

Next the poet describes the scenery of the Here is the full poem both in English mountain sides where the water flows on a creek causing echo in the crevices of the mountain, the rest of the mountain sides are overgrown with a variety of flower bushes giving a beautiful sight.

Echoing in the rock crevices, mountain slopes with variety of flowers

After describing the setting of the episode, the poet goes to describe the two characters of the event, by describing first a person from the tiny hamlet's comes a young lass, describing her as having broad shoulders. Interestingly in the modern age we may not much appreciate the beauty of broad shoulders, during the Sangam

era, people appreciated the broad shoulder that carried the family, further it is the shoulder of the lass that holds him tight to her breast!

However, he goes on to describe the lass as having the countenance like water, meaning her beauty is gentle like water. Probably the bard had remembered the brooks flowing down the sides on the hill;

It is interesting to note that just after mentioning the countenance as though strong shouldered was also soft like water, which had quenched the lad's carnal thirst.







The Story of Black Settler Levi Carroll

In an exciting collaboration with local researcher Peggy Plet, the City of Waterloo Museum is thrilled to bring Levi Carroll's story to life in Waterloo Park this July and August, right within the cabin you pass on your leisurely walks.

Join us in Waterloo Park this summer to explore what makes a place a HOME and uncover Levi's inspiring story. Throughout the summer, we have planned a series of engaging hands-on activities, and our knowledgeable staff will be on site to answer your questions and share the rich history of Levi and his family.

Few are unaware of the log cabin's dual history in Waterloo Park or the fact that it was in Waterloo, moved to Berlin (Kitchener), and then moved back to Waterloo. Many have only known it as Ontario's earliest schoolhouse. However, these walls have more of a story to tell, and local researcher and author Peggy Plet is eager to share this story with the community. The unassuming log house in Waterloo Park, once nestled in Berlin (Kitchener), is the backdrop for the remarkable story of Levi Carroll and his family. Formerly an enslaved

labourer, his journey to freedom allowed him to cultivate crops for his own profit in the Waterloo Region. Carroll played a significant role in the settlement of this area, calling the cabin his home for over 50 years. Levi purchased the plot of land near the High School (Kitchener Collegiate Institute). The sale contained all the buildings on the property, including the log cabin he had lived in for 16 years. He raised his family here and was a well-known member of the community. Many remembered him as quiet, kind, well-liked and respected. Levi would live to be one of the oldest residents in the area.

All feedback collected during Community Conversations will be summarized in the City's annual progress reports and form the basis for the 2027 to 2030 Strategic Plan.





City of Brampton shares next steps of the Residential Rental **Licensing Pilot Program**

The City of Brampton is **L** providing an update on the next steps in the Residential Rental Licensing Pilot Program (RRL) since the initial registration fee waiver period has closed.

From July 1 to September 30, the RRL registration fee will be discounted 50 per cent from \$300 to \$150. To date, close to 2,000 registrations have been received. As part of the pilot, landlords in Wards 1, 3, 4, 5 and 7 are required to register their rental units to help create a safer community for everyone.

In the next phase of the pilot, the City will begin implementing measures to ensure compliance. City Council endorsed fines for noncompliance with the RRL pilot program as follows:

- ▶ \$600 for a first offence
- ▶ \$900 for a second offence
- ▶ \$1,200 for a third and subsequent offences

In addition, Brampton Enforcement and By-law Services and Fire Prevention will continue to focus efforts on community education and conducting inspections in response to residents' concerns or where there have been previous concerns of compliance with property minimum maintenance standards and or fire safety.

The City of Brampton will provide updates on the pilot program as it continues to be implemented.

About the Residential Rental Licensing Pilot Program

The City of Brampton is committed to creating safer places for renters to call home. Brampton's Residential Rental Licensing Pilot Program aims to maintain neighbourhood character, enforce property

standards and uphold the Ontario Fire Code for safety to create safer places for renters to call home. Landlords in Wards 1, 3, 4, 5 and 7 with one to four rental units must obtain a licence per property.

Good neighbours, stronger communities; noise by-law reminders for the summer season

Being a good neighbour means being mindful of the noise you create and its impact on those around you. With warmer weather bringing more opportunities to socialize and celebrate outdoors and undertake projects and renovations, to ensure a peaceful and enjoyable community for everyone and in accordance with By-law 93-84 and Public Nuisance By-law 136-2018, residents are reminded to keep noise at a reasonable level.

When hosting a social event, avoid playing loud music, especially during late hours. In addition, be mindful of dogs to ensure they do not bark excessively.

If undertaking home renovations or using loud equipment, do so during reasonable hours. The operation of heavy equipment, machinery or tools used in construction, drilling or demolition is not permitted between 9 pm and 7 am, except until 9 am on Saturdays, Sundays and statutory holidays. To minimize noise disruptions, power devices, such as lawnmowers, grass trimmers, drills, sanders, grinders or similar devices, are also not permitted for use outdoors within a residential area between 9 pm to 7 am, except until 9 am on Saturdays, Sundays and statutory holidays.

Vehicle mufflers or other devices which emit loud, explosive or unreasonable noises, including modified mufflers or exhaust systems, are prohibited. Vehicles cannot operate on a roadway if the exhaust outlet exceeds 92 decibels A (dBA) while the engine is idling. That is equivalent to the sounds of a hair dryer. Repetitive exposure to noise at this level without protection poses a risk of irreparable hearing damage. Excessive and unnecessary motor vehicle noise, such as sounding horns, revving engines or squealing tires, is also not allowed. In addition, residents should avoid repairing, rebuilding, modifying or testing any motor vehicle, motorboat, outboard motor or recreational vehicle outdoors within a residential area between 9 pm to 7 am, except until 9 am on Saturdays, Sundays and statutory holidays.

Residents are encouraged to contact Peel Regional Police to report noise disturbances related to fighting, screaming, shouting, swearing or the use of insulting or obscene language, as these activities may constitute criminal offenses. In cases of loud parties, Enforcement Officers may also refer complaints to the police.

INTRODUCTION

The world renowned Rameswaram temple also known as Sri Ramanathaswamy temple, is a glorious Hindu Temple at the southernmost edge of India. This temple is dedicated to the Hindu God Siva. Rameswaram, as its very name implies, is the holy place of Rameswara, i.e., Iswara installed by Rama. The presiding deity is known variously as Rameswara, Ramalinga or Ramanatha. This temple is considered a holy pilgrimage site for both Saivites and Vaishnavites. Mythological accounts depict the presiding deity, the Lingam of Ramanathaswamy (Siva), as having been established and worshipped by Sri Rama, before he crossed the bridge to the presentday island of Sri Lanka. Rameswaram is as old as Ramayana. Its importance as a place of pilgrimage is equalled by only that of Kasi (Varanasi). Pilgrimage to Kasi will be completed only after worship at Rameswaram besides a holy bath in *Danushkodi* (Setu) at the confluence of *Mahodhadi* (Bay of Bengal) and Ratnakara (Indian ocean). Setu is a Sanskrit word to denote a bridge or a causeway. It has now acquired a special significance to mean the bridge across the ocean constructed and used by Rama to reach Lanka. It is said that, at the request of Vibhishana, brother of Ravana and an ally of Rama, Rama broke the Setu with one end of his bow and hence the name Danushkodi (Dhanus means bow and Kodi means end).

LEGEND



According to Puranas, as advised by Rishis, Rama along with Sita and Lakshmana, installed and worshipped the Sivalinga here to expiate the sin of Brahmahatya for killing a Brahmin (Ravana was a Brahmin being the grandson of Brahma himself). It is said that Rama fixed an auspicious time for the installation of a Siva Linga and sent Anjaneya to Mount Kailas to bring a Lingam. As Anjaneya could not return in time Rama asked Sita to make a Lingam and she made one with sand and Rama, Sita and Lakshmana worshipped it. When Anjaneya returned with a Lingam from Mount Kailas and found that they had already installed a sand Linga and worshipped it, he was enraged and tried in vain to remove the Lingam of sand. To pacify Anjaneya, Rama had Anjaneya's Lingam (Visvalingam) also installed by the side of Ramalinga and ordered that all the pujas should first be performed for the Visvalingam brought by Anjaneya. Ramalinga is one of the twelve Jyotirlingams in India which include the ones; Viswanath Jyotirlinga in Varanasi (Kasi), Kedarnath Jyotirlinga in Rudraprayag, UP, Somnath Jyotirlinga in Gir, Somnath, Gujarat, Mahakaleshwar Jyotirlinga in Ujjain, MP., Omkareshwar Jyotirlinga in Khandhwa, MP., Vaidyanath Jyotirlinga in Deoghar, Jharkhand, Bhimashankar Jyotirlinga in Pune, Nageshwar Jyotirlinga in Dwaraka, Gujarat, Trayambakakeshwar Jyotirlinga in Nasik, Grishneshwar Jyotirlinga in Aurangabad, and Mallikarjuna Jyotirlinga in Srisailam, Andhra Pradesh. Later Vibhishana installed a Jyotirlinga in the form of a Spatikalingam and that is by the side of Visalakshi shrine.

HISTORY OF THE TEMPLE

The temple in its current form is believed to have been built during the 17th century. The temple is said to have been sanctioned for construction by King Kizhavan Sethupathi or Raghunatha Kilavan. The contribution of Jaffna Kings of Pandya Dynasty to the temple were considerable. King Jeyaveera Cinkaiariyan (1380-1410 CE) shipped stone blocks from Koneswaram temple, Trincomalee



to renovate the temple's sanctum sanctorum. Jeyaveera CinKaiariyan's successor Gunaveera Cinkaiariyan (Pararacacekaran V), a trustee at Rameswaram who also oversaw structural development of this temple and the promotion of Saivite beliefs donated part of his revenue to Koneeswaran. Especially to be remembered are the immense sums that were spent during the tenure of Pradani Muthirulappa Pillai towards the restoration of the Pagodas which were falling into ruins and the splendid Chokkattam Mandapam or the cloistered precincts of the temple at Rameswaram that he finally completed. The rulers of Sri Lanka also contributed to the temple. Parakrama Babu (1153-1186 CE) was involved in the construction of the sanctum sanctorum of the temple. Also, Sri Lankan King, Nissanka Malla, contributed to the temple's development by making donations and sending workers.

Pappakudi, a village was donated as a grant to Rameswaram Temple and one Deva Venkala Perumal Ramanathar in (1667 CE) by Perumal Servaikaran, son of Sokkappan Servaikarar who belongs to Pandiyur. They were local Cheftain under Tirumalai Regunatha Sethupathy Thevar Rein in Ramnad Kingdom.

The temple is one of the most famous pilgrimage sites and has several historical references about it. The Maratha Kings who ruled Thanjavur established Chatrams (Choultrries) or rest houses throughout Mayiladuthurai and Rameswaram between 1745 and 1837 CE and donated them to the temple.

SPECIAL FEATURE



ARCHITECTURE OF THE TEMPLE



Like all ancient temples in South India, there is a high compound wall (madil) on all four sides of the temple premises measuring about 865 feet long from east to west and about 657 feet long from north to south with huge towers (Gopurams) to the east and west and finished gate towers on the north and south. The most striking feature of the temple is that there are long corridors in its interior, running between huge colonnades on platforms about five feet high. The junction of the third corridor on the west and the paved way leading from the western gopuram to Sethumadhava shrine forms a unique form of a Chess Board known as Chokkattan Mandapam, where the Utsava deities are adorned and kept during Vasantotsavam (Spring festival). The outer set of corridors is reputed to be the longest in the world being about 400 ft. each in the east and west and 640 ft. each in the north and south and the inner corridors are about 224 ft. each in east and west and about 352 ft. each in the north and south. The total length of these corridors is about 3850 ft. There are about 1200 pillars in the outer corridor. These pillars form the most impressive structure in the temple.



The colossal granite walls are marked by intricate carvings and depictions of Hindu deities. There are five main halls namely; Sukravara Mandapam, Anuppu Mandapam, Setupati Mandapam, Nandi Mandapam and Kalyana Mandapam. Inside the sanctum sanctorum lies the two lingams – the Ramalingam and the Visvalingam. One can also see a huge statue of Nandi, Siva's bull vehicle, which is a source of awe due to its 12 ft. long and 9 ft. high form.

There are separate shrines for Sri Ramanathaswamy and His Consort Goddess Parvathavardhini separated by a corridor. There are separate shrines for the Goddess Visalakshi, the utsava images, sayanagriha, Lord Vishnu and Lord Ganesa.

The samadhi of the great Yogi Patanjali is said to be in this temple and there is a separate shrine for him also.

INTERESTING FACTS ABOUT THIS TEMPLE

People from all the world flock to this temple because it is so majestic and grand. Some of other fascinating facts about this temple are:

 Among all the Hindu temples in India, this one has the longest corridor.

- The temple's interior features Extensive halls that span between massive colonnades on platforms more than five feet high.
- The intersection of the third corridor on the west and the paved path leading from the western gopurams to the Sethumadhava shrine forms a unique structure in the shape of a chess board, and so it is popularly known as Chokkattam Mandapam.
- The outer set of corridors is reputed to be the longest in the world being about 6.9 m in height, 400 feet in each east and west and about 640 feet in north and south and inner corridors are about 224 feet in the east and west and about 352 feet each in north and south.



- It is one of the 275 Paadal Petra Sthalams, and three of the most respected Nayanmars (Saivvite Saints), Appar, Sundarar and Thirugnana Sambandar, have exalted it with their singings.
- This temple is one of the 12 Jyothirlinga temples, where Lord Siva is worshipped in the shape of a Jyotirlingam, meaning *Pillar of Lights*.
- This temple is one of the holiest *Hindu Char Dham* (four divine sites comprising of *Badrinath*, *Puri*, *Dwaraka and Rameswaram*.


THE THEERTHAMS INSIDE THE TEMPLE AND THEIR SIGNIFICANCE

Agni Theertham is the primary sea shore associated with this temple. It is submerged under the sea and hence the snanam ritual starts from taking a dip at Agni theertham. It is just a walking distance from the temple entrance. There are sixty-four Theerthas (holy water bodies) in and around the island of Rameswaram, Tamil Nadu. According to Skanda Purana, twenty-four of them are important. Bathing in these Theerthas is a

major aspect of the pilgrimage to Rameswaram and is considered equivalent to penance.

Twenty-two of the Theerthas are within the Sri Ramanathaswamy Temple. The number twentytwo indicates the twenty-two arrows in Sri Rama's quiver. These twenty-two theerthams are said to be dug by Lord Rama when he fired His arrows piercing the sand. The twentytwo theerthas that are within the temple are: 1. Mahalakshmi Theertham; 2. Savithri Theertham, (3) Gayatri Theertham, (4) Saraswathi Theertham, (5) Sethu Madhava Theertham, (6) Gandhamadhana Theertham, (7) Kavatcha Theertham, (8) Gavaya Theertham, (9) Nala Theertham, (10) Neela Theertham, (11) Sanku Theertham, (12) Sakkara Theertham, (13) Brahmahati Theertham, (14) Soorya Theertham, (15) Chandra Theertham, (16) Ganga Theertham, (17) Yamuna Theertham, (18) Gaya Theertham, (19) Siva Theertham, (20) Sadhayamirtha Theertham, (21) Sarva Theertham and (22) Kodi Theertham

O years have passed since I **OU**settled in Canada. I graduated here and have a good job. I am leading a comfortable life with a spacious house and children, but no peace of mind. I know that you all will be asking the question as to why I don't have peace of mind. This is not a commodity you buy from a shop. This is a state of your mind, a feeling of the mind or a wishful thinking. Many Sages and Saints have written and spoken about this from time immemorial. Many of you may have listened to the movie song "Enge Nimmathi? (Where is peace of mind) written by poet Kannadasan. Whether he led a peaceful life is a big question. There are so many factors which influence one's peace of mind.

From the experiences I had from my early years and the way my parents and relatives lived their life, I learnt that the basics of a peaceful life are honesty, good behavior, love and responsibility. The main aim of most of our people in Canada is to accumulate wealth, by a big house and a costly car. I think this may apply to other communities as well. This may be the natural aim of most human beings. But the fault lies in how we achieve this or go about to achieve it. This may be the factor which arises as a problem in your life and causes the disturbance of your peace of mind. This situation will lead to pain, agony, stress and disease in the long run. I thought that my life may be a lesson to others and hence decided to relate it here.

Our home phone was ringing during the weekends and at night. When I answered the phone the people who called asked me whether my husband was at home and when I replied in the negative, they told their names and asked me to pass the message to him. I took this casually at the beginning. When I told my husband about these phone calls, he took it lightly and said they have no work and called to find out about any possibility. But as the days passed by the calls were many and caused problems. Some of them told me that

my husband had borrowed money from them and never returned. Some of the calls were threatening and as a result they caused me pain and also spoiled the studies of my children. When I asked my husband about this, he told me that he had already returned the money and told me not to answer the phone anymore. But the calls were continuing nonstop. Some threatening calls were recorded in our voicemail. So, he canceled the voicemail. As a result, some of my relatives complained that they are unable to contact us by phone. We were in a predicament to change our phone number since the present number was registered with the bank, family doctor and some government departments.

After this, the people who met me told me stories about my husband which were shocking. Some unknown people knocked at the door and told stories about his dishonesty. As a result, I started losing my peace of mind. I am holding a very responsible job which necessitates peace of mind and happiness. As a result, I found

it difficult to manage my daily work. I am in a highly paid job and my husband did not have a permanent job. He used to leave home early in the morning and come back late at night. At the end of every month, he used to give me a check for \$1,000. Sometimes he failed to give me this. As a result, there were arguments at home in front of the children. Sometimes I used to send my children upstairs and quarrel with him. I was looking after the household expenses, and he took the responsibility of paying the mortgage, electricity, water and other maintenance. I found that these were in arrears, even though I gave the money to him to pay for all these. He never paid them and used the money for something else. One day the bank manager called me for non-payment of the mortgage for 2 months. This was shocking news because I gave him the money to be paid.

As far as I remember my parents were conducting the Family Matters in an organized and systematic manner. They brought up their children in a better way and made them an engineer, a teacher and a financial advisor, even though they were new immigrants trying to establish their family in a new country. My father worked two jobs at the beginning and my mother also worked. They spent according to what they earned. There was peace at home and the children also realized their responsibility and studied well.

I found my husband was telling lies, dishonest and hiding his activities from me. This aggravated my peace of mind. I never divulged these to anyone as this was a shame on the family. I tried my level best to explain this to him, but it fell on deaf ears. I felt that the situation was getting worse and hence told my parents about it. They came home and discussed with him and warned him to get a permanent job and to refrain from these unwanted activities. After this it seemed to have a slight Improvement in his behavior, but things took a different turn. One day he started an argument with me accusing me of spreading the story of him as an unemployed, dishonest liar and a good for nothing guy.

One day the bank manager called me and asked me to meet her.. I took leave from my job and went and met her. She was a very kind lady and told me that our mortgage payment is overdue and also the line of credit you both signed last month is also overdue.

This was a big blow to me. Because I never knew anything about the line of credit for \$50,000 and never signed on anything. Immediately it dawned on me that someone else must have signed for the line of credit. Had I told this to the manager I hope you all could have known the consequences. He and the lady who signed would have been in hot water. Hence, I told her that we are facing some financial difficulties and that I would try to pay as soon as possible. I returned home with a heavy heart. As usual he left early and came home late in the night. I had no chance of verifying this from him. I knew very well that he was trying to avoid me. Whenever I called him on his cell phone, he used to say that he's busy with work and would call me later. I got more worried and feeling desperate. So finally I decided to withdraw money from my RRSP by paying more tax and paying off the line of credit. This RRSP was contributed by me before marriage. One day I had the chance to ask him about this line of credit. He started telling lies and it made me angry. It turned out to be a big quarrel. More than the money taking a woman to forge my signature made me mad. I lost my patience. I was feeling helpless and frustrated. My children were watching my pathetic plight, and they were dumbfounded and started crying. No one must meet such an awful situation. The entire family was affected by an irresponsible husband. Men must be aware of this very sensitive issue. I am not trying to condemn all the husbands by saying so. This situation was a deep blow to me and my children. I hope such a situation must not arise in your family or in your lifetime ever. When I was going through this trauma, my husband was as usual, telling lies and behaving as if everything was normal. This made me more angry. I started shouting at the top of my voice and cried aloud. He remained like a stone. I felt dizzy and sat on the chair nearby. My daughter came rushing and embraced me crying. She was 8 years old then and my son was 12 years old. He also started crying. My husband consoled them and took them upstairs. I found it difficult to carry on life with him and decided to go for a divorce. But my children were shocked and shouted, "No no don't do that Amma". My husband explained that he did this because he was unemployed and had no other way to

manage the family's financial matters.

Finally, because of the children I warned him and told him that I will not tolerate any more of his untoward behavior.

Now I am managing the finances myself without relying on him. I'm in a wait and see mood. A husband and wife must take the responsibility of running the family. There should be an open discussion among them and no hiding of events or facts. A family is a sacred Institution, and we are the ones guiding our children's future. If one of us makes a mistake it will affect the entire family. An unemployed person must realize his responsibility and must look for any kind of job to make the ball rolling. There are plenty of jobs available in the market. I knew of several men who were holding very noble jobs like teachers and doctors back home, who were employed as gas station attendants and security guards after arriving in Canada. Unlike in our Asian countries, any job in Canada is highly respected. Our community is known for its strict code of conduct and moral values. Marriage is regarded as a sacred bond and both husband and wife must stay together through thick and thin until their death. Divorce and separation are unheard in our society. We must grin and bear any shortcomings and live with many trials and tribulations to safeguard the family values.

I sometimes wonder whether it is worth the sacrifice of my wishes and pleasure for the sake of my children. In order to safeguard our family values now I am living like a dead person. I wanted to give my husband a chance to reform himself. I thought of seeking the help of a family counselor and on inquiry found that they not only grab money out of you for several sessions, but also finally advise you to go for divorce, which may end in a long litigation. What will happen to the children if you are divorced? Not only do you spoil your life and peace of mind but also your children's life. Hence, I finally decided to continue my life as a dead person walking for the sake of my children. Some of you may think that I am foolish in sacrificing my life for the sake of my family. But I am hoping that my husband will turn a new leaf in life by realizing his follies. But the views and activities of our younger generation are exactly opposite of mine. They are following the footsteps of the majority communities and as a result divorce and separation are the norms of the present-day life of theirs.





19TH YEAR IN CIRCULATION

My residency in Internal Medicine in the Bronx was marked by the harrowing presence of the AIDS epidemic, where patients faced agonizing deaths with little hope for effective treatment. The residency itself was a grueling experience. To make matters worse, we had to break the worst news to our patients — the diagnosis of HIV positivity — a soul-crushing task. However, amidst this darkness, there was a glimmer of hope during our Endocrinology rotation, embodied in the form of Dr. Ernest Swartz. A towering giant in physical stature, yet a kind-hearted man of gentle demeanor, his mere presence erased the burdens we carried. During that time, both my parents were battling complications of diabetes, making Dr. Swartz the ideal person to pose my nagging question, "What are my chances of developing diabetes?" His signature laughter lingered for a while, then he offered a riddle in response. He said it wasn't that difficult to avoid diabetes as long as I could keep myself perpetually hungry. I was left baffled, unsure of what to make of his answer.

A little over a century ago, a similar situation prevailed: doctors braced themselves before delivering the diagnosis of juvenile diabetes to parents—it was a death sentence in every sense. Refusing the recommended starvation diet keeping a child in perpetual hunger — for an emaciated child meant certain death within a year. Even with consent, the treatment could only prolong the agony for another one or two years. Sadly, the treatment was worse than the disease itself.

Fortunately, in Toronto, amidst quarrelsome partnership, an awkward

quartet, Banting, Best, Collip, and Macleod, pioneered the discovery of insulin as a solution. Thanks to the mass production efforts of Eli Lilly and Company, this breakthrough brought an end to the tragic era of untreated Type 1 Diabetes. Yet, the drama surrounding insulin's discovery persisted before and after its Nobel Prize recognition. . . awarded eventually to only Banting and Macleod, infuriating not only the other two but many more from the woodwork. Initially hailed as a cure, insulin ultimately proved to be more of a band-aid, merely postponing major complications, especially for those who failed to adhere to dietary restrictions.

Then, the era of plenty ushered in a new challenge: the widespread prevalence of Type 2 Diabetes. This issue stemmed from an excessive demand on insulin production within the body, compounded by the body's lack of response to the available insulin, known as insulin resistance. Consequently, a multitude of oral agents flooded the market — some designed to stimulate the pancreas to produce more insulin, others aimed at curbing sugar output from the liver, and still others focused on enhancing the responsiveness of the liver, fat tissues and muscles to insulin. However, these medications again offered more of a temporary solution than a permanent cure. As expected, complications persisted, albeit with a delayed onset. None of these agents provided robust protection against life-threatening complications such as heart attacks and strokes.

Among the array of oral agents, the class known as Biguanides, faced widespread rejection due to earlier instances of causing lactic acidosis (Except in developing countries). Metformin, as part of the same group, endured skepticism merely due to its association.

Its redemption came after a prolonged FDA scrutiny. Soon, with the findings of the UK Prospective Diabetes Study (UKPDS), Metformin would ascend to become the primary treatment for type 2 diabetes, a position it would firmly hold in the USA since 1995, barring exceptional circumstances such as kidney impairment. However, this dominance has recently faced challenges with the introduction of two new classes of medications. But before we explore them, it is essential to examine the method of measuring blood sugar that facilitated numerous drug trials and clinical practice in general — the emergence of Hemoglobin A1c.

In the 1960s, Samuel Rahbar developed a fascination with the hemoglobin molecule. As electrophoresis (identification) advanced and interest in sickle cell anemia grew, Rahbar eagerly sought out new genetic variants. In Teheran, he stumbled upon a subtle variant of the most common form, Hemoglobin A, that diverged from the norm. Further investigation revealed a common characteristic among these patients: they all suffered from diabetes.

Like many scientists, Rahbar's peripatetic nature led him to the Bronx, where he found himself with access to a wealth of blood samples. Once again, he observed the same pattern, this time in every sample, but particularly pronounced in those with diabetes. A thorough review of existing literature revealed the identification of five subtypes of Hemoglobin A1 (A1a, A1b, A1c, A1d, and A1e), with Rahbar's findings closely resembling A1c.

In his discovery, he observed that nondiabetics typically possessed less than 6% of A1c band while diabetics possessed more than 7.5% of total hemoglobin, attributed to the addition of glucose during the red cell's lifespan, since red cell

doesn't possess nucleus any addition must come from without. Thus, the birth of Hemoglobin A1c as a marker for diabetes control emerged.

Let's now delve into the two new classes of medications: in 1932, Belgian scientist La Barre introduced the term "incretin" to describe substances released from the intestines in response to food ingestion. This concept gained traction as researchers repeatedly observed variations in blood sugar decline rates following oral versus intravenous sugar administration. Such disparities indicated more pronounced insulin spikes with the oral route, underscoring the significance of gut-secreted factors in regulating insulin release.

But identifying these factors felt like a herculean challenge. Many tried and failed repeatedly. When the identification of these factors reached an impasse, influential scientists conveniently dismissed their existence. As a result, the search for "incretins" was shelved for nearly half a century. However, interest was revived with the invention of radioimmunoassay—a breakthrough credited to Rosalyn Yalow, a scientist at the Bronx Veterans Administration. This innovative technique allowed for precise measurements of known hormones, enabling the detection of even the minute fluctuations during the incretin effect and paving the way for the identification of incretins.

The first identified incretin was GIP (Glucose-dependent Insulinotropic Polypeptide), followed by GLP-1 and GLP-2, both bore resemblance to glucagon and were hence termed glucagon-like peptides (GLP). Habener and Drucker took this further and uncovered truncated forms of GLP-1, possessing heightened incretin effects, notably in inducing increased insulin production.

Just like the discovery of insulin has its blemishes, the GLP-1 story couldn't escape one of its own: Svetlana Mojsov. a scientist from Rockefeller University, conducted independent research on GLP-1, including synthetic GLP-1 and its antibodies, during her time at Massachusetts General Hospital. Having worked with Drucker, who was under Habner's supervision at that time, she made a shocking revelation, accusing Habener of deliberately excluding her from patents relating to these discoveries. Legal battles ensued, ultimately resulting in Mojsov's rightful inclusion on the patents. Despite this victory, she was unjustly overlooked for the prestigious accolades repeatedly bestowed upon her male counterparts. However, recent recognition as one of the 100 most influential pioneers in the world has finally brought her the acknowledgment she deserves.

With incretins now identified and measurable, their ability to increase insulin levels in response to food intake presents a promising avenue for combating diabetes. Moreover, the socalled incretin effect fades once food is metabolized, preventing a dangerous drop in blood sugar levels. Scientists

recognized the potential of harnessing these properties against diabetes, but encountered a hurdle: GLP-1 is easily degraded by the enzyme DPP-4. To address this challenge, researchers explored two avenues: inhibiting DPP-4 or developing a mimic for the GLP-1 that bypasses DPP-4. For the former, oral DPP-4 inhibitors were developed, but they proved to be weak in their incretin effect. (sitagliptin)

For the latter, a mimic of GLP-1 that bypasses the DPP-4 enzyme was found in the southwestern part of the United States, where Gila Dragons exist. It's their saliva that contains this mimic, and once isolated, it was named exendin-4 Isolation was done by an endocrinologist, John Eng, once again at the Bronx VA and proved to be effective. With that, the first GLP-1 receptor agonist was born in 2005 (Exenatide).

The development of human GLP-1 mimetics that resist degradation and combine with albumin to prolong their systemic presence was pioneered by Bjerre Knudsen in Copenhagen. This innovation led to the creation of Liraglutide in 2010 and once a week injection Semaglutide in 2017. Building on this foundation. Richard DiMarchi and Matthias Tschöp advanced the field by combining GLP 1 with GIP, resulting in Tirzepatide. Tirzepatide demonstrated remarkable weight loss effects in addition to its antidiabetic properties. Both scientists further enhanced this approach by developing a triple agonist—Retatrutide—that targets GLP-1, GIP, and glucagon, achieving even greater weight loss.

These advancements underscore a significant shift in understanding endocrine regulation. The focus is moving away from traditional endocrine organs like the thyroid, pituitary, and adrenals, and towards the gut and surrounding fat tissues. Emerging research highlights that these regions may constitute the body's largest endocrine system, with ongoing investigations on known gut and adipose hormones (adipokines) and also searching for new incretins, promising to unlock new therapeutic potentials.

The initial aim of developing human GLP-1 mimetics was to reduce blood sugar levels. However, this search quickly expanded into various other critical areas, significantly impacting clinical practice Studies have unequivocally confirmed that these treatments provide protection against heart attacks, strokes, kidney failure, and liver failure, particularly from fatty liver disease. Additionally, they are well-known for their effectiveness in promoting weight loss. Ongoing research is exploring their potential benefits for memory loss and Parkinson's disease. The benefits from bariatric surgery partly stem from the inadvertent manipulation of these hormones, namely reduction in hunger hormone Ghrelin and escalation of satiety hormones GLP-1 and Peptide YY. While the West is reaping the benefits of these medical advancements, many developing countries remain largely unaware of these innovations. Bridging this gap is crucial to ensure that people

worldwide can access these life-saving treatments.

Having explored incretins, let's now shift to the second newer class of drugs—SGLT-2 inhibitors, introduced around 12 years ago. The body conserves energy, especially sugar, through the kidneys, which reabsorb glucose via cotransporters (SGLT-1 and SGLT-2). While advantageous during times of energy scarcity, this mechanism becomes detrimental in cases of energy excess.

People lacking these cotransporters due to genetic variations excrete more sugar in their urine and maintain lower blood sugar levels. Surprisingly, they also never develop low blood sugar levels. This phenomenon inspired researchers to find a way to mimic this effect. Interestingly, the discovery began with phlorizin, a compound from apple tree roots initially investigated for its antimalarial properties, which caused glucose excretion in humans by blocking the function of cotransporters.

This led to the development of synthetic analogs that block SGLT-2. Initially aimed at reducing excess blood sugar, SGLT-2 inhibitors, like GLP-1 agonists, have since shown additional benefits, such as reducing heart failure and kidney failure. Remarkably, they are also effective in treating heart failure in patients without diabetes, due to their safety profile in not causing hypoglycemia. The two most common SGLT-2 inhibitors are Empagliflozin and Dapagliflozin.

Initially, the medical community in the West faced significant challenges in encouraging patients to accept new treatments, due to factors such as cost, insurance refusals, and patient uncertainty. However, public awareness and demand for these treatments, especially GLP-1 agonists, skyrocketed after high-profile endorsements from celebrities like Oprah Winfrey, particularly highlighting their effectiveness in weight loss.


This surge in popularity, coupled with the recognition of obesity as a disease, has, in my opinion, veered the narrative in the wrong direction, shifting the focus away from personal responsibility and the fight against the powerful processed food industry in addressing the obesity crisis. Additionally, the medical community's push for the early use of these treatments in childhood obesity has sparked debate. Concerns have arisen about the ethical and financial implications of placing a large population on lifelong medication from early childhood onwards.

Amidst such ambivalence, I thought about Dr. Swartz and was saddened to learn of his passing. His obituary mentioned that he was still perusing endocrinology journals well into his 90s. I couldn't help but wonder what he would have thought about these recent developments. Knowing his keen insight and sense of humor, he likely would have admired the development of the new classes of medications but also would have had a hearty chuckle at how the narratives on obesity seem to place the blame solely on nuances of endocrinology.
